TO ALL STUDENTS

In terms of Article 5(xi) of the Statute of the International School for Foundation Studies, two members are elected by and from among the students of the School. In accordance with Article 6 of the Statute of the International School for Foundation Studies, the term of office is of one year, renewable for up to four years.

There are <u>two</u> vacancies on the Board of the International School for Foundation Studies and the term of office shall extend from 21 March 2024 till 20 March 2025, renewable for up to four years, till 20th March 2028.

Nominations, on forms available from the University of Malta website (http://www.um.edu.mt/studentrepresentatives), are to be handed in at Help Hub or via email on helphub@um.edu.mt by not later than noon of Friday 23 February, 2024.

Nominations are to be duly proposed and seconded by enrolled students. Nominated students are required to signify, in writing, acceptance of their nomination.

Nominations received will be published on the University of Malta website on <u>Tuesday 5 March</u>, <u>2024</u> and all students will be informed of this by email.

<u>Eligibility to vote:</u> All students enrolled at the International School for Foundation Studies during the current academic year.

Voting for these elections will take place on <u>Thursday 21 March, 2024</u> between 9:00 a.m. and 5:00 p.m.

An **ONLINE** election system will be used. On the day of the election, you will receive an e-mail on your University e-mail account with a link to vote. You can only vote once and your voting choices will remain anonymous.
