It-Tabib Paul Cassar twieled fl-1914. Studja fil-Liceo u fl-Universita` ta' Malta, fejn iggradwa bl-unuri fil-Medicina fl-1940. Hu serva bhala tabib tul it-Tieni Gwerra Dinjija fi sptarijiet ta' emergenza f'Malta u fir-Renju Unit. Inghata rikonoxximent ghas-servizz siewi li ta.

Wara li ghamel studji *post-graduate* fil-Psikjatrija f'Londra ģie lura Malta fejn minbarra l-professjoni tieghu sab żmien biex jaghmel riċerka estensiva dwar suġġetti differenti ta' l-istorja Maltija. Il-ktieb tieghu *Medical History of Malta*, ippublikat fl-1965 ģie rrikonoxxut mad-dinja kollha u wassal biex Dr Cassar inghata Honorary Fellowship mill-Universita' ta' Malta (1970).

Minbarra diversi artikli li ģew ippublikati f'ģurnali medići u storići, hawn Malta u f'pajjiżi ohra, hu kiteb ghadd ta' kotba li ttrattaw aspetti diversi dwar l-istorja medika ta' Malta.

Cassar kien membru ta' l-istaff akkademiku tal-Fakultajiet tal-Mediċina u tal-Liġi, bħala għalliem u Eżaminatur tal-Psikatrija u tal-Mediċina Forensika. Kien ukoll membru tal-Kumitat ta' l-Antikitajiet, tat-Tribunal tas-Sahħa Mentali, tal-Hospital Management Committee tal-Isptar San Luqa (Malta), Supretendent Mediku ta' l-Isptar Monte Carmeli, H'Attard (1963), Konsulent Psikjatriku tal-Ministeru tas-Sahħa (1964), Past President tal-British Medical Association (Fergha ta' Malta 1966), kif ukoll Serving Brother tal-Venerable Order of the Hospital of St John of Jerusalem (British Realm) (1967).

Cassar hu membru tal-Malta Historical Society, ta' l-Academy of the History of Pharmacy u ta' l-Assoċjazzjoni tal-Psikjatri Maltin.

Dr Paul Cassar was born in 1914 and received his education at the Lyceum and the University of Malta, from where he qualified with honours as a medical doctor in 1940. He served in a medical capacity during the Second World War.

After undergoing postgraduate studies in psychiatry, he returned to Malta where in addition to the excercise of his profession, he found time to carry out extensive research in various aspects in Maltese history. His scholarly work *Medical History of Malta*, published in 1965 has earned him international recognition and the unique Honorary Fellowship of the University of Malta (1970).

Besides numerous articles and papers in Maltese and foreign medical and historical journals, Cassar has also written a number of books dealing with various aspects of Maltese medical history.

He has served on the teaching staff of the Faculties of Medicine and Laws of the University of Malta, and as Lecturer and Examiner of Psychiatry and Forensic Medicine. He was also a member of the Antiquities Committee, the Mental Health Tribunal, the Hospital Management Committee of St Luke's Hospital, Physician Superintendant of Mount Carmel Hospital, Attard (1963), Consultant Psychiatrist at the Ministry of Health (1964), Past President of the British Medical Association (Malta Branch) (1966), Serving Brother of the Venerable Order of St John of Jerusalem (British Realm) (1967). D.Litt. (Honoris Causa) was conferred upon him by the University of Malta in 1984.

He is a member of the Historical Society of Malta, of the International Academy of the History of Pharmacists and of the Association of Maltese Psychiatrists.
