M'għandix spazju biex nesprimi dak kollu li rrid ngħid – iżda mhux b'dan dizappuntat. Dizappuntat bil-mod kif qed niġu trattati mill-awtoritajiet konċernati u wisq iżjed mill-Eżekuttiv ta' l-Assoċjazzjoni tal-Pulizija ta' Malta (MPA). Donnu li l-Eżekuttiv tal-MPA, jew għal inqas xi uħud minnhom, tilfu dik il-ħeġġa li kellhom meta bdew iduru 'l hemm u 'l hawn biex jiġu eletti bħala membri tal-Eżekuttiv.

Ilni żmien twil nišhaq fuq l-importanza ta' komunikazzjoni bejn l-Eżekuttiv tal-MPA u l-membri tagħha kif ukoll mal-Midja in ġenerali. Sar xi titjeb fuq l-ewwel binarju meta twaqfet pagna fuq *Facebook* u saret *webpage*. Iżda dan mhux biżżejjed. Mhux kulhadd għandu *Facebook* account jew aċċess għal internet. Laqgħat ta' informazzjoni mad-delegati u wisq aktar mal-membri huma, fl-opinjoni tiegħi, importanti. F'dawn il-laqgħat, wieħed ikun jista' jagħmel domandi biex l-affarijiet jkunu aktar ċari.

Wara li saret pressjoni minni, fl-aħħar saret laqgħa nformali ta' informazzjoni għad-delegati tal-Konferenza Ġenerali. Din il-laqgħa tlabtha wara li l-Eżekuttiv kien laqqa' lil kull membru biex jinformat bl-offerta li għamel il-Gvern fuq it-talba ta' l-Assoċjazzjoni dwar il-ħlasijiet ta' l-*overtime* b'lura. L-Eżekuttiv dak iż-żmien kien stqarr li se ssir votazzjoni fuq din it-talba – din il-votazzjoni ma saritx u għalhekk xtaqt inkun naf, kif għandu dritt kull wieħed u waħda minna, x'gara wara dawk il-laqgħat li saru mal-membri tal-Korp u x'kienet r-raġuni li ma saritx il-votazzjoni.

Wara hafna qtiegħ il-qalb u skużi min-naħa ta' l-Eżekuttiv, fl-aħħar issejthet laqgħa fl-10 ta' Awwissu 2011. Pero' jiddispaċini ngħid li għalkemm kien hemm *attendanza* sabiħa ta' delegati, dan ma kienx il-każ min-naħa tal-membri tal-Eżekuttiv. Numru ta' membri tal-Eżekuttiv li ma kienux eżentati baqgħu ma dehrux u hallew lis-Segretarju waħdu! Din żgur mhux *attitudni* xierqa.

F'din il-laqgħa, fost hwejjeġ oħra, staqsejt x'qed jiġri fuq it-talba tal-MPA biex issir *Union*. Ir-risposta li ħadt kienet li ma kien hemm l-ebda *żviluppi*. Iżda, jien staqsejt kemm qed tkun pro-attiva l-MPA – per eżempju, ġie ppreparat xi abbozz ta' statut għal meta

jkun hemm *Union*? Risposta: Ie. X'qed nistennew? Għalfejn ma kkonsultajniex *Unions* tal-Pulizija ta' barra biex naraw x'għandhom huma u napplikawh għaċ-ċirkostanzi tagħna; għalfejn ma ppreparajniex abbozz aħna u ressaqnih lill-Ministru? Ma nistgħux nistennew il-bajtra taqa' f'ħalqna! Hemm bżonn li jibda eżercizzju immedjat biex jiġi ppreparat abbozz ta' statut ta' *Union*.

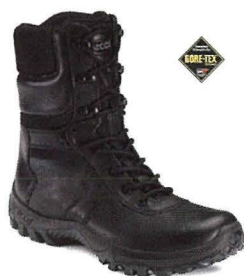
Staqsejt ukoll dwar ir-relazzjonijiet tal-MPA mal-Midja. Fl-1 ta' Ġunju 2011 u fit-12 ta' Lulju 2011, gazzetta prominenti lokali bl-Ingliż iddedikat l-Editorjal tagħha għall-Korp tal-Pulizija u t-talbiet tal-Assoċjazzjoni. Lanqas kien hemm kumment wieħed! Fejnu l-Eżekuttiv? Nistgħu naffordjaw li jkollna mbottatura bħal dik mill-Midja u norqdu fuqha? Ir-risposta min-naħa tal-Eżekuttiv kienet li biex joħroġu stqarrija irrid ikun hemm approval mill-Eżekuttiv kollu!! Iżda mill-1 ta' Ġunju sal-lum kien hemm żmien biżżejjed u xorta ma sar xejn.

Din m'hix serjeta! Nifhem li jrid ikun hemm struttura biex tiwverifika x'joħroġ lill-Midja iżda din m'għandhiex tkun b'mod li xxekkel li tiġi kkomunikata r-reazzjoni, pożittiva jew negattiva, tal-MPA. Setting Sail...

Cutting edge technology moves from dry land to the high seas

Around the world, Naval and Coastal guards are making use of high tech observation and detection equipment to combat crimes such as people trafficking and illegal fishing. But as criminals employ ever more clever techniques for evading detection, those policing them also require the use of increasingly capable technologies.

What is interesting to know is where these new technologies is coming from. With incredibly advanced hardware being developed and deployed to aid ground forces on operations in places like Afghanistan, it makes sense that some of the latest and sophisticated equipment for naval and coast guard use is actually being adapted from equipment originally developed for land-based troops. It means that sea and coast-based forces are now able to get rapid access to very sophisticated technology without the added costs of developing it from scratch.

The company already has a strong reputation for supplying high tech observation and detection systems to armies in the UK, Italy and other countries, but increasingly it is adapting these land-based systems to also meet the needs of sea-based forces.

One key example is the **LINX**. A handheld target locator which works during the day and at night, **LINX** can give its operator detailed targeting information including range and position data, and can also transmit the data back to a command post via a wireless data link.

The **LINX** has already been selected by the Italian Army for the "Soldato Futuro" soldier modernisation programme, but it is also an ideal fit for naval use, with the hand-held –binocular style-nature of the system making it work well on choppy seas. The rugged design of the system also makes it well suited to operations in harsh sea environments, meaning that crews are able to observe and acquire targets, sending image and location data back to commanders. In another example, the Janus-N is a naval variant of **SELEX Galileo's** well known Janus electro-optic turret for land applications. While the turret was originally developed for land applications, **SELEX Galileo's** close working relationship with the Italian Navy revealed that the Janus, with its high performance electro optics and stabilisation technology, was the perfect fit for a variety of naval vessels such as in-shore patrol boats, Search-and-Rescue platform and even Rigid-hull Inflatable Boats (RHIBs).

The systems have now been combat proven by the Italian Navy on board 'Classe Comandanti' patrol boats and the Navy is said to be extremely impressed with the results. Importantly, because the technology was already mature and in-service, **SELEX Galileo** were able to make the systems fully operational in just 10 months from the contract to supply them was signed. A smaller version of the Janus, known as Mini Janus, has also proved successful, with its low-cost panoramic sight for all kinds of vehicles providing commanders with advanced all-weather surveillance capabilities.
