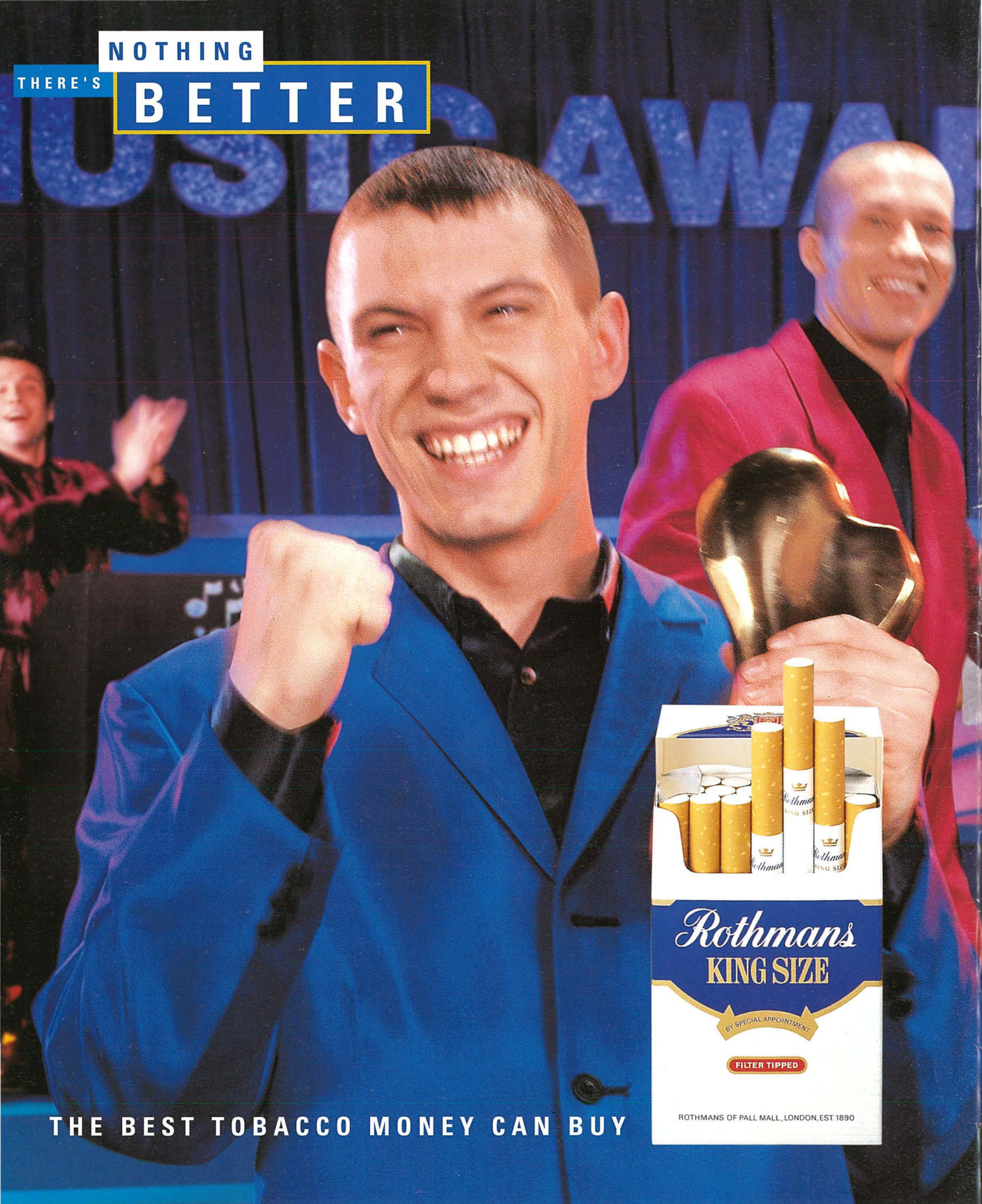

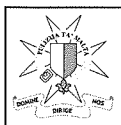

# Diskors tal-Kummissarju tal-Pulizija fl-okkażjoni tal-Ftuh Uffiċjali tal-Kumpless Amministrattiv

Iż-żmienijiet jinbidlu u magħhom irridu nġarrfu ninbidlu aħna.

Fi żminijiet li qegħdin ngħixu fihom illum wiehed irid iffittex li jsebbah l-ambjent li fih jaħdem hu u dawk ta' madwaru. Dan iġġodd aktar u aktar fil-konfront ta' dawk li mhux biss jagħmlu sigħat twal fuq il-lant tax-xogħol tagħhom iżda wkoll meta x-xogħol ikun diffiċli u li jirrekjedi attenzjoni kontinwa. Il-konfront ta' ambjent aħjar mhux biss itaffi l-inkonvenjet ta' hinijiet twal iżda jagħti mpetu ġdid lill dawk li jgawdu minnu.

Ma hemmx dubju li x-xogħol tal-iskwadri speċjalizzati fil-Korp tal-Pulizija u cioe dawk tas-C.I.D., Drogi, Vizzji, Frodi, Laboratorju Forensiku, huma fost ta' quddiem nett f'dak li huma hinijiet twal u ċirkostanzi kull tant xejn sbieħ. Ir riżultati pożittivi miksuba minnhom mhumieħ għajr frott ta' hidma sfieqa u twila u li mingħajra ma kienux jinkisbu r-riżultati li nkisbu.

Għalhekk kien aktar minn xieraq li dawn l-iskwadri speċjalizzati jingħataw ambjent ferm aħjar minn fejn huma jkunu jistgħu jaqdu d-doveri tagħhom. Kif tkunu tistgħu taraw aktar tard dawn l-iskwadri ser jibdeu jagħmlu użu minn xejn anqas minn 68 uffiċċji ġodda ukoll mġħammra fl-arja kondizzjonata u tagħmir ieħor

meħtieġ. Dawn il-kmamar jinkludu wkoll laboratorji, interrogation rooms, i.d. parade rooms minbarra restrooms u faċilitajiet oħra.

Magħquda magħhom hemm 49 ċella minflok 23 li kien hawn qabel li l-koll kemm huma għandhom aċċess dirett għall-arja u huma mġħammra b'faċilitajiet sanitarji u buzzers. Il-kumpless huwa fornutt wkoll b'erba lifts u jipprovdi sabieħ ma jkunx hemm kuntatt bejn persuni miżmuma u membri tal-pubbliku li l-preżenza tagħhom ikun meħtieġa matul l-investigazzjonijiet.

F'dan il-bini nsibu wkoll l-uffiċċju tal-Interpol, dak ġdid li qed jitwaqqaf għall-Europol u dak tas-Sirene u dan sabieħ il-Korp ikun imħejji kif jixraq meta Malta ssir parti mill-Unjoni Ewropea.

Il-bini ta' dan il-kumpless huwa lest u wara huwa maħsub li jingħataw bidu sabieħ jittraġaw is-swali ta' taħt dan il-kumpless. Għandna l-ħsieb li f'xi uħud minnhom jittellgħa mużew dwar ix-xogħol fejjedi tal-iskwadri speċjalizzati. Huwa wkoll il-ħsieb tagħna li f'wahda minn dawn is-swali mwaqqfu sala tal-Konferenzi mġħammra bi kmamar għall-interpreti filwaqt li l-oħrajn jittraġaw biex ikomplu jaqdu d-doveri tal-Laboratorju Forensiku.

Iżda sinjuri naħseb li l-koll taqblu miegħi meta ngħid li l-aqwa

element fil-hidma fejjedi tal-pulizija jibqa l-individwu. Għalkemm ambjent aħjar jikkontribwixxi bil-bosta fil-hidma ta' min ser jagħmel użu minn dan il-kumpless, huma d-dedikazzjoni, l-onesta, u l-lealta li jridu jmexxu l-quddiem il-hidma tagħna u jgħinuna nirbħu aktar u aktar il-fiduċja tal-poplu li lilu naqdu. Għaldaqstant f'isem shabi kollha nitolb lill Onor. Ministru sabieħ il-parti tal-kumpless minn fejn ser joperaw is-Diepartment tal-Investiazzjoni Kriminali tiġi dedikata lill ex Kuntistabbli MARK FARRUGIA li kif tafu l-koll ta' haġtu fit-tweġtieq tad-doveri tiegħu.

Qabel ma ngħaddi l-mikrofonu lill-Onor. Ministru nixtieq niringrazzja mill-qalb lill dawk kollha li taw sehemhom sabieħ sehħ dan il-proġett b'mod partikolari lill dawk il-membri tal-Korp li hadmu bla heda biex jaraw dan il-proġett jintemm fil-ħin. Baqgħalna hafna x'nagħmlu pero persważ li naslu wkoll.

Nieħu din l-okkażjoni sabieħ minn qalbi nrodd haġr ukoll lill Mro Chev. Abel J. Mizzi li matul dawn l-aħħar xhur ħa u qiegħed jieħu ħsieb il-Banda tal-Korp.

Grazzi ukoll lill Ambaxxaturi ta' diversi pajjiżi tal-ġħajnuna tagħhom kemm f'dak li hu tagħmir kif ukoll f'dawk li huma korsijiet.





# Diskors tal-Ministru Tonio Borg fl-okkazzjoni tal-Ftuh Uffiċjali tal-Kumplex Amministrattiv

Diskors tal-Ministru Tonio Borg fl-okkazzjoni tal-Ftuh tal-Kumplex Amministrattiv u Lock Up Gdid fil-kwartieri Generali tal-Pulizija, Floriana nhar it-Tlieta 17 ta' Lulju 2001.

Il-holma ta' dan il-proġett li se ninawguraw il-lejla, twieldet b'decizjoni tal-Kabinett tal-11 ta' Settembru, 1995. Dak in-nhar il-Kabinett approva fil-prinċipju r-rakkommandazzjonijiet li kont ghamiltu li jinbena kumplex amministrattiv u lock up gdid fil-kwartieri Generali tal-Pulizija. Fis-sottomissjonijiet tiegħi lill-Kabinett kont iddeskrivejt is-sitwazzjoni kif kienet dak in-nhar. Fil-fatt dak in-nhar l-uffiċini tal-Vice Squad, Interpol u Laboratorju Forensiku u CID kienu allokatu fi haxx-il-maħzen f'forma ta' 'huts'. Kollha kienu ibatu, f'gradi differenti, minn undita' kbira u s-sitwazzjoni kienet tal-biki. Kienu għoljin 34 filata, għalkemm seta' jintuzaw biss 10 filati, u l-hitan divizorji hafna drabi kienu wesghin 10 piedi, b'rizultat li terz biss tal-area okkupata setgħet tintuza.

Il-lock-up kien f'sitwazzjoni aghar. Kien jikkonsisti f'26 ċella mdeffsin f'tnejn mill-imħażen li semmejt. L-ebda waħda miċ-ċellel ma kellha aċċess dirett la għall-arja u lanqas għad-dawl naturali. Ma kien hemm l-ebda faċilita' sanitarja fl-ebda ċella.

Fl-1994 Qorti Maltija f'kaz li ġara fl-1986, qalet hekk:-

"Il-Qorti kienet preokkupata bil-kondizzjoni fil-Lock up fil-kwartieri Generali tal-Pulizija li fil-fema konsiderata tagħha hi tali li, fil-kumplex tagħha, tista' tiġi

kwalifikata li tirrazzenta ambjent li jiddegrada l-persuna u l-personalità umana" Il-Qorti osservat li wara li kienet zaret il-Lock up, kienet tal-fehma li

"hemm diversi fatti li immedjatament u ovvjament jirriżultaw ripunjanti għal min hu sensitiv għat-trattament dekoruz tal-persuna umana u dana f'termini bazici" (Joseph Azzopardi vs Kummissarju tal-Pulizija et)

Il-Qorti ikkritikat id-dawl ferm ristrett taċ-ċella, in-nuqqas ta' servizzi sanitarji, in-nuqqas ta' arja u dawl dirett, u nuqqas ta' ventilazzjoni. Kienet zjiedet il-Qorit:

"iċ-ċella hi nieqsa mid-dawl u arja tant li d-detenu jinzamm il-hin kollu illuminat artifiċjalment, qisu tiġieġa għall-produzzjoni".

Fir-Rapport tiegħu tal-1990, il-Kumitat tal-Prevenzjoni mit-Tortura (CPT) osserva hekk dwar l-istess post:-

"The cells are very small, poorly lit, and oppressive in design"

u kkundanna iktar il-fatt li dal-post, li bil-kemm kien diċenti għal min joqgħod fih għal-48 siegħa, kien 'jospita' fih l-immigranti illegali li ġieli kienu jqattgħu xhur sħaħ go fih.

Fl-1995, ic-CPT reġgħet qalet:-

'The Committee wishes to stress that the lock-up cannot be said to provide satisfactory conditions of detention for persons held for police questioning.'

Quddiem dan kollu, il-Kabinett ha decizjoni għaqlija fl-1995 li jibni dan il-kumplex u fil-Budget għas-sena 1996 giet ivvutata is-somma rekord ta' Lm800,000 bħala spiża kapitali għall-Pulizija li kellha tkopri parti mill-ispiza tal-bidu tax-xogħol tal-kumplex gdid. Illum dan il-kumplex sejjer mhux biss jelimina il-problemi li kienu jhammrulna wiċċna bħala pajjiz ċivilizzat, izda wkoll se jospita f'ambjent ta' xogħol hafna aħjar, l-uffiċini tal-iskwadri u taqsimiet speċjali tal-Korp tal-Pulizija.

L-investment ta' dan it-tip għandu żewġ merti. L-ewwelnett qed intejbu l-ambjent tax-xogħol tal-Pulizija tagħna, mill-kbir sa ż-żgħir. Dan għandu jzid is-sodisfazzjon tal-membri tal-Korp fix-xogħol tagħhom, u l-produttività tagħhom. It-tieni nett qed nuru lil kulhadd li l-Pulizija tal-lum, filwaqt li hija impenjata fiz-żamma tal-liġi u ta' l-ordni u il-ġlieda kontra 'il-kriminalità', hija kommissa ukoll li dil-ġlieda issir bil-mezzi u bis-saħħa tal-liġi u tal-harsien tad-dinjita' tal-bniedem.

Winston Churchill kien qal:

'The mood and temper of the public with regard to the treatment of crime and criminals is one of the most unfailing tests of the civilisation of any country'

Jekk dan hu minnu għal detenzjoni f'habs ta' persuni kundannati mill-Qorti, kemm iktar hu validu għal detenzjoni ta' persuna arrestat li hija biss sospettata li ikkommettet delitt. F'dan l-istadju preliminari ta' investigazzjoni, il-preżunzjoni ta'

I-innocenza hu iktar qawwi, u ghalhekk ma jrid isir b'xejn li bih persuna arrestata tigi deliberatament jew intimidata, anki bil-kundizzjonijiet materjali ta' l-ambjent ta' detenzjoni tagħha.

Dan kollu jista' jidher bħala tfettig jew dgħufija minn min il-ġlieda kontra il-kriminalita' qisha bħala ġlieda li tiġġustifika kollox u tghatti id-dnubiet kollha. Jiena ma nqishiex hekk. Il-Gvern ma jqishiex hekk. U ghalhekk se ninawguraw illum dan il-kumpless li se jsaħhah il-ġlieda kontra il-kriminalita', pero' se joffri dinjita' li kull min ighammar jew jahdem f'dal post, ufficjali tal-Pulizija jew cittadini privati.

Ir-responsabbilita' tal-ġlieda kontra il-kriminalita' ma hiex tal-Pulizija biss; hija tal-legislatur, tal-amministrazzjoni u fl-aħħar mil-aħħar tagħna ikoll.

Irrid ngħid illi il-Pulizija wettqet suċċessi mhux zgħar fil-ġlieda kontra il-kriminalita' b'mod speċjali dik konnessa mad-droga. Insemmi biss li fl-ewwel sitt xhur ta' dis-sena ġew mressqa il-Qorti 268 persuna fuq posess, zjeda ta' 34% fuq is-sena l-oħra kollha, 140 fuq traffikar, zjeda ta' 28% fuq tnax-il xahar tas-sena l-oħra, ġew arrestati fl-ewwel sitt xhur daqs kemm ġew arrestati is-sena kollha. Inghataw 271 sentenza f'sitt xhur, is-sena li għaddiet fi tnax-il xahar 254. Niehu gost ukoll ninnota li fl-ewwel sitt xhur ta' din is-sena ġie registrat kull xahar naqqis fiċ-ċifra ta' reati rapportati lill-Pulizija komparat mas-sena li għaddiet.

Fis-26 ta' Ġunju 2001 il-Gvern wara li kien ippublika White Paper f'Ottubru 2000, ipprezenta fil-Parlament Abbozz b'155 klawsola li jwettaq revizjoni shiha tal-Kofiċi Kriminali. Din ir-revizjoni tintrouci għall-ewwel darba ir-reat ta' kongura, dak ta' asoċjazzjoni biex wiehed iwettaq reat. I-uzura, it-traffikar illegali ta' persuni umani, il-mibegħda razzjali il-pornografija tat-tfal it-

trasmissjoni doluza ta' mard infettiv, ir-reat ta' korruzzjoni fis-settur privat, ir-reat speċifiku ta' mohqrija jew traskuraġni tat-tfal, ir-reat ta' min iwiegħed vantaġġ mhux xieraq lil haddieħor, ir-reat ta' min ma jhallasx il-manteniment li jkun ftiehem ma' martu.

Se nsaħhu il-posizzjoni tal-vittma tar-reati li għall-ewwel darba se jkollha d-dritt li tkun prezenti f'kull stadju tal-proceduri kriminali u anki tkun assistita minn avukat fil-maġġoranza tal-każi. Barra minn hekk tkun tista' tagħmel it-talba lill-Avukat Generali sabiex jappella minn sentenza tal-Qorti tal-Maġistrati.

L-Avukat Generali se jingħata id-dritt li jappella minn sentenzi tal-Qorti tal-Maġistrati. Se jkollu ukoll id-dritt li jitlob il-Qorti tawtorizza investigazzjonijiet speċjali, iffirzar u konfiska ta' assi f'reati ta' iktar minn sena prigunerija.

Irridu pero' nzommu il-bilanċ bejn id-drittijiet tal-individwu u dawk tas-soċjeta'. Għalhekk għall-ewwel darba, kull arrest jew tfittxija, hlief f'kazijiet urgenti, biex isiru, irid ikun hemm mandat 'warrant' ta' Maġistrat. Il-persuna arrestata se jkollha dritt li permezz tal-Pulizija tkkomunika il-fatt tal-arrest tagħha, jekk trid hi, lill-qraba tagħha. Se jkollha d-dritt li tigi eżaminata waqt li tkun arrestat f'dal-kumpless li se nifthu illum, minn tabib tal-għazla tagħha u fuq kollox se jkollha dritt li tikkonsulta ma' avukat tal-għazla tagħha għal siegħa qabel il-interrogazzjoni tagħha.

Il-Liġi tal-liberta' provvisorja qed tigi mibdula sabiex sa mill-ewwel seduta anki fuq talba verbali, tista' tintalab il-liberta' provvisorja. Barra minn hekk il-prattika tal-'habeas corpus' qed tigi inkorporata fil-liġi.

F'dawn l-aħħar tliet snin il-Gvern zjied l-ispiza kapitali b'40% fl-ewwel budget ta' din il-legislatura u zamm il-livell tal-vot għal spiza kapitali fuq l-istess livell għal tliet

snin. Dana kien ifisser illi l-ispiza konnessa ma' dan il-kumpless li laħqet kważi il-miljun lira (Lm 900,420) ma tippregudikax ix-xiri ta' tagħmir u vetturi għall-ġlieda kontra il-kriminalita'. Niehu gost inħabbar illi inxtrat magna kompjuterizzata ġdida li tqabbel id-data tal-fingerprints f'idejn il-Pulizija, tagħmir li għandu jhalli r-rizultati fil-futur qarib.

Barra minn dana l-ispiza rikorrenti tal-Pulizija zdieget b'26% fi tliet snin, filwaqt illi saru tliet reklutaġġi u għadu kif fetaħ ir-raba' wiehed. F'dawn l-erba' reklutaġġi l-applikanti għall-ewwel darba kellu jkollhom mill-inqas tliet 'O' levels bil-Matli u Ingliz obligatorji u fl-aħħar reklutaġġ it-tul, għalkemm jittiehed in konsiderazzjoni m'għadux fattur ta' eligibilita'. Il-kumpless il-ġdid li se ninawguraw huwa importanti. Izda l-ebda bini waħdu ma jilħaq l-iskop tiegħu jekk in-niew li jkun hemm fih u juzawh ma jkunux motivati fix-xogħol tagħhom. U l-ebda Pulizija waħdu u l-ebda skwadra waħedha ma jistgħu jilħqu l-ghan tagħhom jekk ma jkollhomx il-fiduċja tal-pubbliku. Dik il-fiduċja mill-istudji ta' stħarrig għadha hemm, izda trid tinkiseb u tintrebah kuljum. Tinkiseb bid-dixxiplina, bl-eżempju, bil-mod kif il-Pulizija jitttrattaw man-nies, anki dawk li jiksru il-liġi. Li wiehed ikun goff mal-pubbliku jagħmel hsara daqskemm tagħmel ġid azzjoni, mqar zghira, ta' solidarjeta' umana li hafna Pulizija juru mal-membri tal-pubbliku fil-mument meta dawn ta' l-aħħar l-iktar li jkunu mxennqa għal hniena u mogħdrija. Il-vizjoni tiegħi tal-Pulizija ma hiex ta' Pulizija vendikattiva izda ta' waħda li twettaq il-liġi mingħajr biza' u favuri, izda wkoll mimlija kompresjoni. J'Alla dal-pass importanti li qed niehdu illum iwettaq din il-vizjoni.

# THE SWISS GUARD AT THE VATICAN

## Bodyguards of the Pope

During the Holy Year of the Millennium, the Pope played a central role in the celebrations held by the Catholic Church and the Christian community. No less central is the role played by the Swiss guard in ensuring his security and well being. The Swiss Papal guard at the Vatican in Rome holds the distinction of being the world's smallest army, as well as the world's longest-serving unit of soldiers in Foreign Service. As an Army it is unique in that the Swiss Guard has served as the personal bodyguard of the Pope for almost five centuries and continues this duty today. The unit possesses a long, colourful history with traditions dating back to the Middle Ages, but fulfils an important real world security mission today for a major secular and spiritual head of state.

In terms of heritage, the guard was founded in 1506 at the height of Swiss military primacy in Europe. During this period, the Swiss were in high demand to serve as mercenaries in the European armies of the era. Their military prowess, trustworthiness, loyalty, and battlefield reputation were extraordinary, and they served as the palace and personal bodyguards for various European sovereigns. The Papacy was no exception to this trend. Impressed by their activities, Pope Jules II created his own unit of approximately 150 Swiss bodyguards in 1506.

In 1527, the Swiss guard had the opportunity to demonstrate its loyalty to the Pope in battle. In this year, an army of German mercenaries fighting for the Holy

Roman Emperor Charles V attacked Rome to plunder the Vatican and kill the Pope. On 6 May 1527, the Guard fought a fierce, rearguard action that allowed the Pope to flee across a passage to another, more secure fortress in Rome. In this action, 147 out of 189 Swiss guardsmen gave their lives for the Pope, and this event is celebrated annually by the Swiss guard to commemorate the battle. On this day, every serving Swiss Guardsman renews his oath to remain "true and honourable to the Pope and give his own life to this duty if necessary". All new recruits ledge to "lay down their life, if necessary, in defence of the supreme pontiff ... and his legitimate successors." Although several other military units have served the Papacy at different times over the past 500 years, the Swiss Guard alone remains in service. This was mandated in 1970, based upon the guard's historical link with the Vatican, its religious orientation, and its mission of providing personal security for the Pope.

## The Modern Day Mission

The Swiss guard's purpose today remains basically unchanged since its founding. Besides being the Vatican's titular Army, the unit's main mission is to guard and protect the Pope and ensure his personal safety and the security of his residence on a 24 hour basis. The following tasks are closely associated with this mission:

- Personal Protection Tasks: Escorting the Pope on his journeys abroad, protecting him and controlling

personal access to the Pope at all times.

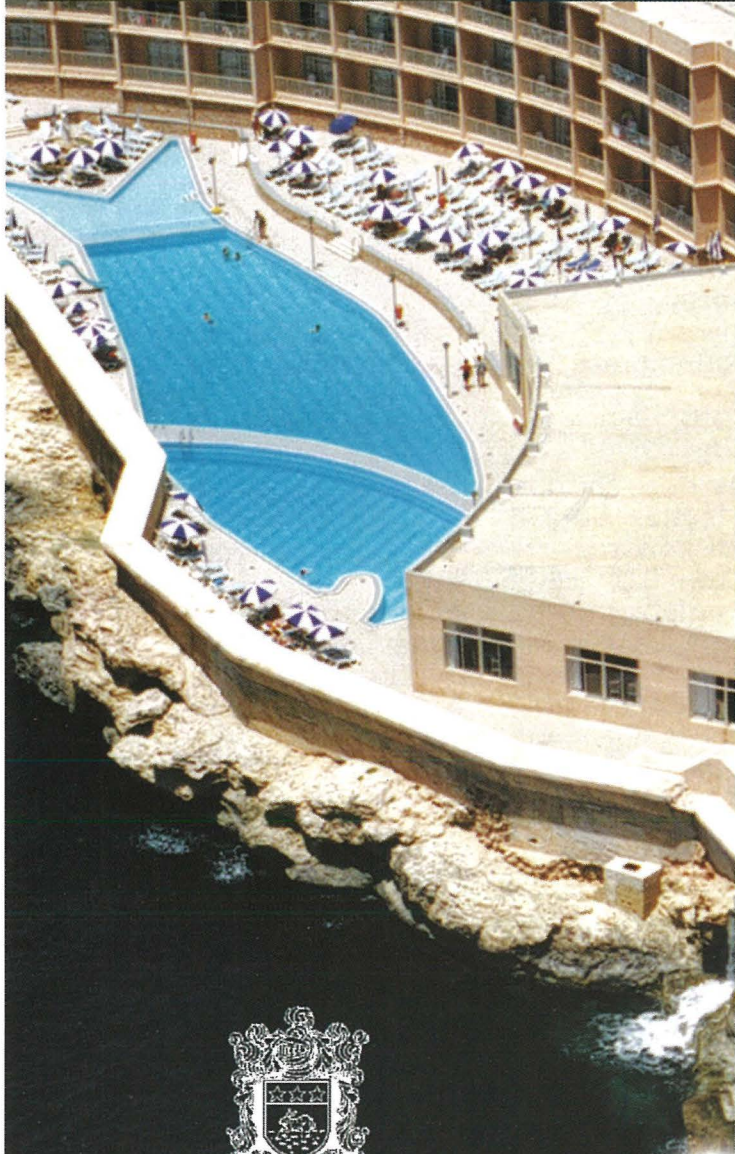
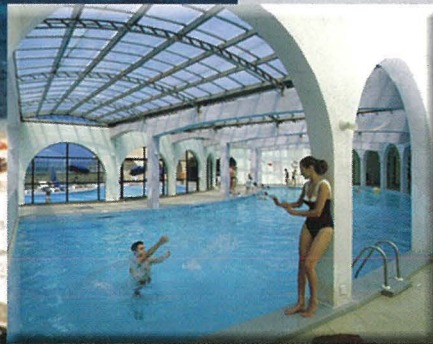
- Guard and Control Duties: controlling entry and exit in the Vatican, crowd control for Vatican public functions, and keeping order at Papal internal events.
- Ceremonial Duties: Performing formal duties for church functions and honouring visiting dignitaries.
- Performing other military duties as required.

Although ceremonies play a large, time-consuming role for the Guard, their core mission is a paramilitary function with primary emphasis on the personal security of the pope. Regular police duties and other law enforcement functions are performed by a small, unrelated Italian organization within the Vatican City.

## The Unit's Structure

Organizationally, the Swiss guard normally has a fixed strength of 100 men, organized into three platoons of approximately 30 men. To meet the additional security requirement of the Holy See for the Year 2000, at this authorized headcount has been increased to a strength of 110 soldiers. The Guard is commanded by a colonel who has three Officers, vice senior non-commissioned Officers, and 18 junior non commissioned Officers to assist him. The Colonel is considered a member of the Papal family and therefore enjoys great prestige and privileges within

the Vatican hierarchy. There is also a chaplain who holds the rank of Lieutenant colonel for the religious training and support of the Guardsmen.

Each candidate for the Swiss Guard must meet several prerequisites before being considered for admission into this elite unit. He must be an unbarred, Catholic, Swiss citizen between the ages of 19 and 30. He must be physically fit, have completed Swiss basic military training, and have a minimum height of five feet nine inches. With regards to education, he must possess an apprenticeship certificate of a Matura Diploma. Upon meeting these basic prerequisites, the prospective recruit is interviewed concerning his motivation and reasons for joining and his past involvement in the Catholic Church. This is followed by an examination of his medical condition. Once accepted, the Guardsman commits himself to a minimum of two years of service.

### Training

All Swiss Guardsmen have a 15-week Swiss military basic training as a foundation. In addition to his cornerstoned, the Guardsman will receive two to three additional weeks of initial Swiss guard specific recruit training at the Vatican. This phase includes unarmed self-defence, tear gas usage, weapons training with assault rifled, submachine gun and pistols, as well as halberd training for ceremonies only.

Additionally, the new Swiss Guard recruit must learn the basic knowledge concerning the Vatican, to include city layout, history, access control information, and Vatican key personnel recognition. Basic Italian language instruction is a further critical component of

training given the frequent contact with the Italian public and Vatican hierarchy. This language training is offered throughout the Guardsman's tenure at the Vatican and regular refresher training is given by the Guard cadre throughout the year in the areas of weapons, self-defence, and Vatican knowledge. Two to three times per year, the Swiss Guard attends an Italian military base for weapons training and receives additional support when necessary from the Italian Police and the paramilitary Carabinieri.

### Duties

A Guardsman's normal duty cycle is two days on and one day off, although special duties often preclude having a day off. Typically, two platoons are on duty, with the third platoon either free or used reinforcements for the other two. Variations to the duty cycle occur regularly based upon Vatican events and the Pope's agenda.

Guard duty also differs between a winter and summer organization when the Pope resides in Castle Gandolfo during the summer months. Guard posts, both stationary and mobile, are located throughout the Vatican for protection and access control purposes.

When the Pope travels abroad, he is accompanied by a contingent of officers for protection. In this capacity, the Swiss guard Officers wear civilian clothing and carry SIG 226 9mm pistols. Of course, the government hosting the Vatican visit also provides additional protection for the Pontiff, but the Swiss guard remains responsible for his direct personal safety.

A Swiss Guardsman is adequately paid for his duty and has the opportunity to receive a

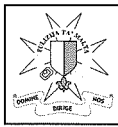
lifetime pension after either 10, 15, or 20 years of service. The Vatican housing, food, medical insurance, uniforms, and equipment, plus a fully paid one-month vacation for each year of an officer's service. As an additional benefit, Swissair provides all Guardsmen with a 50% reduction on their round trip flights from Rome to Switzerland for their holidays.

### Weaponry

In terms of weaponry, the Swiss Guard is reticent about revealing the full extent of this arsenal. Guardsmen typically train on the 7.5mm SIG 57 assault rifle as well as the 9mm Beretta M12 submachine gun. For handguns, the Swiss guard uses the 9mm SIG 226 and an undisclosed type of Beretta pistol. The deep pockets of the Guard's colourful blue and yellow striped trousers have space for tear gas spray for situations requiring non-lethal force. All guardsmen learn a mix of karate and judo as part of their unarmed combat training.

The most recently publicized security incident for the Swiss guard occurred in 1981 when the international terrorist Ali Agca tried to assassinate the Pope in St. Peter's Square, Rome. Fortunately, a Swiss guardsman overwhelmed him before he could complete his attempt. Thus, although the Swiss Guard may seem like ceremonial tiny soldiers to the general public, they are, in reality, a well trained and highly motivated paramilitary unit. The Swiss Papal guard serves as the defence force for the world's smallest country, and guarantees the personal safety of one of the world's most important and well known religious figures – at times a daunting task in a world filled with terrorists and fanatics.





# CASE OMBUDSMAN NOTES

Case No 2666

## POLICE

### ISSUE OF LICENCE TO CATERING ESTABLISHMENT

A number of residents complained with the Commissioner of Police for having authorised the inclusion of 'use as snack bar' in addition to the wine and spirit licence issued to the owner of a retail outlet in their neighbourhood.

It was confirmed that the retailer had applied to operate as a snack bar way back in May 1996. The advice of the Police Licences Advisory Board (PLAB) was sought, the change was refused after establishing that the smell would cause an inconvenience to neighbours and the installation of a chimney would prevent them from using the roof.

An Appeal filed in May 1997 from this decision was not upheld by the Police Licence Appeal Tribunal (PLAT). The reason for refusal was that the premises were small, with limited ventilation and inappropriate for cooking and preparation of food.

Some weeks later applicant requested again the Commissioner of Police to issue the licence claiming that the Planning Authority, the Ministry for the Environment and the Mosta Local Council had cleared his application. He stated that in the meantime he had installed equipment to eliminate the inconvenience as instructed by the Health Authorities, however the refusal decision remained. In a further attempt submitted in September 1997 to the Appeals Tribunal applicant argued that he had invested heavily following the approval by the Planning Authority and when board members revisited the place they were convinced the odours had been eliminated. The matter was referred back to the Commissioner advising time that in view of the alterations carried out, the Advisory Board was now recommending the issue of licence.

Complainants filed a fresh appeal to

the Appeals Tribunal, whose members visited the residences of objectors in February 1998, but no decision was communicated to appellants. Complainants submitted their case to the Ombudsman in August 1998. It was then established that the Chairman of the Tribunal had resigned, and it was therefore not holding any meetings. From the Ombudsman's investigation the following points emerged:-

- a) applicant's request had not been addressed to the Appeals Tribunal, but to the Advisory Board who recommended the issue of licence;
- B) the Appeals Tribunal, according to established procedures, should not deal again with a case on which they had already made a decision; and
- c) as the Advisory Board held that the previous inconveniences were eliminated whilst complaining neighbours contended otherwise, a solution may be for the Commissioner of Police to appoint one or more technical experts in order to act on their advice.

On July 1998 the newly constituted Tribunal reconsidered the case and reported to the Commissioner of police that they felt it was not prudent to consider the merits of the case afresh but endorsed the the previous Tribunal's recommendation that a technical expert R experts should be appointed and the commissioner would act according the their findings.

The bureaucratic attitude adopted in this case attracted the criticism of the Ombudsman, in that the Appeals Tribunal failed to deal with the appeal but made a suggestion to appoint technical experts whereas the commissioner of Police claimed impotence in the absence of a decision by the Tribunal. The Ombudsman noted that the case involved two applications, the one filed in May 1996 which was refused by the PLAB and confirmed by the PLAT. The second application made in September 1997 had been approved on the recommendation of

PLAB but had been approved on the recommendation of PLAB but had never been dealt with by PLAT. Even though the second application was by way of a letter, it had to be considered as a separated and distinct from the first refused application. The Ombudsman found no reason to justify his entering into the merits of the application as such; the matter being of a technical nature had to be tackled by the competent board. The Advisory Board's advice given to the Commissioner had been acted upon and approved, but the objectors appealed to the tribunal who refrained from giving a fair hearing as prescribed by Regulation 6 of the Police Licences (Procedures) 1991.

In similar circumstances the commissioner could have insisted with the Appeals Tribunal to give a proper hearing to the appeal within a short time. If the assessors on the Tribunal require external expert advice they may seek it themselves. The Ombudsman finally pointed out that the Appeals Tribunal acts in an advisory way, 'to hear and determine the final advice to be given to the Commissioner of Police', as such the ultimate responsibility for the grant or cancellation of licences rests with the commissioner and not the tribunal. the claim put forward by the latter that little can be done is therefore not valid and deserves criticism because it left complainants waiting without any response to their appeal.

the Ombudsman's opinion was that this was a case of maladministration in that the competent authorities failed to deal expeditiously with complainants' appeal and also because they were never informed of the outcome.

He therefore recommended to the Commissioner of Police to request the Tribunal to hear the appeal and tender their advice within a month.

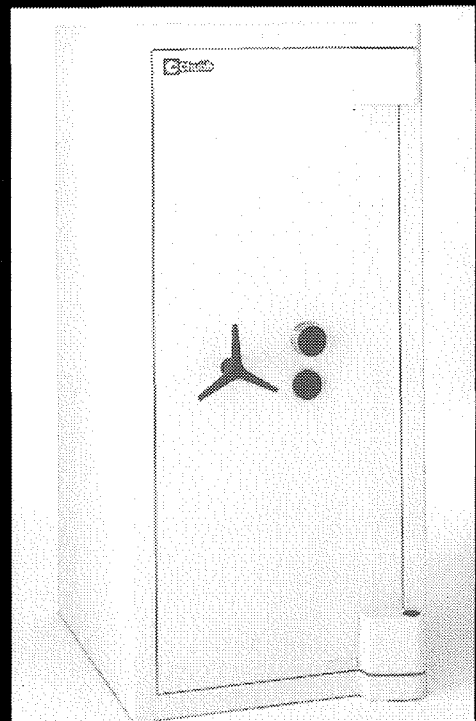
Complainants had been informed that the recommendations were being followed up, the case was therefore concluded and the file closed.

# FORENSIC SCIENTIFIC EXAMINATIONS IN SEXUAL ABUSE CASES

*Christopher Farrugia PhD Forensic Science (Strath.)*

This presentation was given in the 1st Maltese Forensic International Conference held in November 1998. The author, a member of the Forensic Science Laboratory, has been working and studying in the forensic field for these last thirteen years.

## Introduction

In cases of alleged sexual abuse, the areas of forensic investigation include a thorough medical examination, and psychological and psychiatric tests.

It also encompasses scientific tests which are centred round the presence and analyses of body fluid specimens and particulate matter.

This evidence coupled with relevant statements will help the Magistrate in building up the case and possibly also decide the nature of the sexual abuse that occurred.

Sexual abuse is a wide term which includes voyeurism, defilement, paedophilia, bestiality, sexual assault and rape.

## SCIENTIFIC EXAMINATION

The main focus of this presentation is on seminal fluid. This could provide the forensic scientist with material of great evidential value, that could help to identify the perpetrator of sexual assault crimes (high discrimination potential).

## SEMEN

Semen is a complex material produced by a number of glands and ejaculated from the penes. It consists of two parts - the cellular and the fluid fractions.

The cellular fraction is the spermatozoa.

The fluid fraction is the seminal plasma.

The amount, consistency, colour and odour of semen are neither characteristic nor constant. At ejaculation the consistency is viscous, but it soon liquifies, after 20 minutes.

## SPERMATOZOA

Sperm are unequivocally the longest surviving seminal constituent in the vagina. It is the most important useful indication of the presence of semen, remaining sometimes for as long as 3 - 4 days after other seminal constituents (seminal acid phosphates and choline) have ceased to be detected. In fact sperm are usually found up to 3 days after intercourse and occasionally up to six days afterwards.

Sperm of different animal species can vary widely in size and morphology. This can be important in bestiality cases. The population of sperm in a single human individual also varies.

With time sperm lose their tails and appear simply as sperm heads. Producing a smear can shear the tails from some spermatozoa.

Sperm can be detected physically under a microscope at (c \*400 magnification) using the Leichman stain, Xmas tree stain or Papanicholau stain.

Because of the presence of a nucleus a DNA profile from sperm can be taken. DNA profiling is highly discriminatory.

## ASSOCIATED MEDICAL CONDITIONS

Azosperimia or Oligospermia or

the production of few sperms;

Aspermia or the production of no sperm, usually produced by vasectomy.

Such medical conditions do not usually effect the seminal plasma. Identification of semen as aspermic can be very valuable evidence particularly if the suspect can be shown to have been vasectomised, or alternatively to have a normal sperm count. For this reason examination of smears is useful.

In aspermic and azospermic men semen detection will be difficult should the swab be taken at any prolonged time after intercourse. Microscopical examination can also be useful in showing the presence of other fluids e.g. large no. Of epithelial cells.

Their presence is an indication of contamination by vaginal fluid or saliva. Such contamination can affect blood grouping results.

## SEMINAL PLASMA

Seminal plasma consists principally of 4 parts

- i) spermine;
- ii) choline;
- iii) fructose and
- iv) acid phosphates

The most important of these is acid phosphates, which is ground in high concentration in semen. However acid phosphates is also widely distributed in nature, another source being vaginal secretions.

## EXAMINATION OF SEXUALLY ABUSED VICTIMS

It is important that this part of the examination is carried out conjointly between the forensic doctor and the gynaecologist. It is essential that victims.

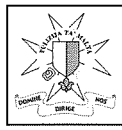

- a) should be examined as soon as possible after intercourse and
- b) samples should be taken in the correct manner and order.

Precautions should be taken to prevent i) contamination and ii) loss of samples.

Samples should be conveyed to the laboratory in such a way as to prevent breakdown of biological specimens and maintain continuity of evidence.

The doctor also takes the required forensic specimens as part of a set nature. Samples collected are

- 1) blood
- 2) saliva swab(s)
- 3) three swabs and smears for high vaginal, low vaginal and labial regions and vaginal wash.
- 4) Plucked hair and pubic hair;
- 5) Paper towel, comb and bag for collection and storage of combed pubic hairs.
- 6) Other items that could be gathered are anal swabs and fingernail scrapings.

Each item collected has a specific purpose

- i) Blood (and saliva) are controls from the victim to establish her own groups;
- ii) The pubic combing are designed to detect hairs from the attacker(s) which can be compared with the plucked hair controls;
- iii) the vaginal swabs allow us to detect semen and may help us estimate the time since intercourse. They may also help us group any semen if possible. The distribution of the semen can also be significant, e.g. if the majority is in the labial region it may suggest incomplete penetration due to struggling victim.

Semen in the vagina is proof of intercourse. However in many apparently genuine rape cases

no semen is detected. In such cases the forensic evidence is restricted.

If the opportunity presents itself a penile swab from the suspect should be taken. Traces of mixed seminal and vaginal secretions can persist in the penis for some time. It is important that such swabs are taken as soon as possible.

### EXAMINATION OF EXHIBITS

Semen can be found on items of clothing, bedding, furniture etc.;

Stains are first localised and recorded, tested using acid phosphates reagent, and then collected.

Semen stains are usually white and powdery, but can turn yellow on ageing.

Screening tests are carried out by the Brentamine Reagent for the presence of acid phosphates. The test is usually conducted by passing a damp absorbent paper onto a garment for about 30 seconds. During this time the stain transfers to the filter paper. The outline and orientation of the paper on the outline are noted and the paper is then spread with acid phosphates reagent. Purple stains should appear within 30 seconds.

This is a strong indication of human semen. The areas are then matched back with the original and the stains of interest noted.

The distribution and amount of semen can be vary important. for example semen in a man's underpants may have only little or no significance, but on a woman's blouse it can have great significance. If screening tests are applied careful notes of the type and extent of staining should be taken. Such evidence can be used to corroborate a victim's story. Conversely a statement may give an indication of which areas are likely to be productive.

Quantitative of semen can give a rough indication of the time the offence (?) took place.

One other type of evidence which can be useful in cases of sexual abuse is the presence of disease organisms, example VD. Such organisms can be transferred from assailant to victim or vice - versa. If appropriate samples are taken by a doctor, the organisms can be identified and classified according to a sub-type. They can provide very strong evidence.

### PACKAGING OF CLOTHING

- Clothes should be packed separately
- Clothes should be left to dry before being packaged
- Packing should be done in paper bags
- Persons should be made to undress in a paper towel which is collected as well.

Until arriving in the laboratory items should be stored in a cool, dry and dark environment.

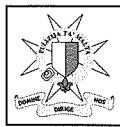
Items should never be stored and transported until they have been thoroughly dried without heating. All items should be stored and dried with the minimum of folding and crushing to avoid damage and destruction of delicate stains.

### OTHER SCIENTIFIC TESTS THAT COULD BE CARRIED OUT

It is very important that we should look as what is happening in the world especially in Europe. In this respect DNA profiling techniques are constantly being used and grouping techniques are slowly being phased out.

Moreover, DNA profiling techniques are being standardised so that if a crime happened in Germany, the same probes are used in France for a through comparative analysis to take place. Work in this regard is being carried out by EDNAP.

It is essential that Malta should implement a DNA profiling programme which is compatible with that of our European counterparts.

## Intervista ma l-ex Sargent 255 George Muscat

(L-Ewwel Parti)

Peress li meta ngagga fil-Korp tal-Pulizija fl-1927, il-qagħda politika-Reliġjuża bejn Strickland u l-Knisja kienet xi ftit tahaq, ma setghax jonqos li kellu hafna xi jghid dwar il-qagħda f'pajjizna f'dak iż-żmien.

Izda, bħal dejjem, ahna nillimitaw ruhna għal dak li għandu x'jaqsam mal-Korp. Kif ukoll ser naghmlu f'din l-okkażżjoni. Intant, sehibna George serva fil-Korp bejn il-11 ta' Gunju, 1927 u s-17 ta' Gunju, 1953, kellu n-Numru tas-servizz 255, u spicča fil-grad ta' Sargent tal-Prima.

George jirrakonta illi skond il-proċedura ta' dak iż-żmien, fil-11 ta' Gunju 1927 kien wiehed minn 50 persuna li ntgħazlu biex wara li jagħmlu xaghrejn tahrig fix-xogħol tal-Pulizija, kien isir ilhom eżami u min jigi l-ewwel ikollu l-ewwel preferenza biex ikun ingaġġat fil-Korp.

Linja.

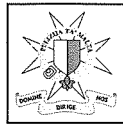

Dan l-akkużat, Censu Caruana, kien għadda Ġuri u weħel 12-il sena haħs. L-incident kien sar fl-1937 fi Triq Prince Albert.

# I.P.A. International Police Association

Dear IPA friends.

Since we have started giving information about our Association on this police publication a considerable number of police officers have contact me to know more about IPA. As a result of this new members are joining in and more are making use of the service offered. Our intention is to keep you continuously informed.

IPA Identity card: IPA members are recognised and accepted through out the world by their IPA identity card, which cards are supplied by the International Treasurer in Switzerland. An identity card is considered to be valid when issued by the National Section and the membership is renewed annually. Upon payment of the renewal fee, the National Treasurer issues a stamp for that particular year, for which a levy is paid to the International Treasurer. Renewal stamps must to be affixed at the back of the ID card.

According to the Fundamental Principles and Scope, article 8 - membership cards, it is stated that:-

1. Only the standard international IPA membership card with a valid year stamp is proof of membership in the Association.
2. The international Treasurer shall be responsible for having the IPA membership cards printed. The Sections shall order their membership cards and year stamps from the International Treasurer. When issuing them, they shall comply with the regulations such as Section identification and numbering.
3. The cards remain the property of the issuing Section.
4. IPA membership cards without a valid year stamp may be retained and returned to the issuing Section provided that they have been invalid for at least one year. This does not apply to members of Sections

whose voting rights have been suspended.

## **I.P.A Professional Commission survey reports.**

Thanks to the positive comments I received from colleagues with regards to the IPA Professional Commission analysis report regarding Police Training Comparison within member countries, in this edition I am presenting the results of another survey with regards to the Social Position of Police Officers in the Community. A questionnaire on the subject was distributed to all members, and 28 were returned and the results are as follows.

### **Summary of Questions:**

1. **In your country is police work considered a profession?**  
In four Sections police work is Not considered a profession.
2. **At the conclusion of the Police training course, do the officers receive a diploma?**  
In six Sections officers do not receive a diploma at the conclusion of the police training course.
3. **Are police well accepted by the community?**  
In two Sections the police are Not well accepted by the community.
4. **Do police receive similar pay as people involved in other professions of a similar nature? (i.e. Nursing, Military, Private security).**  
In two Sections police do Not receive the same pay.
5. **Does the community support the police in general?**  
In one section police are not supported by the community.

One Section gave a yes/no answer.

## **6. In your country are police proud of being a police officers?**

In three sections police are not proud of being a police officer. One Section gave a yes/no answer. One section no answer at all.

## **7. Do police officers generally let others within the community know that they are police offers?**

In three Sections police generally do not let others within the community know that they are police officers. On Section gave a yes/no answer.

## **8. Do police have the same social security as other members of the community? (i.e. health, insurance coverage, pension etc.)**

Not all Sections have the same social security as other members of the community.

## **9. Is it acknowledged that police work effects an officers social life?**

All sections believe that police work effects an officers social life.

## **10. Are Police officers allowed to be a member of a political party?**

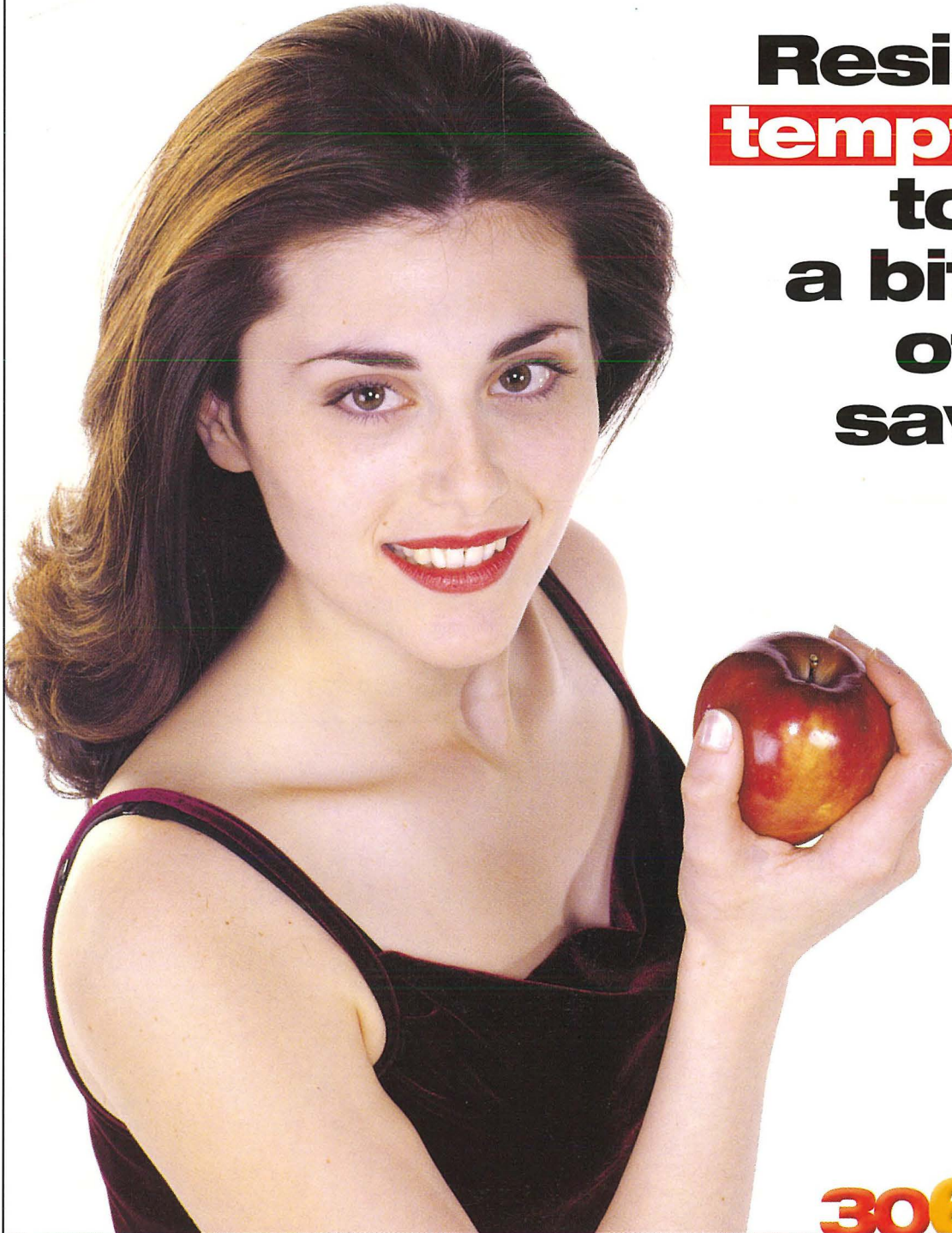
In 12 Sections police officers are Not allowed to be a member of a political party. One Section answered Yes/No

The pre filter **1** removes large dust particles and pet hair; the ionizer **2** positively charges contaminated particles before reaching the ion filter roll **3**. This filter actually contains two layers – an electrostatic filter and a titanium oxide filter.

The electrostatic section captures positively charged particles and microorganisms.
