# THESIS ON POLICE

The Police department has recently been the subject of a research at the University of Malta, carried out by a group of 4 students as one of their prepared studies. The specialised subject researched is "Using Marketing Tools to Encourage Recruitment into the Police Force".

In their mini thesis, graduate students of the B. Comm. degree, Angel Azzopardi, Anita Bezzina, Sonia Bezzina and Claire Bugeja studied the concept of marketing the Police Force. Certainly and rightly, "it is important to have someone responsible in attempting to project a more marketable image of the Police Force".

In their summary of this thesis, these four B. Comm. graduates, conclude that the required attention in this respect, is lacking and much more is to be done to improve what is normally done in advertising our image that is "the Police publicity is centred around dog shows and rescue shows". These although they themselves arouse much interest, yet, "do not provide enough information on what the police job involves. Thus, potential recruits should be supplied with an attractive magazine".

This important study, clearly gives us as a police

The researchers based their conclusions, on various surveys held locally, interviews with various members of our Force including high officials of our top management, and also references to other foreign publications dealing specifically with Management and Marketing.

## Concern

Having read this thesis, I found various points that need immediate attention. For example the level of satisfaction among the various ranks differ quite dramatically. An average of 40% of the lower ranks interviewed are dissatisfied with their present status. In my opinion this gap should be narrowed, if not eliminated.

## More Research

Specialised studies of this sort give us more steam to revive our Force. I feel that we have to conduct more studies and research on other branches concerning the Force, so that we will some day, have a better prepared professional Police Force in Malta.

# POLICE ACADEMY

1993 was an extremely busy year for the Academy, with a total of 277 students attending 8 different courses; not including the Saturday Seminars for Inspectors, dealing with all aspects of the law and its implementation by Police Officers.


The revised curricula for both the Trainee and Apprentice Police Constable Basic Training Courses, the former of 6 months and the latter of 1 years' duration, is now more varied and wide reaching, covering as it does the full range of Police orientated subjects and including Academic, Legal, Human and Socio-Cultural studies, apart from the normal skills and practical training. All recruits spend a minimum of one month on a practical attachment of a Station, as also a most interesting and useful period on intensive training with the S.A.G.

Practical computer studies have been introduced, using the purpose built Computer Room. Another novelty is the fortnight residential period at the Martin Luther King Hostel, St. Patricks. Other than dining and learning to live together in a relaxed and informal atmosphere, the recruits attend seminars and discussions on current topics, and an analysis of their own progress during training.

Another new venture is the assignment of all recruits, Trainees and Apprentices alike, to various Homes for the Handicapped and the Aged. Rightly so this is considered to provide a most important element in the Social and Environmental development of a potential Police Constable.

The Officer Cadets, during their very intensive fifteen month training, which naturally covered a very wide and detailed syllabus, academic as well as technical, included also a five week course held at the Lincolnshire Police Training School in the U.K., made possible in no small way by the generous assistance of the British

Foreign & Commonwealth Office who sponsored the course in its entirety.

This year, for the first time, the Cadets were also put through a tough, residential "Team Leadership and Development Skills" course, run by experts from the U.K. The training introduced a new concept to the practical aspect of cadet leadership training, its main aim being to identify the chief characteristics of a junior leader who as an Inspector is required to undertake responsibility for the Planning and Organization of a team, in addition to maintaining the normal functional obligations of an officer of his rank.

Another new course was that held for Drivers, which was practical as well as theoretical; while Constables sitting the exam for promotion to Sergeant attended a course leading up to that examination.

A most important addition to the Academy programme was the course in Public Relations for Inspectors. It is hoped that most officers will eventually attend similar training.

# POLICE ON THE BEAT PART III - by PS 369 J. Mizzi

The motor cycle has a number of disadvantages:

1. They are dangerous for the rider, particularly in inclement weather and are virtually unusable during heavy rains or storms.
2. The rider is open to the elements and cannot operate at his very best in cold or weather.
3. Motor cycles are noisy, consequently they can be heard coming but the rider cannot hear what is happening around him.
4. Great concentration is needed on the road ahead and so there is relatively little possibility of looking around to see matters worth investigating.
5. It takes valuable time to get off a motor-cycle and put it on its stand, when about to question a suspect or give chase on foot.
6. A motor cycle cannot convey prisoners or bulky property.
7. Reception of messages requires the motor-cyclist to stop his machine to make a written note.

Against all these disadvantages, the solo motor-cycle has two real advantages. First, it can be comparatively cheap, particularly if a low-powered motor scooter or a small motor cycle is used. Second, a motor cycle can get to the scene of incidents in crowded streets by travelling on the outside of streams of vehicles in traffic jams. Thus the only legitimate function of a motor cycle is for traffic work, or to provide a cheap means of transport for short journeys.

## Motor Cars:

Given a motor car, a police officer can patrol large areas, carrying useful equipment, with very little close contact with the public is not needed, the police car provides an effective way of spreading manpower available thinly over the ground.

Probably the most serious disadvantages of the motor car for police patrolling are, first, that the driver needs to concentrate on where he is going and secondly, that the crew are isolated from the public by the metal and glass of their car. At the same time one cannot under-estimate the effects of using police cars on the relations between police and public. Any system that relies for its contacts on the police officers getting out of their cars to walk around, is adversely affected by the reluctance of police officers to do that. For its success such a system relies heavily on the initiative and common sense of the sergeants of senior officer in charge of a mobile car which should normally be manned by two or more public officers. It is difficult to generalise on the merits of such patrols, but it is probably fair to say that unless it is very skilfully administered,

it cuts across a number of basic rules of foot-patrol notably the need for boot-beat officers to be able to relate to the people on their beat and become known to them as an individual.

It is also quite expensive to run both in respect of man power and cost of maintenance of vehicles and fuel.

## Police Horses

The main function of police horses is in crowd control and their use, although controversial, is of great value. With this respect Lord Justice Scarman wrote:


"In my view mounted police are essential, if we are to avoid riot squads and riot equipment... When used to suppress disorder, mounted police do cause apprehension: but properly used they do not cause casualties." Mounted police can also be used for directing traffic especially during rush hours on major roads and also for patrolling the open country during the day.

The adaptation of police methods to needs. There is no universal policing method that can be applied to every country, or even to every part of one country. Each area must be considered separately to identify its policing needs and suitable methods adopted to meet those needs. Planning an effective police system, it is necessary to know all the policing problems to that particular area. The use of statistics of population growth, crime, incidents, calls for police assistance, traffic accidents and densities complaints can give a preliminary indication of the work load to be expected but it must be remembered that as an area changes, so will its policing problems.

Everyone consents that cities are developing at a high rate and rapid changes are occurring in a relatively short time. Information collected from statistics is not sufficient enough without the opinion of the police officer working in that area and the people who live there. A densely populated area, with a large number of social problems and frequent calls to the police for assistance, might require a form of neighbourhood beats to enable the police officers to work within the community as distinct from merely providing a rapid response to calls. Many suggest methods may have to be superimposed to provide the right level of service whilst cost-effectiveness will have to be balanced against the expectations of the people in the community. If the area is extensively patrolled by police officers in cars, they may be able to provide rapid response to emergency calls but doing so may detract from their prime objective of preventing crime. For this reason, mobile patrols

A method used by many urban police forces is



a mixture of foot beats to provide a police presence on the streets to make contact with the public, carry out law-enforcement duties and to obtain information. Superimposed on these is a fleet of cars, usually double-manned, to provide a quick response to emergency calls, to deal with suspicious motor-vehicles, to pursue mobile criminals and to provide a visible police presence. Provided that the rules for foot-patrols are observed and the number of area cars is sufficient to provide a guaranteed response, this system has considerable merit.



## L-EWWEL XOGHOL

Fl-1942 Aquilina dahal fl- "A" Company tal-K.O.M.R. fejn dam erba' snin, tlett snin minnhom bhala Staff Sergeant mal-Malta Pioneer Corps. Kif spicċa mill-Army dahal fil-Pulizija bin-numru 978 bhala Riservista. Warali ħadid fuq il-Belt ghajtlu ghall-Induction Course fid-depotta' Fleur De Lys, u wara, għaltnax-il sena shah, kien stazzjonat fl-Uffiċċju tal-Għassaq tal-Birgu li dak iż-żmien kien il-Head quarters tal-Eastern District li kien ikopri d-Divizjonijiet "A", "D", "E", "F", "G", u "H". # **NEIGHBOURHOOD WATCH, A CRITICAL APPROACH** - by Supt. Dr Angelo Farrugia LL.D.

We live in an affluent society where our material possessions are very tempting to thieves. Our homes are left unattended for many hours whilst we are earning money to pay for these items. We know also that wherever a crime has been committed, the police solely on their own cannot make headways in their investigations without everyone's cooperation. They need information. Any information relating to some incidence of a crime or a suspicious activity is and could be vital in the proper investigations being carried out by the police. Doing nothing and expecting everything is an impossible mission.

Recently I came across a critical view on information gathered by the neighbours in an Australian newsletter issued by a Neighbourhood Watch Association (1). One of the co-ordinators said that "we don't want people rushing to police without thinking about things. What they should do is put all this information together and see if it fits. We urge them to come forward, as we fear that the person will try again if he is not caught!" This means that the police are always after any information that could lead them to suspects. They are the professionals who can do the filtering of information. This is the only known practical way how we can make life difficult to burglars and thieves or other criminals. We have to work together to prevent and help detect crime.

## **OPPORTUNIST CRIMINAL AND NEIGHBOURHOOD WATCH**

Of course you cannot stop a determined burglar from breaking into your home. However you can distract burglars by making entry difficult and make your home appear occupied. We have to explain to the people that first, the owner of a house, office, business concern, has to survey his property and grounds and make it more secure. The various questions that have to be answered are the obvious but still await the answer :-


1. What is most likely to be taken;
2. Where is a burglar most likely to get in;
3. Where are the weak areas etc. etc.

Research conducted in England by Forrester et al (1988) resulted that the findings of an offender survey which identified visibility at the point of entry as one of the most important factors in target choice, their victimisation survey found that prior to the establishment of Neighbourhood Watch, the point of entry was visible in the majority of those victimised. These type of studies by experts show that the stress is on crime prevention. After all Neighbourhood watch is a long term strategy. It is a community based crime prevention programme, aimed at reducing the incidence of preventable crime, particularly household burglary.

## **OTHER BENEFITS OF**

### **NEIGHBOURHOOD WATCH**

One of the expected benefits of Neighbourhood Watch is an improved community spirit but not all studies confirmed a positive



feeling. In England for example only 13% of Neighbourhood Watch members improved neighbourliness in England and Wales as per Mayhew et al (1989). Anderton (1985) on the other hand found that 94 % of his sample felt a stronger community spirit since Neighbourhood Watch developed a community spirit in 65% of the schemes and these were more noticeable in high risk areas. Studies of this sort in Malta cannot be done once we have still to have the authoritative blessing of the very launching of the proper organisation of Neighbourhood Watch schemes. Certainly another commonly expected benefit of Neighbourhood Watch is improved relations between the police and the public. In fact Hussain (1988) found that 73% of schemes in his sample, respondents thought that Neighbourhood Watch had improved Police/public relations. According to chief Superintendent Derek Abran of the London Press Service in a paper edited by David Read on "Neighbourhood Watch deters the burglar", said that "we had to try and convince the people that the aim of neighbourhood Watch is the answer in the fight against crime. In this year of our initiative by the hotels of the North and other residents' associations of this neighbourhood, we have created a national wide conscious. People are today speaking more. About Neighbourhood Watch. Papers, letters, and editorials have been published in our locals and Sundays on Neighbourhood Watch. Members of the Maltese parliament from both sides of the House of representatives, had tabled questions on Neighbourhood Watch. I am sure that you all agree that this has been a success story. So far we have moved in the right direction. Yet we need to press more our energies in convincing more and more people, whoever they are, that both the authorities and the public have to share the responsibility of further launching of these Neighbourhood Watch Schemes, including their financing.

Abroad, for example in UK, in such seminars and conferences of this kind, the authorities themselves participate and present their own views. Stecen Morrison MP in the British parliament, when addressing a national Neighbourhood Watch conference in 1990 told the delegates present that "where neighbourhood Watch works well, it is better for our society". That is why at this stage, in this fourth Neighbourhood

Watch seminar to be held in Malta, I feel that you all did a lot of work on your own. Had it not been your initiative, you hoteliers of the North, no one in Malta today would really know the very meaning of Neighbourhood Watch.

### LOCAL COUNCILS

Now that all the necessary introductions for Neighbourhood Watch in Malta have been made and prepared, other interesting parties, and I have in mind the local councils, should cultivate this concept and make it work for the benefit of society. To organise the people and have Neighbourhood Watch schemes launched in every street in Malta and Gozo, one needs the deployment of both police personnel and many other volunteers. At Least now we know and are telling everyone that Neighbourhood Watch is a modern philosophy that has to stay with us.

### MISCONCEPTIONS OF NEIGHBOURHOOD WATCH, STATISTICS AND SUGGESTIONS

The initial belief of the common citizen is that involvement in the scheme meant patrolling the streets vigilante - style is a common one and we all have to dispel this quickly. Besides most people tend to fear to report incidents or suspicious people because they feel of appearing noisy and wasting police time. In March this year in Victoria, Australia, the chief commissioner Neil Comrie said that "one has only to speak to the residents and show them the expected satisfaction of a Neighbourhood Watch programme. The reduction in General crimes statistics confirms this success" (2). It is true that interest and participation in Neighbourhood Watch can diminish once a low crime rate has been achieved or once the 'honeymoon period' has lapsed. We need to keep up the interest among ourselves first. We have to learn from the mistakes of others who have experienced Neighbourhood Watch schemes for many years. The obvious is obvious. We must always try and convince the people that the aim of Neighbourhood Watch is to make them socially conscious and report matters to the police and/or coordinator, they otherwise might not. Neighbourhood Watch schemes for example were found difficult to establish in America and Canada in areas characterised by a lack of feeling of 'territory', lack of social cohesion, or where residents feel no responsibility towards crime. Also many of those living in areas where offenders live, are unwilling to tell their neighbours that for example they are away. When such problems exist, and we have to face such similar problems in Malta, we have to re-organise the particular Neighbourhood Watch scheme in that particular neighbourhood. The emphasis has always to be on the right choice of the co-ordinator.

### CO-ORDINATOR

The co-ordinator is the link between residents and police. Non urgent items are passed to the local co-

ordinator. Urgent items are passed to the police straightaway. If some neighbours mistrust their neighbours, they should all, at least, trust their co-ordinator and the police. The co-ordinator is crucial in encouraging residents to be more vigilant and to report suspicious behaviour to the police, in addition to encouraging participation in the Neighbourhood Watch activities, as for example today's seminar. Certainly research should assess the extent to which co-ordinators effectively perform their role and whether this influences surveillance and reporting behaviour.

Ideally the co-ordinator should be the person who can always provide an answer to the neighbours. Recently in the neighbourhood of Maroondah (G) District in Melbourne, Victoria, in Australia, a co-ordinator gave a fine detail on the difference that lies between security lighting and outdoor lighting. In short and in an exact way he said (3) that "outdoor lighting is largely decorative. The difference between, is one to make the house look attractive and the other is intended to make it safe. The latter require the use of sensor switches which are available in two types, movement detectors or heat sensors, which can suddenly light up intruders and scare them off". One here quickly notices the emphasis on 'intruders and scare them off' which rightly the co-ordinator stressed! Research has shown that in England, 70% of the residents/neighbours first consult their co-ordinator and also first pass information to him rather than consult and inform the police. The co-ordinator is also responsible for the regular updating of address details for Neighbourhood Watch areas and district committees. In Australia, for example, he monitors the proper operation identification of property. There for example the marking of valuable household items are marked with their driver's licence number proceeded by the first letter of the state, and this by using an engraver or an ultra violet pen. Speaking about property marking, the police should on the other hand show motivation to really examine stolen recovered property for markings.

### THE LAUNCHING OF NEIGHBOURHOOD WATCH SCHEME

In England, hardly a week goes by, without a launch of a new form of Neighbourhood Watch. From Business watch to Yacht watch, Farm Watch, Pub watch and Poacher watch, citizens are consistently realising that they should come together to try and cut crime. The first neighbourhood Watch scheme in England, was started in the village of Mollington, Cheshire, in 1982 followed by London metropolitan area. Today just eleven years on, there are about 115,000 schemes covering five million homes across. In the USA, an estimated 20 Million US citizens are involved in crime-watch schemes. Malta is still at its infancy. The promotion of the launching of Neighbourhood Watch schemes is generally done by the police forces in most countries. Where the level of



interest among residents of a particular neighbourhood is high, then a Neighbourhood Watch scheme is organised. In Australia, the level of interest amongst residents of the area is canvassed and recorded in a petition. Interest must be shown by at least 75% of the area for the petition to be successful. In Malta interest among residents' association is noticeably on the increase. We have to maintain this interest in Neighbourhood Watch. The police should prepare leaflets on Neighbourhood Watch for residents and should devise training programmes for co-ordinators. These leaflets should be written in both the Maltese and English languages. In late 1992 for example, in Australia, such leaflets were printed in six other languages besides the official English language and this to make sure that the message is passed to all, including immigrants.

Where Neighbourhood Watch schemes are functioning, then street Neighbourhood Watch signs have to be erected and news letters produced and circulated. Where a Neighbourhood Watch scheme is organised, others follow suite. In England, statistics show, that 60% of the Neighbourhood Watch schemes in England actually start because residents decide themselves they want a scheme once there is another Neighbourhood Watch scheme near their neighbourhood. The government in UK, thus is helping the increase and awareness in Neighbourhood Watch by spending millions of pounds on research and even advertising. Besides in Neighbourhood Watch schemes, interest has also to be maintained by organising regular meetings for the co-ordinators, by introducing measures to improve the environment and by having organised reward schemes that would have for some reason or other been exceptional and constitutional in a particular crime prevention or even detection.

## MONITORING

Each scheme should monitor itself the running of the scheme and the results. Analysis of data relating to a period of several years is to be regularly done. Unfortunately most of the research, even abroad, is conducted only within the first year of operation, thus failing to assess long term effects or allowing the scheme to become really established before assessing its effectiveness.

## OTHER STATISTICS

As regards the very implementation of Neighbourhood Watch, N.W. Schneider (1980) found that in high crime areas, door to door canvassing produced participation levels twice as high as other areas. Research showed that where there was a high level of car and home ownership and which was initiated by residents, achieved a participation rate of 77%. Bennett (1990) found that only 20% of residents in one area and 5% in the other, said that they deliberately looked out for anything suspicious because of the existence of the Neighbourhood Watch scheme.

## CONCLUSION

In this paper I restricted my critical approach on Neighbourhood Watch to various studies and researchers conducted abroad where Neighbourhood Watch has been experienced for many years. I feel that it is only from such studies we have to learn the proper lesson to have the ideal Neighbourhood Watch in Malta. The effect of Neighbourhood Watch as a crime prevention, is always most evident and clear. We have to W.A.R. on crime. By W.A.R. I mean W for Watch your locality, your property and your neighbour; A for act to protect your property and to protect your neighbour's property; while R stands for report by phoning 199 for immediate police attendance, your co-ordinator, and finally report and discuss in Neighbourhood Watch meetings. The effect of crime prevention is even being understood by those prisoners who are being reformed. March Leech, a prisoner in Glenocril prison, near Stirling in England, precisely on this point said that (4) "we need to practise prevention and not rely on prisons to 'cure'". I believe that we should continue from here. I do not feel that we should follow the trend that crime prevention has to be further sanctioned by law as suggested Justice Woolf's (5) when he said "that people who failed to protect their property from crime should be fined". Incidentally we have a similar provision in our law, the Criminal Code, Cp 9, section 338"2" which reads that "every person is guilty of a contravention against public other who ..... is present at any attempt against the life or property of any person and fails to give information, thereof to the executive police", a provision of the law which is seldom if ever, applied. The general public must join the W.A.R. voluntarily, as only here the results would be the best to the satisfaction of all.



# RIOTS OF THE 7TH AND 8TH JUNE OF 1919

By Mr. A. Mifsud Tommasi. LP.B.A. educ. - Commandant Police Academy

The following extracts are the original reports carried out by the commission specifically then appointed to inquire into the events of the 7th and 8th June 1919 and into the circumstances which led up to those events. The report of this commission were concluded on the 18th and 19th September, 1919. These extracts were prepared for this publication by the Commandant Police Academy, Mr. Anthony Mifsud Tommasi L.P.B.A. (educ.)

## Events of 7th June, 1919 - Part One

On the 7th June large crowds of people collected in Valletta as a meeting of delegates to a National Assembly was to be held at the Circolo "Giovine Malta" - a Club having for it's primary object the diffusion of Italian Ideas. The president of that club was at the time and still Dr. Enrico Mizzi.

The meeting as hereinafter stated had been convened by Dr. Sceberras, for the object of discussing the despatch of the Secretary of State for the Colonies with regard to the grant of a new Constitution to the Island, and passing of resolution on the subject.

The meeting has been widely advertised and the population was urged to lend moral support to the Assembly by congregating in Valletta in large numbers. The further object of calling large crowds to town in hereinafter commented upon.

Any large crowd must necessarily contain proportion of shady characters and this consideration led the public to discuss openly in the cafes the likelihood of acts of violence and even damage the property occurring on the occasion of the Assembly's meeting, although of course it was not expected that things would go to the length they actually did.

At the request of the Acting Commissioner of Police (made on the 5th) a party of the Malta Composite Battalion consisting of 25 men was housed in the Castille. This party does not appear to have been actively engaged on the 7th.

The crowd began to collect at about 3.30p.m. in Strada Reale, and went opposite Wagner's establishment near the Court House, shouting and insisting on the closing of shop doors. The crowd was not interred with. Stones and other missiles were thrown at the windows of the establishments: A La Ville de Londres where the Maltese Flag with the Union Jack in the centre was flying on the roof. The crowd insisted upon that flag being lowered, and broke a mirror on the main door of the establishment. The crowd next went to the Union Club, and insisted on having the doors of the Club closed. They threw stones and iron at the windows, smashed some panes of glass and insulted the officers who were there. Three Police officers, who tried to keep the crowd back were ill-treated. Eventually the doors of the Union club were closed.

The same crowd proceeded down Strada Reale, and on reaching the Queen's Square began smashing the windows of the Public Library, insisting that the Flag

which was at half-mast owing to the death of the Chief Justice should be lowered.

Police Sgt. Pillow and Constable Griscti who tried to prevent the disturbances and to arrest some of the boys who were throwing stones were overpowered and severely beaten. The Flag was eventually lowered, presumably by the caretaker of the Library.

The crowd next attacked the Lyceum. They gained access by breaking the iron window near the main door and wrecked whatever they could lay hands on. No Police Officer was present. The mob insisted on a Flag which was on the Meteorological Station being lowered; and some individuals from the crowd went on the roof and threw the Flag down into the street. The Flag was burned together with several articles of school furniture. The two men of the R.A.F. in charge of the Meteorological Station did not interfere. The crowd which by this time was increasing, then proceeded to the Palace Square and insulted the soldiers on duty at the Main Guard, whereupon the N.C.O. in charge closed the door. As some window panes of the offices on the ground floor of the Palace had been smashed, the doors of the Palace were also closed.

The mob then divided into two parties, one party attacking the Officers of the Daily Malta Chronicle, the other party proceeding through Strada Stretta down through Strada Reale to Strada S. Lucia. At the time there was no Police Officer at the door of the Chronicle.

The door was forced open and a few boys and men rushed in and set out throwing from the balcony office furniture, type trays, paper etc. The crowd in the street set fire to the articles thus thrown out.

Of a Police Force of 30 men and two Officers sent to protect the Chronicle Office. Only the two Officers and six men succeeded in getting through the crowd. The persons inside the Chronicle Office got out. The Police appear to have thought fit to abandon the place because missiles were being flung at them through the balcony. The place itself was reeking with gas.

The other party went down Strada S. Lucia and wrecked the house of Mr. F. Azzopardi throwing into the street all papers and furniture. There was a solitary Policeman who having been hit by the crowd was unable to protect the premises, even if he had been inclined to do so.

The crowd which by this time amounted to 2000 or 3000 went towards the Crown Advocate's House (Prof. Refalo) but did no damage as somebody in the crowd told the people that it was not worth while to do so.

The crowd then proceeded to wreck Cassar Torregiani's house. The mob broke into the house and started destroying and throwing the furniture out of the balcony in the presence of the Police who played the part of onlookers.

In the meantime between 4.45 and 5.p.m. the Acting Commissioner of Police informed by telephone the



G.S.O. that the Police had been overpowered and that Military assistance was required to suppress the riots. His Excellency the Officer Administering the Government and Acting Commander-in-Chief gave instructions that the request should be complied with, and that the G.S.O. should order the troops who had been held in readiness to turn out at a moment's notice to proceed to Valletta Police Station and that the G.S.O. should proceed there himself to ascertain from the Police where assistance was required and to give instructions to the O.C. Troops accordingly. At about 5.30p.m. a detachment of the Malta Composite Battalion, strength 64 other ranks, arrived at the Main Police Station, form Floriana Barracks. The Acting Commissioner of Police asked that the men should be sent to the Chronicle Office and Torregiani's house.

A party of 6 men under Captain Ferguson accompanied by the G.S.O. Major Ritchie, and Superintendent of Police A. Busuttil went by Strada S. Giovanni to Strada Forni to disperse the crowd and protect Torregiani's house. The party was hooted and missiles were thrown at them; some were hit.

Major Ritchie and Captain Ferguson warned the men not to fire without orders. The party was too small to quell the disturbance whereupon Major Ritchie ordered the men to remain in Cassar Torregiani's house and sent Captain Ferguson to get reinforcement. Captain Ferguson was attacked by the mob. His helmet was knocked off, tunic torn and his revolver and ammunition taken from him. Captain Ferguson met Lieutenant Osborne with a party of about 24 other ranks. He directed the party to halt while further reinforcements from the Police courts were called for. This party was marched down to Strada Forni. The mob was then at very close quarters and very hostile, throwing bottle, large pieces of wood etc. The troops were lined up across the street in two ranks facing up and down the hill opposite Cassar Toregiani's house. All ranks were again warned that there was to be no firing without orders.

As soon as the soldiers were seen to kneel and assure the firing position the mob fell back several yards. One or two civilians on the uphill side defied the troops. Major Ritchie who appears to have taken charge of the party facing downhill ordered them to charge and so cleared Strada Forni up to Strada S. Giovanni. At that time some shots were fired from some window near Cassar Torreggiani's house. Some doubt has arisen as to the exact time and number of shots and the exact spot from which the firing took place. That shots must have been fired is borne out by the evidence of Major-General Hunter-Blair. Colonel Saville, one soldier and by two civilian gentlemen. At the same time the soldiers facing uphill fired without orders from the Officers, about five or six rounds with the result that two civilians were killed and seven wounded.

A party of ten men under Lieutenant Shields was sent to protect the Daily Malta Chronicle Office. It does not appear that they were accompanied by any Police

Officer. When they entered the premises, missiles were thrown at them by the crowd, chiefly by boys. The place itself was found to be reeking with gas, and the crowd outside, which at that moment must have numbered 300 or 400, had brought the fire to a point between the Chronicle Office and the Shop called "Europa". The Officer did not think it prudent to keep the men inside. He asked a member of the Casino Maltese, Dr. Wirth whether there was any exit other than the one in Strada Teatro. The answer was in the negative at least that gentleman knew of no other exit. Lieutenant Shields stated before the Court of Enquiry, that he asked whether an exit was possible through the Casino Maltese, but evidently he was not understood. An exit could only have been possible with the aid of ladders, which were not at hand and at that moment considerable confusion existed in the Club, which the Committee had ordered to be closed. The fire outside the Chronicle door was not such as to prevent the men from leaving the premises. Lieutenant Sheilds fearing an explosion of gas, especially as burning bits of wood were being thrown at the premises, decided to leave the place. He ordered one of the men to fire one round into the burning debris to frighten and disperse the crowd. The order was obeyed, and a man (Lorenzo Dyer) who was near the fountain opposite the Chronicle door was hit and died shortly afterwards. Presumably the same bullet wounded another man. The Officer then marched off his party to the Police Station.


Whilst this was happening one of the men who had been wounded was carried into the room at the "Circolo Giovine Malta" where the sitting of the Assembly was still going on. The crowd outside became more excited and wanted to rush the Court House into which building the soldiers had been marched. The members at that Assembly hastily passed their resolutions, and at the suggestion of Contino Caruana Gatto some of the members volunteered to go and calm the crowd, as they thought that the Assembly was to a certain degree responsible for the presence of the crowds in Valletta.

A deputation was formed with some difficulty as the greater part of the members had seized the first opportunity of leaving the premises.

At an interview with the Lieutenant-Governor the deputation asked for the withdrawal of the troops, and guaranteed that if that were done, there would be no further disturbances that day. Very reluctantly the order to withdraw the troops was given after the Lieutenant-Governor had communicated with the Officer Administering the Government. The crowd dispersed after having been addressed by the deputation. No further disturbances appear to have occurred on that day.

# SPORT : XI ASPETTI LEGALI

17-18 ta' Marzu, 1990 minn Mag. Silvio Meli LL.D.

## A. Definizzjoni - X'hinu Sport?

Minhabba l-fatt illi si tratta ta' materja komplessa u mhux daqshekk riċerkata, l-analisi legali tal-fenomeno sportiv hija waħda mimljija diffikultajiet li ma' l-ewwel daqqa t'għajnej jidhru insormontabbi. Fil-fatt, meta ġejt ġentilment mitlub nipprepara din il-“paper” ergajt hassejtni verament mizmum taht l-ilma - bla nifs!

Tali diffikultajiet jitfaċċaw immedjatamente li wieħed jipprova janalizza l-istess kelma - “sport” kelma Ingliza ta’ etimologija dubbia, ġeneralment ritenu ta’ oriġini neo-Latina (“deportare”), li kienet intodotta fil-lingwa għieg modern tramite il-Franciz antik, (“disport”).

B’mod l-aktar ġeneriku, certi awturi jiddefinixxu l-isport bħala kwaliasi logħob jew eżercizzju, kompetitiv jew le, sportaneu jew foerzat, li għandu - anke bl-aktar mod remot - moviment fiziku. Oħra jawn jaraw bħala attivita’ li l-element predominant tagħha huwa l-eżercizzju fiziku f’atmosfera kometittiva mgħoni b’reġolamenti u istituzzjonijiet spċċifici, suxxettibbi li jinbidel f’attivita’ professjonal, Oħra jawn ukoll, jaraw l-isport bħala attivita’ libera tal-bniedem u bħala tali, peress li mhix imposta, issir mingħajr talba għall-kumpens.

Viżjoni totalment differenti hi dik tal-kittieb mgħaruf George Orwell li f’ “The Sporting Spirit” ta’ l-1945, ovvjament ispirat mit-Tieni Gwerra Dinjija, kiteb: “Serious sport has nothing to do with fair play. It is bound up with hatred, jealousy, boastfulness, and disregard of all rules and sadistic pleasure in witnessing violence, in other words it is war minus the shooting”. Jidher iżda illi f’dan il-kuntest il-verita’ hija eqreb lejn dak espress minn Sir Denis Follows fil-“Philip Noel-Baker Memorial Lecture” g’Loughborough College:

(1) “I have reached the conclusion, after many years of trying, that sport defies definition. The Sports Council tried it and gave it up as a bad job”.

## B. Il-Ġustizzja u l-Isport

L-awturi ġeneralment sabuha diffiċċi biex jirrikon cilljaw l-istituti legali mal-fenomeno sportiv. B’hekk kellhom neċċessarjament jibbażaw ruħhom anke fuq-analisi tal-fenomeno minn kampi oħra extra-legali.

Kwalunkwe “sport” hu essenzjalment “logħba” u għalhekk għandu fih innifsu jeskludi kwaliasi motiv altruwistiку jew etiku. Pero’, għandu jkun ovvju għal kulħadd illi l-isport hu aktar minn hekk, u l-kwistjoni m’ħix daqshekk sempliċistika. Di-fatti, għalkemm “... sport is meant for fun and play ... fair play in sport with justice in the law ...” (2) huma l-elementi kardinali li wieħed irid janalizza u jinkoragġixxi.

“Without rules of play and effective penalties to enforce them ... chaos results. In society, without the rule of law, and effective sanctions to enforce it and to deter law-breakers, anarchy results. When either of these two situations exists, civilization breaks down”. (3)

Għalhekk, iż-żewġ fatturi bażiċi u essenziali li jelevaw l-isport minn garegar priv minn kwalunkwe sens għal attivita’ prettament umana u għalhekk kulturali, huma l-ugwaljanza u l-liberta’.

## i. L-Ugwaljanza

Sintekkament, kull sportiv praktikanti jippretdi li jkun accertat li t-trattament li hu jingħata f’certi ċirkostanzi għandu jkun ugħalli għal kulħadd. Tali ugwaljanza għandha tissussisti tul id-durata shiħa ta’ l-isport in kwistjoni.

Għalhekk, il-formazzjoni u l-applikazzjoni tar-regolament sportiv għandu jistmerr kull eċċezzjoni bil-qawwa kollha għaliex altrimenti tkun qed tinholoq dīzugwaljanza illecita li ma tistax tkun ħlief ta’ dannu għall-ispiru sportiv.

Il-participant għandu dritt jippretdi illi l-istess principju jkun applikat fl-istess sett ta’ ċirkostanzi u tali

certezza, li tappilka regolamenti b'mod kostanti, tikkaratterizza l-fenomeno sportiv. Pero’ il-veru spirtu sportiv imur ukoll oltre, u huwa hawn opportun nikkwota estensivament mis-sentenza tal-Qorti ta’ l-Appelli Kriminali Ia’-Ö presesta mill-Onorevoli Mħallef William Harding B. Litt. LL.D.:

“il-veru spirtu sportiv lanqas biss jippermetti illi ma tigix accettata d-deċiżżjoni tar-referee għaliex suppost illi t-“teams” ikunu qaghdu għad-deċiżjoni tieghu tajba u hażina, anqas u anqas huwa immagħinabbi, ħlief minn min ikollu animu pervers u tendenzi krimnu, li għandhom jiġu adegwitatment repressi, illi f’okkazzjoni simili r-referee jiġi kastigat b’attijiet ta’ vjolenza għaliex ikun ha deċiżjoni li ma tqogħibx lill-partitari tat-“team” li għalih tkun sfavorevoli. L-entuzjasmu f’attivitajiet sportivi ma għandhux jiddeġenera fi brigantagg, jew f’“hooliganism”, degradanti ghall-isem tal-pajjiż. Ma hemm xejn f’kondotta simili illi tista’ qatt tindu ī din il-Qorti illi tirritjeni eċċessiva l-pieni nflitta mill-Maġistrat. Anzi l-opinjoni ta’ l-Imħallef sedenti kienet tkun xort oħra kieku ma kienx hemm il-principju tan-“non reformation in pejus” fuq appell tal-kundannatt”.

## ii. Il-Liberta'

Dan hu element fondamentali fl-isport li jippermetti lill-praktikant li liberamente joħroġ mir-rutina ta’ kuljum u jippartecipa attivament, anke b’sagħiċċu, fl-isport ta’ l-ġħażla tiegħu.

Ovvjament, partecipant mhux mgħoni b’liberta’ assoluta iżda b’liberta “awto-kontrollata” u meqjusa wkoll fil-konfront tal-liberta’ tal-partecipanti l-oħra. Fil-fatt, hafna huma tal-fehma illi l-limiti ta’ l-azzjonijiet li partecipant jipponi fuqu nnifsu jikkostitwixxu l-istess pjacir li bih hu jippartecipa.

F’dan il-kamp, il-praktikant mhux biss huwa mistenni li joqgħod għar-ġaqobba regolamenti ta’ l-isport minnu pratikat, iżda huwa mistenni wkoll illi l-azzjonijiet tiegħu fil-kuntest sportiv m’għandhomx jolprepassew dak li hu leċitu fil-ligħiġiet ordinari (5). Kemm il-darba dan ta’ l-ahħar isehħi wieħed ikollu jibati l-konsegwenzi u jagħmel tajjeb għad-danni minnu kkaġunati anke civilment. Hafna drabi l-linja ta’ demarkazzjoni hi diffiċċi li tindividwha u kif qalet tajjeb Mrs. June Davies, ‘chairperson’ tal-Qorti tal-Maħistrati ta’ Abercarn, Gwent, South Wales (6).

“It is difficult to decide where the rough and tumble of sport ends, and where criminality begins to appear in a game... We therefore think the case would be properly dealt with by a Crown Court”.

## C. L-isport u l-Leġislazzjoni

Antikament l-eżercizzju sportiv kien jaqa’ biss fl-ambiru tad-“Dritt Pubbliku”. Di fatti, jekk nieħdu bħala eżempju l-Logħob Olimpiku ta’ l-Era Antika, l-Ellanodici m’ħux biss kellhom purisdizzjoni jipproklamaw lir-rebbieħ iżda kellhom ukoll id-dritt li jeskludu kopetituri inidonei; jiffustiġaw lil min ikun indixxiplinatu saħansitra, jekludu bliet shaħħ mill-istess logħob (7).

Illum l-isport irriemerga bħala manifestazzjoni kollettiva li pero’, għall-hafna, għadha tisfugġi definizzjoni ampja u accettabbli. Di fatti, dan hu wkoll rifless mill-istess interventi leġislattivi li ġeneralment huma limitati, għal dik il-parti tal-fenomeno sportiv li b’xi mod jew ieħor imissu l-interess pubbliku. Per eżempju:

1. L-Att tal-1976 dwar il-Prevenzjoni ta’ Siri ta’ “Players” - Att XIX ta’ l-1976.

2. L-Att dwar il-“Pools” tal-Gvern Malti fuq il-Logħob - Cap. 131; Volum IV ta’ l-Edizzjoni Riveduta tal-Ligħiġiet ta’ Malta.

3. Regolamenti dwar ir-Registrazzjoni ta’ Kazini, ippublikati bin-Notifikazzjoni tal-Gvern Nru. 505 ta’ 1 ta’ Ottubru, 1939, u kif sussegwentement emendati. Oqsma oħra huma dīzgrazzjatament kompletament

injorati u konsegwentement qegħdin jiġi osservati diversi diffikultajiet li l-isport jista' frankament facilment jgħaddi mingħajrhom. Fost dawk princiċiali hemm s-segħenti:

1. Id-dritt li assoċjazzjonijiet sportivi legittimamente jippretendu rigward protezzjoni ta' l-emblemi rispettivi tagħhom.
  2. Certa rigidita' f'xi regolamenti ta' assoċjazzjonijiet li per konsegwenza certi kategoriji ta' sportivi jistgħu jkunu restretti milli jezercitaw l-isport favorit tagħhom.
  3. It-“transfer” ta' players minn “Club” għal iehor u rrapporzi kontrattwali li jistgħu jeżistu bejn il-“players” u l-“club”.
  4. L-assigurazzjoni ta' l-isportivi.
  5. Il-posizzjoni tal-minuri fl-isport.

L'esistenza ta' dawn il-lacunae u oħra

E' esistenza di dawihh facili e di certa logica waraihom. Di fatto hafni

Certa logika warajhom. Bi farr, halna awtar, awtor evon f' dan il-kamp josservaw illi-l-isport hu fih innifsu materja aguridika, appartenente għall-ixsfera tal-hajja soċjali li ma tantx tirrikjedi regolamentazzjoni. Dawn jargumentaw illi r-rabta li permezz tagħha il-partecipanti jobbligaw ruħhom li josservaw ir-regolamenti ta' l-isport in kwistjoni m'hix waħda ta' natura ġuridika peress illi-l-ftehim milħuq majkkwalifikax bħala kuntratt veru u proprju.

Dawn huma ta' l-opinjoni illi r-regolamenti sportivi huma awtonomi u kompleti, u li ghalhekk m'humex imposti, u lanqas għandhom ikunu imposti bl-istess metodu li huma imposti l-ligġiżiet ordinarji tal-pajjiż. Tali regolamenti fil-fatt jorbtu biss l-idawk li jkunu jridu jċedu għalihom billi ja'filljaw ruħhom ma federazzjoni sportiva partikolari.

Necessarjament, l-isport jinkludi wkoll il-kunċett ta' kompetitivita' - konflikt - ta' lanqas il-paragun ta' valuri sportivi. Dan jimplika l-ezistenza ta' organu li jiddikjara awtorevolment is-superiorita' ta' wieħed mill-partecipanti fuq l-oħrajn. Il-kompetizzjoni minnha nnifisha timplikali fit-tmiem wieħed jiġi dikjarat rebbieħ. Ghalkemm din hija kwistjoni b'certi konnotazzjonijiet għurdici hafna huma tal-fehma li din hija aktar kwistjoni puramament teknika priva minn kwaliasi diskrezzjonalità. Dan peress illi l-assocjazzjonijiet sportivi m'hux biss-ghandhom id-dritt, iżda l-obbligu, li jenforzaw ir-regolamenti ta' l-isport bla biża, hazen jew gibdat tal-qalb. Gurisdizzjoni f'materja dixxiplinari hija ta' natura xi fiti differenti u testendi fuq il-membri kollha ta' l-assocjazzjoni. Tali gurisdizzjoni għandha tkun ristretta għall-assocjazzjoni li quddiem tħaqib mill-kwarr tħalli, sakemm din ma tistraripax mill-kamp sportiv għal xi-kamp iehor legali bħal per eżempju il-kamp kriminali. Generalment din il-materja ta' dixxiplina tkun già maħsuba fl-istatut partikolari. Huwa bizzżejjed jingħad f'dan il-kuntest illi r-rigorozità li biha tittieħed din il-materja tirrifletti s-sensibità tal-membri għal din il-problema u l-klima morali prevalent iż-żgħid.

Intrinsikament, l-attività sportiva tinkoraggixxi certi valuri, kemm individwali kif ukoll kollettivi, li strettament imoru oltre l-kamp gúridiku veru u propju.

Fosthom nistgħu nelenkaw:

1. is-sens ta' sagrifîcë
  2. l-auto-dixxiplina
  3. id-determinazzjoni
  4. il-fiducja'
  5. il-lealta'
  6. il-generosita'
  7. l-altruizmu
  8. l-umilta'

Huma proprju dawn, flimkien ma fatturi ohra (inkluzi is-sikurezza tal-partecipanti u l-ispettaturi vjolenti), li għandhom iwasslu lill- "Moviment Sportiv Malti" sabiex inaqqs ordinament għardiku intiż spċifikatament sabiex joħloq struttura generali sportiva legalment rikonnox-xuta, u dan, għall-kjarezzata ħsieb u direzzjoni.

#### D. Konklusioner:

D. Konkruzjonijiet:  
Analisi superficjali ta' l-istatuti tad-diversi assoċjazzonijiet sportivi tizvela diversi anomaliji f'certi elementi essenziali li iistgħu iż-intralċaw u ifix klu l-ahja.

andament tal-fenomenu sportiv. Ćerti statuti fil-fatt jittradixxu ċerti tendenzi li jistgħu jimminaw il-principju ta' ugwaljanza tant bażiku fl-isport.

Is-sitwazzjoni prevalenti hi waħda karenti fl-'uniformita', fejn kull, assoċċazzjoni hi ovvijament libera li torganizza lilha nnifisha kif jidhrilha, jew aġjar kif jidhrilha l-maggoranza tal-membri fl-istess. Nippreciża, illi fih innifsu m'hemm sejn hażin f'dan, u ma nistax niġi misinterpretat. Jibqa' l-fatt pero', illi meta wieħed jiġi biex jaġħmel eżami analitiku ta' l-istess satutti tali differenzi jistgħu joħolqu problemi li asseċċejazzjoni tista' liberament tgħaddi mingħajrhom.

Il-lígi ma tpoggi ebda ostakolu lill-kwalunkwe grupp ta' persuni li jaqblu u jifthemu li jwaqqfu assoċjazzjoni li l-iskop tagħha ma jkunx wieħed illecitu. Fil-fatt, jista' liberament jangħad illi kwalusi assoċjazzjoni hi possibbli kemm-il darba din ma tkunx "soċieta" per delinquere". In oltre, l-istatut ta' tali assoċjazzjoni, li għandu l-forza ta' kuntratt bejn l-istess membri huwa dejjem sugġġett ghall-interpretazzjoni ġusta, korretta u raġjonevoli (8).

Jibqa' l-fatt pero' illi tali alternattiva tista' forsi tkun aktar effiċċienti u effikaci partikolarmen fl-ambitju ekonomiku-organizzattiv, li ma jistgħax hlief ikun ta' benefiċċju għall-isport u koerenti ma l-ideali tiegħu.






Wara biss 5 minuti li dahal P.S. 567 Teddy Bajada fetħah lis-skor meta nkariga ruha minn penalty wara hands ta' difensur li mbllokka xutxta' P.C. 874 Patrick Zammit ndirizzat lejn il-lasti. Meta din il-persuna t'assikura vettura, nghidu alha fuq somma ta' Lm4000, jekk il-vettura tigi misruqa l-assikuratur ser jiġi kumpensat b'dan-l-ammont, jew inkellajisru certi indikazzjonijiet li l-vettura m'għadix ta' dik il-kundizzjoni li l-persuna tingħata dawk l-Lm4000. Allura meta jithallas il-premium għaliex l-assikurazzjoni ma jghidulux biex inaqqsas il-premium, peress li jekk il-vettura tigi misruqa jew distrutta mlux ser jieħu dak l-ammont ta' flux fuq x'hix ikun assikurat?

X'għara? Xi ħadd fettillu jifta kawża l-Qorti u rebagħħha. Illum metajib qiegħi 'il-'Policy of Insurance' wara għandek issib AVVIŻ IMPORTANTI, li jgħid hekk:

Il-vlaur tal-vettura stmat minnhekk jista' jkun għoli wisq.

"Il-kumpens li wieħed għandu dritt li jirċevi mingħand il-kumpanijata" assigurazzjoni luwa mfisser fil-Polza. Dint ġid li l-kumpanija ta' l-assikurazzjoni trid tirrifondi l-valor attwali tal-vettura strat meta dint īnsteraq jew iġġarrab hsara li ma tistax tissewwa (Total Loss) - pero' l-Polza tkompli tgħid li f'ebda każ-żgħad ma għandu jithħallas kumpens s-s "sum insures" jiġi fieri l-valor li jkun ta' l-assikurat.

Dan il-valur wieħed jasal għaliex billi jikkonsidra l-prezz li l-vettura ta' l-istess għamla, żmien u kundizzjoni, ġgib kicku kellha tinbiegħ 'second hand'.

FTAKAR LI S-SOMMA LI TIDHER FIL-'POLICY' SCHEDULE' U FUQ L-AVVIŽ TAL-HLAS M'HIIJEX NECESSARJAMENT L-AMMONT LI JIĞI MHALLAS. DIN HJA L-ISTIMA LI INTI TAJTNA TAL-VALUR TAL-VETTURA U TIRRAPREŽENTA L-OGLA SOMMA LI OATT ITSTA' TIĞI MHALLSA TAHT IL-POLZA.

GHALHEKK NIRRIKMANDAW LI TIRREVEDI LISTIMA TIEGHEK TAL-VALUR TAL-VETTURA KULL SENA QABEL MA ĢGEDDED IL-POLZA META INTIMA TAGħMLIX DAN, JISTA; JIGRILEK LI TKUN QED THALL AS-AKTAR 'PREMIUM' MILLI IMISSEK

Aħna nistgħu biss inkunulek ta' għajnuna, pero' hija responsabilità tiegħek li tagħtil-valur xieraq tal-vettura li trid tassigura. Infatti tista' tagħżel li ġġib stima ufficjalju indipendenti mingħand 'motor surveyor' approvat".

Smajtuha ddoqq. Peress li kien hemm sentenza tal-Qorti issa qed javżawna li għandna nnaqqsu l-premium. Nispera li ull min hallas l-assikurazzjoni nduna b'din il-kitba u ma qabadx hallas bi-amment, għax nħiduha kiflini, tal-assikurazzjoni mhux ser jgħidulek li hallast iż-żejjed u jekk jinqal għażi xi haġa jgħidulek li iż-ilek infurmawk.

Iżdaġ-ikbar waħdahija din li ser insemmi. Hawa l-iqtar li nixtieq iż-żi l-assikuraturi jiġi responduni ċar u eż-żarru dak li ser nistaqsi. Naturalment minnha jidwir tal-jeuwa.

Meta jien nitlob l-ispejjeż-żejt tal-ħsarat li soffriet il-vettura tieghi, l-assikurazzjoni tal-vettura 1-ohra tgħidli "JIDDISPJA CINA IŻDA S-SID TAL-VETTURA M'GHAMILX CLAIM". Dan xi jfisser? Ifisser li l-assikurazzjoni tieghu mhux ser tgħamilli tajjeb għall-ħsarat u jekk irrid niftaħlu kawża jien personali. Ghallura dan hu sewwa? Meta jien inħallas dawk il-flus m'għandiekk ikolli il-proteżjonji tal-assikurazzjoni tieghi? u għalfejn hemm bżonn li l-individw lu-ichor jgħamel il-claim? Jekk jidher ċar li għandu tort, għaliex l-assikurazzjoni tieghu ma tixxu ir-responsabilita u thallax l-ispejjeż-żi? Ujekk jien m'għandiekk flus biex niftaħlu kawża nibq'a' bli ħad tħad u nsaffar l-Aida kif jgħid il-Malti?





Wasal iż-żmien illim'hemmx għalfejn wieħed jgħamel il-claim. Jekk għandu tort, l-assikurazzjoni tiegħi għandha minn-hajnejha tħalli. bniedem, twęggħu u matkunx assikurat. Huwa importanti hafna  
illi l-vittma għandha tingħata kumpens tal-ġriči li tkun sofriet.  
Barra minn dan hemm pieni horox għal min isuq vettura mingħajr  
ma tkun koperita b'polza tas-sikurta taħbi ir-riskji tat-terzi persuni.  
Semmejt dawn l-eżempji mingħajr ma nnaqqas xi ġiħu u gid li  
dejjem joffru l-kumpaniji tal-assikurazzjoni.

Nixticq nagħlaq billi nistieden lil qarreja ta' din ir-rivista biex jiktbuli dwar dan is-suġġett, spċċjalment mingħand xi individu jew korporazzjoni tal-assikurazzjoni u jagħtihni risposta ta' dak li jien staqsejt, jew inkella jiġi markawli dwar dak kollu li jien għid.



