

Haga oħra li sa ffit taż-żmien ilu lanqas biss kollna noħolmu dwaru, illum il-ftehim jipprovdi wkoll għall-hlas għall-Hdud doppji u l-festi pubblici bir-rata ta' hlas ta' siegha, siegha w-nofs, barra ż-żieda fir-rata ta' hlas għall-overtime.

Dan il-ftehim juri li l-gvern jirrikonnoxxi r-rol speċjali tal-pulizija u dan gie rifless f'dan il-pakkett b'incentivi

ġoddha. Jidhru wkoll żidied oħra fl-allowances u ħolqien ta' oħrajn.

L-Assocjazzjoni mhux Trade Union

Kummenti xejn favorevoli, bħal dejjem, għadhom jiġi minn membri tal-korp li ma tantx jagħmlulna kuraġġ, bħal kummenti negattivi fil-konfront tal-assocjazzjoni li din ma tagħmel xejn ghax bla saħħa. L-ġhan tal-assocjazzjoni hu differenti minn dik ta' xi 'Trade Union' u kontinwament irregolata mil-liġi u bl-ordinanza tal-pulizija. Iżda bħal kull istituzzjoni, kellna wkoll titjib li mhux ta' minn jsemmiehx.

Penzjoni wara 25 sena servizz

Kienet fuq insistenza u ħidma tal-membri tal-assocjazzjoni li fil-passat, tejbu xi affarrijiet zghar, iżda importanti ferm. Ir-riforma mħabbra kienet waħda biss minn dawn is-suċċessi. Ma ninsewx, u din tgħodd għalina l-membri ta' eta żgħira u li ngaggaw fil-korp wara s-sena 1979 li sa ffit ilu aħna kollna nistgħu nirtar bil-penzjoni wara li nagħlqu s-sittin sena. Għal dawk il-membri li għandhom aktar servizz infakkarhom li qabel meta kont tiftira anke għax kont bil-25 sena jew 30 sena se-vizz ma kontx tista taħdem u tieħu l-penzjoni bla tnaqqis ta' xejn. Madankollu għad hemm ħafna x'wieħed x'jista jirrangha sabiex ikollna dawk il-kundizzjonijiet aktar xierqa, per-eżempju, personalment jien ma naqbel xejn mal-fatt li l-paga ta' surgent tal-pulizija hija biss ffit aktar minn dik ta' kuntistabbi. In-natura tax-xogħol ta' surgent u responsabilità kifukoll id-dmirijiet huma ferm-ċċifferenti minn wieħed għall-ieħor, filwaqt li d-differenza fil-paga mbagħad hija ta' Lm-20.00 fix-xahar fil-massimu. Dan żgur li jirriflettiex tajjeb ir-responsabilitajiet tas-surgent. Nifhem madanakollu li jekk wieħed jara fliema skala qiegħed surgent ma hemmx fejn jogħla aktar, iżda b'daqshekk ma jfissix li surgent m'għandux ikoll aktar allowance.

Jien infurmat ukoll, li l-maguri ukoll mħux qeqħdin daqs tant kuntejti fl-iskala li qeqħdin, filwaqt li xi wħud hassewhom li ġew 'demoted'. Dwar dan il-'branch board' tal-maguri Itaqa w-kelu jgħaddi rapport lill-awtoritajiet.

X'hemm fil-gejjjeni?

Dan l-istudju għandu jigi zviluppat aktar il-quddiem, u dwar dan għandhom isiru laqgħat apposta u l-membri jiġi nfurmati bid-dettalji kollha kifukoll sabiex l-assocjazzjoni tkun f'pożizzjoni biex tara x'rispons jkun hemm mill-membri. Naturalment, aktar ma jkun kbir in-numru tal-membri fl-iskema il-hlas ta' shubija jkun jista jinżamm baxx kemm jista jkun.

"Programm ta' Riabilitazzjoni għal min jabbuża mid-Drogi" immexxi mill-Caritas.

Fil-Korp tal-Pulizija minn dejjem kien hemm xi tip ta' Vice Squad li kienet tinvestiga l-aktar reati fejn jidħlu vizzjji ta' logħob, ta' l-azzard, prostituzzjoni (white slave traffic) u "absentees" fejn jinvolvi tfal minorenni. Fil-bidu ta' l-1978 inhasset il-htiega li titwaqqaf "Drug Squad".

Jiena kont wieħed mit-tlieta li ffurmajna din l-iskwadra. Ir-raguni tiegħi persunali ġħala accettajt li nkun membru ta' din l-iskwadra kienet li xtaqt li t-tfal tiegħi, li dak iż-żmien kienu għadhom żgħar, jitrabbew u jikbru f'ambjent nadif mid-droga.

F'dak iż-żmien ftit li xejn konna nisimghu dwar id-droga u l-unika esperjenza li kelli kienet meta xi ftit żmien qabel, fuq informazzjoni kont sibt xi ħames jew sitt sigriet tal-ħaxixa fuq il-bejt. Fil-fatt, peress li qatt ma kont rajt xitla tal-ħaxixa qabel kont ikkonfermant ruhi ma'l-ispettur tiegħi, li kien għamel crash course organizzat mid-Drugs Enforcement Agency Amerikana.

Waqt li f'Lulju 1978 flimkien ma' l-Ispejtur Leo Borg u ma' l-Ispejtur Gaetano Walker (li dak iż-żmien kien għadu dieħel fil-korp tal-pulizija bħala kuntistabbi) konna Ruma nitharrġu dwar id-droga fl-iscuola Ufficiale Carabinieri, konna ġejna nfurmati minn Malta li kien miet żagħżugħ b'effett ta' doża qawwija ta' eroina.

Kienet l-ewwel tragedja effett tad-droga go' familja Maltija. Ma kienetx ta' l-ahhar ghax ftit wara li ġejna lura minn Ruma konna ġejna mghajta biex ninvestigaw kaž ieħor ta' żagħżugħ li nstab mejjet bid-droga.

F'dak iż-żmien l-eroina kienet aktar mifruxa fost iż-żgħażaq ta' familji sinjuri minħabba l-prezz tagħha, waqt li fil-Kottonera u Ghawdex kienet aktar komuni l-Cannabis (ħaxixa). Marsa, Hamrun, Belt Valletta u Gżira kienet l-aktar komuni l-pilloli medicinali fosthom il-Valium u Tiunals (rainbows).

Fost iż-żgħażaq b'diet tinfirex certa kurzita' u bdew jiġu ffurmati klikek baxx baxx f' ġafna lokalitajiet differenti. Izda għall-ġenituri d-droga kienet biss xi haġa tal-films u problema ta' b'liet kbarr minn Malta.

Il-pubbliku ma kienx konxju li f'Malta beda jikber mostru li kien se jibla' numru ta' żgħażaq.

B'dan il-ħsieb fl-1983 numru ta' ġenituri li kienu digħi' gew effettwati u milquta mill-problema tad-

droga ingħaqdu u flimkien ma' Mons. Victor Grech u Fr. Charles Cini S.D.B. bdew jiddiskuti x'jista jsir mhux biss għal dawn iż-żgħażaq li l-familja tagħhom.

Minn kuntatti li digħi kellu Fr. Cini, irnexxielu jibgħat xi żgħażaq għall-kura fl-Irlanda. Dan ma kienx b'xejn u għalhekk qamet il-kwistjoni x'ser isir minn dawn iż-żgħażaq li l-familja tagħhom ma setgħetx thallas.

Il-Caritas taħt it-tmexxija tad-Direttur tagħha Mons. Victor Grech b'diet taħseb mhux biss fil-familji milquta mill-problema iż-żgħażaq li l-familja tagħhom tas-socjeta'.

Hafna kienu dawk li għax ma hassewx il-problema dieħla ikkritikaw lill-Caritas għax qalu li qed tallarma lill-poplu, iż-żgħażaq li l-familja tagħhom ma setgħetx bilfors kellu jaħsibha mod ieħor.

Fl-1984 il-Caritas ġabet Malta lil Mr. Jim Camberton u lil Mr. Tom McCarry, tnejn mid-diretturi ta' Coolemine Lodge - Centru ta' Rijabilitazzjoni għad-Drogati f'Dublin, l-Irlanda.

Mil-laqgħat li kellhom mal-grupp ta' ġenituri milquta bil-problema tad-droga, u ma' xi wħud mid-drogati, qablu li kellu jsir xi haġa malajr għax bl-esperjenza tagħhom dawn iż-żewġ esperti indunaw li l-problema kienet dahlet sew fi għżejtna.

Għaldaqstant il-Caritas waqfet għaqda ta' voluntiera u dawn ġew imħarrġa biex jagħtu l-informazzjoni meħtieġa lill-poplu Malti dwar id-drogi u l-effetti tagħhom. Din l-ġħaqda bl-isem ta' "Prevention and Action Group", b'diet taħdem billi tagħti taħdidiet lill-ġenituri u żgħażaq fil-parroċċi, skejjel u kull fejn kienet tiġi mistiedna. Użat il-media u ppubblikat numru ta' kotba u fuljetti informativi dwar id-drogi u l-effetti tagħhom. Introduciet programm ta' "Life Skills" fl-iskejjel biex tgħin l-istudenti jkopru mad-diffikultajiet tal-ħajja b'mod naturali u mhux minnhom permess ta' drogi.

Il-pulizija kienet minn qabel jiġu mistiedna biex jagħtu taħdidiet lill-pubbliku. Dawn il-laqgħat kienet jservu barra biex tingħata l-informazzjoni iż-żgħażaq li l-familja tagħhom u l-ġenituri b'qalb miġugħa.

"Jekk ninforma l-pulizija li ibni qed jieħu d-droga, tista' l-pulizija tgħin mingħajr ma ibni jittella l-qorti?" din kienet mistoqsija komuni minn ġenituri b'qalb miġugħa.

Kont nistħajjalha mistoqsija bħalma kienet jagħmlu l-Fariżej lil-Ġesu. Tirrispondi kif tirrispondi dejjem

Din is-sezzjoni l-ġdida li tifforma parti mill- "Vice Squad" hija f-data fidejn l-ispettur Sharon Zammit, mgħejjuna mis-surgent Joseph Cassar PS 521, mis-surgenta Josephine Gauci WPS 24, il-kuntistabliet nisa Connie Cauchi WPC 64, Mary Rose Pulis WPC 72 u M'Grace Bianco WPC 60. Dawn in-nies huma responsabbli li jinvestigaw kull xorta ta' offizi sesswali, prostituzzjoni, u offizi ta' vjolenza fid-dar kemm fuq il-kbar kif ukoll fuq it-tfal. Huma marbutin ukoll bid-doveri tagħhom li jfittu l-'absentees' li jiġi rrappurtati li generalment jittrattaw fuq kaži ta' tfajjlet li jaharbu mid-dar. HOT GARLIC BREAD

Cooking time: 10 mins.

Oven: 220c 425f, gas mark 7.

150g (5oz) butter 3 garlic cloves, peeled and crushed

1/4 teaspoon chopped fresh parsley

2 wholemeal or white french loaves

1. Using a fork, mix together the butter, salt, parsley and garlic cloves.

2. Cut the loaves into 5cm (2 inch) thick slices. Spread the garlic butter on both sides and put the slices back together to reshape the loaves. Wrap in foil the bake for 10 mins.

Serve immediately.

This recipe became very popular in Malta these last few years. It is served as an appetizer in many restaurants and now even in pizzerias. Garlic bread is also ideal for barbecues or as a snack.

SPINACH AND CHEESE LASAGNE

Cooking time: 30 mins (approx.)

Oven: 200c 400f, gas mark 6

175g (6oz) wholewheat lasagne (about 10 sheets)

Salt

Paprika to garnish

Filling:

2 x 225g (8oz) packets frozen spinach

Freshly ground black pepper

1/4 teaspoon grated nutmeg

25g (1oz) pecan nuts, shelled and chopped (or pine nuts)

Sauce:

40 g (1 1/2 oz) plain flour

40 g (1 1/2 oz) butter

600ml (1 pint) milk

200g (7 oz) mature cheddar cheese grated

Freshly ground black pepper

1/2 teaspoon English mustard

1. Cook the lasagne in boiling salted water for about 15 mins. until tender.

2. Meanwhile cook the spinach. Put the frozen spinach in a pan over gentle heat, breaking the spinach up as it thaws. Simmer for about 2 mins. then increase heat so that any liquid evaporates. Season with salt, pepper and nutmeg and stir in the pecan nuts.

3. While the spinach is cooking make the sauce. Melt the butter, add the flour and cook for 3 mins., stirring. Pour in the milk

and bring to the boil stirring all the time until the sauce thickens and then simmer for 3 mins. Add all the cheese except for 35g (1oz) and season with salt, pepper and mustard.

4. To assemble the dish, pour half of the sauce into a shallow dish and lay half the pasta (lasagne) sheets on top. Spoon the spinach over this and cover with remaining pasta sheets. Pour the rest of the sauce over the top and sprinkle with reserved cheese (1oz).


5. Bake near the top of the oven until piping hot and brown on top.

6. Sprinkle with paprika and serve hot.



Wara insistenza ma l-Uffiċċju tal-Lieutenant Governor, Sir Harry Luke, irnexxielu jikseb appoġġ minnu permezz tal-Kurunell Micallef Eynaud, l-A.D.C. tal-Gvernatur, biex jidhol fil-Pulizija. Dan il-Pass ħadu għax la l-Ministru tal-Ġustizzja ta' dak iż-żmien u l'anqas il-Kummissarju stess ma tawh widen għax-xewqa tiegħu. Iżda kelli jkun is-sur Salvu Galea stess, il-Kummissarju tal-Pulizija, li wara hamest ijiem biss li kien kellmu Sir Harry Luke, bagħat għaliex u tah il-ġurament. Mistoqsi x'jiftakar bil-bidu ta' din il-karriera, Bowerman qal li dak iż-żmien il-licenzja tas-sewqan kienet għadha bla ritratt ta' l-individwu. Dan kien iwassal għal abbużi billi nies bla licenzja kieni jsuqu xi vettura u meta jiġi mwaqqfa mill-Pulizija, kieni juru xi licenzja minn ta' shabbom. Tikkalkula li kien jirraporta xi sitt kaži simili kuljum - akkuża lil min saq bla licenzja u oħra lil dak li jkun ippermiettielu jsuq bla licenzja. Wara tlett snin servizz il-Kummissarju bagħat għaliex biex jagħmlu Surgent iż-żda Bowerman irrifjuta din il-kariga għax ħass li ma kienx kapaci

Meta deher il-Qorti x-xufier weħel lira biss għax il-Maġistrat ħass li Bowerman kien mar minn fuq waqt l-arrest tax-xufier li assolutament ma kienx ried jobdi l-ordni tiegħu.

Bowerman, li għad għandu ibnu John fil-Korp, minn dejjem kien bniedem ta' principju. SOCIETY FOR THE REFORM OF CRIMINAL LAW

Important recent amendments in the Maltese criminal code

The original amendments in the Maltese criminal code were mainly carried out in bulk, way back in 1850 following a detailed study and report on the proposed code of criminal laws for the Island of Malta and its dependencies by an advocate at the Scottish Bar, Andrew Jameson, who in his introductory report to the then Secretary of State for the Colonies stated, that his study and proposed amendments were mainly to deal with "defects and chiefly in those parts, wherein from its Neapolitan origin, there may be too great a departure from the liberal spirit of English law".

1. The original criminal code had as its basis the Ionian code and the Criminal code of the then Kingdom of Naples as its model. There was also an influence of the code Napoleon, and an apparent reference "to the German code".

2. The code Penal, as was then referred, after being formed by the most learned Jurists of France, underwent the rigorous scrutiny of several commissions. Incidentally at present there is a similar ad hoc commission, the Permanent Law Reform Commission, which has to provide also proposed amendments to most laws of Malta.

In the Maltese Criminal Code, there is seldom any attempt made to define well-known offences. These include among others theft, forgery, and arson. For some reason or other we still left precise definition at the mercy of the courts. This does not mean, that our criminal code lacked amendments from time to time, for we all know that the law also acts in same degree even upon public opinion. Yet it is also necessary, to beware, of even the appearance of undertaking the moral guilt of certain actions, and thus, in some degree, corrupting the moral sense of those who are amenable to the law. However my intentions in this paper will be sufficient if it is at least agreed that the true end of penal jurisprudence is to prevent crimes. I do not intend to lead my thoughts to other hot issues that are present in our criminal code such as the seemingly insufficient constitutional check or control over the indefinite exercise of Magisterial or Juridical authority. My purpose in this paper is to limit myself only in what actually was amended in the Maltese Criminal Code in the last five years.

Punishment

Some of the amendments were just alterations that have been proposed with the view of moderating the punishment and obviating those objections to the language of the articles which it is hoped will guard against the risk of confounding mere imprudence or

acts done or omitted in moments of trouble and confusion, with the result of premeditated fraud. On punishment, one may scientifically argue that if the severity of a punishment is found to have neither an increased deterring effect, nor an increased reforming tendency, then it is only an unnecessary cruelty. In Malta for example, the nature of the climate which in summer is extremely relaxing, is calculated to render long period of imprisonment extremely severe in their effects. Even this topic on sentencing policy which automatically has to interfere in this subject of "recent amendments in the Maltese Criminal Code", is also the subject of great controversy and was often discussed in specific seminars in my country. To say it all, one of the considered punishments in Malta, hundred years ago, was a plan of exchanging Maltese convicts with an equal number of Ionian convicts to be received in return, and such convicts to be employed by the respective governments in coercive, and in cases of excess on either side, terms of reasonable compensation to be adjusted. However this proposed plan never materialised. Yet we did realise novations in the sentencing policy in Malta, following Act 29 of 1990 that amended the Criminal Code, where suspended sentence of imprisonment was also introduced. So as you can see, we are still experimenting in the sentencing policy.

Aggravations

Another feature related with punishment in the Maltese Criminal Code is that it specifies the circumstances of aggravation or extenuation as far as these are of a general and certain kind

and to fix a certain proportionate increase- or diminution of punishment, according to the existence of such circumstances. This plan is attended with the advantage of producing greater systematic neatness: but it is doubtful whether it is likely to be equally beneficial in the actual administration of the law.

Malta's ratification of various conventions

Following Malta's ratification of various conventions including the Declaration on the Protection of All Persons from being subjected to Torture and other cruel, inhuman or degrading treatment or punishment,

3. an important article was introduced in the Maltese Criminal Code - now section 139A following Act 29 of 1990, which before was only a constitutional check. The section of the law created a particular crime concerning the torture and other cruel, inhuman or degrading treatment of punishment. It reads that "any public officer or servant or any other person acting in an official capacity who intentionally inflicts in a person severe pain or suffering, whether physical or mental-

a. for the purpose of obtaining from him or a third

person information or a confession;

- b. for the purpose of punishing him for an act he or a third person has committed or is suspected of having committed, or
- c. for the purpose of intimidating him or a third person to do, or to omit to do, any act, or
- d. for any reason based on discrimination of any kind, should on conviction, be liable to imprisonment for a term from five to nine years, so the sentence policy here is strict imprisonment.

Provided that no offence is committed where pain or suffering arises only from, or is inherent in or accidental to, lawful sanctions or measures:

Provided further that nothing in this section shall affect the applicability of other provisions of this code or any other law providing for a higher punishment.

Theft with violence

Another important amendment (4) was the widening of what has been earlier meant by "violence". According to this 'adde' of section 280 of the Maltese criminal code, if "the violence is directed against any of the persons mentioned in sections 276 A the punishment applicable to theft when accompanied with the aggravating circumstance of violence shall be the punishment as increased by that section".

Fraudulent access to telecommunications systems

Certain specific crimes which hundred years ago were unimaginable are today a reality of life and one of these, is a consequence of the telecommunication infrastructure. The new crime is now found in section 298 A of the Criminal Code, which reads, "whosoever shall construct, alter make, be in possession of, sell or purchase any device where by such person may unlawfully connect with any telecommunication system shall on conviction,

- a. where the offence is committed for gain or by way of trade to imprisonment for a term not exceeding one year or to a fine (multa) of not more than two thousand liri or to 60th such fine and imprisonment; and
- b. in all other cases to a fine (multa) of not more than one thousand liri.

Violation of copyright

A century ago, violation of copyright and patents were a subject better fitted for the civil remedy by way of actions of damages rather than a criminal prosecution for fine and in default thereof imprisonment. Today violation of copyright is a crime and the present provision, section 298A of the Criminal Code came into force on the 1st January of this year. It reads that "whosoever, for gain, or by way of trade, prints, manufactures, duplicates or otherwise offers for sale or distribution, any article or any other thing in violation of the rights of the copyright enjoyed by any other person and protected shall on conviction be liable to imprisonment for a term not

exceeding one year or to a fine (multa) not exceeding five thousand liri or to both such fine and imprisonment". The defect of this provision of law, is that proceedings under this section may not be taken ex officio but can only be carried out "on the complaint of the injured party".

Receiving stolen property

As a result of the easy transport and movement of property obtained from crimes which certainly one hundred years ago, was not so frequent, our legislators thought it proper to make it also a crime in Malta, for anyone to be handling or in possession of stolen property even though its origin is abroad. So the following amendment was added to the original section 334 of chapter 9 of the laws of Malta (7), "for the purpose of this section such property shall only be deemed to have been stolen, misapplied or obtained by means of an offence committed abroad. If it has been obtained by any act of commission or omission which, if committed in Malta, would have amounted to any of the offences, mentioned in paragraphs (a) (b) and (c)". (8).

Equality of partners in marriage and fornication

Due to equality of both partners in marriage, an amendment of 1986, it is also an offence for any of the partners in marriage if "when so ordered by a court fails to give to his or her spouse the sum fixed by that court as maintenance for that spouse and, or, the children, within fifteen days from the day on which according to such order, such sum should be paid". (9).

A much more important amendment to the Maltese criminal code was the repealing of section 236 where until very recently, in 1990 (10), there existed a privileged punishment to men in the cases of homicide in an act of fornication. This section of the law used to provide that in the case of homicide committed by a husband or his wife or his wife or her paramour or both, at the moment of discovery them in the act of adultery, the extenuation admitted is agreeable to the ordinary feelings of mankind and to the laws, many years ago, then it was believed, of all countries.

Absence of incest as a crime

The Maltese criminal code still have the absence of incest as a crime. Jameson (11) had then already remarked that this crime should be included and even commented that " I have been unable to discover the reasons which have induced the learned persons who formed the code Penal of France to omit all prohibition of this offence. The mere infrequency of its occurrence in Malta is no good reason why such a revolting offence against social morals and the purity of domestic life should pass unpunished". A proposed article of this crime which astonishingly till today was never introduced as an amendment in the Maltese Criminal Code, is the Italian version which literally

translated reads that "whosoever shall be guilty of any person within the degrees prohibited by law shall be punished with imprisonment from twenty five months to three years".

Criminal procedure and law of evidence

The criminal code of Malta includes in it also the law of evidence and criminal procedure. In these fields there were various minor amendments however the notable ones include the amendment related with the evidence by accomplice and that on the bail. In the former, according to the amended section 639 (12) of the code, "where the only witness against the accused in any proceeding for any offence other than those under sections 112 to 118, 120, 121, 124 to 126 and 138 (13), is an accomplice, whose evidence is not sufficiently corroborated by other circumstances, the evidence of such single witness shall not be sufficient for the conviction of the accused". This means that in those crimes 'of abuse of public authority', 'of unlawful exaction' or 'of extortion and of Bribery', the evidence of an accomplice as a single witness will be sufficient for the conviction of the accused.

On bail, until 1989, it could never be granted to persons accused of any crime against the safety of the government and also to persons accused of any crime liable to the punishment of imprisonment for life. Following a constitutional judgement in Malta, which was mainly based on the European Convention Act of 1987, the law on bail was radically changed. The amendments in bail (14) made it always possible for any person, even if charged with murder or treason, to be granted bail. Today our courts (15) are even challenging the constitutionality of these amendments once Malta has ratified the European convention of Human rights. This means that the law on bail has even to made more liberal! We are certain moving now from one extreme to the other. The court needs only take into consideration, before granting bail, "The nature and seriousness of the offence, the character, antecedents associations and community ties of the accused, as well as any other matter which appears to be relevant" (16).

Conclusion

Any criminal code experiences natural evolution through the passage of time which after all is a reflection of the needs of society. In fact, for example, we often speak today of crimes of omission. These type of crimes are very uncommon if not nonexistent in our criminal code, nothing is said and stated, for example, whether death committed by an unlawful omission is to be deemed to come under a homicide charge. Hundred years ago, Malta's criminal code included a crime on "Failure to assist an exposed infant". This used to be the old article 233 of the code. This crime was subsequently abolished. Should we continue to treat similar breaches of the moral law to be unfit subject for the criminal code? Many would say that it would be impracticable to punish such violations of moral duties with effect, and unwise, if impracticable. However one has to give consideration

of whether the "conventional view" (17) in criminal liability for omission should continue to be followed or should there be a recognition of a principle that criminal statutes should be interpreted so as to apply to omissions as well as to acts. Amendments in this sense have still to be experienced if ever in the Maltese Criminal Code, and sentencing is no exception!!

POLICE ON THE BEAT - Part 2

The basic system of beats evolved in the early years of the nineteenth century and has survived unchallenged up to this present age although several changes have since taken place. The main aim of having uniformed police officers on the streets whether of Fixed Points, Foot Patrol, Motor cycles, Motor cars or Police horses are related to the objectives of policing already mentioned.

Fixed Points

Derived as it clearly is from the army sentry, the fixed point or post is often used as a means of providing protection for items, people or premises which are particularly vulnerable to attack by criminals. The most common examples are embassies, banks, ministries, etc. As a means of policing, it is very unpopular with the people who work the fixed posts and is not much better regarded by most supervisors. It is tedious to be confined to one specific spot and duty of this kind causes fatigue and difficulty in maintaining concentration.

Fixed points are also of limited value relative to the cost. Only to a limited extent does the presence of one man reassure the potential victim and act as a deterrent. With a well-trained police dog or the use of electronic aids the range of the policeman may be extended, but the fact that he can be easily diverted or overwhelmed by the determined criminals will always detract from the value of police sentries.

A wider use of the fixed point to provide a police presence at a particularly busy place was common in the past. The presence of a police officer at a strategic point, prevent disorder and enable the local people to be sure where they could find a policeman in cases of emergency.

A modern extension of the static policeman might well be achieved through the use of electronic surveillance equipment. A number of experiments have been conducted on the use of television for watching city streets, car parks and the like.

The results have not been completely successful. In part, this has been due to the limitations of the medium, lack of sufficient definition to be able to identify criminals, vulnerability of the system to bad weather conditions and operation fatigue. Another feature of such systems is the need to have the resources in hand to take actions when the operator sees something suspicious; they are not as economical in their use of manpower as might be thought. The main developments of television systems, to aid the security of buildings and for monitoring public order events.

Foot-patrols

There is value to be obtained from the ability of people on foot to hear suspicious sounds without the destructions of engine noise and see suspicious sights without having to focus most of their attention on the road ahead. They are quite and so do not excessively advertise their presence at night, yet they are prominently visible as a deterrent during the day. They are available to anyone who wants to stop them and seek for help. At the social level, they are not obviously at one with the people. They can form relationships with the public as they walk amongst them. They become known as individual men, their responsibilities become known; the people are able to select the one police officer that they feel able to speak about a given problem. In return, the police officer are given informations that they can feed into the system of use to solve crime or problems in their own area.

Provided that they are equipped with effective radio sets, they can call for aid to enable them to tackle problems that are too much for one person on foot and can carry out

inquiries in their areas as directed by radio.

Given sufficient scope and support, plus an element of stability, a foot-patrol officer can know the area he policies at a dept impossible to any other system. His patrolling is not dictated by one-way street or width of roads. For certain types of areas, the police officer on foot patrol is the most effective means of policing. Above all, he can stimulate social activities to prevent crime by working within the community. He can identify tensions before they erupt; he can remonstrate with children, advise families and diagnose welfare problems; work of this kind cannot be done from the motor vehicle.

Yet, foot patrols are expensive in the sense that the area that a man can cover on foot is limited. Such patrols are open to the elements and quickly become fatigued in very hot or very cold or wet weather.

Furthermore, the foot-patrol officer makes a very small contribution to the response of the police on emergency calls. Walking is the least sufficient of the means of moving from one place to another and so much of an individual's physical energy is used just for this.

It is often said that foot-patrols are unpopular amongst police officers. This is an overstatement. Some police officers prefer to walk around a beat than to do a duty in a motor vehicle, but there are provisos. The foot-patrol officer needs to be given the responsibility for policing an area at his own discretion and not according to a set of route. The area must be suitable for foot-policing in that it has people in it to whom police can talk. Unresidential area and factory estates do not provide interesting beats because there is no one to whom the police can relate. Densely-populated city areas containing small shops, houses and flats are ideal, yet even here there may be problems if the population contains violent elements.

For this reason, it may be necessary to use police-men in pairs rather than put individuals at risk. The foot-patrol police officer is always vulnerable even in relatively passive areas and may need very urgent assistance to save him from injury if he is involved in a skirmish. A foot-patrol system needs a mobile support system that can give a quick response to calls for help.

The police officer needs to be given the time in which to build up his relationship with the people of the area and this precludes too many changes. In order that people can know him, the police officer has to be in the area often enough and long enough to become recognisable as an individual. Many foot-beat schemes fail because this essential feature of the method is not recognised. To change a foot-patrol officer frequently from one area to another on a rotation system is to destroy one of the main advantages of the system.

Motor-Cycles

The use of motor cycles in patrolling beats also has its advantages and disadvantages. It may be argued that this system would enable the patrolman to cover a much larger area in eight hours than if he was on foot. He would ride the motor-cycle to a place of special police interest than get off his machine and patrol on foot. After checking one area, he would travel to the next and patrol that on foot and so on. In practice, this system may not be successful due to the limitations of the motor cycle and the fact that policemen, once on a vehicle, are reluctant to quit it and parked motor-cycles are vulnerable to vandalism. Furthermore, the increased areas allotted to each police officer means an increased number of routine inquiry calls that tend to make up much of his time.
