Hu qal li lill-Pulizija jikritikha u jżeblaġħha min irid jipprofitta ruħu meta jikser il-ligi u ħegġeg lill-poplu Malti biex lill-Pulizija jaġħtuha kull għajjnuna. Il-ħsieb tar-rijorganizzazzjoni, kif gie rrapurtat li qal il-Prim Ministro, huwa biex il-Korp tal-Pulizija jkun imġħammar b'mezzi aktar moderni u effċċienti biex ikun jista' jaqdi d-doveri tiegħu b'mod aktar effettiv u hekk issaħħa aktar il-fiduċja tal-pubbliku.*



PART 4

Webley-Green Models

This important line of revolvers was always known as 'W.G.' and they ran in a series from 1882 to 1896, with manufacture continuing beyond the last date. In general terms, they can be divided into three groups, and that is how they will be described here; EARLY MODELS, TARGET MODELS and ARMY MODELS. The contribution made by Edinson Green was the barrel fastening, which was a pivoted stirrup and is the type still used on modern revolvers. Although this has been an important feature of all Webleys since 1883, it does not seem as though Green got the recognition he deserves for inventing it.

EARLY MODELS

Webley-Green Model 1882

Webley-Green Model 1882. Known as the 'W.G.' series, these revolvers were very much the first actual Webley design of a break-action, simultaneous-ejection system. They contained elements of previous Webley production, as one might expect, and were in many ways a combination of all the better elements of the revolvers that Webleys had made up to that time. In general design, the 'W.G.' was much like the Kaufmann series, and it had the Kaufmann action, but the cylinder and its release was


taken from Webley-Pryse, Wilkinson-Webley and Enfield. The birds' head but was retained, so was the flat lanyard loop, but the best recognition feature of the 'W.G.' is the cylinder fluting. This is angular in form, and much less attractive than the usual half-round shape. This first Model was chambered for the .455/.476 black powder rounds in a six-chambered cylinder, and a 6 inch barrel.

Webley-Green Model 1885


For 1885, the cylinder release was changed from the Pryse nut to a larger slotted nut that could be turned with a coin. The extractor was altered in small ways also, so that it became more of an original Webley design than an amalgam of others. The calibre and barrel were unchanged, so that the differences between this and the 1882 version are not immediately apparent.

Webley-Green Model 1889


The 1889 model changed the shape of the butt from the bird's head, but left all other aspects of the revolver as they had been on the two previous versions. The change was brought about by cutting through the front and back straps and brazing on the revised shape. This new shape was a flared butt with a wide base. For these heavy revolvers, it is a much practical idea, and gives better control and grip. These revolvers were found to be very good target weapons, and some were made with 7½ inch barrels and improved sights. All the 1889 models were stamped on the left side of the barrel extension with the mark 'W.G.' Model 1889, whereas the other two models were only stamped 'Webley Patents', 1889 was the first year that the company stamped the date on its' revolvers.

Webley-Green Model 1892

For 1892, the calibre was reduced to .455 and the barrel standardized at 7½ inches; the flared butt was retained. Substantial changes were made to the action, the cartridge extractor and the cylinder release, the principles of which have been retained in Webley revolvers ever since. The cylinder release which was patented in 1891 allows for manual release of the cylinder when the revolver is open, but automatically locks it in place as it closes. The cam and lever for operating this system are screwed externally to the left side of the barrel lug and, with slight

variations, have been a Webley recognition feature for the last eight years. A change in the shape and action of the pawl ensued that the hammer was now lifted up instead of being pushed, when the weapon was cocked by the trigger. These models were primarily for target shooting, and it was intended that the customer should fit whatever sights he needed; the standard version had a fixed foresight and a U backsight with allowance for lateral adjustment.

Webley-Green Army Model 1892

A fairly rare model was also introduced in 1892, which can be regarded as the first of the 'W.G.' Army series. In many ways, this 1892 model was the 1882 model brought up to date. It used the same 6 inch barrel in .476 calibre and the birds' head butt, together with fixed sights, but is incorporated the improved cylinder release and action of the target version of 1892.

Webley-Green Target Model 1893

This model incorporated only one change from the previous year. It had a flat-faced hammer, and a small spring-loaded striker set in the standing breech. The precise reason for this change is not clear, and it did not survive for long. Another change was that this was to be the last year in which the year of manufacture was stamped on the weapon. Perhaps the various retailers had complained that the age of their stock was too easily identified, or there may have been other, more cogent reason; but whatever the reason, it further increases the difficulties of the present-day weapon researcher. This revolver was the last to be fitted with the angular cylinder grooves which are the identifying mark of the early years.

TARGET MODELS Webley-Green Target Model 1896

From now on, the 'W.G.' Target revolvers were more or less fixed on the 1892/3 design, with only very minor variations. The outward difference between

these and the early series, lies in the cylinder fluting which is now rounded in section, though individual models carried other minor machining differences from time to time. The 1896 model was chambered for .455/.476 and had a conventional hammer.


Other Webley-Green Target Models

The production of target revolvers was a continuous process with Webley, and they were made to special order, usually using the existing model as a base for the design. It appears that the 1896 model was also made with a 9½ inch barrel, and certainly one revolver still exists which had a 4 inch barrel, yet it is engraved 'W.G. TARGET MODEL'. The calibre was usually .450/.455, as this was a calibre of ammunition in which some regularity was being achieved, and whose performance could be guaranteed to close limits.


These target revolvers were nearly all sold in individual cases or boxes, and were meant to be treated with considerable care and respect. They had no holster guide, but all had a lanyard loop in the butt. In 1889, the standard TARGET Revolver sold for £9 os. od., exactly. Nickel plating cost an extra 8s. Od. The price would have been about 7 times the weekly wage of the highest skilled man in the factory, and it compares reasonable well to the proportionate increase in prices and wages today.

Army Models


Army models were made at the same time as the target versions, and the two employed the same improvements and changes. We have already shown how the 1892 Army Model was very similar in its internal workings to the Target Revolver of the same year, despite its use of ten year old frames and butts. One main difference between target and army models lay in the use of a replaceable firing pin hole for the Military piece. This was achieved by a screwed bush with the firing hole drilled down the centre. All army models had six inch barrels and fixed sights, and were made in the three calibres, .450, .455

and .476. They not only fired the commercial range of ammunition, but took the Enfield cartridges also. The Webley .455 cartridge was excepted for service use in 1891, and the .476 Enfield round became obsolete on that date, although it continued in use for many years after. However, .455/.476 revolvers were stamped with these calibres on the left of the barrel that they could accept both types.

The three clearly identifiable Army models were produced in 1892, 1894 and 1896. The first two have already been described in general terms. The 1896 model continued the same pattern, though it was sold with a flared butt for most of the production, but was otherwise virtually unchanged from the others. The use of the different model numbers when there is so little change to justify it, makes for confusion when identifying a particular piece, but it was probably done in an attempt to help sales, in a fiercely competitive market, and it may have been related to some sort of batch production system.

THE HISTORY OF PHOTOGRAPHY

PART 8

COLOUR PRINTING

Some modern colour processing is almost as easy as the black and white. After exposing under the enlarger the colour paper is processed either in a colour print drum or a colour processor. But various modern methods varies, some makes are a one bath process other take three baths. Other ultra modern (but not reliable) method is that the colour paper is developed by sprayed development and sprayed bleach-fixing. There are two systems in colour printing:

The additive method: When the three primary colour overlap each other they produce the three suplimentary colours plus the white.

i.e. When RED overlaps the BLUE, it produces MAGENTA.

When BLUE overlaps the GREEN, it produces CYAN.

When GREEN overlaps the RED, it produce YELLOW. When the three primaries and the three secondaries or suplimentaries meet, WHITE is produced.

The Subtractive method: When the three suplimentary colour overlap each other they produce the three primary colours plus the BLACK. i.e. When YELLOW overlaps the CYAN, it produce GREEN.

When YELLOW overlaps the MAGENTA, it produce RED.

When MAGENTA overlaps the CYAN, it produce BLUE. The three primary and the three suplimentary colour produce Black when they meet, or rather when overlap.

The subtractive principle is that upon which nearly all workable colour process are based, in photography as well as graphic arts.

In additative system, the additive filtering is produced by means of colour head on the enlarger condenser housing, between the light source and the lens. While in the subtractive method the filtering is produced by means of filters, through the filter drawer, between the en-

larging lens and the light source; also a heat absorbing filter must be added to serve as a heat dissipation and prevent the valuable negative from becoming overheated resulting in curling and the negative might be damaged.

LASER

Light Amplification by Stimulated Emission of Radiation.

Light source emitting continuous or intermittent light pulses in the form of coherent waves of great concentration and intensity. Also known as **Optical Maser**.

The light produced is extremely pure in colour: its line width is less than 0.03 Å-narrower than any known spectral standard. The light waves are coherent that is united or bonded together: instead of the usual random or scattered radiations, they radiate in phase and so can be controlled like radio waves. Output emitted in a 5-mm wide beam, diverging by less than 0.5 deg. At 10 KW, this is some 5,000,000,000 times brighter than the light of the same wavelength in a similar beam from the sun. Due to its coherence it can be focused to a spot of only 10-8 sq. cm. Lasers may be solid, liquid or gaseous and may operate at low absolute temperature. The first and commonest laser comprises of a synthetic ruby rod (aluminium oxide containing chromium), with silvered ends, pumped by electronic flash. This excites the chromium atoms, which emit red light of 0.05 Å bandwidth. Liquid lasers contain benzene or other organic ring liquids.

THE USE OF LASERS IN PHOTOGRAPHY

The laser's frequency may eventually include the whole visible spectrum, leading to variable tuning and bandwidth, besides light amplification. This offers the photographer a powerful cool light source, tunable to

single pure colours or wide mixtures. Available in flash or continuous form, the narrow beam can be condensed to a minute spot. The high speed intensity microsecond flash will assist high speed photography and may even make astronomic flash exposures possible, while the spectral purity of the light may make safelights and filters unnecessary. N.B.: Lasers are still in their infancy and their usefulness depends on future developments.

VIDEO

In 1951, Charles Gins Berg developed the video tape recorder (VCR) for the Ampex Company, Basically the video tape recorder uses a magnetic tape to record and reproduce not only audio signals but also visual signals as well. The combined signals can be amplified and finally reproduced on a television receiver through a Cathode Ray Tube (CRT). Or back projected on a large screen. Thus given the appropriate name of the Latin verb as derived from vidi and visum, video means to see, to look at or to understand by seeing and hearing.

In the video cassette recorder the two sets of pulses, the line and field are extracted from the video signal and all used to drive the line and field scanning circuits. The scanning (line) rate in Malta-PAL is 625 lines colour TV is 15.625 KHz and the scanning (field) rate is 50 Hz. and 312.5 lines per vertical scan. So a complete television picture is produced every 1/25 of a second or 40 ms. In Malta the CCIR-Comité Consultatif International des Radio - communication - is Standard B which is the bandwidth of a complete TV is 7MHz, with upper side band 5.5 MHz and lower 1.25 MHz and sound signal 15 KHz. The sound carrier is located 5.5 MHz. above vision carrier. But to develop the video tape recorded without being able to produce original film on tape will be ridiculous. So again the

THE HISTORY OF PHOTOGRAPHY

Colour Video Camera was developed. Thus having the amateurish or professional equipment we know today.

The heart of any video camera is the tube. Which turns the incoming light into an electric signal. Although many different types of camera tubes exist, all domestic types employ a tube called VIDICON. This tube can be incorporated with a microphone. As they are both transducers which converts light and sound into electrical voltages. It is the smallest of the various types of television tube and is well suited to portable cameras. Video colour cameras are of either Vidicon, Newicon or three separate Vidicon tubes – for each primary colour band. The Vidicon tube is energised by means of a power-pack in the camera itself or a battery belt pack.

SIX VIDEO SYSTEMS

The six existing video systems come in different shapes and sizes: The VHS system; The Betamax system; The U Matic system; The VR CR 2000 system; The Longitudinal Video Recorder system and the 8 mm Video system.

V.H.S. – Video-Home System. Uses a half inch Conventional Helical-Scan tape.

Betamax or Betacord-Uses the same half inch Conventional Helical-Scan tape as the VHS but rolled in a smaller plastic cassette.

U Matic – The professional VCR of all formats. Uses 3/4 inch Conventional Helical-Scan tape. The U Matic tapes come in two different classes: the KCS-20 mins and the KCA-one hour.

VR CR 2000-Video Reversal Cassette Recorder. It is still not very popular even after a decade of its introduction which has the recording time of twice four hours and uses a reversal cassette tape.

Longitudinal Video Recorder-This LVR (VRS) was short lived

and its only advantage over the old VHS was that it can record a pre-recorded tape of four hours in a couple of minutes instead of the initial time. Looking like a VRS or Betamax mains operated VTR. This system comes in both UK PAL and American NTSC. It employs 300 parallel tracks each running at 24.6 secs. No take-up spool is used as the tape comes with a leather length and taken up by the VTR like an automatic cine projector. A very high speed (tape to head) is used and as the video head is fixed this is done by running the tape at 4 meters per second. The 3 hour tape is divided into 72 parallel tracks each 100 micro-meter wide. So this uses a 600 m track (3 hour) in 150 seconds. An automatic system changes directions and head scan the next track when the end of a tape is reached. This process carries on until all 72 tracks are full.

8mm Video system (8 VS) – This Camcorder is very compact, very smart and lighter than normal. A 600 meter of tape 8 mm wide and 8.5 micrometer thick can be rolled in a few centimeters long compact cassette tape.

COLOUR SYSTEM USED LOCALLY

Each of these formats work on PAL; Secam or NTSC. PAL – Phase Alternating Line, which is 625 lines to form a picture on 50Hz. The colour system used in Malta, Britain and most of West of Europe and Australia, most of S. Africa and parts of China.

SECAM – Sequential Couleur Avec Memoire, which is 625 lines to form a picture on 60 Hz. The colour system used in France, USSR and some of the Arab States, Greece and Turkey.

NTSC – National Television System Committee, which is 525 lines to form a picture on 60 Hz. and line frequency of 15,75 KHz. The colour system used in USA, Canada and Japan. Record shows that the VHS Video system is the most practical, trouble free and popular of all the other six systems.

A pre-recorded VHS cassette purchased in the USA cannot be played on a UK VTR, due to the American tape has been recorded

to the NTSC 525 lines/60 Hz field, and not even run at the correct speed in a UK VTR. A pre-recorded VHS cassette purchased in France which was recorded in Secam on 625 lines/60 Hz field and played on a UK VTR, only a Black and White picture will be produced. This is because the line standards are the same for the PAL and Secam. Only the line frequency is different. A Secam tape cannot be played on an NTSC machine and vice-versa.

TWO CONVERSION METHODS

To overcome this standard line problem, a standard conversion machine is needed. There are two methods of turning NTSC 525 lines into PAL 625 lines and vice-versa.

1 – Optical method, that is basically playing the tape on an NTSC outfit and shooting the monitor with a PAL camera. The result from broadcast standard installations of this type is quite good but there are considerable problems to overcome such as the colour balance and the picture jumps.

2. – A better way of conversion is to employ a Digital Standard Converter. Which breaks down the picture into digital form, stores it in a memory and reads it out at a different line standard as desired. Extra lines from 525 to 625 lines can be generated by repeating the existing ones or omitted from 625 to 525 lines as required. The result is excellent but the price is very high.

So the U Matic format machine 3/4 inch tape head was designed to record and play-back PAL tapes to replay only on NTSC machines.

The JVC produced dual standard TV receiver VTR, where it could play PAL, Secam and NTSC. Then came the Sony U Matic 2060 which records both PAL and Secam signals and plays them back as well on NTSC 4.43 signals. Suitable triple standard monitor are also available. However the U Matic recorders are not suitable for domestic use. The Beta format VTR, will record Secam and PAL signals and replay them as well as replaying the NTSC ones.

Alexandra and her husband, Czar Nicholas II, had consulted the finest doctors in Europe and found no cure for the small boy. They had tried every conceivable religious prayer and his condition never changed. Perhaps, the empress thought, even though he be a mystic, this Rasputin could cure or at least protect her son. She sent for him.

Rasputin arrived at the Royal Palace in 1905, ironically just in time to hear that the czarevitch had fallen and had begun to bleed. He was led into the boy's room and, holding only one candle in the darkness to his eyes, hypnotized the child into a trance.

The empress gasped in wonder as the boy stopped bleeding immediately. She had found her cure and Rasputin soon had the freedom of the palace, coming and going as he chose, always on hand should the boy have an attack. This placed Rasputin in a power position he was never to relinquish except once, when he was banished for a brief time in 1912.

For the most part, Rasputin actually named, through the empress, anyone he chose to an important government position.

When World War I broke out and Emperor Nicholas (who had tried to reduce Rasputin's power) went to the front, the Mad Monk

became the untitled ruler of Russia. Through the empress he fired and named ministers.

Newspapers that attacked him for the immoral and insane person he was were destroyed. Members of the aristocracy who urged the empress to get rid of this lunatic were banished.

A rabid nationalist, Rasputin caused severe rationing of food, and massive drafts of men for the fighting fronts, while all the while wasting fortunes on his lavish private parties. The monk ignored criticism. He felt he was the most powerful man in Russia and he could do as he pleased. He controlled the empress and therefore the government.

ASSASSINATION

One man, Prince Felix Yusupov, thought differently. He, along with several other noblemen, concluded that the only way Russia's monarchy would be saved was with the assassination of Rasputin. Even the czar's cousin, Grand Duke Dmitry Pavlovich, helped to plan the killing.

On the night of December 29, 1916, Yusupov lured Rasputin to his castle, saying that he was giving a party. The Mad Monk wanted to know if Yusupov's wife would be present. He had always coveted Yusupov's attractive wife, the Princess Irene. Yusupov said she would. Thus, using his wife as a lure, the prince convinced Rasputin to attend.

When the Mad Monk arrived, he was already drunk. He gave off a foul odor. "Where is the woman?" he grunted to Yusupov. The prince showed him into an empty banquet hall, its long table littered with dirty plates.

"You're late. You missed the

feast. But my wife will be right down. Here, sit down here and have some of these delicious cakes."

The prince pushed forth a plate of specially made brown cakes. Each one of them had enough cyanide to kill ten men, the poison personally prepared by a Dr. Lazovert. Rasputin popped one and then two into his mouth.

Yusupov could not believe his eyes as the Mad Monk ate all of the cakes rapidly and then belched. "Good. Is there more?"

"Yes, I'll get them." Trembling, Yusupov went to an adjoining room. "He's eaten all the cakes," he hurriedly told fellow plotters.

"The wine, have him drink the wine," urged Lazovert. The wine jug contained several ounces of cyanide; a sip of it would mean instant death for most men. But Rasputin was not most men.

"Where is your wife, Yusupov? You told me she would be here."

"She's preparing herself."

Rasputin got up and walked back and forth before the huge fireplace in the banquet hall. "I don't like to be kept waiting. You promised."

The prince was frantic. The poison had failed. (Of course, the assassins had no way of knowing that Rasputin had dyspepsia, a condition where his stomach did not secrete hydrochloric acid, which is necessary to activate cyanide.) Yusupov drew a large dagger and rushed the Mad Monk from behind, stabbing him a half dozen times until Rasputin fell. Then he tied him hand and foot and went back to get his fellow conspirators.

When the assassins re-entered the room and bent to lift the still form, Rasputin suddenly came to life, his pawlike hands firmly around Yusupov's neck, his fierce eyes blazing. One of the conspirators drew his pistol and emptied it into the Mad Monk who collapsed.

Rasputin's body was tied with chains and rope and his body was taken to the frozen river Neva. There, six men hacked away at the ice until there was a hole large

enough through which the body could be dumped. Yusupov kicked him through the hole with relief.


But that was not the end of Rasputin. To their horror, the assassins learned the next day that the Mad Monk had almost survived. His body was found on the opposite shore of the Neva. From what they could discover, he had gotten free of his bonds and smashed through the ice with his head.

But the effort had been too much. It wasn't the poison, stab wounds, or six bullets that had killed him. Rasputin had swallowed too much water and drowned. Ignoble as was his end, Rasputin's memory was fairly venerated by the empress. While ordering a chapel built to house,

his much damaged body at the czar's estate, Tsarkoye Selo, she turned her wrath upon the conspirators, but Yusupov and his wife quickly left Russia to save the crown embarrassment, as well as their own lives, it appears, since the prince felt sure that revolution would soon topple the Romanov dynasty. He was right. Yusupov travelled widely for some time, the assassin dabbling in the dubious arts of faith healing. He died in New York City in 1967 at age eighty-one.

Rasputin's body, like his reputation, was horribly violated when the czar fell. Revolutionaries broke into his chapel, dragged out his casket, pried it open with sticks and, after soaking the remains with kerosene, burned it on a huge log pyre as a large, silent throng gathered to watch the blaze throughout the night, perhaps making sure, as it were, that the Mad Monk was truly finished.



DRIVING UNDER THE INFLUENCE OF DRINK AND DRUGS

"Of all the serious motoring offenders, the drunken driver is one of the most controversial and least popular, and the impression is that he has now replaced the "road hog" as a target" (1) However, leading writers on the relationship between alcohol and traffic accidents affirm the "It had become obvious to inform observers many years ago that in nearly every country of the world whatever official statistics were available, grossly underestimated that part played by alcohol in causing accidents". (2) This can also be said to be true in Malta where a brief glance at the Annual Abstract of Statistics (Department of Information) under the heading "Causes of Road Accidents" covering the years 1966 to 1984, effect of alcohol on the driver seems to be grossly understated. (3) In the United States of America, Klien et al (4) committed themselves to the statement that "for practical purpose a fatal crash can be considered synonymous to an alcohol crash unless proved otherwise. The report of the Australian House of Representatives, Standing Committee on Roads Safety of 1980 on alcohol, Drugs and Roads safety found that in 1979, 3,506 people were killed in road crashes in Australia, at least one third of adults, killed, i.e. about 1,000 in 1979 had significant concentration of alcohol in their blood. Research suggested that alcohol is a factor in fifty per cent of crashes involving a fatality.

Western society seems to be inextricably linked to alcohol as a means of brightening up any social convivial atmosphere. If it seems impossible burdensome in the light of accepted social habits that the law should be remembered that social habits can change and be completely changed within a measurable period of time. It has been observed that in Scandinavian countries, an unremitting application of a stern Law, proscribing driving when blood/alcohol concentration is above a statutorily specified level, has produced a climate where one does not expect guests to turn up at parties in their own cars, unless accompanied by another person, such as wife who will remain (and will be expected to remain) on nonalcoholic beverages. Swedish visitors to England before 1967 (when prescribed level offence was introduced in the United Kingdom) were observed to behave in this respect exactly as they would do at home although they knew that the British has no restraining law remotely comparable to their own and inspite of the pressure of British drinking habits (5).

Therefore if the law is to play a role in reforming social habits, it must be adequate and meaningful to all the driving members of society. How far it is meaningful to the Maltese driver will be seen hereunder.

Section 14 (1) A of the Traffic Regulation Ordinance provides that if a person drives a motor car "while under the influence of intoxicating liquor or drugs" he commits an offence. The present wording of our law is derived from the 1930 Road Traffic Act of the U.K. (Section 15) (1) although the latter was much wider in its reach as it provided

that any person who, when driving or attempting to drive or when in charge of a motor vehicle on a road or other public place is under the influence of drink or drugs to such an extent, as to be incapable of having proper control of the vehicle, commits an offence.

This offence officially recognised that it was not necessary to be "drunk" in the popular sense i.e. with gross incoordination of movement, in order to be dangerous on the roads. (6) The Royal Commission on Transport, First report of 1929 (page 12) had stressed the difficulty of drunkenness, since it was felt that the "justice" ideas to what constituted this condition were too extreme to include the driver, who although not falling all over the place, was unable to exercise the judgement needed to drive a vehicle safely. (7)

INTOXICATING LIQUOR

Different countries use different expressions to denote what is scientifically known as alcohol – a member of a class of carbon compounds possessing certain structural features in common and therefore having certain predictable chemical properties. (8) In traffic offences the terms alcohol, liquor etc., are not used in any scientific meaning. They generally refer to any fermented, distilled or spirituous liquor.

Section 14 1(a) does not refer to a driver being intoxicated but refers to a driver being under the influence of intoxicating liquor. To be intoxicated is to be excited or stupefied by alcohol to the point where physical or mental control is markedly diminished. The prosecution does not need to prove "drunkenness" in the sense that the driver's mental and physical faculties have been impaired to the extent that the driver has little or no awareness of the events around him.

The Court has to determine whether the driver has consumed

a sufficient quantity of alcoholic liquor which (i) causes him to lose in whole or in part, either his mental or physical abilities or both and (ii) which causes him to be unable to drive his car to the same standard as a normal and sober driver. Generally, the prosecution has to establish the lack of proper control and that this was due to the influence of liquor.

"In fact in the provision in question forming part of the Traffic Ordinance, the purpose of the law is not to envisage the offence of drunkenness as such (as for instance s. 352dd of the Criminal Code) but to safeguard traffic by punishing anyone who, because of drink is unfit to drive and therefore is likely to cause accidents". (9)

Admissibility of Post-Hypnotic Testimony

"... the admissibility of post-hypnotic testimony is contingent upon a showing that the hypnotically refreshed recall is reliable."

The inaccuracies associated with hypnotic recall cannot, necessarily, be blamed on the individuals involved in the process. Rather, the inaccuracies are more often attributable to problems inherent in the hypnotic process itself, problems such as hypersuggestibility, hypercompliance, and confabulation.

Hypersuggestibility

Hypnosis is a state of altered consciousness "marked by heightened suggestibility"⁶ or hypersuggestibility. Thus, an individual in a hypnotic state is very open and responsive to suggestions made by the hypnotist. While this particular characteristic is what makes hypnosis a successful technique in both the medical and entertainment fields, hypersuggestibility presents a very serious problem when using hypnosis for investigative purposes. When using hypnosis to refresh the memory of a potential witness, there exists a very real danger that the subject will respond to suggestions made by the hypnotist, no matter how subtle or unwitting those suggestions may be. The unfortunate result is an inaccurately refreshed recollection based on a commingling of the subject's original observations and the suggestions received from the hypnotist.⁷

Hypercompliance

Very closely related to hypersuggestibility is a characteristic of hypnosis known as hypercompliance—the hypnotized subject's overwhelming desire to please either the hypnotist or others who have urged him to undergo hypnosis.⁸ Motivated by hypercompliance, it is not uncommon for a subject being questioned under hypnosis to suppress an appropriate response and respond, instead, in a manner that he believes is expected of him.⁹ When the subject under hyp-

nosis is a potential witness attempting to refresh his memory, and the individual he is seeking to please is a prosecutor or an investigator, it is not difficult to imagine the havoc hypercompliance could wreak on the subject's accurate recall.

Confabulation

In a hypnotic state, a subject, already prone to hypersuggestibility and hypercompliance, will unconsciously invent facts in order to answer questions posed by the hypnotist, if the subject lacks adequate knowledge or memory to respond honestly to the inquiry. This process of artificially enhancing memory or "filling in the gaps" is called confabulation.¹⁰

Although hypersuggestibility, hypercompliance, and confabulation present serious problems when attempting to refresh the recollections of a witness through hypnosis, these problems are, by no means, unique to hypnosis. It is not uncommon for an individual who is overly anxious to assist in an investigation to engage in activities closely resembling hypersuggestibility, hypercompliance, and confabulation without the aid of hypnosis. However, many experts in the field of hypnosis contend that an additional feature of hypnosis puts the previously hypnotized witness in a class by himself. This distinguishing feature is the fact that a witness who admits to being

uncertain of the accuracy of his recollections prior to hypnosis often becomes firmly convinced of the accuracy of his recollections after hypnosis, despite the fact that his recollections may include false memories induced by hypersuggestibility, hypercompliance, and confabulation.¹¹

These problems inherent in the use of hypnosis were powerfully demonstrated in a laboratory test which involved instilling false guilt in experimental subjects through hypnosis. The subjects were so strongly convinced of their own guilt that they were unable to pass a subsequently administered lie detector test. Although completely innocent, the subjects' admissions of guilt registered as truths on the polygraph.¹²

JUDICIAL ANALYSIS

Overwhelming as the problems inherent in the hypnotic process appear to be, some experts still believe the harmful effects of hypnosis can be minimized and are of the opinion that if proper precautions are taken, previously hypnotized witnesses can provide accurate courtroom testimony.¹³


Use any paper you may have around the house if it is the right color and not too heavy or too thin. You can even use white paper if you like, and color it with water colour paint or crayons. Use ordinary library paste that comes in tubes or jars for pasting paper edges together.


(HOW TO WRAP THE LEAVES AND STEMS)



Some flowers have ruffled edges. To get this effect this is what to do; Take hold of the flower petal with the thumb and fore finger of each hand (fig. 4).




Bring the right hand slightly toward you and stretch the paper over the left thumb (fig. 5). Repeat all along the edge of the petal.







Kolonna tal-Belt hi xogħol Pietru Pawl ukoll. Fiż-Żejtun insibu l-Anglu ta' l-Ort u l-Kolonna li huma ta' Xandru Farrugia (1781/1871). F'Għawdex insibu l-Kurċifiss tal-Vara l-Kbira u l-korp tal-Monument li nhadmu minn P.P. Azzopardi u Xandru Farrugia rispettivament, għal Bażilika ta' S. Ġorġ.

Il-parti l-kbira tal-Vari huma magħmulha mill-kartapesta. Il-pijunier f'dan il-qasam kien Saver Laferla (-/1761). Sal-lum għadna nistgħu naraw xi xogħol tiegħi fil-Belt (L-Ort, Il-Veronika u d-Duluri) u forsi wkoll Il-Kurċifiss tal-Vara l-Kbira fl-Isla. Warajh gew Antonio Mifsud bix-xogħol tiegħi f'Haż-Żebbug u Peppi Vella (1802/1866) b'xogħol f'Hal Ĝaxaq u Hal Luqa. L-istatwarju li għandu xogħol imixerred ma' kważi Malta kollha hu bla dubju s-Sengleean Karlu Darmanin (1825/1909).

Barra s-sett Mosti, wieħed mix-xogħlijiet sbieħ tiegħi hu l-Ort ta' Bormla, li lu differenti minn dawk ta' settiġiet oħra. Kristu hu mimdu lura fl-art u miegħu flok anglu wieħed hemm tnejn. Appena miet Karlozz, kif kien magħruf Darmanin, tfaċċa x-xogħol ta' Wistin Camilleri (1885/1979), li għalkemm f'Malta għandu xi xogħlijiet, il-biċċa l-kbira ta' sengħelu tiġi kka fis-settiġiet Ghawdxin.

Ta' min isemmi wkoll lil Ġużeppi Caruana (1887/1973) u lil Glormu Dingli (1911/–), li ghalkemm il-vari li għamlu mhux tant numerużi, m'humiex nieqsa mid-daqqa artistika li kellhom dawn iż-żewġ statwarji.

Statwarji li qed ikomplu jtuna xogħol sabieħ illum huma l-ahwa Ĝħawdxin, Alfred u Michael Camilleri Cauchi. Ta' l-ewwel nistgħu nghidu li tħrasforma s-sett Qormi u rrrendieh wieħed mill-isbah. Tat-tieni għandu u għadu qed jaġħmel diversi statwi f'Għawdex, fejn jispikkaw id-Duluri tal-Kattidral u dik ta' S. ġorg, kif ukoll l-Irxoxt tax-Xagħra u dak tan-Nadur.

Barra statwi tal-injam u tal-kartapesta nsibu wkoll oħrajn imlibbsa drappijiet mill-ifjen, li aktarx huma ta' origini spanjola. Din id-drawwa f'Malta f'Malta qiegħda fil-Birgu biss. F'Għawdex tinstab f'S. ġorġ, fil-Kattidral kif ukoll iz-Żebbug. Xi wħud minn t'Għawdex imlibbsin anke par-rokkka.

Għalkemm fil-purċijsjonijiet tal-lum għadek tara fratelli b'wiċċhom mgħotti, u b'sinjal ta' penitenza jkaxkru l-Ktajjen jew jerfghu xi salib tqil, minn wara l-gwerra, kotrot id-drawwa ta' oħrajn li jirrappreżentaw persunnagi mill-antik testament, b'konnessjoni jew tixbieha mal-Passjoni. 



Legal Notes

•Slight bodily harm and voluntary damage to property – proceedings instituted by the police ex-officio – effect of waiver of complaint by the injured party.

Vella, Attard, Cordina and Bajada were charged before the Court of Magistrates of Judicial Police for the Islands of Gozo and Comino with inflicting slight bodily harm on the persons of Georgina Vella and Joseph Fenech; causing voluntary damage to the property of George Grech; disturbing the response of the inhabitants at night time in terms of s. 352(m) of the Criminal Code; and with breach of the peace in terms of s. 352(bb) of the said Code.

S. 235 of the Criminal Code provides:

- (1) A bodily harm which does not produce any of the effects referred to in the preceding sections of this sub-title, shall be deemed to be slight, and shall be punishable with imprisonment for a term not exceeding three months, or with a fine (**multa**).
(2) In the cases referred to in subsections (1) and (3) of this section, proceedings may not be taken except on the complaint of the injured party....

S. 339 provides:

Whosoever, by any means other than those referred to in the preceding sections of this sub-title shall wilfully commit any spoil, damage or injury to or upon any moveable or immovable property belonging to any other person shall, on conviction, be liable.... (c) if the amount of the damage does not exceed fifty pounds but exceeds ten pounds to imprisonment for a term not exceeding six months... provided... that in the cases referred to in paragraphs (c) and (d), except where the damage is caused to public property, proceedings may be instituted only on the complaint of the injured party.

In the course of proceedings before the Magistrates' Court, Georgina Vella, Joseph Fenech

and George Grech waived their complaints against the four accused in terms of s. 539 of the Criminal Code. The Court therefore abstained from taking further cognizance of the charges of slight bodily harm and voluntary damage to property and found accused guilty only of disturbing the repose of the inhabitants at night time and of breach of the peace.

The Attorney General appealed.

The Court of Criminal Appeal, in allowing the appeal, held:

- (a) the offences of slight bodily harm and voluntary damage to property were within the jurisdiction of the Court of Judicial Police as a Court of Criminal Judicature, as the punishment for either offence did not exceed six months imprisonment;
(b) s. 385 of the Criminal Code provides:

As regards offences within the jurisdiction of the Court of Judicial Police, the prosecution shall lie with the injured party or with the persons mentioned in section 536 on behalf of such party, where proceedings cannot be instituted except on the complaint of the injured party: Provided that if the offence in respect of which no prosecution may be instituted except on complaint of the injured party, is aggravated by public violence or is accompanied with any other offence affecting public order, or if, in the absence of any such circumstances, the injured party shall fail to institute proceedings and shall not have expressly waived the right to prosecute within four days from the commission of the offence, it shall be lawful for the Executive Police ex officio to institute proceedings in respect of the offence.

- (c) in the cases contemplated in

the proviso to s. 385, the criminal action becomes a public action and the waiver of the complaint by the injured party has no effect on the said action (**The Police v. Caterina Farrugia** Criminal Appeal, 23 February 1957, and **The Police v. Karmenu Cassar** Criminal Appeal, 21 April 1945, followed);

- (d) in the present case not only where the offences of slight bodily harm and voluntary damage to property accompanied by offences affecting public order (disturbing the repose of the inhabitants at night time and breach of the peace), but the injured parties had not instituted private proceedings nor expressly waived the right to prosecute within four days as laid down in the proviso to s. 385.

The Court of Criminal Appeal found all four respondents guilty also of the charges of causing slight bodily harm and voluntary damage to property.

The Police v. Adelina Vella, Lawrence Attard, Maria Cordina and Joseph Bajada Court of Criminal Appeal, 27 November, 1986.



DEL SHANNON STORY

• DEL SHANNON cut his biggest hits more than 20 years ago. But if Del were to start fresh today, an unknown as he was in 1961, and if he were to cut the same songs that made him a star in the 60's, chances are he would once again catapult to stardom. This quality of timelessness is perhaps the highest compliment one can pay an artist.

'Runaway', "Hats Off To Larry", "Little Town Flirt", "Stranger In Town", "Do You Wanna Dance", "Keep Searchin'", (We'll Follow The Sun), "Handy Man". These are songs that stick in the mind, songs that have been and continue to be integral parts of rock and roll. Del established these tunes as classics in some cases, covered other artist's versions and enhanced them in others. In all cases he made them his.


Del's beginnings were inauspicious enough. Born Charles Westover in Grand Rapids, Michigan on December 30, 1939, he dreamed like many other youngsters of the 50s, of being a rock star. Taking up guitar at 14, he played in local bands until he entered the Army in 1957. Sharpening his skills in many Army musical productions, Del once again took up the life of a would-be singing star following his discharge.

HIS FIRST APPEARANCE

While performing at a local Michigan dance, disc-jockey Ollie McLaughlin of WHRU in Detroit spotted the young singer and touted him to executives of New York's big top records. Del was flown to New York, and he cut some sides. One of these sides was 'Runaway', a welcome relief from the formula rather bland rock of the day. 'Runaway' with its plaintive teenage story, wild falsetto vocals and tense instrumentals backing shot to the number one spot in the nation's rock charts in February, 1961. Shannon, who had also written the song was off and running.

Far from being a one hit wonder (which was not a particularly uncommon phenomena in rock's formative years), Del followed in May, 1961 with 'Hats Off To Larry', another distinctive sounding single that reached the

rock listing's number 5 slot. "Little Town Flirt" touched down at 12 in December 1962. The Beatles and the rest of the British musical invasion landed full force in 1964 and wiped many American hitmakers, off the musical maps. Shannon however, was not affected. He cleverly took a song that has recently hit for Jimmy Jones and did it up Del Shannon style. Handy Man reached number 22 in July, 1964.

KEPT ON GOING

Del followed with a successful chartmaking cover of Bobby Freeman's "Do You Wanna Dance" and in November of 1964 he exploded back into the top 10 with "Keep Searchin'" (We'll Follow The Sun), a teen anthem that has become an all time popular oldie. "Stranger In Town" was another top 30 single in 1965. At his peak in the early and mid 60s, Del Shannon was a genuine

superstar. He anticipated a new sound in rock and roll, an electric, frantic sound that soon became 'the' sound. He was a singer-songwriter. He anticipated the universal interest in country music that bloomed in the 70s, by cutting an LP of Hank Williams songs in the '60s. He recorded a Beatles tune before most of the world had heard of them. He wrote for other stars. He became an international star, handling tours in such diverse locals as England and the Philippines. He was Britain's most popular male vocalist in 1962 and 1963 according to several trade papers.

What of Del Shannon today? Well, Jeff Lynne, leader of the supergroup Electric Lights Orchestra recently produced some material for Del. And it is no accident that Bonnie Raitt, Narel Felts and others have cut 'Runaway', and that James Taylor just hit the top 10 with 'Handy Man'. Del Shannon was a star. He is still a star.




Miscellaneous Webley Models 1898 – 1914

One difficulty with the firm of Webley is the extent of the range of their revolvers. Almost every year from 1870 to 1910, another model of a change to an existing model appeared on the market. Some were sold in quantity, some disappeared soon after, but all contributed in one way or another to the refinement of design, and all were made to the same high standards associated with the name of the company.

Webley Pocket Revolvers Webley Pocket Hammerless Model 1898

In 1898, Webley produced a small break-action six-chambered .320 pocket revolver with a concealed hammer. The barrel was 3 inches long, and the butt was steeply curved. It weighed 18 oz., which somewhat detracted from its maker's claim that it was ideal for the pocket, but within those fairly generous weight limits, it was a very well made and reliable weapon. Above the hammer shroud there was a small sliding safety catch, and the barrel was held by a simplified latch which incorporated a backsight notch.

Webley Pocket Hammer Model 1901

The 1901 version of the W.P. (Webley Pocket) reverted to a more normal hammer and had an even simpler barrel latch. In this model, the latch had no thumb catch and was serrated on the top so that it could be pulled open with the thumb. This refinement was then introduced on the hammerless version also. Surprisingly these pistols continued to be sold until 1934, in both versions.


Double Barreled Under And Over Pistol 1890

This pistol is an oddity in the Webley series, though the firm did not make a similar weapon in the 1870s in a variety of calibres. There is little evidence to show it was successful and its revival 20 years later is interesting. The pistol was made in .450 calibre with a pair of 3 inch barrels, machined from the solid and rotating in a clockwise direction on a central pin. The barrels were turned by hand and locked by a small spring loaded lug. The model is a great rarity and it must be assumed that it was not a commercial success.
