# IL-BINI TAD-DEPOT QABEL MA GHADDA F'IDEJN IL-KORP TAL-PULIZIJA

□ IL-PULIZIJA żgħażaġh li twieldu wara l-gwerra, qajla jgharrfu il-bini tad-Depot kif kien imgarraf bil-hidma ta' l-għadu. Sa dak iż-żmien ma kienx għadu Depot tal-Pulizija.

Fis-sena 1734 il-Gran Mastru Antonio Manoel de Vilhena kien bena palazz fl-inhawi ta' Balzunetta, il-Furjana, għaliex fih jil-taqgħu u jgħixu flimkien dawk ix-xebbiet li minhabba l-faqar kbir li kien hawn, kienu johorġu jaħdmu biex jaqilgħu x'jieklu u jghinu lil neshom. Bosta drabi whud minnhom kienu jaslu biex jitolfu giehhom ukoll. Għaldaq-hekk li l-Gran Mastru bena dak il-palazz, li beda jissejjaħ bl-isem ta' **Conservatorio**, fejn dawk ix-xebbiet ikunu jistgħu jitghallmu sengħa, u meta jaslu biex jizzewgu, kienet tingħatalhom ukoll dota.

Għadda ż-żmien, il-gzejjer Maltin bidlu l-bandiera darbejtn, u fis-sena 1825 biddlu isem dik l-istituzzjoni f'dak ta' **Casa d'Industria**, id-dar tas-snaġja'.

Fis-sena 1836 kienet waslet hawn Malta Kummissjoni, magħrufa bl-isem ta' Austin & Lewis, biex tnejji x'passi kellhom jittieħdu għar-riforma fl-amministrazzjoni tal-gzejjer.

Inzerta li s-sinjura Austin, il-mara ta' wiehed mill-Kummissjoni Inġliża, Sir John Austin, kienet hadet interess kbir

f'Malta, li b'rihet is-suggerimenti għaqlija li kienet tat, setgħu jittwettqu whud mir-riformi. Hi kienet tat parir li dik l-istituzzjoni Casa d'Industria kellha tispicča u tagħlaq. Għalhekk dawk ix-xebbiet intbagħtu f'imkejjen oħra. B'hekk fis-sena 1850 wara li kienu bidlu hafna mill-istruttura tal-bini tiegħu, għamluh spatar, bl-isem ta' **Central Civil Hospital**, u gābu fih dawk il-morda li

kien hemm fl-isptar ċivili fil-Belt, u lin-nisa mill-Casetta, kif kienu jsejnhulha dak iż-żmien.

Għadda ż-żmien, u aktar ma bdiet titkattar il-popolazzjoni aktar kiber il-mard, u dak il-bini kellu jerga' jinbidel xi ftit biex aktar jimmodernizzawh. Hekk sar fis-sena 1879, u mal-milja taż-żmien baqa' jikber u aktar jersaq lejn il-progress.

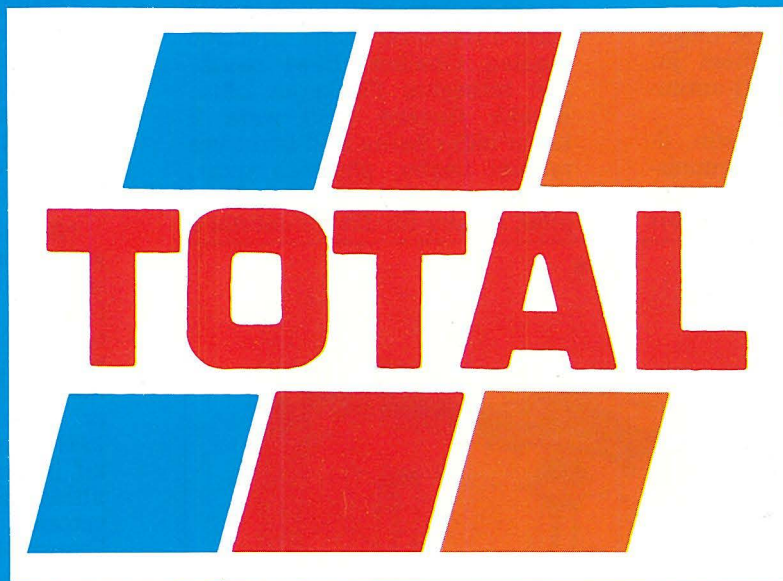
Nhar l-10 ta' Ġunju 1940 faqqgħet il-gwerra, u l-gzejjer tagħna sfaw qishom quddiem nett biswit l-għadu, li xerred biza, nies jixterdu minn djarhom biex jieħdu kenn band'oħra, u sugġetti għall-bumbardamenti mill-ajruplani ta' l-għadu. # THE HISTORY OF PHOTOGRAPHY

By MARIO SCHEMBRI

PART 7

## COURT PROCEDURE

The usual procedure for taking the evidence of a photographer witness: When the officer takes the stand, he first takes the oath—unless objecting of doing so, if so a form of declaration may be substituted. Then he gives his name and profession or official status. He then states where, when and of what he took the photographs to the Magistrate or the Judge. He then is asked to describe each and every photograph. He then check his signature at the back of the photo. When confirmed in the presence of the accused in the case of Magistral sittings, he is then subject to cross-examination.

The desired sizes for the normal photographs to be used in evidence in Court are 5"x7" both in black & white or in colour, coloured polaroid prints are also acceptable, no other size is desired, one reason is that the size of the envelopes must be to accomodate the 5 x 7 prints, otherwise they would not fit in the jacket file of the Process Verbal or any other documentation.

## EVIDENCE BY

### PHOTOGRAPHS

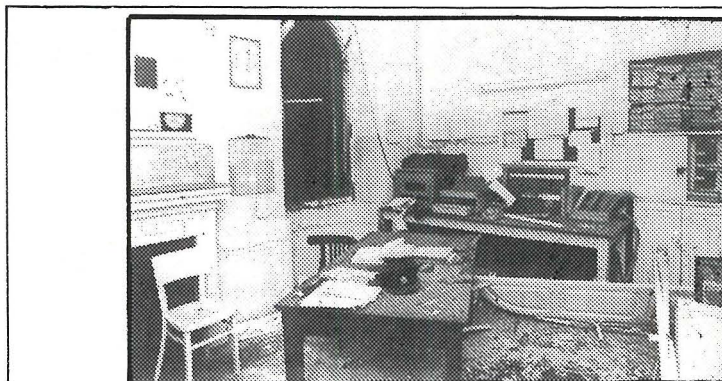
The purpose for which photos are produced in legal proceedings and used in evidence:

1. To provide a record of something that it would otherwise be difficult or impossible for the Court to see...ie... Scene of Crime, Traffic accident, Homicides or Suicides etc....

2. To present the result of an experiment or test-in many cases made in a laboratory. Such as photographs demonstrating the similarity in finger-prints, foot-prints, tool-marks, fired bullets or cartridge cases etc.....

3. To show something that only photographs can reveal infra red photos and photos taken with unusual filters.

The Court is not concerned with how such photographs are

taken; it deals only with their use as evidence in the Courts.

There must be no handwork on either negatives or prints to be used in evidence. Simple shading control is permissible during printing, but there must be no spotting even if there are multiple pinholes in the actual negative. There should be no reconstruction of the scene for photography. No attempt should be made to replace anything previously displaced. The photographer should simply record what is in front of his camera and explain any discrepancy between what the photo shows and what the witnesses describe. There is no room for ingenious technical tricks. All work should be as straightforward as possible. All photographs must be produced under laboratory conditions. The average photographer should always assume that while the members of the Court may know everything about law, but they know little or simply nothing about the technicalities sometimes confusing of photography.

## POISONS

Various chemicals used in photography need special care in handling owing to their poisonous nature. The sale of some of these is governed by law. Substances controlled by the Pharmacy and Poisons Act, 1933, are set out in the Poisons List and are the only poisons for

the purpose of the act.

## CATEGORIES OF POISONS

The Poison List is divided into two parts.

Part I – sold only by chemists (authorised sellers of poisons).

Part II – sold by authorised sellers of poisons and listed sellers of poisons.

When a person requires a substance for other purpose than his trade or business, he must be known to the seller. In addition he must, before the delivery of the poison, affix his signature to an entry made by the seller in the Poison Register.

Any photographic chemical which is termed as poisonous must when sold be labelled with POISON or other prescribed indication of character either in red letters or set against a red background.

## THE COLOUR OF DAYLIGHT

The atmosphere always contains a certain amount of water vapour. Finely divided droplets of water in this form act as a colour filter letting yellow, orange, red and infra-red through and reflecting blue, violet and ultra-violet rays. When looking at the sun through mist or fog, you see it as an orange-red disc, while if you stand with your back to the sun, the mist itself appears blue-white. A car head-

lights as seen through the fog appear as dull orange, but the driver see it as dazzling white.

So the water vapour in the sky tends to colour the daylight orange and rob it of blue rays. So the more vapour the light has to shine through, the more orange the daylight appears.

Morning and evening light are both inclined to be redder than broad daylight. When the sun is low down on the horizon its rays travel obliquely through the vapour layer and to pass through more of it.

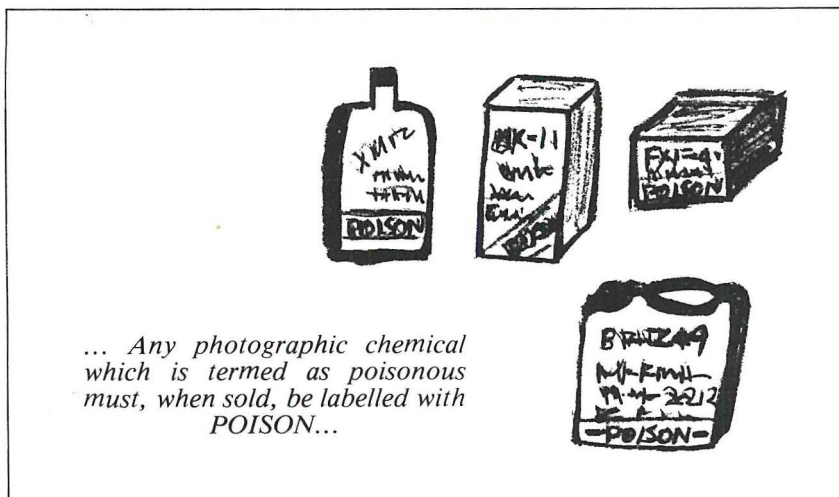
### COLOUR TEMPERATURE

The colour temperature (Kelvin Scale), expressed in deg., is the temperature on the absolute scale (deg. C. + 273) to which a perfect black body radiator would have to be heated to emit light of the same colour as the light source in question. (A perfect black-body radiator is one which does not reflect any light falling on it).

The lower the colour temperature of a source, the richer the light is in the yellow and red rays;

The higher the colour temperature, the richer it is in the blue rays. Colour temperature is important in colour photography as colour films are sensitized to give a true colour. Thus some films are balanced for a colour temperature of 6,000 deg.K. (daylight), while others are balanced for 3,200-3,400 deg.K. (tungsten or photoflood light).

The colour temperature of a light source can be modified by special filters, which absorb some of the blue or some of the red end of the spectrum. Filters of this type are known as Photometric or Light Balancing filters. For overall correction, they may be used over the camera lens instead.

### MIRED VALUES

Micro-Reciprocal degrees. The Mired value of a light source is its colour temperature in degrees Kelvin divided into 1,000,000. Thus a C/T of 5,000 deg.K. corresponds  $1,000,000 / 5,000 = 200$  Mireds and 3.200 K to about 313 mireds.

### DAYLIGHT

Direct sunshine at noon in the middle of the Maltese summer has an intensity of more than 10,000 foot candles-equal to more than 400 photoflood lamps placed less than 6ft. away from the subject, and almost a 1,000 times stronger than the artificial illumination in an ordinary living room. When the sun is highest in the sky, the light is the strongest-in June..... While when it is in the lowest position the light is the weakest-December.

### COLOUR PHOTOGRAPHY

Until the negative-positive processes were introduced, the reversal transparency was the most (if not the only method) widely used method of making colour photos, in spite of the fact that the results required to be projected or at least illuminated from behind. Colour printing of the highest quality was highly expensive due to the laborious colour separation method. In the evolution of colour photography, the reversal transparency is equivalent to the Daguerreotype

for which a silver plated metal sheet formed the sensitive surface. In reversal colour transparency it is similarly unique. Unless several exposures are taken at the same time, extra copies can only be obtained by re-photographing the original transparency by printing upon reversal print-material.

### THE COLOUR FILM

The colour film is composed of a colour emulsion of one basic colour upon another. Practically there are three basic colour, inevitably three layers of separate colour emulsions on top to each other. Bonded together upon a strip of cellulose plastic, gelatinized and coated with anti-halation backing.

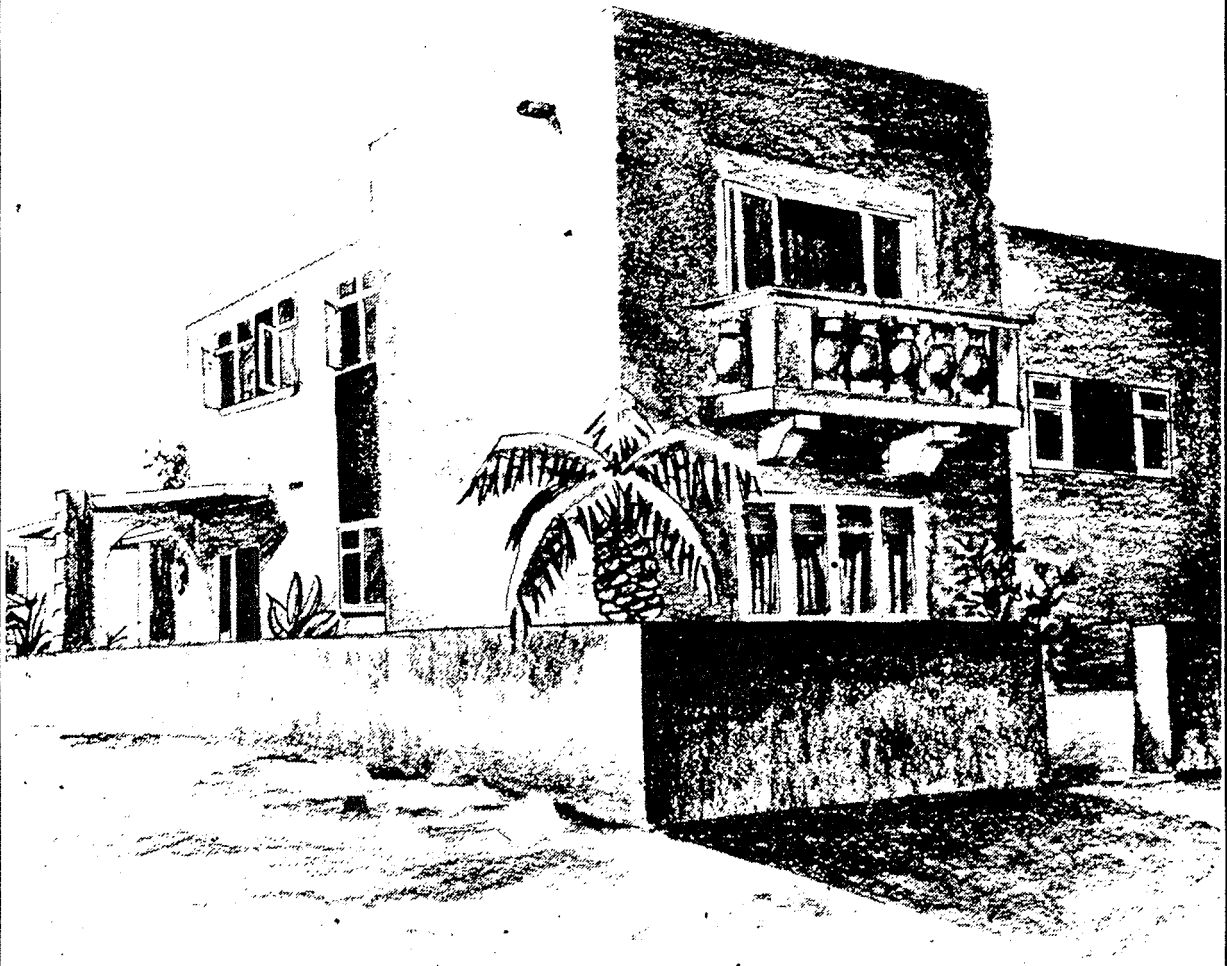
### NEGATIVE

#### PROESSING

The processing of colour negatives follows a broad general pattern which is common to all makes of film. Through the particular formulae, the times of immersion and the necessity for various intermediate baths varies. The principal steps are:

Colour Development.... Stop-Bath.... Thorough Washing.... Bleaching.... Washing.... Fixing... Final Wash.

The Kodak Process C-22 for S and L types of film and the Agfa CN 17 and CNS neg films and the NPSI processing are now absolute. The Kodak have come up with a formulae The C 41 Colour Process. It is capable of developing any kind of colour film on the market.

PART 3

□ AFTER part 2 of this series, I decided to put aside some of the Webley Models to shorten the Webley History, until it came to my knowledge, from quite a good number of readers and colleagues that they never imagined that so many different Webley Models were made.

Obviously now I have committed myself to fulfill the desire of these faithful readers and colleagues.

The BRITISH BULLDOG Double-Action Models. The 'Bulldog' models were one of Webley's more successful designs. The model was in production from 1878 until 1914, in a variety of types, all displaying the same general virtues of toughness and dependability. From the first, the 'Bulldog' was intended as a civilian pistol, although there seems no doubt that at least one of the mounted infantry regiments in South Africa were issued with it. As a rule, however,

the Bulldogs were only disposed of through retailers throughout the Empire and the rest of the world.

It was short-barrelled five-chambered revolver of large calibre, with a distinctive curved butt. It was copied and made in

several countries, both in rimfire and centrefire, and some manufacturers even made special ammunition for it.

**FIRST MODELS 1878.** The first model, in .442 centrefire was quickly followed by a .450 centrefire and .44 rimfire, all these three versions easily identifiable by the fact that their cylinders are smooth and not grooved. The only other "Bulldog" to have a smooth cylinder was a .320 model produced in 1880. This was a smaller version of the .450 model.

**SECOND MODELS 1883.** The 1883 model is generally known as the third model, the first two being the .442 and .450 of 1880. There were differences between the second and third models, the first was that the cylinder was grooved, thereby saving a little weight, and the second was the fact that the butt was longer. This last feature was probably welcomed by the majority of owners,

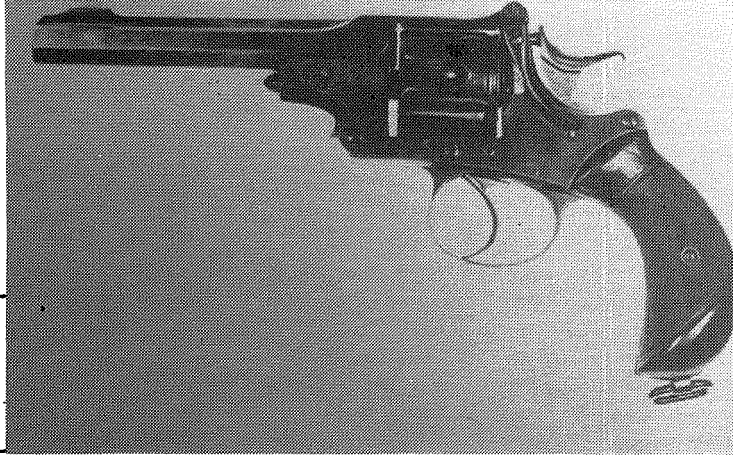
recurred on subsequent models, and became a recognition mark. The hinged load-ing-gate locked the hammer at half-cock when it was opened, and when the hammer was cocked it locked the gate shut. The hammer rebounded under the influence of the tail of the main spring, and the cylinder was securely locked by a positive stop at the moment of firing.

The stock was one piece of walnut, and there was a lanyard ring on the butt plate. All told, it was a thoroughly serviceable weapon of generous dimensions and considerable resistance to rough use and wear.

At the same time as the previously described revolver was being sold, Webleys produced another for the same potential market and called it 'Webley's New Model Army Express', which can be done little to help the possible customer. The new Model weighed 38 oz. and was modelled on the same lines as the original 'Express' that is, generously. The octagonal barrel was screwed into the frame and fitted with the same ejector-rod as the former version. The most noticeable difference between the two 'Express' revolvers is in the butt. In the new model, it is a curved bird's head rather like an enlarged version of that on the 'Bulldogs' and the 'Pug' and the stock is in two pieces held by a single screw. A lanyard ring of oval shape is fitted, to take a flat leather strap. These 'New Express' Models were chambered for the usual .450/.455, and also for the .476.

This type of revolver was issued to units of the South African Republic in the mid 1880's and a few were fitted with Silver & Fletcher safety hammers and extractors. Another type used in South Africa, and issued to the Cape Mounted Rifles was a single-action version of the original 'Express'. This single-action weapon was made specially for the Regiment, and the action was modified using parts from the 'New Express' revolvers. The calibre was .476 and this seems to be the only type of single-action revolver produced in the solid-frame series.

An oddity in the Webley solid-frame range, and one which illustrates the firm's willingness to make to order, is a solitary example of a 12 inch barrelled model, fitted with a detachable stock. The revolver is quite out of the ordinary run of production, since it is chambered for the .44 Smith & Wesson cartridge, but it is an interesting illustration of the gun-makers skill.

Double-Action Hinged Frame Models Webley-Kaufmann 1880.

Kaufmann was a talented weapons designer who became associated with Webley in 1878, and remained with them for three years. In that time, he introduced the first Webley top-break revolvers. There are certain features of these Kaufmann models which distinguish them from others which were in production with Webley at that time.

The first feature is, of course, the top-break and its locking arrangements (Patent 3313, 29th July 1881.). This is ingenious, though one might say that it is a trifle too complicated. In essence, it is a three-part transverse bolt which passes through two lugs on the top of the standing breech, and also through a tenon at the back of the top strap. This bolt is pushed to the left by a spring, and is caused to lock all three items. When the unlocking stud on the left of the frame is pushed in, it moves the bolt to the right. The bolt is actually in three sections, and the joints of these sections come opposite the gaps between the tenon and lugs. The top strap can then be moved and the weapon unlatched. On return, the bolt is pushed across again by the spring, and the tenon is once again locked home. Although widely used, this arrangement must have been vulnerable to dirt.

The lock mechanism was simplified, which made for reliable

and easy operation of the five main parts. Both ends of the main — spring were made to work, the fixed or standing end being used to return the trigger and pawl, and to rebound the hammer. The cylinder was positively locked by two separate methods, and there was a cam-operated ejectore which opened when the revolver was broken.

The first models were six-chambered double-action centre-fire revolvers, with barrels 5¾ inches long, curved birds' head butt in the express style, with lanyard rings for flat straps, and a general air of solidity and ruggedness, which the weight of 40 oz. certainly encourages. The calibre of this first model was .450 in.

The first model was soon followed by a second, in which certain improvements were made. The first change was in the barrel latch. The thumb stud of the first model was replaced by a more usual pivoting lever operated by the right thumb. This acted upon the same three-part bolt through the action of sloping surfaces, and was much easier to use. Another change was in the cylinder lock, which was simplified. In some of the revolvers, there was a safety device which prevented the opening of the cylinder while the hammer was cocked. There were several patents relating to these Kaufmann revolvers, dated between 1878 and 1881, and Kaufmann marked the weapons with his initials 'M.K.' and a number. This was stamped on the right of the frame inside a triangle, and it forms an easy recognition mark for the Kaufmanns. The second model was in .455 calibre and some were made in .476. Although a popular type, the Kaufmanns were not made for long, but they form one more significant step in the refinement of the breech-loading revolver.

since the kick from a revolver firing a bullet of more than 200 grains, as these did, requires a firm hold.

**THE PUG.** The 'Pug' probably appeared before, or at the same time, at the first 'Bulldogs'. It was a rimfire five-chambered pocket revolver with a snub barrel and a generally squat appearance which gave rise to its descriptive name. The calibre of this first model was .410, and the barrel was 2-3/8 inches long. It was gateloaded from the right-hand side, and the empty cases were ejected by using a short rod which was carried in the butt, retained by a screwed knob on its end. The 'Pug' has an attractive appearance, being more streamlined than the other 'Bulldog', and the hammer is quite distinctive in the way in which the comb is covered downwards following the line of the rear of the frame. The 'Pug' is a pure pocket pistol, and the frame is rounded and smoothed to prevent it catching in the clothing, but even so, there is a foresight on the barrel. It was also produced in .450 centrefire, and the difference between this and the rimfire model, apart from the cartridges is first, in the hammer. This has the more usual upturn to the comb and one might think that this would catch in the pocket, yet the second difference is that the foresight has been abandoned. Both 'Pugs' are of course, solid-frame revolvers with the small curved butt which characterizes the 'Bulldog' series.

**.450 TOWER BULLDOG 1885.** This variant of the 'Bulldog' series seem to have been produced in only quite small numbers. It is little different from the general design of 'Bulldog', though the frame is slightly more angular and is extended behind the hammer and above the stocks to give a better grip. The hammer comb has a pronounced upward curve to it, more than any other 'Bulldog' and sufficient, one might conjecture, to catch in the largest pocket. Despite this the recognition feature of this revolver and the source of its name, is the Model name stamped on the left

of the frame. There is the usual Webley trade mark and the words 'London Tower'. Above these words is a view of the Tower itself, stamped just forward of the cylinder. It seems that these 'Tower' models were sold with the name of the gunsmith prominently engraved on them, but few have survived.

These civilian revolvers can be roughly divided into two general categories, the first are the large holster revolvers which were bought by service officers, and the second were the smaller household protection or pocket models. Naturally, there was a variety of models to cover both categories, and the firm would always make to special order. However, the larger holster models were made in .320 and .442 calibre. Both were heavy, but comfortable to hold because they were well balanced and had a large stock. A flat spring on the left side of the frame holds the hammer at half-cock, but can be over-ridden by pulling the trigger. The barrels were octagonal, the cylinders plain, and the stocks fully chequered. An ejector rod was stowed in the butt, held in by a screwed knob as with the 'Bulldog'.

The pocket or household revolvers were made in .320, .360 and .380 centrefire calibres, and a few in .442 rimfire. Barrel lengths varied from 2 1/8 inch to 7 inches for a target version of a .360 model. They were chambered for five or six cartridges, generally

five for the pocket models. There are many of these revolvers remaining in both public and private collections, and they display a wide variety of special items which the owners requested. It must also be assumed that the various gunsmiths who sold these weapons were at pains to offer some special variant to attract sales. Thus there are special ejectors, special barrels, variations in the shape of the stock, and in some cases, variations in the shape of the stroke, and in some cases, variations in the shape of the frame. However, all are basically the Webley solid-frame revolver directly derived from the R.I.C. original models.

## □ THE ARMY EXPRESS MODELS 1878

The Army Express revolvers were heavy, powerful weapons designed solely for service use. They were contemporary with, or just after, the Colt Army Model, and it is not possible to say now if they were in any way influenced by the American Model. The 'Express' proper was preceded by a six-chambered .450/.455 centrefire model, which was an advance on anything produced by the firm up to that date. This series is generally known as the Army Express Revolver, and it was not in production for very long. The barrel was six inches long. On the right was a spring-loaded ejector rod operated by a flat half-round plate on its front, a feature which

# GRIGORY YEFIMOVICH NOVYKH:

## RASPUTIN

### — END OF A MAD MONK



Russia's notorious "Mad Monk," Grigory Rasputin, whose resistance to assassination was almost miraculous.

● Where he came from and what he really was no one will ever know. His name, Rasputin, was not given to him at birth. Rasputin means "debauchee", a name that this strange, unpredictable creature certainly earned. Born in a peasant home near Pokrovskoye, western Siberia, about 1872, Rasputin was to become Russia's most powerful leader, a sex-mad lunatic, and suffer not one, but four assassinations, all on the night of December 19, 1916.

Rasputin's given name was Grigory Yefimovich Novykh and early in his youth he joined and finally became a leader of a sex cult called Khlysty. The members of this demented group first beat themselves into bloody, pulpy messes (like the superstition-stricken flagellants of the Black Plague era) and then danced frantically around the earthen floors of peasant huts.

Overcome by exhaustion the members collapsed and in a prone position ripped away their clothes like mad dogs attempting to catch their tails. Males and females then carelessly copulated. Husbands ignored their wives and grabbed the nearest female. Wives thrust themselves upon the closest male stranger. This weird rite ended when the dozens of pretzelized couples would at last climax down to the last dynamic duo.

Rasputin was usually in the center of the goings-on and he took one woman after another. He was capable of having nonstop sex with as many as thirty women each night, it was said.

The Orthodox Church of Russia finally condemned the excesses of the Khlysty sect. Through fear, most of its members ceased their orgies — everyone except Rasputin. His sexual appetite had increased so enormously that no man's wife was safe from his assaults. In addition, his sexual prowess caused him to believe that he was inspired by God and that he could actually work miracles if he chose.

The Church branded Rasputin a heretic and he was tried by the Church. But since little evidence

and no witnesses (people were afraid even then of Rasputin's odd hypnotic powers) against him could be found, he was released. Rasputin suddenly took on the role of a roving holy man common in those days — referred to as staretz — and began a pilgrimage to St. Petersburg. It was really a way of escaping punishment for his gross offenses in western Siberia.

He walked more than a thousand miles until he came to the majestic home of the czars. He arrived in 1903 and immediately ingratiated himself with high-ranking churchmen, who introduced him to the flighty, fanciful aristocracy who lived in St. Petersburg's dream world. Here, Rasputin went back to old ways of debauchery. But this time he was more subtle. Seducing some count's wife under the guise of religious cultism could be dangerous.

The monk first gained a reputation as a hypnotist who could perform miraculous cures (mysti-

cism then being in fashion). Discreetly, he led the high society women who patronized him into believing that anyone coming into physical contact with his body would be healed and purified. Naturally, complete purification would only come through intercourse and, according to reliable reports, almost all the ranking women of Russia's aristocracy in St. Petersburg had more than one round with him in bed.

There was one problem for these women other than secrecy: Rasputin smelled like an open latrine. The Mad Monk did not believe in bathing and sometimes went for months without washing his hands and face. He felt (or so he told his gullible patrons) that washing diminished his supernatural powers. His stench was so powerful that women literally bathed in perfume before going to see him, so that their own smells overpowered his.

# Legal Notes

**Maintenance order – husband's failure to pay maintenance amounting to a contravention against public order – defence of impossibility – whether Magistrates' Court may vary the amount of maintenance.**

Farrugia was charged by the police before the Court of Magistrates of Judicial Police with breach of s.352 (xx) of the Criminal Code.

S.352 (xx): Every person is guilty of a contravention against public order who... when so ordered by a court fails to give to his wife such sum, fixed by that court as maintenance for her and, or, his children, within fifteen days from the day on which, according to such order, he should pay such sum.

The evidence showed that by a decree of the Second Hall of the Civil Court, Farrugia had been ordered to pay Lm22 a week by way of maintenance to his wife. He had complied with the maintenance order for the first four weeks but had subsequently defaulted. The Magistrate acquitted Farrugia on the grounds that he (Farrugia) had initiated the necessary steps before the Second Hall to have the maintenance order varied and was in any case prepared to pay Lm5 a week to his wife.

The Attorney-General appealed on the ground of an error of law on the face of the record.

The Court of Criminal Appeal, in an elaborate judgement upholding the appeal, held:

A. a decree ordering provisional maintenance and a judgement ordering the supply of maintenance are executive titles enforceable after the lapse of twenty-four hours from delivery (ss.479(A) (3) (a) and 253 of the Code of Organisation and Civil Procedure);

B. a decree ordering the supply of maintenance are executive of maintenance are in all cases provisionally enforceable notwithstanding that an appeal therefrom has been entered (s.265 of the Code of Organisation and Civil Procedure);

C. the Code of Organisation and Civil Procedure establishes the procedure as to how such decrees and judgements may be reviewed, varied or revoked, and no court of criminal justice has jurisdiction to enquire into the merits of such decrees and judgements, much less to revise, vary or revoke them;

D. the courts of criminal justice have a duty, in terms of s.352 (xx) of the Criminal Code, to ensure that orders for the payment of maintenance are complied with within fifteen days from the day on which payment becomes due and, in default, to punish the offender according to law;

E. the various provisions of the Code of Organisation and Civil Procedure and of the Criminal Code are a clear manifestation of the legislator's determination to ensure that such maintenance orders, be they provisional or definitive, are scrupulously observed;

F. however, if it is impossible for the accused to comply with such an order he may be acquitted;

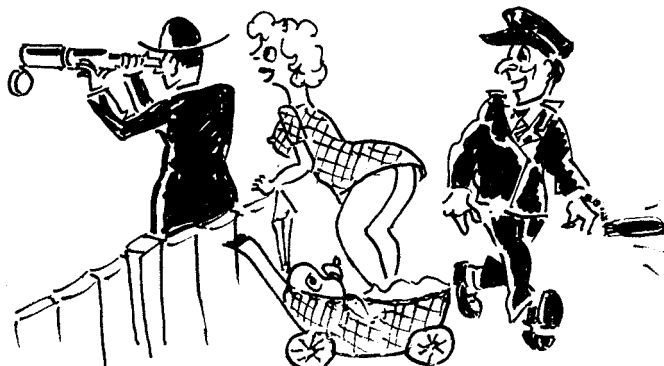
G. for the defence of impossibility to succeed, the Court of Magistrates of Judicial Police has to be satisfied that such impossibility is genuine and actual and that the accused has taken all the necessary steps to seek a revision, variation or revocation of the maintenance order before the competent court;

H. in the present case the presiding Magistrate appears to have taken the view that the mere fact that accused had initiated the necessary steps before the competent court was sufficient to exculpate him. This was an error of law.

The Court of Criminal Appeal revoked the judgement of the first court and sentenced Farrugia to ten days detention.
