GHAMLU UNUR LILL-KORP TAL-PULIZIJA TA' MALTA

• *IL-PRIM MINISTRU u Ministru ta' I-Intern, I-Avukat Karmenu Mifsud Bonnici u I-Kummissarju tal-Pulizija, I-Avukat L. Pullicino għamlu unur lill-Korp tal-Pulizija u lil Malta meta nhar I-Erbgħa, 30 ta' April, 1986, huma ġew ipprezentati b'midalja kull wieħed ta' I-Interpol liema midalja tirrappreżenta l-ogħla unur li din I-Organizzazzjoni Internazzjonali tal-Pulizija qatt tat.*

F'diskors li għamel is-Sur Kendall – is-Segretarju Generali tal-Interpol, fi tniem il-15-il Konferenza Reġjonali tal-Pajjiżi Ewropej membri ta' I-Interpol, ir-ringrażza lill-Kummissarju u l-Prim Ministru għax-xogħol siewi li għamlu biex il-Konferenza spicċat b'succcess. 

15th EUROPEAN REGIONAL CONFERENCE — MALTA

28th — 30th APRIL 1986

•THE 15th European Regional Conference of the ICPO — INTERPOL was held at the Mediterranean Congress Centre from the 28th to the 30th April, 1986. Except for the 1st European Regional Conference which was held in Rome in 1966, all other European Regional Conferences were held at the Secretariat General of Interpol in St. Cloud France.

Hence it is the first time in twenty years that this Conference was held outside France. Twenty-one member Interpol Countries from Europe and observers from

International organisations and local departments participated. These include the Customs Co-operation Council — the Council of Europe — Drugs Enforcement

Administration — US Counterfeit Division — the Royal Canadian Mounted Police and the Australian Federal Police.

Observers from the Armed Forces of Malta — the Attorney General and the Customs Department were also present.

The Prime Minister Dr. Carmelo Mifsud Bonnici addressed delegates and observers during the inauguration of this Conference on Monday, 28th April. He welcomed the delegates and stressed about the importance of exchange of information and police co-operation in areas such as the drug and terrorism problems. The Prime Minister also gave particular importance to Malta's fight against terrorism explaining that Malta would not hide any information from any country on terrorist activities.

Prior to the Prime Minister's speech Mr. Ray Kendall, Secretary General of Interpol addressed all delegates. He thanked the Prime Minister for having taken the time to open the Conference and the Malta Government for

the invitation extended to Interpol to hold this conference on the Island, these being clear indications of the importance to police co-operation and more especially international Police co-operation.

During his opening speech Mr. Kendall explained that the Maltese initiative to hold this conference in Malta could be regarded as a historic occasion and that in future other European countries will follow the Maltese initiative by inviting Interpol to hold such conferences in their country. He explained the role played by the European Region in Interpol and touched the issues which were to be discussed at the conference. Speaking about the problem of terrorism Mr. Kendall also made reference to the painful hijacking Malta experienced some months ago. In terminating his speech, Mr. Kendall thanked the Prime Minister, the Commissioner of Police and the Malta Police Department for the good atmosphere created and for placing at

Interpol's disposal the facilities of a successful conference.

The Agenda was then adopted. Several topics were discussed during the three days of the Conference and these included drug trafficking — currency counterfeiting, means of co-operations — Fraud and Economic crime and other topics.

During the conference delegates had the possibility to get together and discuss matters at an informal level. A social pro-

gramme was prepared for the delegates during the evenings. These included a reception at Police Headquarters on Sunday, 27th April — a Mediaval Banquet at Villa Rosa Castle on the 28th April — a reception at the Hilton on the 29th April and an official dinner at Verdala Castle on the 30th April.

The following is the speech of the Prime Minister, delivered during the Conference:

Speech made by the Prime Minister of Malta, Dr Karmenu Mifsud Bonnici.

• I EXTEND a warm welcome to the European Regional Conference and I thank ICPO for having accepted the invitation of the Government of Malta to hold this Conference in our country. These meetings are indeed essential. Countries which aspire to live in a civilized way must necessarily proceed to exchanges of views, share their information, avail themselves of the experience acquired by the other countries to benefit in all fields especially that connected with the maintenance of law and order, police action against crime, and all forms of criminality which undermine law and order within a civilized society.

These exchanges of views are also essential to analyse various shades of criminality. It would be pertinent to examine the methods used in the whole world to fight criminality if each country were to communicate to all the other countries the information gathered, if it shared the experience acquired in the struggle against crime. This would constitute a very interesting step forward. Such an exchange can only be made through a very close collaboration between the authorities of all the countries and within the framework of conferences like the one held today. Such a meeting can only contribute towards the strengthening of this co-operation which we need so badly.

The Government of Malta would like to indicate that it unreservedly supports international co-operation in the field of police activities. Malta is perhaps more exposed than other countries to the dangers of isolation due to its territorial exiguity and limited resources, also exposed to foreign influences. We are more vulnerable than other countries which are stronger and better equipped. It is therefore in our interest to collaborate with the police of other countries. But independently of this somewhat egoistic aspect, we have got ideological reasons for collaboration. We want to join in the effort of all governments in countering crime. As a nation we want to be a law-abiding state, we do not want any

sporadic incidents to tarnish our image. The respect we have for law is the historical result of the concept we have of civilized society. That is why on the ideological plan we also think that we should wholly involve ourselves in the preservation of law and order within the country and at an international level.

Compared to the past, it is today even more essential in certain fields, to promote international co-operation if one wants to obtain efficient results. A case in point is drug trafficking, one of the first subjects that I have in mind. Recently, we have had some bitter experiences and we realized that Malta could become the centre for important drug



traffickers hailing from far-away countries.

But it is also true as regards fraud and breaches of contract which are on the increase in international circles due to the more widespread communications between countries and the closer links established between groups of countries.

This is also true for terrorism whose violent activities are on the increase in various parts of the world. One can only fight with efficiency such activities, which are a real plague for civilized countries, through the co-operation of police forces in different countries. It is particularly necessary that each country wishing to involve itself in the fight against international terrorism makes available to all the other countries all the essential information gathered by it on the intents of those who organise acts of terrorism. The Maltese authorities have made it clear, recently, that they would not conceal any information of this kind to any of the countries requesting it, whether these be countries with which they have friendly relations or even countries with which they do not have any official relations so far. It is a first step. The transmission of information must transcend all other political considerations. This can only materialize if one were to fight with efficiency the plague of terrorism in today's world. We declare that the Maltese Government has bound itself to do whatever in its power to discourage any act of terrorism of whatever origin. Mr Kendall has just mentioned a hijacking involving Malta. The policy of our Government aims at discouraging hijackings in our country. We have given proof of our determination in the way we have tackled this last incident by making it clear that we do not intend giving in to the demands of criminals whoever these might be. We do not want to accede to their demands and we are of the opinion that if all countries made the same declaration stating that they would not give in to any of the



Għaddew sitt xhur minn mindu l-kumitat preżenti gie elett. Ta' min wieħed jara f'hiex kien jikkonsisti x-xogħol tal-Assocjazzjoni matul dan il-perjodu. Dan qed nghiduh għall-benefiċċju tal-membri l-ġoddha sabiex ikunu aġ-ġornati fix-xogħol tal-Assocjazzjoni u tal-bqija tal-membri l-oħra sabiex ukoll ikollhom rendi-kont tax-xogħol kollu li fih kienet involuta l-Assocjazzjoni.

Presentation of Equipment to the Malta Police by the Federal Republic of Germany

As a result of the close co-operation existing between the Malta Police Force and the Bundeskriminalamt (Federal Criminal Police) various equipment was donated to our services for use in the fight against crime and illicit drug trafficking.

On Friday, 25th April 1986, a presentation ceremony was held at Police Headquarters, during which Mr. Gerhart Boeden, Vice President of the Bundeskriminalamt officially presented the Malta Police with a dog transporter, two saloon vehicles, photographic and radio equipment and six German Shepherd dogs to intensify the fight against drug traffic in Malta. During this presentation ceremony the

Ambassador of the Federal Republic of Germany, his Excellency Dr. EBERHARD SCHMITT

was also present.

On this occasion Mr. Boeden delivered a speech to a number of police officers who were present. He stressed about the importance of close co-operation amongst the police forces in different countries. The Commissioner of Police Dr. Laurence Pullicino thanked Mr. Boeden and after addressing the officers present, he conveyed the thanks of the Malta Government to the German authorities. His Excellency Dr. Schmitt also delivered a short speech. Also present during the presentation were officials from the German Embassy in Malta, and other officers from the BKA.

THE HISTORY OF PHOTOGRAPHY

PART 3

POLICE PHOTOGRAPHY — 1852 TO THE PRESENT DAY

The use of photography in police work dates from the Autumn of 1852, when the Swiss Federal Government authorised the Department of Justice and Police to have photographs taken of all vagabonds, tramps and beggars found in abandoned buildings of cellars other than their own.

In September 1852 the Governor of the Bristol Civil Prisons, issued a circular recommending other prisons all over England to follow his practice of having a photo taken of every prisoner in their charge. It was not until 1870 that the photographing of every prisoner in England and Wales was made compulsory. In 1871, France followed suite. The procedure was justified during 1871/2, when 375 arrests were made in consequence of the criminals having to be identified by means of photographs.

Today the more advanced photographic techniques are in constant and daily use by all the Police forces of the world. That also includes Malta, although small in comparison, its photographic section dates back from the late 20's. The first Photographic section saw its birth together with the birth of the first CID Section. The CID and its branches were opened by the C.O.P. Mr. Aixia in 1927. The first photographer was Gianni (his surname could not be traced). He used to go around with his magical camera (as it used to be called — 'The Magic Box').

Before that most photographic coverings were performed by Civil Photographers namely J. Ellis Photographers of Valletta.

One recorded event is, counterfeited bank notes as found in possession of Mikiel Borg id-deffien.

There is little or no record at all of any photographic events before the 1924's.

On June the first, 1984, the new photo section of the Police Dept. was opened. It is well equipped, modernised, damp-proofed and newly constructed. All the work involved was conducted by police personnel specialised in their own trades. Such tasks were under the initiative and expert supervision of the C.O.P. Dr. L. Pullicino, LL.D. The new colour laboratory and video sections are newly constructed and modern equipment installed.

Well equipped photographic departments are an integral part of Police administration and their contribution, especially in crime detection is of great importance.

Great emphases are placed on photographic evidence by the courts of Malta. Hardly a major crime of any importance is solved without photographic evidence of some kind. Evidence of this type is factual objective and without bias. For recording the Scene Of Crime (S.O.C.) its value is inestimable.

LOCATION WORK

The photographing of the Scene of Crime follows a well defined practice. The locus is recorded exactly as found and before anything is touched or dis-

turbed. Nothing is moved before a complete photographic coverage has been made from several angles to meet all eventualities. If bodies, articles, etc, have been moved they are never replaced in an attempt to approximate their original position. Any clues present such as shoe prints, finger prints, bullet marks, scratches, signs of entry and exit, etc, are recorded in relation to each other.


Articles bearing on the crime such as weapons, tools (modus aparente) are photographed in their exact position before removed for examination, finger printed and further photographed.

Wounds on bodies are always photographed against a measurement, then from the study of the photograph, be determined the shape, size of weapon used. When identification is in doubt, tattoo marks, distinctive marks or prominent scars are an asset.

In recording the Scene of Crime, the aim is to re-produce by means of photographs, and tell the story of the crime. All prints must carry a good range of tones and be absolutely sharp from back to front.

EQUIPMENT

Any good, interchangeable lens/back camera is desirable for this type of work. In the Malta



THE HISTORY OF PHOTOGRAPHY

Police we usually use SLR cameras and various lenses of different focal lengths.

A comprehensive range of filters, both for general and special effects.

A good reliable flash gun. The electronic flash guns, owing to the comparative low light output from the portable types is hardly suitable where large areas have to be covered sharply and well lighted from front to back.

A good and sound tripod and a good supply of different (speed, Sensitivity), monochrome, colour, transparency, ortho or recording films.

COMPARISON RECORDS

With many offences a photograph is the only way in which the evidence can be presented to the courts to supplement the opinion and explanation of the expert.

In case of fingerprint evidence, the similarity of the print is quite easily followed by means of the photograph.

Ballistic evidence, sometimes of a highly technical nature is made quite clear through photography.

In forgery cases the expert's evidence on handwriting is always supported by means of photographs.


Comparison photos involves the trace as found at the SOC. Boot and shoe impressions found at the Scene of Crime can be prepared with suspect's footwear. Marks made by jemmies and tools can be photographed same size.

IDENTITY PORTRAITS

Photographs of the criminal aid the investigating officer in his hunt for the criminal. A true likeness is required and essential. Pin sharpness is essential and under no circumstances must there be any retouching. All facial blemishes, marks and scars must be clearly portrayed.

Profile and frontals are made to 1/8 th. scale and full length to 1/27th. scale.

Prisoners are photographed by taking profile and front against

an official number and dated. In case of a relapser, it is always desirable to re-photo the prisoner as the most recent likeness is needed for obvious reasons.


Surveillance photography is carried out by means of long focal distant lens or telephoto lens. Mirror lenses are undesirable due to the round reflective mirror effect and can be detected from miles away.

QUESTIONED DOCUMENTS


Document reproductions are carried out on a large scale in cases of fraud and processed as photostat (photocopied) or by means of photographs. Sometimes if not always special properties of the invisible light rays at both ends of the spectrum are utilized.

Ultra Violet (UV) rays are used on a good amount in a number of rays in police photography. They are used in all cases in the preliminary examination of the document, where forgery is suspected.

The obliteration of original written matter (chemically) and substituted by other writing, can be generally detected. Any application of chemicals to paper can always be revealed because the


GALILEO GALILEI

Fis-sena 1583, wieħed student żaghżugħ bl-isem ta' Galileo Galilei kien qiegħed bil-qiegħda fil-Kattidral ta' Pisa, belt Taljana. Wieħed li kien jaħdem hemmhekk kien għadu kif xegħel lampier kbir li kien imdendel mas-saqaf permezz ta' katina twila. Galileo qagħad iħares lejh jitbandal. Hu nduna li ghalkemm kull tbendila kienet iqasar minn dik ta' qabilta, it-tnejn kien qed jieħdu l-istess hin. Hafna minna forsi ma tantx kien jagħtu każ ta' dan il-fatt, iż-żda Galileo kelle l-mohħi ta' xjenzat. Hu dejjem ried ikun jaf "għaliex?" Hu għamel għadd ta' esperimenti permezz ta' biċċa spaga li mattarfa tagħha kien wahħal biċċa ċomb. Beda jbandal l-ispaga bħalma kien ra jagħmel il-lampier, billi f'dawk iż-żminijiet ma kienx hemm arloggji Galileo għamel użu mill-polz tiegħu biex jieħu l-hin ta' kull tbandila taċ-ċomba. Hu sab li ghalkemm kull wahda kienet iqasar minn ta' qabilha, it-tnejn kien qed jieħdu l-istess hin.

SKOPERTA KBIRA

Galileo kien skopra l-principju tal-pendlu. Dan il-principju hu magħruf bħala "isochroniżmu", li tħisser "l-istess fil-hin". F'esperiment aktar il-quddiem, xienzati oħra sabu li fil-fatt kull tbandila tal-pendlu kienet tieħu ftit inqas hin minn dik ta' qabilha minħabba l-arja u l-“friction”. Iż-żda, xorta wahda l-principju tal-pendlu li skopra Galileo hu mhaddem fi strumenti li jkejlu l-movimenti ta' l-istilel u fl-arloggji tal-pendlu li tant nagħmlu użu minnhom. Ta' min li wieħed jinnota li sa dan iż-żmien, Galileo kien digħi għamel skoperta kbira fl-użu tal-ħsieb xjentifiku. Mingħajr dan il-kwalitā ta' ħsieb, Galileo qajla seta' jiskopri l-principju tal-pendlu. Albert Einstein kien l-aktar li fahhar lil Galileo għal din l-iskopertà hekk importanti fil-ġrajjha tal-bniedem.

Galileo ggradwa mill-università ta' Pisa fl-1588, u baqa' hemm

biex jgħallek il-matematika. Fl-ekċi ta' ħamsa u għoxrin sena, huwa għamel it-tieni skoperta kbira tiegħu – skoperta li farrket 2000 sena ta' tradizzjoni, u li ġabitu bosta għedewwa. F'dawk iż-żmienijiet, hafna mill-hekk imsejjah tagħlim xjentifiku kien kollu bbażżat fuq it-teoriji tal-filosofu Grieg Aristotle, (384-322 B.C.). Dan kien għadu meqjus bhala l-awtorità fil-qasam tax-xjenza. Min kien jazzarda li ma jaqbilx ma' xi wahda mill-ħafna regoli li kellel Aristotle ma tantx kienet jieħdu pjaċir bih dawk ta' madwaru. Elfejn sena qabel, Aristotle kien qal li ogħett tql kien jaqa' għal l-art iktar malajr minn wieħed ħafif. Galileo ma qabilx. Skond teorija msemmija, hu ddiecieda li jagħmel dimostrazzjoni pubblika tat-teorija tiegħu. Hu stieden lil shabu l-professuri l-oħra biex jitilgħu miegħu sal-quċċata tal-famuż torri ta' Pisa, li kien digħi mnejjal kif inhu llum il-gurnata.

Galileo ha miegħu balla ta' kanun li kienet tiżen qisu għaxar kilogrammi, u balla oħra li kienet tiżen biss kilogramm. Hu xxabbat mal-ħadid u telaqhom it-tnejn flimkien fl-istess hin. B'għaġeb kbir għal kull min kien madwaru, iż-żewġ balal it-tnejn waqgħu ma' l-art fl-istess hin. Jekk huwiex veru li ġara dan

l-avveniment jew le, il-fatt jibqa' li Galileo skopra principju mportanti ħafna fl-istorja tal-fizika: li l-velocità ta' oggetti li qiegħdin jaqgħu hu totalment indipendent mit-toqol tagħhom. Iż-żda aktar minn hekk, hu wera li xjenzat veru għandu jesperimenta kull rogola, minflok li jaċċetta kull ma jgħidlu. Kienet haġa ta' l-iskantament tqis li għal perijodu ta' elfejn sena, il-bniedem kien emmen l-ideja ta' Aristotle min-ġħajnej lanqas biss ma sperimentaha. Kelli jkun Galileo li ma kellux moħħi ta' mazzun li jibla kollox.

Iż-żda, mmaġinaw intom id-didżappunt li hass Galileo meta minkejja l-provi kollha li kellhom quddiemhom, shabu l-professuri l-oħra qal li hu kien mar imqarrar-raq bih innifsu u baqgħu sejrinej ħallallu u jsostnu t-teorija ta' Aristotle. Huma kkritikaw lil Galileo, u talbu li Galileo jitneħha mill-pożizzjoni li kellel u jitkeċċa mill-università. Fl-ahħar, wara tliet snin ta' miżerja kbira, Galileo kellel jitlaq.

AVVANZI FL-ISTUDJI

B'xorti tajba, xi ħbieb li kellew tawh l-ghajjnuna tagħħom, u fis-sena 1592 hu lahaq professur fl-università ta' Padua, gewwa l-Italja. Hemmhekk hu seta' jkompli jagħmel l-esperimenti tiegħu mingħajr ma kellel lil hadd biex idejqu jew imaqdru. Fis-snin li dam jgħallek gewwa Padua, Galileo ressaq għadd kbir ferm ta' teoriji xjentifikasi godda u invenzionijiet. Hu vvinta mill-ġdid it-termometru, li kien ivvintah xjenzat Grieg fit-tielet seklu, u li wara kien intesa għal kollox. L-iż-żejjed importanti fost l-invenzionijiet tiegħu kien it-teleskopju, imsemmi bil-kliem.

mil-Latin ‘tele’ li tfisser ‘il-bogħod’ u ‘scopio’ li tfisser ‘tara’ jiġifieri strument li bih stajt tilmah affarijet fil-bogħod. Ta’ min iġħid li għalkemm dan it-teleskopju ta’ Galileo ma kienx l-ewwel wieħed, iżda kien l-aqwa wieħed li qatt ġie magħmul sa dak iż-żmien. Dan l-istruмент kien jagħmel l-ogġetti jidhru tlieta u tletin darba akbar milli kienu jidhru normalment.

STUDJU SISTEMATIKU

Galileo kien l-ewwel bniedem li studja s-sena b'mod sistematiku permezz ta’ teleskopju. Hu ra li l-qamar kollu muntanji u widien fuqu. Hu ra wkoll li l-qamar u l-pjaneti ma kienux jirriflett d-dawl tagħhom infushom, iżda kienu jirriflett d-dawl tax-xemx. Hu skopra li l-galassja tagħna “il-Milky Way” hi magħmulha minn miljuni ta’ stilek żgħar. Hu skopra erba’ qmura jduru ma’ Jupiter. Hekk kif baqa’ javanza fl-istudji tiegħu, hu beda jmieri t-teoriji l-qodma li kienu jgħidu li d-dinja kienet iċ-ċentru ta’ l-univers, bix-xemx u d-dinja jduru madwarha. Hafna snin qabel, fis-sena 1543, l-astronomu Pollak Koperniku kien ippubblika l-ktieb imsemmi tiegħu, u li fih iddikjara li x-xemx hi attwalment iċ-ċentru ta’ l-univers tagħna, u li d-dinja u l-pjaneti jduru max-xemx. Din it-teorija ta’ Koperniku kienet ikkundannata mill-Knisja u kważi ntesiet, sakemm Galileo pubblikament iddikjara li hu kien jaqbel magħha.

Id-dikjarazzjoni ta’ Galileo qajmet protesti kbar mill-Knisja. L-uffiċċiali tal-Knisja kienu irrabjati ferm u regħġu mill-għid ikkundannaw it-teorija ta’ Koperniku, u ikkundannaw ukoll il-kotba kollha li kienu jaqblu ma’ din it-teorija. (Koperniku sa dak iż-żmien kien ilu mejjet għal aktar minn sebghin sena).

Galileo kien ukoll ippubblika ktieb fuq dan is-suġġett jaħraq bl-isem ta’z; ‘Historia e Dimostrazioni intorno alle Macchie Solari’, li fih wera li kien jaqbel għal kolloks mat-teorija ta’ Koperniku u din kompliet tkattar l-ġħadab ta’ l-awtoritajiet tal-knisja kontra tiegħu. Hafna huma tal-fehma li kien Galileo

nnifsu li ġab dan is-saram kollu fuqu nnifsu għax kien bniedem kemmxejn aggressiv. Iżda madankollu Galileo wiegħed lill-Papa Pawlu V li ma jkomplix sejjer b'din l-ideja “żbaljata” (26 ta’ Frar 1616), il-kliem preciżi kienu: ‘li ma jżommix, ma jgħallimx u lanqas jiddefendi’ id-duttrina kkundannata mill-knisja. Wara li għamel din id-dikjarazzjoni, jidher li l-awtoritajiet tal-knisja reġgħu bdew jiffavvixx l-inkwizizzjoni lil-Galileo. Fis-sena 1632, mingħajr ma ta’ każ ta’ dak li kien wieghed, Galileo ppubblika l-ktieb “Bialogo sopra i due massimi sistemi del mondo”, dan kien biċċa xogħol miktub f’għamla ta’ djalogu bejn tlieta minn nies fittizji.

HATI TA’ DISPREZZ

L-ewwel wieħed kien favur tas-sistema ta’ Koperniku, it-tieni karattru kien jirrappreżenta liċ-cittadin komuni li kien qed jistħarreg fuq iż-żewġ sistemi u t-tielet kien jaqbel mal-fehmet ta’ Aristotle. Bil-kemm kien għadu hareġ il-ktieb li ma ġibitx l-attenzjoni ta’ l-Inkwizizzjoni. Il-Papa Urbanu VIII, li qabel kien il-kardinal Barberini, habib u ammirat ta’ Galileo, kien imgiegħel jaħseb li Galileo kien waqqgħu għaċ-ċajt fil-ktieb tiegħu billi xebbhux mat-tielet karattru, bħala xi hadd li ma kienx jimpurtah mix-xjenza u li kellel moħħu magħluq ferm għall-progress. Minkejja li issa kellel sebghin sena u kien marid, Galileo kien imgiegħel jidher quddiem l-inkwizizzjoni u wara ġuri twil hu nstab ħati ta’ disprezz kontra l-knisja u ġie kkundannat li jaċċed dak kollu li kien sostna qabel għarkobbejha u bil-ġurament. Jingħad li meta hu kien ha l-ġurament kollu u bies issalib, huwa qal “Eppur si muove”, iżda din hi biss legġenda u dawn il-kliem, ‘iżda xorta waħda timxi’ wisq naħseb li ma qalhomx minħabba r-riskju li jispicċċa l-ħabs.

Kien għad hemm kontroversja kbira bejn l-istudju fuq jekk Galileo nghatawx tortura meta kien qiegħed il-ħabs waqt l-istħarrig ta’ l-inkwizizzjoni.

Huwa żgur li kellel jgħaddi mill-“examen rigorosum”, li fl-ahħar ikun fiha t-tortura. Iżda d-dokumenti ufficjali ta’ dan il-għuri ma jsemmu qatt li dan l-ahħar pass ittieħed mill-awtoritajiet. Iżda minn naħa l-ohra, huwa żgur li dawn id-dokumenti kienu tbagħbsu minn xi hadd, Galileo kien rega’ ġie kkundannat għall-ħabs mill-inkwizizzjoni; iżda din is-sentenza biddilha l-Papa Urbanu għat-talba ta’ Ferdinandu, id-duka ta’ Toskana, f’permess biex Galileo jmur jogħqod fi Siena u fl-ahħar f’Firenze. F’dan il-post għall-kwiet f’Aroeteri, ħdejn Firenze, hu kompli r-riċerka tiegħu mingħajr waqfien, ukoll meta sar aghħama għal kollox f’1637 hu għamel skoperta ohra astronomika, dik tal-movimenti tal-qamar u ż-żminijiet li fihom kienu jsiru.

KIEN UKOLL UMLI

Legal Notes

Probation order – appointment of probation officer for female probationer – whether principal probation officer may supervise probationer – formalities to be observed in making a probation order.

Bickle Brincat, a minor, was found guilty by the Court of Magistrates of Judicial Police of having committed an offence against decency or morals by acts committed in a public place or in a place exposed to the public. The Court made a probation order placing Bickle Brincat under the supervision of the principal probation officer (a male) or of a female probation officer delegated by him.

The Attorney General appealed on the grounds that the probation order was null and void.

The Court of Criminal Appeal, allowing the appeal, held that –

1. a principal probation officer cannot be appointed to supervise a probationer in respect of whom a probation order is made in terms of section 5 of the Probation of Offenders Act, 1957; only a probation officer may be so appointed;

2. the probation officer must be chosen by the court and the choice cannot be delegated to any other person, whether that other person is a probation officer or a principal probation officer.

3. a male probation officer may not be appointed to supervise a female probationer;

4. Before making a probation order the Court is to explain to the offender in ordinary language the effect of the order and that if

he fails to comply therewith or commits another offence, he will be liable to be sentenced for the original offence; and if the offender is not less than fourteen years of age, the Court shall not make the order unless he expresses his willingness to comply with the requirements of such order. This explanation and the consent of the offender to the order must clearly result from the sentence itself and it is not sufficient that they are inserted in the copy of the probation order.

The Court of Criminal Appeal ordered the record of the proceedings to be sent back to the first court for the probation order to be made according to law.
