F'din l-ahħar tragedja tilfu ħajjithom membri tal-Korp li kienu qed jagħmlu xogħol li għalkemm kienu mħarrġa fiu u għamluh diversi drabi, iżda li jinvolvi certu periklu bħal ma jinvolvi periklu xogħol iehor tal-Pulizija. Ix-xogħol tal-Pulizija minnufih jinvolvi certi sogru u periklu.

Kien madankollu gest sabiħ li xi snin ilu almenu twaħħlet irħama ħdejn il-Kappella fil-Kwartieri Generali tal-Pulizija bl-ismijiet tal-Pulizija maqtula fi żmien it-Tieni Gwerra Dinjija.

Iżda l-Korp kelli aktar vittmi li isimhom għandu jibqa' jiġi mfakk u għalhekk ikun xieraq li kelli jsir mafkar fejn jidhru l-ismijiet kollha ta' dawn il-vittmi. 



Tislima lis-Surgent Salvu Muscat u l-Kuntistabbi Joseph Hare

• It-tragedja fuq il-patrol boat li grāt fis-7 ta' Settembru fejn sfaw mejta żewġ membri tal-Korp tal-Pulizija flimkien ma' membri tal-Qawwiet Armati ta' Malta haliex telfa kbira mhux biss għall-familjari tal-vittmi, iżda għall-Korp tal-Pulizija.

Dak in-nhar tat-tragedja, is-Surgent Salvu Muscat flimkien mal-Kuntistabbi Joseph Hare, li jagħmlu parti mit-Taqsima tal-Isplussivi tal-Korp, marru biex jiddisponu minn splussivi kkonfiskati mill-Pulizija minn persuni li kienu qed iżommuhom jew jaħdmuhom illegalment. Dan huwa xogħol ta' proċedura tal-Pulizija u wara xi żmien dawn l-isplussivi jiġu mormija fil-baħar bil-ġhan li ma jibqgħux ta' periklu. Dan kien parti mixx-xogħol ta' dawn il-membri tal-Korp li kien sar diversi drabi qabel.

Dak in-nhar l-isplussivi kienu qed jingarru bil-patrol boat tal-Qawwiet Armati C-23 u għall-habta ta' nofs inħar meta dawn l-isplussivi kienu qed jintremew fil-baħar xi erba' mili bogħod minn Kemmuna, saret splużjoni li haliex vittma liż-żewġ membri tal-Korp flimkien ma' ħames membri tal-Qawwiet Armati li tnejn minnhom, baqgħu ma nstabux.

Iż-żewġ pulizija vittmi ta' din it-tragedja kienu s-Surgent Salvu Muscat u l-Kuntistabbi Joseph Hare, it-tnejn tat-Taqsima ta' l-Isplussivi tal-Pulizija.

Is-Surgent Salvu Muscat ingaggħa bħala Kuntistabbi fil-31 ta' Dicembru 1974 u wara xi żmien stazzjonat fil-Kwartieri Generali tal-Pulizija huwa gie trasferit għall-Mosta mnejn ftit taż-żmien wara ntbagħħat Hal Qormi. F'Novembru 1975 huwa beda jagħmel parti mit-Taqsima tas-Sigurtà u Immigrazzjoni u mal-ħatra tiegħi ta' Sergeant

f'Ottubru 1978 huwa fforma parti mil-Laboratorju Xjentifiku tal-Pulizija. Is-Surġent Muscat kien ġie nkarigat mit-Taqsima ta' l-Esplussivi.

L-ewwel taħrig f'din it-taqṣima speċjalizzata ngħatalu fil-Kwartieri Generali tal-Qawwiet Armati ta' Malta, dak iż-żmien f'St Patricks fejn ha taħriġ mal-Bombs Disposal Unit. Bejn Lulju u Novembru 1977 huwa attenda kors ta' taħriġ fl-Iskola Militari ta' Piacenza, l-Italja. Kors ieħor simili kien dak fid-Direzione di Artiglieria, Ruma, bejn April u Gunju 1978. Fl-1981 huwa attenda għal kors ieħor dwar l-anti terroriżmu f'Belgrade, il-Jugoslavja. Salvu Muscat kien miżżewweg lil Anna Gaffari li wkoll għamlet xi żmien fil-Korp tal-Pulizija u kellhom tifla ta' sena u disa' xħur.

Il-kuntistabbli l-ieħor vittma ta' din it-tragedja huwa Joseph Hare ġuvni ta' 23 sena minn Tas-Sliema. Hare ingaġġa fil-Korp fi Frar 1979 u wara xi żmien stazzjonat fit-Taqṣima tal-Kontroll tal-Prezzijiet huwa beda jifformu parti mit-Taqsima ta' l-isplussivi. F'April 1981, flimkien mas-Surġent tiegħu huwa attenda għal kors ta' taħriġ f'Belgrade, il-Jugoslavja.

L-ahħbar ta' din it-tragedja gab luttu f'Malta u Ghawdex u l-ghada sar luttu nazzjonali. F'din il-għurnata thassru wkoll xi attivitajiet in konnessjoni ma' xi festi.

Nhar il-Hadd, 9 ta' Settembru, l-kadavri taż-żewġ membri tal-Korp flimkien maż-żewġ membri tal-Qawwiet Armati ngiebu Malta mill-Isptar Craig, Ghawdex, filwaqt li dak in-nhar stess f'Għawdex sar il-funeral ta' wieħed mill-vittmi.

It-Tnejn, 10 ta' Settembru fis-2.30 p.m. beda l-funeral ta' l-erba' vittmi Maltin bi tluq mill-Isptar San Luqa b'korteo li mexa matul Triq San Luqa, Triq Pietro Xuereb u Triq Schembri għal Triq Rjali, il-Hamrun. Fil-bidu ta' dan il-korteo mexa kontingent u l-banda tal-Qawwiet Armati. Wara kien hemm l-erba' twiebet merfugħha minn membri tal-Pulizija u tal-Qawwiet Armati rispettivament. Wara l-kadavri mxew ii-kappillani tad-diversi parroċċi tal-mejta u warajhom imxew il-familjari tal-mejta. Il-

Qiegħed jiġi riprodott ritratt ieħor ta' l-Ex Kummissarju Cachia bl-uniformi tas-sajf meħud ftit wara li sar Kummissarju.

Iż-żewġ pontijiet tal-hadid inħadmu fit-Tarzna. Meta fit-12 ta' April 1904 l-Imperatur Wilhelm, il-Kaiser tal-Ġermanja li kien qed jagħmel żjara fil-gżira, mar iżur it-Tarzna, urewh il-mudell tal-breakwater, u kien għogbu u faħħru ħafna.

Fi żmien il-gwerra meta t-Taljani ttantaw jidħlu fil-port biex jippruvaw jinvadu l-gżira, waslu sa ġdejn il-breakwater, irnexxielhom itajru wieħed miz-żewġ pontijiet, iżda sfaw vittmi, mgħarrqa u mirduma taħt l-istess breakwater.

Il-mawra ta' Pietro Della Valle f'Malta

minn Chev. Joseph Galea

•Nhar it-22 ta' Novembru 1625 il-Kunsill tal-Kavallieri kelli jzomm laqgħa b'urġenza biex tigi diskussa petizzjoni li kienet saret lill-Kummissarju tas-Saħħa minn wieħed turista li wasal Malta fuq bastiment tat-Tusċana, gej mil-Lvant.

Dak iż-żmien, minħabba l-biża' li bastimenti ġejjin mill-Lvant seta' kellhom fuqhom xi hadd marid, biex ma jxerrdux il-mard li jittieħed, kienu jidħlu fil-Port il-Kbir u jinżammu kwarantina.

Aktar tard, minħabba li fil-Port kien ikun hemm ukoll bastimenti oħra, il-Kavallieri li kienu jaħkmu l-gżejjjer, hasbu biex jagħmlu port ghall-kwarantina, għaliex maqtugħ mill-ieħor.

Sa dak iż-żmien, il-Port ta' Marsamxett billi l-inħawi tax-xtut tiegħi kien kollha baħħ, la kienet teżisti Tas-Sliema, la Ta' Xbiex u anqas fejn illum jissejjah il-Fort Manoel. Fil-qala ta' Tal-Pietà ma kien hawn xejn u wara l-pesta tas-sena 1592 kienu qatgħu li jagħmlu cimiterju għall-mejtin tal-pesta, fejn sa' dak iż-żmien kien magħruf bl-isem ta' Xatt il-Qasab. Bnew niċċa mdaqqsa u ddedikawha lid-Duluri, li bit-Taljan tisżejjah La Madonna della Pietà. Minn dakħin har dawk l-inħawi bdew isejhulhom tal-Pietà.

Il-Gżira, maqtugħha għaliha li meta l-Gran Mastru kien fettillu jibni dik il-fortizza sabiħa u majestuża fis-sena 1726, bdiet tisżejjah tal-Forti Manoel u l-inħawi tefgħha ta' ġebla minn din il-gżira ġhadet l-isem ta' Il-Gżira. Il-lum qisha belt oħra.

Fil-qedem dik il-gżira kienet proprietà ta' l-Isqof u l-Gran Mastru Jean Paul Lascaris Cas-

tellar li xtaq li jittrasferixxi l-port tal-kwarantina u bi ftehim ma' l-Isqof kien partat din il-gżira u minnflok ta' lil Isqof l-inħawi tal-Fiddien, ir-Rabat.

Minn dakħin har dawk li hawn Lażzaret laqa' fi ġnus differenti fil-Isienhom, fit-twemminhom u fil-karakteristici tagħhom. Tabil-ħaqeq li dik il-liggi tal-Kwarantina kienet nitfa ħarxa u tgħidix kemm kien hemm tgħemm minn bosta minn dawk li waslu Malta jew bhala turisti jew passiġġieri sejrin band'oħra, jew inkella li kellhom xi interessa fostna.

Il-ligijiet tas-Sanità kienu mizmura fuq xfar l-ghajnejn. Dak in-nhar mela li kien wasal hawn dak il-bastiment, nhar id-19 ta' Novembru 1625, il-Kaptan biex setgħu jagħtu il-pratka, ippreżenta l-lista ta' l-ismijiet tal-portijiet ta' fejn kien waqaf fi triqtu lejn Malta.

Il-Pulizija, dak iż-żmien, kienu jħarsu l-ligijiet tal-Kwarantina dovatament. Il-ligijiet kienu jighidu, li wkoll jekk ma jkunx hemm suspecti ta' mard abbord tal-bastiment, dan kien meħtieg li jidħol fl-inħawi tal-port tal-Kwarantina. U l-pratka kienet tingħata lilu mingħajr tlaqliq.

Il-passiġġieri li kien ikollhom ħsieb, jew ifissru, li xtaqu jib-qgħu hawn għal xi żmien, jew inkella sakemm jerga' jitlaq il-bastiment, kienu jridu jgħaddu mid-Dwana u taħt ghajnejn il-Pulizija.

Iż-żda l-Ufficjal Mediku meta dak in-nhar ġiegħel lil wieħed mill-passiġġieri li kienet waslu għalbiex jiftah il-bagħali u kaxxa kbira li kelli, li kienet laqtet il-kurzitā ta' min raha, dan caħad li jiftaħha.

Dan il-passiġġier kien jismu

Pietro della Valle li fl-Istorja hu magħruf bhala il-pellegrino billi kien vjaggħatur magħruf.

Pietro della Valle (1586-1652) kien ta' nisel familja nobbli Rumania u kien meqjus bhala bniedem għaref, kien jitkellem b'bosta ilsna, jaf l-istorja, il-ġografija u astronomu. Meta kien żgħir kien jikteb poezijsa u proża, imma aktar tard kien ta' għall-mużika u kien inqabad għal xi żmien suldat fil-Bohemja. Aktar tard, minħabba diżap-puntament fl-imħabba li keilu f'hajtu, mar joqgħod Napli u libes il-libsa sempliċi ta' pellegrin. Imbagħad mar Venezja u ddecieda li jitlaq fuq pellegrinagħ għall-Palestina. Imbarka fuq il-frejgata **Gran Del Fino**, vjaġġ skabruż u twil, għadda Zante, Troja, Gallipoli, Kostantinopoli, fejn għex sena shiħa, imbagħad telaq għal Rodi, Lixandra, u aktar tard Bagdad, u l-Persja.

Minn hemm żar Gerusalemm, Damasku, u meta żar Shariz kien ipprova jaqra u jagħti tiffsira ta' l-iskrizzjonijiet bil-karattri kunejformi ta' Persepolis, u wara mar l-Indja.

Kull fejn mar u żar, żamm kitba dettaljata mimlija tagħrif u kurzitajiet li ebda kittieb ieħor ma kien kiteb qabel, u wara gew stampati f'erba' kotba mqassima f'54 ittra (stampati Ruma, 1650-1658).

Kien jigħor ukoll oggetti kurjuži, **objets d'art**, bhak manuskritti orjentali li wara kien irregalahom lill-Biblijoteka tal-Vatikan. Kien kiteb ukoll grammatika u dizzjunarju koptiku.

Psychological pitfalls in the search for evidence

IT must be prefaced that very often, inspite of a laborious investigation, full truth is unattainable however, a police officer must ensure that every possible source of detection be utilised in his pursuit for evidence and must be fully aware of the basic psychological aspects that play a decisive role in his quest. If he disregards them he will be led astray and prevented from reaching a clear understanding of the situation he is investigating and from grasping the facts of the case or, at least, coming to a very close approximation of the factors involved.

The aim of this study is to draw attention to the mental mechanisms that are operative in the gathering of evidence; to the pitfalls that may be met with and how to surmount them; and to the steps to be followed to avoid possible errors in interpreting the facts.

First of all it is essential that the investigator be of a conscientious type of personality; methodical in his procedures at all times and in all cases even the most routine ones to avoid confused thinking and to eliminate mistakes and omissions from carelessness; persistent in clearing uncertainties arising from equivocal settings; and alert in guarding himself against possible misjudgement of his findings due to personal bias.

As regards procedure, the investigator must not limit himself to one source of information however reliable this may seem to be but must seek out as many sources as possible to be in a position to (a) verify the correctness of his findings; or (b) fill gaps in the story concerning points in time and place especially where the possibility of an alibi may arise; or (c) add supporting statements from different and independent sources; the fact that, by using different ways, he consis-

tently obtains the same result is a very reliable indication that he is substantially close to the truth; or (d) eliminate irrelevant and misleading information.

In his search the investigator may come across two or more contradictory witnesses. He must, however, remember that the contradiction may not be real at all but only seemingly so. Indeed all the witnesses may be truthful but they are stating the truth as each of them saw or knew it depending on how capable they were in fixing their active attention on all the aspects of the situation.

We must also consider the likelihood of an unconscious bias on the part of the observer which determines the way he perceives events and forms judgements. This unconscious mentation may give rise to a non-volitional untruth by the observer who, though unconsciously distorting the presentation of objective reality, has no deliberate intention to deceive the investigator (1).

The police officer must not content himself with a solution reached through one particular line of investigation but must remember that there may be other equally plausible but different ways leading to the same answer or solution. For instance, what would you suggest doing to ease traffic congestion in a narrow street? The easiest solution would be to turn it into a one-way traffic street; but you can also lay down a new street or road, or construct a tunnel under it or build a fly-over above it.

The investigator must overcome the temptation to conceive a theory on suspicions only or on one piece of information in which he comes to belief uncritically. This is a dangerous tendency as it makes us ignore alternative possibilities to our theory and thus put us off course from our objective.



In interviewing witnesses, who at the time of the incident under investigation were emotionally disturbed by fear or grief, one must keep in mind that such witnesses may not give a reliable account of events or description of the suspect because of their agitated state which prevents them from focussing their active attention on the details of the occurrence or personal characteristics, clothing, etc of the suspect.

When sifting information from eye-witnesses we must not concentrate exclusively on some isolated item of their deposition but must view the item in reference to the entire context of their statement because fragments of information isolated from the whole context may present only a partial picture of the situation under investigation thus leading to misplacement of emphasis or the overlooking of crucial clues or the outright distortion of the truth.

While experience is a great asset in any human activity, it must be remembered that experience may be fallacious and deceiving in certain instances. A person, for example, may be known to the police as a habitual delinquent with a record of

several convictions but he may not be the perpetrator of the crime you are suspecting him of on a particular occasion. A known drug addict, for instance, may be seen walking unsteadily and behaving strangely and because of our past experience of him we suspect him of being under the influence of drugs. It may be, however, that on this particular occasion his untoward behaviour is not the result of drug intoxication but of alcohol abuse or of some physical illness affecting his sense of balance such as vertigo from labyrinthine disease, raised blood pressure, epilepsy, stomach upset with nausea, etc.

The possibility of mistaken identity must always be kept in mind. This is likely to occur because (a) the human eyes and brain are not precise recorders of events and persons seen and, therefore, important details may be missed by the observer; (b) of a close resemblance of facial features, body-size and shape between two or more individuals; (c) of inaccurate observation on the part of a witness due to insufficient illumination at night or to rapidity of movements of the offender; and (d) of some form of disguise adopted by the offender to conceal his identity. He may, for instance, wear a false beard or a wig; replace his usual spectacles by contact lenses; or change the intonation of his voice when talking. A short and thin man may wear shoes with high heels and put on a padded jacket to make himself look hefty and tall.

The fact that more than one witness claim to have recognised the suspect is no guarantee against the possibility of mistaken identity. A few years ago a 53-year old man stood trial in the USA for a series of robberies. He was identified by seven eyewitnesses as the "Gentleman bandit", so called because of his polite manners and well-dressed appearance, involved in the crime. The man so identified, however, insisted that he was the victim of mistaken identity but the trial was suspended only when another man, fourteen years younger, had confessed to the robberies and given details to the police that only he could have

known (2). The plea of mistaken identity has been raised in our law courts in 1937 (3) and in 1965

The reputable investigator will be always on the alert against the pitfalls considered in this study and for this reason he will be constantly asking himself: "How reliable is the evidence I have collected? How far can I trust what an eyewitness is convinced that he has seen?". By way of an answer he will repeatedly check the validity of the data he has gathered for if these data are faulty his conclusions will be valueless; he will also be prepared to modify or discard conclusions already reached when he is faced with fresh facts that do not tally

with his assumptions; and he will have the courage and perseverance to start anew by seeking other sources of information and exploring hitherto untapped channels of investigation.

Il-vetturi f'Malta u l-ligijiet li gabu magħhom

•F'MALTA, mal-bidu tas-seklu għoxrin, bdew deħlin il-vetturi u ġħad li setgħu daħlu xi vetturi qabel dan iż-żmien, kien fl-1905 li bdew joħorgu regolamenti dwarhom u l-ewwel avviż ta' din ix-xorta deher fil-Gazzetta tal-Gvern tal-20 ta' Jannar fejn ġie avżat li l-ebda karozza ma setgħet tidħol gewwa l-Belt Valletta la minn Bieb il-Belt u lanqas minn Victoria Gate. Fiż-żmien li qed insemmu, il-karozzi setgħu jaslu biss sa fejn qabel kien hemm id-Dwana. Fl-istess żmien, kienet qed issir it-triq li mill-Furjana twasslek għall-Marsamxett u li l-karozzi bdew jagħmlu użu minnha fl-1907, meta allura l-karozzi setgħu jaslu sax-Xatt ta' Marsamxett fejn kien hemm il-lanċe.

L-ewwel Regolament tal-Karozzi u Muturi kienu ħargu fl-1908 u dawn it-tlettax-il regolament pubblikati bl-Ingliż u bit-Taljan, fost affarijiet oħra, kienu jgħidu li l-ebda karozza ma setgħet tīgi misjuqa fil-Belt Valletta jekk mhux bil-permess tal-Kummissarju tal-Pulizija. Wieħed josserva li kien meħtieg permess biss biex tīgi misjuqa vetturi fil-Belt u dan il-permess ma kienx jingħata għall-vetturi ta' aktar minn 1.8 metri (6 piedi wiesa). Skond l-istess regolamenti, il-karozzi ried ikollhom numru ta' registrazzjoni mwaħħal b'mod kif kien jitlob il-Kummissarju tal-Pulizija, liema numru ried ukoll ikollu ddawl fuqu li ried jinxtegħel siegħa wara nżul ix-xemx u jibqa' mixgħul sa siegħa qabel tlugħi ix-xemx kemm-il darba jkun qed isir użu mill-karozza. Il-horn, jew kif imsejja ġil-Malti, kornu, kien ukoll obbligatorju fil-karozzi. Gie wkoll iffissat limitu ta' sewqan fil-Belt Valletta u dan kien ta' daqs ta' ziemel misjuq bi-


trott moderat.

F'dawn ir-regolamenti nsibu wkoll li kien ġie pprojbit l-ipparkjar ta' karozzi tista' tghid fit-toroq principali kollha tal-Belt u li kien meħtieg permess speċjali biex karozza tīgi misjuqa fi Triq Repubblika bejn South Street u Archbishop Street. Il-karozzi ma setgħux jiġu misjuqa fejn kienu jingemgħu ħafna nies u s-sewwieqa ġew obbligati jobdu kull ordni mogħtija mill-Pulizija waqt li dawn ta' l-ahħar kienu jkunu jidderiegu t-traffiku. (Dan ir-regolament għadu in vigore sal-lum). Il-Kummissarju tal-Pulizija kellu s-setgħa, kif għad għandu sal-lum, jisspendi sewwieq milli jsuq karozza.

Fl-1911 saru xi emendi għall-ewwel regolamenti u mill-1911 sar obbligu li l-karozzi kollha jkollhom liċenza u mhux dawk biss li jiġu misjuqa fil-Belt Valletta. B'seħħi minn dan iż-żmien ukoll, kien meħtieg li s-

sewwieqa wkoll ikollhom il-licenza tas-sewqan u din kienet tingħata mill-Pulizija lil dawk is-sewwieqa li kienu jiksbu certifikat dwar il-kompetenza tagħhom tas-sewqan. Dan iċ-certiifikat kien isir minn nies awtorizzati mill-Gvern u fiz-żminijiet li qed insemmu jissemma certu William Frederick Glasson li kien Manager tal-Malta Import and Export Coy bħala espert awtorizzat mill-Gvern biex joħrog dawn iċ-certiifikati. Fl-1930 dawn iċ-certiifikati bdew isiru mill-Pulizija u dawn għadhom isiru sal-lum wara li jsir eżami dwar is-sewqan.

Fl-1916 reġgħu ħarġu Regolamenti oħra tal-karozzi u f'dawn ir-regolamenti nsibu ġdid li sewwieqa barranin setgħu jsuqu vetturi f'Malta kemm-il darba dawn kellhom il-licenza ta' sewqan ta' pajjiżhom. Is-sewwieqa Maltin li riedu jsuqu vetturi barra minn Malta setgħu wkoll jagħmlu dan, iżda riedu

jagħmlu talba lill-Kummissarju biex ikollhom dak li ssejja h-'travelling pass' illum imsejja h-International Driving Permit.

Aktar ma ghadda ż-żmien, aktar bdew dehlin vetturi f'Malta u dan naturalment gab aktar xogħol għall-Pulizija. Fl-1917 il-membri tal-Korp gew mogħtija lista tal-karozzi u muturi licenzjati f'Malta liema lista kienet tigħbi fiha, minbarra n-numru tar-registrazzjoni tal-vettura, l-isem f'min kienet licenzjata u naturalment l-indirizz. Din il-lista kienet f'għamla ta' ktieb u kienet tingarr mill-Pulizija waqt li dan kien ikun fuq ix-xogħol. Minn żmien għal żmien kienu wkoll johorgu emendi għal din il-lista wara li kien isir xi trasferimenti ta' vetturi jew joħorgu vetturi godda u l-Pulizija kienu obbligatil li jżommu aġġornata l-lista tagħhom. Fl-1919 dawn il-lista jew kotba ngabru u l-pulizija li riedu xi informazzjoni dwar xi vettura setgħu jakkwistawha billi jivverifikaw mis-Sezzjoni tal-Licenzi dak iż-żmien imsejja h-ir-Record and Licensing Department.

Fl-1929 reggħu ħargu 85 regolamenti dwar il-vetturi fejn, għall-ewwel darba, jissemma' wkoll li sabiex wieħed jikseb liċenza, kien meħtieg li dan ikollu mhux anqas minn sbatax-il sena. F'dan ir-regolamenti ġie wkoll iffissat il-limitu ta' sewqan fil-Belt Valletta, bliet oħra u rħula. Dan ma kellux ikun ta' aktar minn għaxar mili fis-siegha. F'postijiet oħra barra mill-ibljet u rħula, is-sewqan seta' jkun ta' mhux aktar minn għoxrin mil fis-siegha. L-ambulanzi, char-a-banc u vannijiet kummerċjali setgħu jiġi misjuqa b'mħux aktar minn tħalli il-mil fis-siegha. Regolamenti iehor obbliga lis-sewwieqa li kienu jidha l-vettura tagħhom f'garaxx biex waqt li l-karozza tkun sejra tidħol jew toħrog mill-garaxx, kellu jkun hemm miexi quddiemha, persuna xierqa sabiex tagħti avviż illi l-karozza tkun riesqa.

Hawn tajjeb wieħed isemmi x'kien in-numru ta' vetturi u kemm kienu n-nies licenzjati biex

isuqu.

Skond statistika ufficjali tal-1927-28 f'Malta kien jhawn 922 karoza licenzjata u 329 oħra licenzjati għall-kiri. Persuni licenzjati biex suqu kien hawn 1682 u 459 oħra kienu licenzjati biex suqu karoza tal-kiri. Muturi kien hawn 285 u 13 oħra licenzjati għall-kiri. Persuni licenzjati biex suqu l-muturi kien hawn 319. Permessi sabiex vetturi jidħlu l-Belt Valletta kien hawn 898.

F'dan iż-żmien, jew aħjar b'effett mis-7 ta' Novembru 1927, ġie maħtur Police Traffic Officer li xogħlu kien ta' superviżjoni u kontroll tat-traffiku kif ukoll il-liċenzi li kellhom permess jiġi misjuqa fil-Belt Valletta ried ikollhom imwahħħal mal-pjanċa tan-numri tar-registrazzjoni, plakka tonda u miżbugħa bajda ta' daqs ta' zewġ pulzieri u nofs dijametru. Dawk il-vetturi bil-permess jgħaddu minn Triq Repubblika ried ikollhom plakka ta' l-istess daqs, iżda ta' lew aħmar imwahħħla mal-pjanċa tar-registrazzjoni tal-vettura. F'dawn ir-regolamenti nsibu wkoll tibdil rigward is-sewqan li setgħu jiġi misjuqa l-vetturi u dan tela' għal għoxrin mil fis-siegha fl-ibljet u villaggi u 40 mil fis-siegha barra mill-ibljet u rħula. Dan illum, kif jaf kulħadd, huwa ta' 25 mil (40 kilometru) u 40 mil (65 kilometru) fis-siegha fl-ibljet u rħula rispettivament.

Fl-1930 twaqqaqaf l-ewwel Bord tal-Kontroll li kien kompost minn dawn is-sinjuri:

Chairman: L-Onor W. Salamone; Col. S.F. Newcombe, DSO, RE; Salvatore Galea; il-Kaptan Albert Micallef Eynaud u t-Traffic Manager u Segretarju tal-Bord, il-Kaptan J.L. Muscat.

Il-Bord tal-Kontroll tat-Traffiku għadu mwaqqaf sal-lum bil-għan li jagħti pariri lill-Gvern fuq kwistjonijiet kollha li għandhom x'jaqsmu mat-traffiku ta' vetturi u trasport ta' passiggieri u merkanzija.

Fl-1931 ħarget l-Ordinanza Nru, X, l-Ordinanza dwar ir-Regolamenti tat-traffiku li minbarra milli tat-setgħa lil Gvernatur jahtar il-Bord tal-Kontroll tat-Traffiku li kien twaqqaqaf fis-sena ta' qabel, tat-ukoll certu poteri lil dan il-Bord. Din il-ligi tat-ukoll setgħu lill-Kummissarju sabiex jagħmel regolamenti dwar il-vetturi u laneċċi tal-passiggieri.

Fl-1942, mal-għabra Riveduta tal-Ligijiet ta' Malta, l-Ordinanza Nru X tal-1931 ġiet mibdula bil-kapti lu 105 tal-Ligijiet ta' Malta.

Aktar regolamenti dwar il-vetturi hargu fl-1933 li hadu post dawk tal-1929. F'dawn ir-Regolamenti ppubblikati bl-Ingliz, bil-Malti u bit-Taljan jidħru fost affarrijiet oħra, ir-

rekwiżizzjonijiet meħtiega għall-bini tal-omnibusijiet (char-a-bancs).

Fl-1948 reggħu gew ippublikati regolamenti godda u b'notifikazzjoni fil-Gazzetta tal-Gvern tat-13 ta' Jannar 1948, il-Lux Press gew awtorizzati jistampaw dawn ir-regolamenti bħala regolamenti ufficjali. F'dawn ir-regolamenti nsibu ġdid li dawk il-vetturi li kellhom permess jiġi misjuqa fil-Belt Valletta ried ikollhom imwahħħal mal-pjanċa tan-numri tar-registrazzjoni, plakka tonda u miżbugħa bajda ta' daqs ta' zewġ pulzieri u nofs dijametru. Dawk il-vetturi bil-permess jgħaddu minn Triq Repubblika ried ikollhom plakka ta' l-istess daqs, iżda ta' lew aħmar imwahħħla mal-pjanċa tar-registrazzjoni tal-vettura. F'dawn ir-regolamenti nsibu wkoll tibdil rigward is-sewqan li setgħu jiġi misjuqa l-vetturi u dan tela' għal għoxrin mil fis-siegha fl-ibljet u villaggi u 40 mil fis-siegha barra mill-ibljet u rħula. Ir-Regolamenti tal-1948 kieni l-ahħar regolamenti ufficjali stampati mill-Gvern u dawn, f'dawn l-ahħar sitta u għoxrin sena gew imtertqa bl-lemendi li sarulhom u wasal iż-żmien biex isir xi haġa ġidida. Tajjeb insemmu li fl-1980 l-Assocjazzjoni tal-Pulizija ħadet hsieb tippubblika, għalkemm mhux kopja ufficjali, ir-Regolamenti tal-Vetturi tal-Mutur li mela vojt kbir għaliex sa qabel dan iż-żmien ma kontx issib dawn ir-regolamenti ghajnej xi ftit ittajpjati minn xi whud.

Ligijiet oħra li ġabu l-vetturi kien dawk dwar is-Sigurtà fuq il-Vejikli bil-Mutur (Riskju tat-Terzi Persuni) meta fl-1939 ħarget l-Ordinanza Nru XXXVI. Permezz ta' din il-ligi, ebda persuna ma kienet tista' tuża jew tordna jew tippermetti lil xi persuna oħra li tuża vettura bil-mutur fi triq kemm-il darba ma tkun qiegħda sseħħ għall-użu tal-vettura, minn dik il-persuna jew dik il-persuna l-oħra, skond il-ligi, dik il-polza ta' sigurtà jew

dik il-garanzija dwar ir-riskji ta' terzi persuni illi taqbel mad-dispożizzjonijiet ta' din l-Ordinanza. Fi ftit kliem, din il-ligi obbligat li kull vettura għandha tkun assigurata. Din il-ligi tat ukoll setgħa lill-Gvernatur biex jaġħmel regolamenti li jippreskru xi haġa li setgħet tkun preskritta taħt l-imsemmija Ordinanza u f'Dicembru 1939 b'notifikazzjoni fil-Gazzetta tal-Gvern Nru. 611, hargu l-Motor Vehicles Insurance Regulations. Fl-1947, il-Kapitlu 165 tal-Ligijiet

ta' Malta - Assigurazzjoni ta' Vetturi tal-Mutur għar-Riskji ta' Terzi Persuni - ha post l-Ordinanza Nru. XXXVI tal-1939.

Intervista ma' pensjonant

L-ex-Surgent 285 Salvu Cassar

Surgent Salv, meta dhalt fil-Korp tal-Pulizija u x'kont tħadem qabel ingaggajt fil-Korp?

Qabel dhalt fil-Pulizija kont naħdem ta' xufier tal-karozzi tallinja li f'dak iż-żmien kien b'il-gallerija fuq wara. Fil-bidu tal-1930, kont smajt li riedu xi nies biex jidħlu fil-Pulizija u jiena mort id-Depot tal-Belt fejn sibt lis-Sur Ullo li kien Ajjutant. Peress li ma kienx għad għandi tmintax-il sena, qaluli biex nerġa' mmur napplika meta kont nagħlaq din l-età, u f'April ta' l-istess sena ergajt mort u ngaggajt. Miegħi kien dħlu erba' pjantuni oħra u niftakar lil PC 32 Darmanin, li kien suldat fl-RMA, u l-PC 52 Vella, li kien xufier. Dhalt bħala riserva Nru 22 u wara biss erbgħa u għoxrin ġurnata kont sirt regolari u tawni n-numru 285.

X'kien l-ewwel xogħol tiegħek fil-Pulizija?

Fiż-żmien li kont ingaggajt jien, l-ewwel xogħol tar-riseristi kien ta' għassha mat-tankijiet tal-petrol f'B'Buġa, iż-żda lili ma tawniex dan ix-xogħol imma tefgħuni għassha (shadowing) ma' wieħed Tuneżin li l-Pulizija kienet qed tassisu għaliex kien taħbi suspetti li dan kien għie Malta biex jikkommetti xi delitt. Kont immur fejn kien imur hu u naturalment nirraporta lis-superjuri tiegħi fejn kien imur. Kont naħdem pajżan għalkemm stazzjonat il-Belt.

Kif kienu l-kundizzjonijiet tax-xogħol fiż-żmien li qed issemmi?

Il-kundizzjonijiet tax-xogħol tagħna xejn ma kien pjaċevoli u konna naħdmu disat ijiem qabel nieħdu frank. Matul dawn id-disat ijiem konna naħdmu ta' l-anqas tmien sīghat kuljum u hafna drabi wara dan il-ħin kont trid tibqa' riserva l-Għassa għal dak li jista' jinqala'. Dan kien jinkludi li torqod fl-Għassa fil-ħin li suppost kien liberu. F'dak iż-żmien kont ukoll tagħmel xi naqra xogħol extra li konna nitħallu għaliex b'25 centeżju għal kull erba' sīghat. Il-paga kienet ta' Lm7.36,00 kull ħmistax għaliex konna nitħallu kull ħmistax.



L-ex-Surgent Cassar

Fejn ħdimit aktar wara l-ingagg tiegħek fil-Korp?

F'Ottubru tal-1930 kienu ħadu l-Isptar Centrali, fejn illum għandkom id-Depot, lil certu Bajjada li kien qed jiskonta sentenza ta' habs wara li kien wettaq delitt. Ma' dan Bajjada kienu bdew jagħmlu għassha xi Pulizija mill-Furjana u għalhekk bagħtuni l-Furjana minħabba dan in-nuqqas. Kien qaluli li tefgħuni l-Furjana temporanġament, iż-żda fil-Furjana domt sitt snin. Ix-xogħol fil-Furjana kien jinkludi dak tas-sinjal tat-traffiku ħdejn Putirjal fejn illum hemm l-uffiċċju tal-Pulizija tat-traffiku. Hemmhekk kien hemm 'traffic island' u l-pulizija kien joqogħdu jidderigu t-traffiku bil-lembuba f'idhom. Konna wkoll nilbsu l-elmu abjad bejn it-8 a.m. u l-4 p.m. Dan kien xogħol iebeς hafna.

Fejn ħdimit wara l-Furjana?

Mill-Furjana mort Tas-Sliema. F'Tas-Sliema, minbarra x-xogħol ta' rutina kellna l-port mimli fregati u bahrin Ingilzi. Hafna minn dawn, ta' kull fil-ghaxija, kieni jispicċaw fis-sakra fil-ħwienet tax-xorb li kien hemm

f'Tas-Sliema u l-Gżira u allura, hafna drabi, kien jaqalgħu l-inkwiet. Ix-Xatt ta' Tas-Sliema kellna wkoll Għassha żgħira li kienet ta' ghajnejna kbira għalina b'mod speċjali meta narrestaw lil xi hadd.

Meta sirt Sergeant u fejn bdejt ix-xogħol għid tiegħek?

Kont sirt Sergeant f'Dicembru 1941, fi żmien il-gwerra. Konna sirna disgħa. Jien bqajt stazzjonat Tas-Sliema fejn b'kollox servejt għal għoxrin sena.

Inti kont wieħed minn dawk li kont tiġi msejjah f'dik imsejjah No. 1 Squad meta kien jinqala' l-inkwiet. Xi tgħidli dwar dan?

Minħabba persunti, fl-ewwel żmenijiet tiegħi fil-Pulizija bdew idaħħluni mar-rinforz u kont insib ruħi ma' Pulizija qishom ġganti. Ma kontx niddejjaq avolja kont ta' età zgħira anzi kont neħodha bi kbira jekk kieni jsejħu rinforz u lili ma kinux jagħżluni. Dan servieni biex kull fejn ħdimit ma kont niddejjaq minn xejn. Niftakar xi ftit minn dawk li kien jaħdmu miegħi bħal Ġanni il-580; il-435 Galea; 120 Gauci; 296 Muscat; 685 Azzopardi; 284 Pawlu tal-Mosta;

il-warspite (328); il-Pietru Deguara (216) u Ganni ta' Hal Luqa 582.

Sa ftit taż-żmien ilu, il-logħob tal-ballun kien jintlagħab l-Istadium tal-Gzira. Kif kien ix-xogħol hemmhekk fi żmienek?

Fl-Istadium kien, għadu u jibq'a jinqala' l-inkwiet. Fi żmien li kont inkun xogħol hemmhekk jien, l-akbar rivali tal-futbal kien s-Sliema u l-Furjana u meta kien jilaghha dawn it-timijiet kien jibgħru numru kbir ta' nies fl-Istadium. Inkwiet gieli nqala' kemm f'dawn il-partiti kif ukoll f'partiti oħra u hafna drabi kienet tidhol il-kavallerija biex tikkontrolla dan l-inkwiet. Niftakar li membri tal-kavallerija kien jitilgħu t-taraġ tal-Istadium biziż-żiemel b'kollox meta kien jinqala' l-inkwiet. Hafna drabi, xogħli fil-ground kien ikun märr-referee ġħaliex mhux l-ewwel darba li dan kien jiġi attakkat minn xi ħadd li jaqbeż il-wire ta' madwar il-ground jew minn xi player.

Xi tgħidli ghall-festi f'Tas-Sliema?

Illum il-festi f'dan il-post huma mill-aktar kwieti iżda kien hemm żrajen meta tas-Sacro Cour u ta' Stella Maris kien jagħmlu tagħhom ukoll specjalment waqt il-marċ. Hawn mhux l-ewwel darba li beżbiżt lil xi ħadd għax kien joqghod imqareb.

X'esperjenzi għandek ta' Tas-Sliema fi żmien il-gwerra?

Il-gwerra naturalment għeb xogħol kbir fuqna u konna naħdmu tħalli siegħa kuljum b'sistema ta' sitt sīghat xogħol u sitta mistrieh. Fl-ewwel xhur tal-gwerra, waqt is-sitt sīghat ta' mistrieh, konna obbligati nibqgħu wkoll l-Għassa, iżda wara kien tawna permess biex waqt dan il-hin immorru xi ftit id-dar. Niftakar li hafna nies kien telqu minn Tas-Sliema ġħaliex beżgħu mill-bombi. F'Tas-Sliema kellna wkoll attakki kbar mill-ajru li ħallew hafna mwiet. Wieħed minn dawn l-attakki kien fejn l-Għassa tal-Pulizija f'Marzu 1942 meta fost oħrajn kien mietu s-Sargent 89 Lanzon u 547 Vella. Attakk ieħor kbir kien f'April ta' l-istess sena li kien sar ħdejn il-knisja tas-Sacro Cour meta waqa' wkoll parti mill-kunvent tal-patrijet u f'dan l-attakki kien mietu fost oħrajn

is-Sargent Riviera u patri Gelardu. F'dan iż-żmien kien gie wkoll maqtul is-Sargent 232 Pietru Cordina. Dan kien miet wara li splodiet bomba fi Triq San Duminku. Din il-bomba kienet waqqħet fil-gurnata ta' qabel u splodiet wara hafna hin.

Fi żmien il-gwerra jiena ġejt imsejjah ukoll biex nibda naħdem fl-airport meta l-Pulizija kien jieħdu ħsieb isoddu dawk it-toqob kbar ikkagħunati mill-bombi li kien jibgħu fuq l-airport. Darba minnhom kien hemm attakk kbir mill-ajru waqt li konna naħdmu hemm u twer-wirna. Dak in-nhar kienet splodiet il-karozza li konna naħdmu biha u kien mietu wkoll xi suldati.

Għandek xi esperjenza hażina li bqajt tiftakħarha?

Waħda minn dawn l-esperjenzi kienet ukoll fi żmien il-gwerra. Kien it-8 ta' Ottubru, 1941, waqt il-hin tal-mistrieh tiegħi, iżda 'stand by' riedt immur niekol u ġħalhekk isselift rota mingħand PC 340 Pawlu Micallef biex immur sa Tas-Sliema. Mort, u jiena u ġej lura kif kont nieżel Triq Manwel Dimech, dak iż-żmien Prince of Wales, kif wasalt ftit qabel il-Ballutta, kont qlajt daqqa ta' karozza li kienet ġejja mill-faccata u li kienet misjuqa minn pilot Ingliz. Mad-

daqqa ntift min sensija u haduni l-isptar tal-Blue Sisters fejn ġħamluli erba' punti f'wiċċi u 36 punti f'saqajja u ġenbi.

Nixtieqek tagħlaq billi ssemmi-li xi każ, mhux tas-soltu, li kont imdaħħal fih.

Darba minnhom kont xogħol ir-Regent f'Tas-Sliema, post ta' divertiment li kien jidher jidher ħafna fizzjali tas-servizzi Ingliżi. Dak in-nhar kien gie fizzjali fuqi u qallli li kien hemm wieħed li kellew l-kartiera tas-sigaretti tiegħu (tal-fizzjal) u li din kienet ġiet misruqa minn għandu xi jiem ilu. Il-fizzjal kompla jghidli li dan irriżulta wara li kien qed jitkellem ma' dak ir-ragħ li kellew l-kartiera u waqt li offrew xi sigaretti lil xulxin, il-fizzjal kien ittenda bil-kartiera. Jiena mort nivverifika u rrriżulta dak li qallli l-fizzjal. Wara hadt lil iehor l-ghasssa u kien irriżulta li dan kien alloġġat fl-Osborne Hotel l-Belt u kien harab mil-lukanda u ma kinux jafu x'sar minnu. Irriżulta wkoll li dan kien suldat, maħrab mill-Ingilterra u mfitteż ukoll mill-Pulizija Ingliżi u konnessjoni ma xi qtil. Kieno qaluli li jiena stajt niġi msejjah biex nagħti x-xieħda tiegħi fl-Ingilterra u din ħadha b'ferha, iżda wara xi żmien, dan ir-ragħ għeb u ma smajniex aktar b'aħbaru.

TAHITI - by Rose Tilley

•FRENCH Polynesia encompasses some 130 volcanic and coralline islands consisting of the Society Islands, (Windward and Leeward), The Marquesas, Australs, Tuamotus and Gambiers, Tahiti (Windward Islands) is the main island in French Polynesia.

French Polynesia has a population of 138,000 inhabitants of which 96,000 live in Tahiti. The population is mainly Polynesian, with some Asians and Europeans.

Policing in French Polynesia is divided between the Municipality Police, the French manned

Gendarmerie and the Papeete Police. Papeete, the capital of French Polynesia, has a population of 25,000 people and is policed by a 120-manned station on Avenue Bruant.

Up to 1967 an exclusively Tahitian Police force operated under the control of the Mayor of the capital. The French Government then took over the administration and today the Papeete Police force functions roughly along the same lines as the French Police although Tahitian Police Officers have the advantage of an 8% higher salary than their French counterparts.

Other districts in Tahiti and in the other islands of French Polynesia retain a token Police Force known as the Municipality Police which falls under the control of the respective Mayors of each province. The Municipality Police budgets allows for stylish American Police cars, uniforms and equipment which are the source of some envy amongst the younger members of the Papeete Police force who feel that their French style uniforms, and French supplied vehicles have a somewhat lesser impact.

The Papeete Police force has larger jurisdiction than the Municipality Police which than the Municipality Police which can operate only within those areas governed by the Mayor and alongside the Gendarmerie.

Nevertheless, whether Municipality Police or the French controlled Papeete Police, a Policeman's lot in French Polynesia is a happy one. Tahitians respect and look up to the members of their Police Forces. To refer to Police Officers as 'pigs' as happens elsewhere in the world would be absolutely unthinkable.

WARM GREETINGS

A Police Officer entering a bar, restaurant, cafe or nightclub in fact any public place, whether on or off duty, is greeted as an old friend which he usually is. Tahiti is a warm, close knit community; everyone knows everyone else, thus it can happen that a first misdemeanour, unless a serious crime, is often waived with a warning. If the offence is repeated a sterner warning is evoked, a third repetition and normal Police procedures are put into effect. A further deterrent is that fines are high, say for motoring offences, and prisons are unpleasant.

Sexual offences, mainly rape, constitute the main crimes in Tahiti. This can be explained by the fact that Tahiti has a huge, highly paid military presence and an annual turnover of some 55,000 tourists in addition to

foreign sailors from commercial vessels looking for female company. The local women tend to gravitate towards the foreign visitors leaving the Tahitian male to look for female tourists, the chief complainants of this crime.

Fridays and Saturdays see the bars, nightclubs and discos filling with Tahitians, sailors, French military personnel on leave and tourists which all too predictably results in punch-ups between Tahitians and foreigners.

Act of violence within Tahitian families, motoring offences, arson, fraud, embezzlement, drug offences and the smuggling of firearms account for the remaining crimes.

Police students train for one year after passing a qualifying entrance examination. An essential requirement is that they speak Tahitian. Police students have one stripe for the first year of duty, two stripes after for two years and three stripes after 14 years. Police Officers sit a further examination after four years in the force. If successful a diploma is awarded and the rank of sergeant gained after 7 years duty.

The Papeete Police force has only two women Police Officers who follow up cases, search suspects, and in general carry out the same duties as Policemen.

FIREARMS

Whilst Tahiti has a fairly low crime rate, all Police Officers carry revolvers. Adjutant Norman Terütua Chave, whose great great Grandfather hailed from Somerset, explains this anomaly by the fact that terrorist activities are increasing and Tahitian Police Officers must be equipped and prepared for the eventuality of a possible seige at a Government Office or at the airport which would need to be handled by trained, armed Police Officers. Chave, a marksman who trained for one year at Orly in Paris trains recruits to handle arms and in seige tactics.

Until recently the Papeete Police had only a token union with ineffectual powers. Following his election as a union official in 1981 Chave has developed a strong union and at the same time as improving working conditions for Papeete Police Officers, he

has established a good relationship with the administration. Formerly on 24 hours call until union negotiations led to a 6 day 39 hour week being established, police officers now work 2 days from 1-9 p.m., 2 days from 6-1 p.m., 2 days from 9-6 p.m. followed by three days leave. Overtime duty is unpaid but accrues extra leave.

Following a six month trial of the new rota system, union meetings and discussions with the Police union, recommendations are to be put forward for a morning, afternoon and evening duty rota of 1-9 a.m., 6-1 p.m. and 9-6 p.m. with 3½ days leave.

The union also plans to effect further improvements by pressing for a higher police budget to increase the force and fund an advertising campaign to attract more recruits and establish a longer training period with a

minimum of 3-6 months training in France. Currently any Tahitian Police Officer wishing to further his training in France must apply to the administration, for permission, and if granted, must pay his own fare unless he works 3 years without leave, which qualifies he and his family to travel to France at the administration's expense, for further training. Salaries then come into line with those of the French Gendarmerie.

A further aim of the union is the eventual take over of some of the duties of the French Gendarmerie, which in addition to representing the French Government act as legal advisers, tax collectors (payments by foreigners of immigration taxes on visas and extensions of stay) and carry out policing duties which in other countries would fall within the scope of the local police force.

Investigating Child Sexual Exploitation

Law Enforcement Role

PART 3

The following case illustrates the investigative problems encountered by Federal and local authorities. Child pornography was seized by U.S. Custom officers and turned over to U.S. postal authorities. They, in turn, notified the local jurisdiction for which the child porn was destined. A delivery was made to the suspected recipient, and a search warrant served. The search warrant yielded substantial amounts of child pornography which the subject had either collected or made himself, taking pictures of children he had molested. The subject was depicted in the pictures engaging in sexual acts with children, some of whom the local agency were able to identify. Although interviews were conducted with some of the persons identified, the local investigators (who were vice officers) missed a great deal of evidence and failed to ask questions which would have produced more evidence and probably resulted in more sex-related charges, as well as a more believable story on the part of the victims interviewed. The investigators accomplished a great deal with their limited experience. However, realizing their limitations, they sought the specialised skills they didn't have to bring a better case to trial, freely admitting their shortcomings. The inability to obtain certain items of evidence, destroyed by the subject because the investigators were unaware of their significance, was detrimental to the prosecution because essential elements of the sex crimes they were investigating could not be substantiated.

Child sex offences are multi-jurisdictional crimes, committed by persons whose travel are limited only by the particular individual's means. Rarely is a case found to involve only one city or county; it is not uncommon to find interstate, as well as international, connections.

In order to investigate this type

of crime successfully, specialized personnel must be assigned to work on the problem. However, few agencies have such investigators. Investigators normally assigned to sex crimes or child abuse units often do not have the expertise or experience to undertake such a sensitive and often prolonged investigation. It takes people who are aware of the fallacies and truths which abound about the problems to sexual exploitation of children to properly recognize and handle such cases. By recognizing that the case at hand is not an isolated incident, that it may be connected to others, that it may involve other victims, and that certain evidence may be found which will corroborate the victim's story, the investigator will provide the prosecution with a case that has a greater chance of conviction.

In 1976, a Los Angeles Police Department task force was created to examine the problem of sexual exploitation of children. In the first 2 weeks of investigation, it identified over 300 local adults molesting or exploiting children. Additional information from their covert operations resulted in 34 crime reports and 10 adult arrests, totaling 44 felony counts of various sex-related charges. From the investigations, 17 juvenile victims were contacted, 11 under the age of 15, from which they identified 50 more victims and 30 additional offenders.⁴⁰ The task force's recommendations included developing a more "aggressive" approach to child sex crimes and specialized units to deal with the problems of child molestation, pornography, prostitution, and runaways. They have also recommended greater detailed followup on such cases. The result of the study conducted by task force was the formation of the Sexually Exploited Child Unit (SECU).

The SECU has apprehended pedophiles who otherwise would

not have been discovered. The examination of the information obtained from the arrest of pedophiles or gained from their address books and correspondence provided many leads. SECU's examination of Catherine Wilson's mailing list, for example, revealed that 30 to 40 percent of her clients were registered sex offenders.⁴¹

The SECU also has an excellent method of covert operations and ability to deal with the problem because it recognizes the conspiracy and existence of the pedophiles underground. Only with such recognition and non-traditional procedure can the related problems of child pornography and sexual exchange of children be dealt with effectively.

Child pornography, contrary to popular belief, has not been produced traditionally by large organized operations, but rather involves a network of individual pedophiles who share the spoils of their work, taking advantage of both the porn they produce and the children involved in making the product. Some loosely organized groups or rings of adults and children discovered by police may simply be an early stage of evolution of this network. For example, a Boy Scout troop of 40 boys was found to have been created for the sole purpose of supplying sexual services to older men who would accompany the scouts on outings. Sexual acts and filming of those acts would occur with the knowledge of all involved, including the scout-master who was charged, along with 19 other men, with molestation and child pornography.⁴² Other such networks have been discovered, many with the sanction of churches or other similar organizations.⁴³ Pedophiles have been found to use the underground network as a means of trading, exchanging, and trafficking photographs of children, video cassettes, films, and even the children

themselves.⁴⁴ One group, which had trapped into the network, was found to be receiving 300 pieces of mail each week; another, 600 pieces of mail. The same individuals operated both groups, which grossed over \$70,000 in 1973. The ads listed by these groups sought sexual contacts with children.⁴⁵ With the advent of the home computer, the home sex business can be run with the ease and relative security (computer entries and informational release necessitate passwords and "secret" codes) of a legitimate enterprise. In one case, a computer network listed children by sex, race, hair and eye colour, type of sexual act performed, and other particulars on a mailing list that was "hundreds of feet long."⁴⁶ The list contained names from six different countries.

Such findings might support the contention that there are well-organized and financed connections from small towns of America to large markets of sexual desires in major cities throughout the world. The fact is that such organizations are the exception rather than the rule. However, for those networks which do exist, only covert investigative tactics will work to infiltrate and expose them.

Recognizing that only special, concentrated, and sophisticated tactics are the proper way to deal with the problem successfully, the City of Berkeley, Calif., after creating a task force to look into the problem and make recommendations, budgeted a position for a special investigator. The attorney general of the State of California also concluded that the resources of his office should be made available to local jurisdictions for the same reasons. The use of specialized techniques will be the problem.⁴⁷ NCJOA found that proactive investigations and education of the public are also the prime deterrents. The Queens Bench Foundation found that changes in training of police officers, victim sensitivity, and support provided by police were necessary.⁴⁸ When a different approach was tried in Anchorage, Alaska, the law enforcement community found that they had

the confidence of the public and that they got successful "results" they otherwise might not have achieved.⁴⁹ These results are what the American Bar Association meant when it found that there are many inadequacies and complexities in the manner in which sexual exploitation of children is being dealt with by law enforcement. Its conclusion was that in order to attain successful results, law enforcement, among others, is going to have to change its perspective on the crime.⁵⁰

To date, little effective investigative concentration by law enforcement has been accomplished because of a lack of coordination and a great deal of ignorance on the part of local agencies. The underground has better communication modes than do most law agencies. In addition, the underground communicates among themselves, something many police agencies do not do.

The investigations must be carefully planned, implemented, and analyzed for additional leads. Generally, one case mushrooms into many, many more. From the names found in address books, correspondence, and associates of the offender, properly trained investigators will discover other offenders, victims, and incidents.⁵¹ At minimum, 7 to 8 additional cases could be generated from a properly reviewed and analyzed investigation. Part of the problem is that there is no central bureau or collection point for leads or information obtained. As a result, many leads are never connected and many cases go unsolved. In California, leads which would have provided the identities of several of the victims in the L.A. Freeway Strangler case were not put together for several months. In the early stages of the Atlanta child killings, there was little, if any, cooperation among local agencies. In the computer matching operation run by two men from Los Angeles and San Jose, it took the combined efforts of the respective agencies to make the connections and effect the arrest. These two agencies ran into the same difficulty many others encounter. When the crime reaches beyond jurisdictional

boundaries, they had to rely upon each other and State or Federal authorities as they had little or no ability or resources to legally act.⁵²

Although the sexual exploitation of children is clearly a law enforcement problem,⁵³ most agencies give it a low priority as compared to other "major crimes". The New York Police Department, however, considers the problem to be "immediate.... major.... (and) serious" and has created a task force with other enforcement agencies to address the problem.⁵⁴ Many acknowledge the fact that there are unique aspects of this problem, yet there are few investigators who are specially assigned to these cases. Federal laws are seldomly enforced and there are few full time Federal investigators working on the problem. One U.S. Customs agent said that in 2 years, he conducted 150 investigations which led to 40 arrests and 25 convictions. He noted, however, that the prosecutors were not "enthusiastic about going to trial."⁵⁵ When authorities arrested Catherine Wilson, they claimed they had put a stop to 80 percent of the child pornography in this country. This is gravely misleading, as the arrest may have put a big dent in the commercial industry, yet did little to affect the underground networks operated by pedophiles.⁵⁶ Research conducted by individual States and local inquiries had found they "only scratched the surface and that there is a great deal of the problem which will never be uncovered."⁵⁷ The underground networks are so extensive that the only successful means of penetration can be through specialized concentration.

CONCLUSION

It was estimated that 95 percent of the arrested child molesters in California do not go to prison. Of the possible 30,000 child molests committed each year in the same State, the Bureau of Criminal Statistics reports that only 58 molesters went

to prison and that 104 went to Atascadero State Hospital for the year 1979.⁵⁸ These figures are frightening when one considers that they represent only a minute portion of the actual number of offenders. Statistics like these should stir law enforcement to action, to take an "activist" and "leadership role" in addressing the problem.⁵⁹ Because the nature of this crime is much like a "victimless" crime, little attention is given or devoted to it. Yet, police devote manpower and resources to narcotics, gambling, and prostitution. When asked why this is so, many police agencies simply deny they have such a problem.⁶⁰

Florence Rush says its "time to break silence which protects molesters and endangers children."⁶¹ Several Congressional committees have examined the problem and recognized that different measures must be taken than have been followed in the past. Several federally funded programmes have been undertaken to determine the scope of the problem and find new methods to address it. In the interim, the U.S. Supreme Court, in its New York v. Ferber decision,⁶² finally recognized that child pornography is child abuse and not a form of expression. This is only a step in the right direction. Now law enforcement has to take the cue and work to eradicate the abuse. In an article on the topic of legislation to cope with the problem of sexual exploitation, C. David Baker wrote that two distinct, but directly related, problems had to be addressed. What he, in essence, did was become one of the first to tie the problems of child molestation (child abuse) and sexual exploitation (prostitution and pornography) together.⁶³ The problem is that many have yet to recognize, as the Supreme Court did, this relationship.

In virtually every State in the country, law enforcement has a legal mandate to be involved in child abuse and neglect investiga-

tions. The issued are not over whether they will be involved, but rather, how and to what degree.

What is expected of the law enforcement agency is that they report, investigate, and provide emergency services for suspected cases of abuse or exploitation. Two law enforcement agencies in California are now faced with multimillion-dollar law suits for not properly following these provisions.⁶⁴ Similar law suits could be the possible result of any agency's mishandling of an abuse case of this nature. Law enforcement must recognize that pornography and prostitution are only symptoms of the greater problem of pedophilia and that all three aspects are a serious and grave threat to our communities.⁶⁵ Ethically, law enforcement has the sworn duty and obligation to uphold the law and the responsibility of the welfare of the citizens it serves. Those same ethics will not permit law enforcement to ignore the abused or endangered child. As early as 1977, experts have been crying for law enforcement to do more than it does to eradicate the problem. The experts have exposed the problem, baring its true magnitude and threat. To ignore it any longer would be unethical and a denial of all that law enforcement is sworn to carry out.
