Public Meetings and English Courts

A Historical Note

PART 3 by Vincent A. De Gaetano LL.D., Dip. CRIM. (CANTAB.)

No such criticism can be levelled at *De Morgan v. Metropolitan Board of Works*⁽³⁴⁾ which is conclusive authority for the proposition that there is no right to hold public meetings on Clapham Common; for appellant's argument clearly stated that the public had acquired a right to hold meetings on the common prior to the passing of 40 & 41 Vict. c. cci (The Metropolitan Commons Supplemental Act of 1877), under which a by-law was made prohibiting "the delivery of any public speech, lecture, sermon or address of any kind or description whatever, except with the written permission of the board first obtained, and upon such portions of the common and at such times as may be such written permission be directed and sanctioned by the board"⁽³⁵⁾; while the court disclaimed the right "as claimed by the appellant on behalf of the public"⁽³⁶⁾, i.e., the right to hold public meetings and not just to deliver public speeches, etc.,⁽³⁷⁾. Yet again one may argue that it is not entirely correct to state, as the precis at the head of the report in 5Q.B.D. states, that the court held that "No right on the part of the general public to hold meetings on a common is known to the law" (my emphasis). This, indeed, may have been a correct statement of the law as it stood in 1880⁽³⁸⁾, but the operative part of the judgement seems to deal only with Clapham Common and not with all or any common, whether or not appropriated to public use under the Metropolitan Commons Act, 1866:

The magistrate reports to us that some evidence was given of public meetings being held without remonstrance on the part of the commoners, or of the lords of the manor, though scarcely going back so long as twenty years; but finds that such user did not constitute a right or prove anything more than an excuse or licensed trespass. In this opinion we entirely concur. The common was the soil of the land of the manor, and the only rights over it were rights of pasture and other com-

monable rights of the commoners, and perhaps private rights of way. These are the rights which, not having been purchased by the board, are preserved. No such right as that claimed by the appellant (i.e. to hold meetings on Clapham Common)⁽³⁹⁾ on behalf of the public is known to the law⁽⁴⁰⁾

Homer v. Cadman⁽⁴¹⁾ arose out of a prosecution under S.72 of the Highways Act, 1835⁽⁴²⁾. The appellant marched at the head of a band and took up a position near a lamp-post in the Bull Ring at Sedgley. The whole of this Bull Ring was a public highway; it was in the form of an irregular triangle; and was also the spot at which six other highways converged. Appellant Homer then stood on a chair and addressed the crowd and the band – about 150 to 200 people in all – for the space of an hour. "During that period no person could, without considerable inconvenience and danger, have either walked or driven across that part of the highway where the defendant and his band and crowd were stationed, and the said highway was thereby during such period rendered less commodious to the public. There was, however, space outside the said crowd and between it and the footpaths for vehicles or foot-passengers to pass and re-pass"⁽⁴³⁾. Homer was therefore charged with having wilfully obstructed a public highway. In the magistrate's court Homer pleaded (a) that, since there was passage for foot passengers, horses and vehicles round the space occupied by the crowd, there was no obstruction within the meaning of S.72 and (b) secondly, that he had a right to hold a meeting on that highway so long as there was sufficient space for passage around the crowd. The magistrate refused to entertain either argument and, with regard to the second, maintained that "the defendant had no legal right to appropriate to himself in such a manner and for such purpose aforesaid such part of the highway"⁽⁴⁴⁾. Homer's "right" to hold the

meeting on the highway was not argued on appeal, where counsel for the appellant merely pleaded that the obstruction, if any, was occasioned by the crowd of persons who had gathered round the appellant and for this the appellant should not be responsible, and that therefore the appellant did not "wilfully" obstruct the highway; this argument was again rejected, Smith. J. saying:

The appellant was only entitled to use the highway in an authorised manner, that is, to pass over it to and fro. He certainly had used it in an unauthorised manner, and the magistrate has found that, as no person could have gone across that part of the highway where the appellant and his band were without considerable inconvenience and danger, there was no obstruction to the highway. The fact that only a part of the highway was so obstructed seems to me to make no difference. That the whole highway was no obstructed does not make what the appellant did any the less an obstruction within the meaning of the section.⁽⁴⁵⁾

In such muted and unobstructive language could the right of public meeting in a public thoroughfare be denied by Her Majesty's judges!





The Citizen, Traffic Accidents, and the Law

This is the third in a series of articles in which we are serialising parts of a lecture delivered at the University of Malta to the general public by Dr. J. Galea Debono.

At the time of going to print, the proposed amendments for merging Criminal and Civil Proceedings arising out of traffic accidents have not yet become Law. These amendments will be referred to in the fourth and concluding article in this series.

CIVIL REDRESS is obviously more important from a practical point of view as it strives to reinstate the injured party in his position prior to the accident through financial compensation.

There are various ways of reaching one's goal procedurally. If one is very lucky, he can have his claim settled out of court directly with the party responsible for the damage or his Insurance, with or without the assistance of counsel. If this is not possible, and it seldom is, the parties involved or their respective insurances might agree to have the issue settled by an arbitrator who is usually either a lawyer or an insurance surveyor. This procedure might be somewhat quicker and certainly cheaper than legal proceedings but it has the considerable disadvantage that no appeal lies from the arbitrator's award. Most cases, at least the more serious and contested ones, end before the Judge of the First Hall of the Civil Court, who, more often than not, appoints a lawyer as legal referee to hear the evidence and file a report on his findings. If one of the parties, or both, disagree with the referee's report, they are entitled to ask the Court to appoint three additional referees who will review the first report.

If the parties disagree with eventual judgement, there is always the Court of Appeal, composed of three judges, to review the case. It is not surprising, in the circumstances, that you might now and then read law reports in the press on damages awards for accidents that happened years and years before. That, very often, is not the end of the story.

One has still to enforce the judgement against the losing defendant. This can often prove to be a different and frustrating exercise, unless he happens to be backed by a sound insurance firm ready to honour its policy commitments without further wrangling and delaying tactics.


Under our law compulsory insurance covers only damages arising from death or bodily harm to third parties. Any coverage above that such as - (1) Comprehensive Insurance and (2) Full Third Party Insurance - is optional, though highly recommended in a place where driving habits are notorious. In cases of damages arising from death or bodily harm, a court judgement against a defendant can be enforced directly against his insurance, provided that the insurance firm is notified of proceedings instituted against their insured by means of a Judicial letter within seven days from the filing of the summons in court.

But assuming that an injured party is successful in pursuing his claim and that he obtains a favourable judgement against defendant, and ever hopeful that said defendant can afford to pay for his misdeeds or that he is adequately backed by insurance, what is he like to get in pounds, cents and mils at the end of it all?

The Court can only give financial or pecuniary redress and this takes the form of compensation for:

1. Actual loss 'Damnum emergens'.
2. Future loss of earnings 'Lucrum cessans'.

Our law makes no provision for compensation for moral damages, like other legal systems, where large sums have often been awarded for pain, shock, psychological suffering and the like. In this respect our law is somewhat retrograde, though the position is now much better than it was up to 1962, after the lifting of the £1,200 ceiling on damages awards not arising from malicious acts. Under our law, compensation is strictly related to pecuniary or financial loss.



Under actual loss would fall items like:

1. Repair bills and salvage and towing costs.
2. Hiring of another car whilst one's own is undergoing repairs.
3. Depreciation of a 'new' car following an accident.
4. Hospitalisation and medical fees and expenses.
5. Transportation to and from hospital for outpatient treatment.
6. Cost of travelling by the injured party or his close relatives in order to obtain treatment.
7. Cost of drugs or artificial limbs.
8. Wages paid to a nurse or domestic help during convalescence.
9. Any actual loss of wages, salaries or income resulting between the time of the accident and the time of the judgement or award.
10. And, of course, funeral expenses in fatal cases.

All such items would of course have to be substantiated by bills and receipts.

The computation of potential loss of future earnings is, as can be expected, more engaging an exercise because of the many imponderables involved.

To many it may seem impossible to meet out real justice and award adequate compensation without either overdoing or else awarding much less than that justly due. Indeed, the uncertainty about the length of one's life expectancy, working life, the



possibility of promotions, demotions, loss of jobs, salary increases, inflation trends and the lot make the exercise very much a leap in the dark.

In this vast area of doubt and speculation, our courts, following the 1962 lifting of the ceiling on damages awards, have in a number of judgements adopted precedents laid down by English Courts.

The repeated application of these precedents by judges, referees and arbitrators alike has now stabilised the situation providing a workable, though not of course a perfect formula for the computation of potential loss of earnings. The basic element in this formula is the determination of the Multiplier or Working Life Purchase, i.e. the number of years for which future compensation will be awarded. Case law, taking all the imponderables above mentioned into account, has come out with a maximum multiplier of 20 years. This would apply in the case of victims in their teens, twenties and early thirties. The multiplier would then decrease the more advanced in years the victim happens to be. A man in his forties will be awarded anything between 15 to 10 years purchase. A man above fifty will seldom be awarded more than ten years purchase, and, very often, less.

Having established the multiplier, one next determines the annual or weekly earnings potential over the number of years covered by the multiplier, taking into account likely increases in income and working out an average weekly or annual income. Multiplying this annual earning potential by the multiplier one obtains the gross potential earnings of the injured party.

Next, one relates this to the actual degree of disability suffered which can range from 100% in case of death to say 50% for the loss of an eye or 20% for a bad limp, depending on the gravity of the injury and permanent disability as certified by doctors.

A look at the example below might clarify matters: Youth of 25 years with a 20 years multiplier.

Present wage: Lm20. Wage in twenty years time: Lm40. Average weekly wage: Lm20 + Lm40 = Lm60 ÷ 2 = Lm30 × 50 (weeks) × 20 years = Lm30,000.

This latter deduction is to make good for the interests that are likely to accrue on the amount paid out in a lump sum and received at one go by the claimant, whereas in normal circumstances he would have received this over a long span of time.

Where the victim is dead and a claim is made by his heirs, considerable deductions are often

made to take into account the amount the deceased would have had to spend on himself, and, in cases where the deceased is not survived by a wife or children, to take into account the fact that, if the deceased was of a young and marriageable age, he was likely to get married and raise his own family, thus reducing the probability that the claimants, in this case parents, brothers and sisters, might have continued to enjoy any benefit from the deceased wage earner for a very long time. It is not uncommon for a deduction of two thirds of the total lump sum to be made in the latter cases.


An interesting question arises in cases where a married woman perhaps advanced in years or in

MARINE FRAUDSTERS WAIVE THE RULES

PART I

Marine fraud is a subject the marine world has been bombarded with during the past 10 years. Hardly a week passes without the press highlighting some large scale maritime swindle. Lectures, seminars, and film presentations are given world wide, illustrating the problems and dangers. During these presentations, committees are formed, Acts are quoted from the statutes of Fraud Act, 1977, to the Carriage of Goods at Sea Act of 1971, incorporating the Hague Rules. Representatives depart poorer in pocket, wiser regarding the problem, but with little hope of solution for effective control, and very little happen the next meeting.

In 1979, the Intergovernmental Consultative Organisation (I.M.C.O.) of the United Nations was alerted to the disastrous consequences of maritime fraud. On the 15th November 1979, this organisation passed the following resolution for action and comment by 23 member maritime nations.

"Recommends that governments subject to applicable national and international laws, contact and co-operate in appropriate legislative administration or other measures which could help to prevent and suppress acts involving or likely to involve bariety and the unlawful seizure of ships and their cargos, and safe guard the legitimate rights of all persons and authorities concerned."

Invites governments to notify the Secretary General of measures taken by them in this respect and requires the Secretary General to communicate such information to all member governments."

In June 1980 at the I.M.C.O. Council meeting in London, it was disclosed that replies had been received from three countries. It would appear that maritime fraud was not only possible

but is tolerated.

To use a broad classification, these frauds are:

1. Documentary frauds.
2. Frauds connected with charters.
3. Cargo frauds.
4. Scuttling.

There are thousands of merchant ships plying trade all over the world. A very large proportion can be discounted from dishonesty. The first being the Eastern Block countries where fleets are in governmental ownership for exporting goods. Next one can take away fleets whose sole function is to move companies' produce. Of the large number remaining, further classification must be made into those in corporate ownership, and those in private hands. This can often attract fraudsmen. Often the fraud has no connection with the ship other than the Bill of Lading and the means of transport. This crime can be aimed against the vessels' operators, insurance, buyers of goods, or shippers.

Documentary frauds came to the fore in 1975. Fraudsters presented false Bills of Lading and Letters of Credit to banks and defrauded shippers, importers, and banks of millions of dollars. It was easy and simple in the well-known Somali Sugar Fraud, whereby with false documents, 600 tons of sugar were delivered, not 6,000 tons, and in the Angolan Ground Nut Fraud, vessels arrived in Angola not with nuts, but with useless ground nut husks.

Millions of dollars were lost, the villains got away with fortunes, and the ships lay rotting in the port. It is just as simple today and will continue unless the would be victims have the foresight to realise they are under threat, excise great care, and have the back-up legal support when they are in the danger area. It is difficult to foresee the latter as each country strives to prove

the crime did not happen in their territory and passes the onus to another country. In recent cases, up to six countries have been involved in one transaction. This international involvement is very much on the side of the crook. The police endeavour to clear their own countries, pass the investigation over the border and inform Interpol.

Interpol is a superb international police organisation, but it must be borne in mind that they are mainly administrative and will also pass on the information to the countries concerned. Then one faces problems of international jurisdictions and extradition. With the world becoming smaller in the space and jet age, it is possible that in the very long distant future, there maybe an international police organisation as in "Star Wars" to effectively deal with international crime.

In New York in June 1980, Judge Charles Haight of the United States District Court, said of documentary frauds:

"The shipping industry is particularly vulnerable to documentary fraud because a single transaction can involve actions in several different countries. Where geographical distance is great, and the personal participation is minimal, reliance upon documents is commercially essential. The system is obviously vulnerable to fraudulent manipulation."

The tracking of these criminals is most difficult, but with co-operation from shipping and police forces world wide, there have been many successes.


But there are many which escape the net and find sanctuary in non-extradition countries such as South America. In the cases that receive national press publicity, one could ask who pays in this out-dated system of depositing large amounts of money in banks to be collected by crooks through

false documents before the vessels arrive at the destination. The man in the street would say,

"Why cannot goods be paid for on delivery?" or,

"Why cannot a Letter of Credit plus interest be paid when the goods arrive and are checked?"

He will be told that in the marine industry the present system is the only way, and therefore until the system is altered, the dangers of fraud will remain. The losers are usually insurers, shipping companies, importers, exporters and even the State. Today's loss becomes tomorrow's surcharge, and in the final analysis it is the consumer who pays because he is last in the chain of those to whom the burden of increase can be passed.

Who are these criminals - they are clever men, very knowledgeable in shipping and banking procedures, with world wide contacts. They know the easy pickings are centred around 3rd World countries, who are lacking in experience and expertise in large scale international transactions. They have time on their side. It is often months before the vessels arrive at their destination and fraud appears. The weapon that is used to the full by these modern pirates is telex and other fast international communications which they fully exploit to make the illicite deals look genuine. If they make errors or come under suspicion, they travel to a country where the law cannot reach them, and often carry on fraudulent deals from these havens.

The Chinese Grain Fraud in 1980 was a classic. The brain behind this crime is now serving 20 years imprisonment in the United States. A man with everything, 25 years of age, tall, good looking, very presentable and fluent in four languages. He came from a sound ship owning scandinavian family, and was most knowledgeable in shipping and banking procedures. He with two other accomplices, one a clever Chinese from Hong Kong, recently arrested, the other an Australian being sought by the FBI, together plotted a clever scheme and Chinese State char-

terers fell victims to a very sophisticated fraud, involving three shipments of grain valued at \$12 million. The men arranged this fraud through a 4th person who was the master mind. He set up the deals, gave orders, sent telexes and signed all documents. He had addresses in New York and Los Angeles and was entered as going through international airports and staying at 5 star hotels in many capitals. When the net closed and the Scandinavian was arrested, the 4th mystery man turned out to be a fictitious, he did not exist, and was invented to take the blame and the three crooks would plead innocent agents.

The case received world wide publicity and it is doubtful if this

cover will be used again. But rest assured, other clever cunning schemes will surface. One thing we can be assured of is that people who organise maritime fraud will continue to do so, changing and adapting new methods. It hardly needs saying that those who are interested in preventing this type of crime will have to change and adapt with the same facility.

Charter parties where the owners control often relinquishes for a time when a ship is hired to someone else, have a great attraction for modern fraudsmen. The charter agreement may be voyage charter, for a voyage using the ship or part of it, for a cargo.

Hawn ħafna regjuni fid-din ja fejn hemm in-nixfa eż: is-Saħħara, il-Messiku, Texas, l-Amerika t'Isfel u l-Afrika t'Isfel. Il-pjanti ta' dawn ir-regjuni huma biologikament attrezzati sabiex jgħixu fin-nixfa. Generalment wieħed jista' jinnota certu 'features' f'dawn il-pjanti li huma komuni għal pjanti tan-nixfa, viż: (1) Nuqqas ta' weraq (2) Zokk oħxon (3) Ġilda tleqq, qisha miksija bix-xema (4) Il-preżenza ta' suf jew xagħar fuq il-pjanta.

Il-pjanti li għandhom zkuk jew weraq ħoxnin, biex jaħażnu l-ilma, jisseqjh sukkulent. Minn dawn is-sukkulenti hemm familja ta' pjanti li kważi l-membri kollha tagħha jgħixu fin-nixfa. Din hija l-familja *Cactaceae* jew Kaktus. Dawn jintar fu botanikament mill-preżenza ta' areoles li minnhom jikbru x-xewk, u s-suf tal-pjanta. Mill-areole joħorgu l-fjuri jew il-friegħ.


IL-KURA TAL-KAKTI

Il-Kakti li jgħixu fid-deżert (xi speċi, jgħixu fil-ġungla) jippreferu hamrija ramlija, aciduża u li ma żżommx ilma. Wieħed jista' juža gravel li tintuża fl-aquarja bi particelli ta' daqs 2 sa 4 mm. Ramel fin wisq mhux tajjeb. Huwa tajjeb li tahsel il-gravel sewwa minn qabel. Taħlita tajba għal Kakti hija ta' 1:1, gravel u hamrija. Jekk wieħed irid jista' jissostitwixxi parti mill-hamrija (daqs kwart) bil-peat.

Il-qasrija jrid ikollha xi biċċiet ta' caqquf jew gebel fil-qiegħ biex jgħin biex l-ilma ma jakkumulax gewwa l-qasrija u jikkawża l-moffa. It-tisqija għandha tkun biss meta l-qasrija nixfet għal kollo. Hafna dilettanti jzqommu l-pjanti tagħhom niexfin għal kollo. Hafna tħalli tħalli kollha bejn Novembru u Frar, b'xi bexxa ilma darba fix-xahar.

Il-hamrija Maltija hija alkalina (= il-kontra ta' aciduża) hafna. Il-Kakti ma jikbrux tajjeb f'din il-hamrija. Biex tikkumbatti l-

alkalinità wieħed jista' jzid ftit qtar tal-hall (acidu acetiku) ma' l-ilma tas-saqwi. L-awtur jirrik-manda li wieħed ipoggi boċċa tan-Natalina (tal-Kamla) fil-qiegħ tal-qasrija biex issalva l-pjanta minn mard tal-għeruq, jew insetti.

XI SPECI INTERESSANTI

Bla dubju, l-aktar speci ta' kaktus li aħna l-Maltin naraw hija dik tal-*Opuntia ficus indica* il-“Bajtar tax-xewk”. Din il-Kaktus giet introdotta f'pajjiżna u l-ambjent naturali tagħha hu fil-kontinent Amerikan.

Speċi komuni fil-ġonna tagħna huma tal-grupp *Echinopsis*, li jieħdu l-forma globulari u għandhom fjuri bojod jew roża. Il-fjuri jifθu bil-lejl u jdumu ftit siegħat biss mistuħin. Din il-pjanta jkollha ħafna frieħ li wieħed jista' jagħti lill-hbieb.

Tipi tal-kakti populari huma:

(1) *Opuntia* – jixbku lill-bajtra tax-xewk, però x-xewk jew il-pala tkun ta' għamlha differenti.

(2) *Mammillaria* – pjanti żgħar, b'xewk sabieħ. Jiprodu ħafna fjuri u frott żgħir. Hawn min jiġi speċjalizza biss fil-*Mammillaria*.

(3) *Cereus* – Pjanti twal li jid-hru sikkrit fil-films “western”. Jistgħu jilħqu tul ta' 3 metri f'xi

kazijiet.

(4) *Astrophytum, Gymnocalycium* – pjanti żgħar b'forma ferm sabieħa u bi fjuri kkuluriti ħafna.

(5) *Ferocactus* – sikkrit b'xewk robust u forma ta' ganċi.

(6) *Zygocactus, Epiphyllum* – kakti li jgħixu fil-ġungla. Iridu ħamrija b'aktar peat fiha. Il-Christmas Cactus jew Easter Cactus huma popolari hafna.

KONT TAF....

1. Wieħed mill-akbar kollezzjonisti magħrufin huwa Malti. Dan hu l-Professur J. Borg li kien tabib u miet fil-1945. Kellu waħda mill-akbar kollezzjonijiet ta' dak iż-żmien. Il-kollezzjoni tiegħi issa tinsab fil-ġnien ta' Argotti fil-Furjana. Il-Professur Borg kiteb ktieb fuq il-Kaktus li għadu jintuża sal-lum mill-botaniċi u mid-dilettanti tal-kakti madwar id-dinja kollha.

2. Il-Kaktus *Lophophora williamsii* tikber fil-Messiku u hija wżata mill-indigeni fiċ-ċeremonji reliġjuzi. Il-pjanta tigħi minni xafra u f'dan l-istat hija magħrufa bhala “Mescal buttons” jew “pejote”. Il-pjanta fiha sustanza attiva, “mescaline”, li għandha effetti allucinatory simili għal dawk tal-L.S.D.

L-EWWEL ATTAKK FUQ SANT'IERMU

Sa mill-ewwel jiem tal-isbark tat-Totok fuq ix-xtut ta' Malta waqt li Mustafa, il-mexxej tagħ-hom, u l-Ammiral Piali kienu qeqħdin jifteħmu kif u fejn ser jibdew jattakkaw, donnu li Sant' Iermu dlonk kien waqa' taħt ghajnejhom bħala l-aktar punt strategiku.

Il-fortizza ta' Sant'Iermu kienet inbniet mill-Universită (il-Gvern Malti ta' dari) qabel is-sena 1480 f'tarf dak il-ħanek xaghri u blat imsejjah Ġħolja ta' Xeber Ras. Il-Vicire ta' Sqallija fis-sena 1488 kien hallas minn butu biex tkabbret il-fortizza, u wara żmien il-Gran Mastru d'Homedes fis-sena 1552 kien stieden lill-inginier Pedro Pardo biex jerga' jibni fortizza akbar u aktar moderna.

Billi t-Torok kienu daħħlu l-flotta tagħhom fil-port ta' Marsamxett kellhom donnu ta' bilfors li jattakkaw il-fortizza għax din qeqħda sewwa sew fit-tarf, fuq il-bokka tal-port il-kbir fuq naħha waħda u l-port ta' Marsamxett fuq in-naħha l-ohra.

B'hekk nhar id-19 ta' Mejju 1565 kien beda l-imblockk ta' Sant'Iermu. Sadattant fit-30 ta' Mejju wasal hawn ukoll dak il-furban magħruf sewwa fl-ibħra tagħna, Sidi Dirghut, jew Dragut, kif insejhulu ahna, u kif ra x'kien għamlu shabu qabel il-wasla tiegħu, deher li ma tantx kien tal-fehma li kellhom jattakkaw fortizza dghajfa, dik ta' Sant'Iermu, minnflok ma jattakkaw fortizza aqwa. Iżda billi kienu laqħu bdew fuq Sant'Iermu ssoktaw fuqu għalkemm hu kellu f'mohħu li jattakka lill-Ġħawdex u l-Imdina.

U sa mill-ewwel attakki t-Torok ma tantx kienu ħarġu ta' rgiel. Ara kemm, li bdew jattakkaw għal għarrieda l-fortizza, iżda l-ġħasssa ta' fuq il-pont fid-dahla ta' Sant'Iermu, wieħed kavallier Spanjol, kien żamm bissiħi jitqabbar ma' l-ġħadu sakemm laħqu shabu l-kavallieri u l-Maltin biex jiggildulhom. It-Torok kellhom iġarrbu l-ewwel telfa tagħhom, għax warajhom x'xin ħarbu lura, kienu ħallew dwar elfejn ruħ mejta, jew midruba. Minn tagħna kienu mietu dwar mitt ruħ li minnhom

minn Chev. Joseph Galea

kien hemm għoxrin kavallier.

Minnufiż de Valete minn Sant'Anglu bagħat rinforsi lejn Sant'Iermu. It-Torok minn naħha tagħħom basru li din il-fortizza kienet sejra tiswilhom qares, u għalhekk bdew iħaffru trunċieri u jimmuntaw batteriji kollha jħarsu lejn ix-xtut tan-naħha l-ohra u lejn Sant'Anglu.

L-imblockk tal-fortizza baqa' sejjer bla heda u kuljum kien aktar jiħrax.

Għaddew erba' gimħat - ħsejjes ta' artillerija, dagħdieh tal-bombardamenti tal-kanuni f'kull hin - iżda fuq il-fortizza kienet għadha tperper il-bandiera tal-kavallieri, hamra bis-salib abjad, simboli ta' rieda tajba, ta' gwerrieri qalbeni. Fil-fortizza kien hemm 1,300 ruħ, bejn kavallieri u nies oħra ta' kull ġens, fosthom ukoll Maltin.

L-eqqel tal-attakki Torok fuq Sant'Iermu kien bejn il-jiem 12 u 16 ta' Ĝunju, għied li kien sewa lill-ġħadu mijiet u mijiet ta' mejtin. Imbghad l-ġħada, 17 ta' Ĝunju Sant'Iermu gie izolat għal kollox maqtugħi minn kull naħha. U jumejn wara, il-kaptan Miranda, li ma kienx kavallier, minn ġewwa l-fortizza kien bagħat messaġġ lill-gran mastru fil-Birgu, fejn kien għarrfu li l-fortizza kienet għoddha waslet biex taqta' f'iddejn l-ġħadu.

Waqt wieħed mill-attakki fuq Sant'Iermu balla ta' kanun spara minn fuq is-swar kienet laq-ttet lill-Dragut fuq in-naħha l-ohra tal-port ta' Marsamxett, fejn sal-lum għadna ngħidulu l-Ponta ta' Dragut, u safra' midruba għal mewt.

Wara dik it-taqbida u dak il-ġlied kollu, l-għawniġjun tal-qalbienna f'Sant'Iermu kien tnaqqar għmielu għal mitejn ruħ biss, u għadd minnhom kienu feruti gravament, tant li bosta minnhom kellhom jitqegħdu bil-qiegħda fuq il-gebel għax ma setgħux jieq fuq saqajhom, biex jibqgħu jiggieldu sal-mewt.

Imbghad mal-ghodwa ta' nhar it-22 ta' Ĝunju, it-Torok reggħu għamlu attakk qawwi fuq il-fortizza, iżda tliet darbiet kienu

gew imregġin lura, u ma' nżul ix-xemx il-bandiera kienet għadha tperper fiż-żiffha ħelwa ta' dik il-lejl sajfija.

Mal-lejl kienet jinstemgħu ttokki tal-qaniena ckejkna tal-kappella ta' Sant'Iermu, donnu tneħid, iżda xieħda li kien għad hemm il-ħajja.

L-ġħada mas-sebh tat-23 ta' Ĝunju, lejliet il-festa ta' San Ģwann, il-Patrun tal-kavallieri, il-Gran Mastru mill-Birgu ipprova jibghat l-ġħajjnuna lil dawk ta' Sant'Iermu, imma t-Torok kif raw dan intefġħu b'ħilithom kollha fuqhom u rnexxilhom jgħelbu dik l-ġħajjnuna. L-ġħada fetah il-qawwa kollha fierha u n-nar tal-artillerija donnu li kien żejjen dawk il-ftit hitan tal-fortizza li kienu baqgħu weqfin fost il-herba ta' dak li kien Sant'Iermu.

Kif spicċa l-bombardament aħħarax, il-ġjannizzari intefġħu għall-assalt fuq il-fortizza. Il-furja Torka ma ħafret 'l-ħadd. Dawk il-feruti li kienu miġburga fil-kappella gew maqtula, minn bl-alabardi, min bil-vleġġeg. Uħud minn dawk li kienu sfaw ħielsa, u kienu ftit wisq, x'xin qabduhom gew maqtula u mbiċċra mbgħad rabtuhom ma' xtabi, u samruhom f'għamlu ta' salib, u wara tefgħuhom il-baħar biex bir-riħ u l-mewġ imexxihom fuq ix-xtajta l-ohra, lejn Sant'Anglu.

L-ġhan ta' din il-kefrija kien biex it-Torok ibaxxu l-moral tal-kavallieri u ta' dawk li kien hemm fuq is-swar tal-Birgu, u l-ohrajn fil-fortizza ta' San Mikiel.

Il-kefrija tat-Torok kienet waslet biex l-irju maqtugħha tal-kavallieri u tal-ohrajn gew im-waħħla fuq lasti, u poggewhom fuq il-blat tax-xtut biswit Sant'Anglu biex bħallikieku ibezzgħu lill-shabhom. Iżda din il-kefrija flok ma xejnet il-moral tal-kavallieri aktar żedditilhom il-hila u l-kuraġġ biex jitqabdu mal-ġħadu sal-mewt.

Imbagħad il-bandiera Torka dehret tperper u tittajjar fuq il-fidaliżiet ta' dak li kien Sant Iermu.

Il-waqgħha ta' Sant'Iermu kienet swiet lit-Torok dwar tmint elef ruħ, fosthom uħud mill-aqwa għellieda.

I-ex-Surgent Magġur Grech

Nota: Nibda biex nghid li ma' l-ewwel pubblikazzjoni ta' intervista ta' din ix-xorta, kienu hafna dawk l-ex membri tal-Korp li apprezzaw dawn l-intervisti u hegħewna biex inkomplu.

L-ewwel mistoqsija li għamilt lis-Sur Grech kienet x'kien ix-xogħol tiegħu qabel huwa daħal fil-Korp tal-Pulizija. Is-Sur Grech wiegħeb li l-ewwel xogħol tiegħu kien fit-Tarzna fejn kien daħal bħala 'yard boy' u mnejn spicċa sentejn wara bħala 'assistant electrical fitter'. Wara dan ix-xogħol huwa għamel xi żmien mar-Revenue Guards, id-Dwana u fit-28 ta' April 1921 huwa ngagħha fil-Korp tal-Pulizija fiż-żmien il-Kummissarju Bamford. Bħal hafna pensjonanti anżjani oħra, meta jsemmi lill-Kummissarju Bamford, dawn ma jkollhomx ġħajr kliem ta' tifħir għal dan il-Korp tal-Pulizija u s-Sur Grech semma' meta kien spicċa minn Kummissarju s-Sur Bam-

ford. Is-Sur Grech qal li l-Korp tal-Pulizija kellu certu obbligazzjoni lejn dan il-Kummissarju u l-membri tal-Korp riedu juru l-apprezzament tagħhom lejh meta gie biex iħallihom u għal-hekk dak inhar li s-Sur Bamford telaq għall-ahħar darba mill-Uffiċċju tiegħu, f'dak iż-żmien in-Knights Hall (illum Dar il-Mediterran Ghall-Konferenzi), huwa kien ingħata merħba kbira b'ċapċċip u ħruq tas-suffarelli.

L-ewwel numru ta' identifikazzjoni tas-Sur Grech kien 754 u dan in-numru gie mogħti lilu f'April 1921 meta flimkien ma' xi ġħamsin oħra huwa kien ingagħha fil-Korp. Mas-Sur Grech kienu daħħlu fil-Korp xi 'footballers' magħrufa peress li kien hemm il-ħsieb li jkun hemm team tal-futbol tal-pulizija ta' certu livel. Fost dawn il-players kien hemm Gejtu l-Haċċa li kien jilgħab mal-Hamrun. Il-Bazok, player tal-Furjana, Gejtu Sciberras u Salvu Cilia mlaqqam tal-Hmar. Kif

digà ntqal, il-Pulizija kellha team tajjeb u kienet tieħu sehem ukoll f'kompetizzjonijiet tal-futbol ma' teamijiet oħra tal-futbol lokali.

Dwar l-ewwel taħrif ma' l-ingaġġ fil-Korp, is-Sur Grech semma' li dan kien jikkonsisti f'lectures minn fizzjali tal-Korp,



her middle age, who has never been gainfully employed, is injured or killed in an accident. Would she, her husband or heirs be able to recover damages for future loss of earnings? In recent years the trend taken by our Courts in a number of judgements has been to take a more liberal and perhaps more generous attitude in such claims and awards have been made for potential future loss of earnings

though making certain prudent deductions to take into account the lesser probability of such a loss due to the unlikelyhood of such a woman having to resort to go to work.

This problem has, however, also been solved from angle another as well. In cases where either because of the wife's disablement or death, the husband has to take on domestic help to keep the household going, then he is compensated for the estimated expense he is likely to in-

cur as a result of his wife being incapacitated. Here, perhaps, case law has slightly departed from the above classification of recoverable damages into actual loss and loss of future earnings as compensation for future expenses is strictly not actual loss, nor loss of earnings, nevertheless similar awards have even passed the scrutiny of our Court of Appeal and this is certainly a positive development which I am sure few would criticise.

Mill-Ispettur A. Seychell



• Biex inkomplu fejn ħallejna bil-harga ta' qabel din, illum imiss li naraw xi ħaga dwar l-istorja ta' l-Interpol, specjalment kif originat din l-organizzazzjoni.

L-ewwel attentat biex titwaqqaf din l-organizzazzjoni kien sar f'April tal-1914, meta fuq stedina tal-Prinċep Albert I, gie organizat l-ewwel Kungress Internazzjonali tal-Pulizija Kriminali gewwa Monaco. Dakinhar Ufficjali tal-Pulizija, Magistrati u Avukati minn erbatax-il pajjiż jew territorju Itaqgħu u ġew diskusi ħwejjeg dwar centralizzazzjoni ta' certa informazzjoni li tista' tintuża minn pulizija f'diversi pajjiżi. Minhabba li ftit xħur wara dan il-Kungress faqq-qgħet l-ewwel gwerra dinjija, ix-xogħol kollu li kien sar kellu jit-warra.

Kien Settembru, 1923, meta Itaqgħha t-tieni Kungress Internazzjonali tal-Pulizija Kriminal. Dak inhar hadu sehem il-Kapijiet tal-Pulizija ta' seba' pajjiżi u gie deċiż li titwaqqaf l-International Criminal Police Commission, illi l-iskop tagħha kien li żżid il-koperazzjoni bejn il-Pulizija ta' pajjiżi diversi. Gie deċiż ukoll illi l-Kwartieri Generali ta' din il-Kummissjoni jkunu fi Vjenna, l-Awstrija fejn fil-fatt kien qed jiltaqgħu l-membri. Sal-1938 din il-Kummissjoni mxiet b'pass mghaggel u sa dik is-sena fil-Kummissjoni kienhemm erba' u tletin pajjiż membru. Iżda peress li fl-istess sena faqqqħet it-tieni gwerra dinjija, ix-xogħol tal-Kummissjoni kien affettwat bil-qawwi tant illi sal-1945 din ma setgħetx tiffunzjona. Sadanittant il-Kwartieri tal-Kummissjoni gew trasferiti f'Berlin.

Fl-1946 ezattament bejn is-6 u d-9 ta' Ĝunju, 1946, saret dik li sal-lum baqqħet tissejjah il-Konferenza ta' Brussels. Din ma kienet xejn ħlief attentat biex terga' titwielek l-ICPC u sbatax-il pajjiż hadu sehem.

Fl-istess sena l-Kwartieri Generali ta' din l-għaqda gew trasferiti għal Parigi. Sal-1955 hamsin pajjiż ingħaqdu ma' din il-Kummissjoni. Sal-1972 kien hemm 144-il pajjiż u llum, kif ra-

jna fil-harga ta' qabel, il-pajjiżi msieħba fl-Organizzazzjoni huma sa 134. L-ICPC giet magħrufa bhala ICPO u ciòe l-International Criminal Police Organisation fis-sena 1956, meta l-Kostituzzjoni ta' l-għaqda giet emendata skond il-htieġet għall-Koperazzjoni internazzjonali.

Ta' min isemmi illi meta l-Organizzazzjoni waqqfet il-Kwartieri Generali tagħha f'Parigi fis-sena 1946, din ma kellha ebda propjeta tagħha. Eventwalment, bhala rि�zultat ta' tmixxija għaqlija l-Organizzjoni xtrat l-art u bniet il-Kwartieri Generali f'St. Claude fit il-barra minn Parigi, li ilhom okkupati mill-Interpol mill-1966.

L-Għanijiet ta' l-Organizzazzjoni

Mingħajr ma nidħlu f'dettalji, ikun f'waqtu illi wieħed jagħti ideja lill-qarrejja ta' din ili-pubblikazzjoni, dwar x'inħuma l-ghanijiet ta' l-Interpol. Kif semmejna aktar 'il fuq l-Interpol għandha l-Kostituzzjoni tagħha, u din hija li tikkontrolla l-istruttratura u l-ħidma ta' l-istess għaqda.

Skond l-Artiklu 2 ta' din il-

Kostituzzjoni l-ghanijiet ta' l-Interpol huma kif se nsemmi:

a) Biex tigi assigurata u mhajra l-akbar għajjnuna bejn l-awtoritajiet tal-Pulizija Kriminali kollha, skond kif jippermettu l-ligħiġiet li jeżistu f'diversi pajjiżi u bi tharis tad-drittijiet tal-bniedem, u

b) biex jiġu mwaqqfa u żvillupati istituzzjoni li jistgħu jikkontribwixxu biex jipprevenu u jwaqqgħu d-delitti.

Barra minn dan l-Artiklu 2 ta' l-istess Kostituzzjoni jagħmlha ċara illi mhux permess illi xi pajjiż membru ta' l-Interpol b'xi mod jindahal f'xi ħwejjeg li huma ta' natura politika – militari, religjuża jew razzjali.

Permezz ta' dan l-artiklu rajna fuq fuq xi ħaga dwar l-istorja u l-ghanijiet ta' l-Interpol li ilha tif-funzjoni għal aktar minn nofs seklu. F'artkoli oħra nibdew naraw il-progress ta' din l-Organizzazzjoni li biż-żmien u bil-koperazzjoni ta' kull wieħed mill-mija u erba' u tletin pajjiż membru saret waħda mill-ahjar mezzu ta' assistenza f'invejazzjoni kriminali.





This is just part of his job. The list can go on and on. He will spend 25% of his time answering these types of calls.






