### General Fund

L-ewwel u l-egdem fond huwa dak imsejjah *Police General Fund*, imwaqqaf fl-1919 li ghalih tit-hallas kontribuzzjoni mill-membri kollha tal-Korp u li l-ghanijiet tieghu huma:

- ta' beneficcju ghall-membri kollha tal-Korp f'kazijiet ta' mard jew disgrazzji liema kazijiet jigu studjati minn Bord imwaqqaf ghal tal-apposta u wara li ssir talba mill-membri tal-Korp koncernat. Ta' min isemmi li fl-erba' kazijiet li dan itratta, inghatat is-somma ta' £M850 kif gej: Spettur inghata £M200; Surgent inghata £M250 u zewg kuntistabbljiet inghataw £M200 kull wiehed.
- Mill-1 ta' Lulju 1981 se jibda jaghmel tajjeb biex idipendenti ta dak il-membri tal-Korp li jmut waqt li jkun ghadu jservi fil-Korp jinghataw is-somma ta' £M1000. Dan sar wara li giet studjata l-possibilita li l-membri kollha tal-Korp jigu mdahhla fi skema ta' assigurazzjoni, izda din kienet se tiswa hafna u ma kienitx tintlaqa tajjeb mill-maggoranza tal-membri. Biex tkun tista tahdem din l-iskema kellha tizdied il-kontribuzzjoni bi 30c fix-xahar.

Ta' min isemmi li l-parti l-kbira mill-flus ta' dan il-fond huma nvestiti barra minn Malta b'imghaxijiet tajbin u dan sar bil-permess tal-Ministeru tal-Finanzi u tal-Bank Centrali ta' Malta.

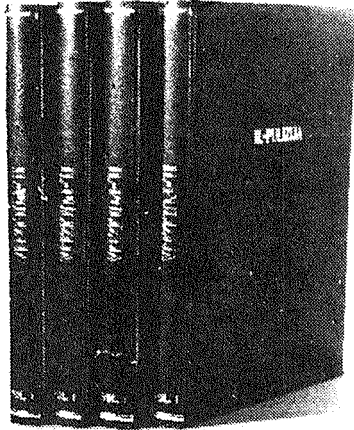

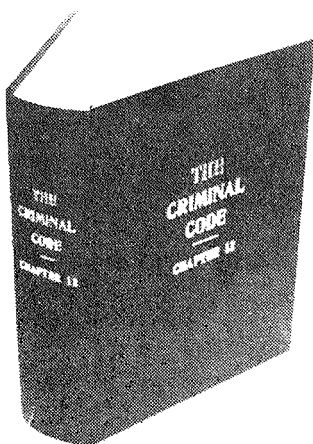

# ORIGINS OF THE MEDICAL DUTIES OF THE MALTA POLICE

## The Plague of 1813

The medical duties of the officers and men of the Malta Police have varied from time to time in accordance with the requirements and turns taken by the outbreak of disease in the Maltese Islands. Their first test came in 1813 when an epidemic of plague struck Malta.

In those days it was believed that plague was disseminated by contact with infected persons or with their belongings or by such objects as hairs, particles of straw and feathers. In conformity with these ideas the Inspector General of Police (corresponding in rank to the present Commissioner of Police) was enjoined, on the 21st May 1813, to make sure that hairs, pieces of paper, feathers and fragments of straw were removed from food items by means of tongs or pincers so that they would not be touched by hand, thus avoiding the risk of infection on the part of the person handling them(1).

By the 16th July the police were detailed to ensure that no clothes were hang in windows or balconies as it was feared that clothes could convey the contagion" as it was then called. The movements of the inhabitants and of domestic animals were restricted; pigeons, birds and poultry were to be confined to their cages; dogs and cats were to be restrained in the owner's home and not allowed to leave the houses and roam about in the streets. Perosns disregarding these orders were to be placed under arrest (2).

The following day the Inspector General of Police issued rules concerning the strict observance of quarantine measures by the personnel under his comand. These officers and men were charged with the supervision of the various barriers set up in the streets of the four cities to restrict the movements of the population and also to see that the selling and buying of foodstuffs were limited to the hours between 6 and 10 a.m. after which time the police had to ascertain that all shops were closed (3).

As the plague persisted in its onslaught in the villages of Qormi, Birkirkara and Zebbug, the Head of Government ordered the Inspector General of Police to throw a sanitary cordon of armed men to encircle the three villages and thus prevent their inhabitants from leaving any of the said villages under penalty of death. This order was speedily carried out by the 10th September 1813 and in this way the three villages were isolated from the rest of the island where the epidemic had shown signs of abating (4).

By the 13th November the mortality was on the decline in Malta and the British governor of Malta ordered a general purification of all the houses and shops of Valletta and Floriana for a period of fifteen days under the supervision of doctors and the police. A general pardon was proclaimed for all those who, in spite of the public warnings given by government when the outbreak was at its peak, had hidden objects liable to be infected. This pardon was to become effective only if the culprits revealed the hiding places to the Inspector General of Police within ten days in order to enable him to take the necessary steps for the depuration of the hidden objects (5).

Fearing a further wave of the disease in Vallëtta towards the end of the year, the Head of Government made arrangements, on the 24th December, for the notification of any new cases of plague. Such announcements were to be carried out by the police who were to go about the streets of the city accompanied by a bugler and a horn-player to warn the inhabitants to retire immediately inside their homes (6). As an added precaution, Valletta was divided into twenty-four districts and Floriana into seven districts to confine, as much as possible, the spread of the disease to the particular district in which it occurred. Each district was placed under the supervision of a Deputy of the Inspector General of Police who was aided by a Police Sergeant, a clerk and a nurse (7).

On the 3rd January 1814 a set of regulations were issued in connection with the above in the following terms:-

- i. The Inspector General of Police, who was responsible for the execution of the plan, received orders directly from the British Governor and as Head of the Police of the whole island he was empowered to issue orders and instructions as the circumstances of the case required.
- ii. Under him were the Deputies of the Districts, two Adjutants for Valletta and one for Floriana.
- iii. The Deputy of each District was to draw up an exact census of the population of his area and affix on the outside door of every house a list of the persons residing therein. A copy of this list was to be brought up to date every week and forwarded to the Inspector General of Police.
- iv. In the case of any sickness occurring in his district, the Deputy was to inform immediately the Inspector General of Police who, in turn, communicated the occurrence to the Chief Government Medical Officer who then took steps to ascertain the nature of the disease.
- v. The most important duty of the Police Sergeant was to ensure that the district was kept clean and that house refuse was taken for disposal to places set apart for the purpose by the Inspector General of Police.
- vi. The Police Sergeant was also to pay frequent visits, in the company of the nurse, to the tenement houses, stores, basements and groundfloor premises to make sure that they were kept tidy and well ventilated (8).

## The Death Penalty

The death penalty was proclaimed on the 15th May 1813 for any one

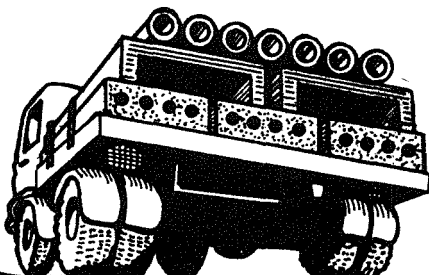

knowingly concealing the existence of the disease on himself or on others. On the 1st August it was extended to those who changed residence without previous permission from the authorities; or entered infected premises or hid any object or clothes likely to be contaminated with the disease (9).

Capital punishment was applicable also — and much more so — to personnel of the Sanitary Office, to civilian and military guards and to members of the Police Force who hid or stole clothes and other articles or allowed others to do so even from places not suspected of harbouring the infection (10).

On the 17th August a certain Anthony Borg was shot in Merchant Street, Valletta, for knowingly concealing the fact that he was suffering from plague. He was the driver of the carriage of the Commissioners of the Ospizio (a home for the aged and infirm at Floriana). This carrying out of capital punishment so impressed the people that a short time afterwards a low ranking member of the Police Force shot himself when he was discovered to be suffering from plague which he had been concealing since some days (11).

On the 13th March 1814 a certain Giuseppe Said from Xaghra, Gozo, who was known to have the plague, wandered out of his home while in a state of delirium from the disease and was shot dead by the Adjutant of Police. Another man faced a firing squad on the 31st March for having concealed the existence of the malady (12).

The police at Xaghra, Gozo, were shouldered with a quite unusual duty. On the 12th June 1814 the surviving members of the families that had been attacked by the disease were taken to Ramla Bay and there made to bathe in the sea three times a day, under the supervision of the police, with the scope of disinfecting themselves from any traces of the disease that might have been still attached to them (13).

#### Assistance Given to the Police Force

The Police were assisted in their medical tasks by:-

- i. The Maltese Provisional Battalion, especially in the formation of sanitary cordons round the infected villages of Qormi, Rabat and Birkirkara (29 August 1813). Guards also escorted the prisoners who were engaged in transporting the plague-stricken to the Lazzaretto, in removing the dead from their homes and conveying them for burial away from inhabited places. These guards also supervised the burning of clothes and other articles used by infected persons (14).
  - ii. The Corps of Maltese Veterans in Valletta in the early stage of the epidemic to prevent breaches of the quarantine measures taken by government to limit the spread of the disease (15).
  - iii. The *Guardie Urbane* formed on the 4 August 1813 to control the movements of the residents of Valletta and prevent unnecessary communications among them, to ensure that only one member from each family left his home for shopping and that only persons engaged in the public service went about the streets (16). These *Guardie Urbane* came into being on the suggestion of the Inspector General of the Police when, owing to the reduction of the personnel under his command, due to the daily deaths from the plague, he proposed to the Head of Government, the formation of a body of men made up of Maltese, British and foreign residents in Valletta to make up for the losses of personnel (17).
  - iv. Guardians of the Sanitary Office who were charged with the duties involved in the quarantining of ships and crews and the isolation of the plague-stricken at the Lazzaretto (18).

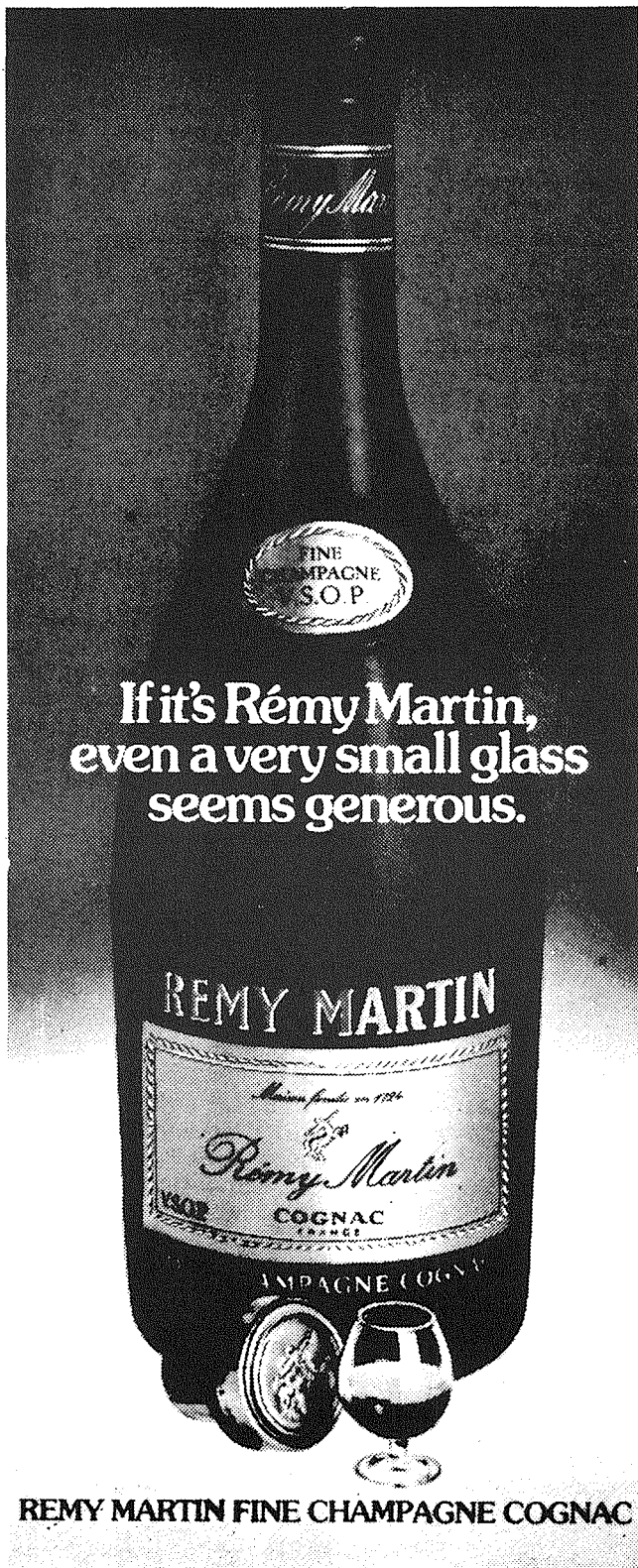

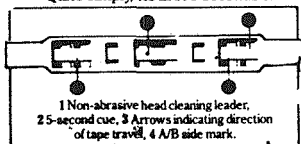

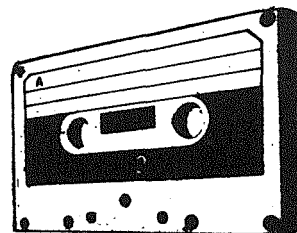

Ibghatu ghal Carol Saliba". Hekk kien ighid il-President tal-Qorti, Sir Arturo Mercieca, ta' kull meta kien ikun hemm xi kaz ta' delitt, u li ma kienx ikun tant facli li jinkixef min ghamel id-delitt.

Carol Maria Saliba, twieled Hal-Qormi fis-16 ta' Dicembru 1890, u minn ckunitu kien trawwem fid-dixxiplina. Missieru kien l-ufficial tal-Kummissarjat tar-rigimenti Inglizi f'Malta, u kien jiehu hsieb it-tqassim tat-trasport u tal-provvizjon kollu. Is-sens ta' dixxiplina militari tnissel fih u kiber mieghu, u nistghu nghidu wkoll li ghadu bih tabilhaqq, ghalkemm ghadu kemm ghalaq disghin sena.

Saliba beda l-istudji tieghu fil-Kullegg ta' Flores, ghall ewwel fi Triq San Pawl, il-Belt, u wara fi Triq l-Ifran. Imbghad dahal l-Universita fil-kors tax-xjenza, u baqa hemm sakemm kienet faqqghet il-gwerra l-kbira fis-sena 1914.

Fix-xahar ta' Settembru 1909 f'Malta kienet twaqqfet is-Saint John Ambulance Brigade, u fost il-*foundation members* tnejn u tletin b'kollox, hemm isem Carol M. Saliba. Hu l-eqdem u l-uniku membru li ghadu haj.

Ghalkemm Malta u Ghawdex ma kienux imdahhla fil-gwerra, izda kienet rifugju kemm ghall hafna midruba, u sew ghall bosta prigionieri maqbuda tal-ghadu, kienet inhasset il-htiega ta' certa attivita' ohra. Saliba mill-ewwel ivvolontarja jidhol ghas-servizz fil-isptar militari tal-Kottonera, u ghal xi zmien ukoll fil-*Convalescent Camp* ta' Ghajn Tuffieha.

Anqas ma kienet ghada spiccat il-gwerra meta Saliba, imhajjar li jidhol fil-Korp tal-Pulizija, applika u wara ezami irnexxilu fix-xahar ta' Dicembru 1917, jigi accettat. Kemm imhabba l-energija li kellu, u sew ghaliex kien wera sa mill-ewwel jiem fis-servizz dak is-sens ta' dixxiplina, il-Kummissarju ta' dak iz-zmien, l-ewwel wiehed li beda jissejjah hekk, Claude Wordruff Duncan (1916-1919), hatru Segretarju privat tieghu.

Imbghad wara baghtuh Spettur iz-Zurrieg, tac-*"C"* Division, u kien ikollu jlahhaq ma' bosta



rhula fil-qrib.

Nhar is-Sibt, 9 ta' Lulju 1926, fil-hemda tal-kampanja kienet instemghet spuluzjoni kbira, li gabet maghha biza kbir fir-rhula. Kienet spoldiet il-kamra tan-nar gewwa Hal-Lew, fl-inhawi tal-Qrendi, waqt li kienu qeghdin jahdmu n-nar ghall festa tal-Madonna tal-Karmnu. B'kollox disgha minn nies kienu gewwa dik il-fabbrika, u bl-espluzjoni iggarraf hajt mid-dar, u waqa s-saqaf tal-kamra t'isfel, bir-rizultat li dawk il-haddiema li kienu qed jahdmu hemm sfaw mirduma u korruti serjament. Il-mejtin kienu Indri Magro ta' 17 il sena, Guzepp Agius ta' 45 sena, Indri Camilleri ta' 22 sena, u Salvu Magro ta' 19-il sena. L-ohrajn kienu salvaw tassew b'miraklu. Il-Magistrat tal-ghassa, Dr. Lewis Camilleri (aktar tard Prim Imhallef u Sir), ghamel l-access fuq il-post. Ix-xoghol li ghamel l-Ispejter Saliba flimkien mal-pulizija tieghu, mhux biss gie imfahhar mill Qorti, imma fil-gurnali wkoll. Fost l-ohrajn intqal ghas-sur Saliba li hu *fearlessly and regardless of personal danger* dahlu fin-nirien, qalb mijiet ta' xoghol tan-nar li kien ghadu ma lahaqx in-nar (*Daily Malta Chronicle*, 16.VII.1926 u *Times of Malta u Progress*, 23.VII.1926).

Il-Kummissarju Major F. Stivala semma x-xoghol fejjiedi ta' Carol Saliba fir-rapport annwali tal-Korp tal-Pulizija (*Malta Government Gazette* 18.XI.1927):

Ix-xoghol u l-hajja ta' pulizija, hu ta' liema rank hu, isir qisu mekkuk, ghaliex filli jkun il-Belt, u filli jsib ruhu f'xi rahal, jew Ghawdex. Din is-sistema kienet ukoll incentiv tajjeb ghaliex il-pulizija mhux biss ikun jaf id-

distrett tieghu biss, izda biex jak-kumula esperjenza tal-varjeta' tal-hajja socjali li jezistu fl-irhula u fl-ibliet. Nghiduha kif inhi, kull rahal f'Malta u Ghawdex, ghandu speci-ta' karatteristika ghaliex.

Mal-milja taz-zmien, mhux dejjem kienet apprezzata l-karriera jew il-hidma ta' pulizija. Min jaf ghaliex? Meta qisu kullhadd ikun qieghed id-dar, minbarra minn dawk li jkun jridu jipproffittaw ruhhom mid-dlam u mill-hemda tal-lejl. il-pjantun ikun fl-ghassa jisghar, qisu jistenna bhal ruh tal-purgatorju, cempila, jew zjara minn xi hadd, biex jitlob l-ghajnuna.

Fis-sena 1931 Saliba gie moghti l-*King's Medal*, li hi l-aqwa dekorazzjoni li jista' jkollu pulizija, dak iz-zmien. Fiz-zewg *despatches* (Nru. 221/1929) li waslu Malta minn ghand is-Segretarju tal-Istat tal-Ingilterra, hemm miktub dan dwar Carol M. Saliba' gie moghti dan l-*award* ghall *exceptional services rendered*. Sa fejn nafu ahna, Saliba huwa l-uniku wiehed li ghandu din id-dekorazzjoni.

Ghadta z-zmien u Saliba bil-vokazzjoni shiha u bid-devozzjoni li kellu (u ghad ghandu) ghall karriera tieghu fil-Korp tal-Pulizija, meta faqqghet il-gwerra kien qieghed jaqdi dmirijietu fil-Birgu, inhawi l-aktar li garbru u raw il-qilla tal-ghadu, il-Kottonera. Fl-ghassa tal-Birgu, daqsxejn ta' dar hdejn il-*Couvre Port*, Saliba irnexxilu imexxi t-tmun, jilhaq ma' kollox sahsitra jaghmiha ta' sagristan jghin lill Dun Pawl Galea, fuq artal li kien hejjilu gewwa l-ghassa, ghal dawk li tilfu djarhom fil-qrib. Zguri li f'ebda inhawi ohra tal-gzira ma kien hemm daqshekk hidma tal-ghadu. Saliba u n-nies tieghu, hekk kif jisimgu t-tnewwieh tas-sirena, kienu johorgu qabel jib-dew nezhin il-bombi lejn it-tarzna u l-inhawi, biex imbghad imorru jigru fuq il-post jaghtu l-ghajnuna kollha, fil-Birgu, f'Bormla, u fl-Isla. Fil-Gazzetta tal-Gvern Nru. 410, bid-data 2 ta' Awissu 1940, Saliba gie gazzetted ghal *exceptional meritorious service in life saving and attending to the injured* waqt l-ehrex attackki mill-ajru.

L-aktar li Saliba u l-pulizija tieghu kienu taw servizz kien

RICHARD MORE O'FERALL  
U RIORGANIZZAZZJONI  
TAL-KORP TAL-PULIZIJA  
(1849-1850)**

Mitt sena ilu, f'Balya, fil "county" ta' Enfield, fl-Irlanda, miet Sir Richard More O'Ferrall (1), li kien Gvernatur Civili ta' Malta bejn Dicembru 1847 u Mejju 1851 (2).

Sir Richard, li kien Kattoliku u Irlandiz gie mahtur bhala l-ewwel Gvernatur Civili ta' Malta, permezz ta' "Royal Commission" bid-data tas-27 t' Ottubru 1847. Huwa wasal Malta fis-17 ta' Dicembru ta' l-istess sena u kellu laqgħa sabiha. Dakinhar stess saret ic-cerimonja tas-soltu fil-palazz. Inqrat ir-"Royal Commission" u wara l-Gvernatur ha l-gurament u b'hekk ha f'idejh l-Amministrazzjoni civili ta' d awn il-Gzejjer (3).

Il-karatteristici principali ta' l-amministrazzjoni tieghu kienu, (a) ir-riformi li għamel f'diversi oqsma (b) ix-xogħlijiet pubbliċi li saru u (c) l-opposizzjoni li sab minn diversi oqsma li wasslitu biex jirrizenja. Fost ir-riformi li għamel insibu r-riorganizzazzjoni tal-korp tal-pulizija, li b'diet taħdem fl-1 ta' Jannar 1850.

### **Il-Korp tal-Pulizija**

Minn ittra bid-data tas-7 ta' Mejju 1849, li O'Ferrall bagħat lil Earl Grey li f'dak iz-zmien kien is-Segretarju ta' l-Istat għall-kolonji, nafu li f'dak iz-zmien il-korp tal-pulizija kien magħmul minn 61 ufficċjal u 159 kuntistabbli u l-ispiza annwali f'salarji biss kienet titla għal £6,848 (4).

Minn rapport li O'Ferrall bagħat ma l-istess ittra, nafu wkoll kif kien imqassam ezatt "l-establishment" tal-pulizija fl-1848 (5). It-tmexxija tal-korp f'Malta kienet f'idejn Spettur li kellu salarju ta' £430 fis-sena, filwaqt li t-tmexxija tal-korp f'Għawdex, kienet f'idejn Spettur għal Għawdex li kellu salarju ta' £340 fis-sena (6). L-Ispettur fl-1848 kien is-Sur Fredrick Sedley, filwaqt li l-Ispettur għal Għawdex kien il-Logotenent Kurunell C.A. Bayley, C.M.G. (7).

Ix-xogħol klerikali tal-korp kien f'idejn numru ta' skrivani. Kien hemm hames skrivani fl-ufficċju ta' l-Ispettur li kellhom salarji ta' bejn £40 u £150 fis-sena u skrivan f'Għawdex b'salarju ta' £50 fis-sena. Kien hemm ukoll skrivan fis-suq tal-belt b'salarju ta' £100 fis-sena, u iehor fis-suq tal-Kottonera b'salarju ta' £60 fis-sena. Il-korp kellu wkoll zewg messaggjiera b'salarju ta' £30 fis-sena. Dawn l-iskrivani u l-messaggjiera kienu meqjusa bhala parti mill "establishment" tal-pulizija.

Il-korp tal-pulizija propju kien magħmula minn, l-ewwel ajjutant li kellu salarju ta' £215 fis-sena, ajjutant għall-Kottonera b'salarju ta' £130 fis-sena, u seba ajjutanti għall-kampanja b'salarju ta' £50 fis-sena u £10 "allowance" fis-sena għaz-ziemel.

Il-korp kellu wkoll tliet surgenti magguri b'salarju ta' £45 fis-sena, u tletin surgent b'salarju ta' £36 fis-sena. In-numru ta' kuntistabblijiet kien ta' 145 u dawn kellhom salarju ta' £20. Dawn l-ufficċjali u kuntastabblijiet kienu koll stazzjonati f'Malta.

F'Għawdex barra mill-Ispettur u skrivan, kien hemm ajjutant b'salarju ta' £70 u £10 "allowance" għaz-ziemel, zewg ajjutanti b'salarju ta' £36 fis-sena, erba surgenti b'salarju ta' £26 fis-sena, u 14 il-kuntistabbli b'salarju ta' £18 fis-sena. Kif wiehed jista jinnota s-salarju tas-surgenti u tal-kuntistabbli f'Għawdex kien inqas minn dak ta' Malta (8).

### **Proposta u Skema Biex Issir Riorganizzazzjoni 1849**

Kien fis-7 ta' Mejju 1849 li O'Ferrall kiteb lil Grey u talab il-kunsens tieghu biex issir riorganizzazzjoni tal-korp tal-pulizija. Flimkien ma l-ittra, O'Ferrall bagħat ukoll skema tar-riorganizzazzjoni.

Fl-ittra O'Ferrall nforma lil

Grey li l-korp tal-pulizija fl-Ingilterra kien ittiehed bhala l-bazi ta' din ir-riorganizzazzjoni, li l-karatteristici principali tagħha kienu se jkunu dawn:-

- a. tnaqqis fin-numru ta' ufficċjali
- b. zieda fin-numru ta' kuntistabbli li kellhom jinqasmu fi tliet gradi
- c. l-istess paga għal min iservi f'Malta jew Għawdex
- d. tnaqqis ta' zewg skrivani u zieda zghira fil-paga tat-tlieta l-ohra
- e. It-trasferiment mill-korp tal-harsien u l-manteniment tal-habsin, u tal-kuntratti għax-xiri ta' l-ilbies.

Il-Gvernatur fisser ukoll lil Grey il-vantaggi ta' din ir-riorganizzazzjoni. Biha kien se jkun hemm opportunitajiet izjed għal "promotions", u din kellha sservi bhala ncentiv biex wiehed jahdem izjed, u kull min jidhol fil-korp bhala kuntistabbli, seta jibqa tiela u jilhaq spettur. B'hekk O'Ferrall kien jittama li nies ta' klassi ahjar kienu jithajjru jidhlu fil-korp.

O'Ferrall nforma wkoll lil Grey li kienet mehtiega zieda fin-numru ta' kuntistabbli, minhabba zewg ragunijiet. L-ewwelnett għax kienet zdiendet il-popolazzjoni, minn mindu l-korp kien ha f'idejh id-dmirijiet ta' pulizija li qabel kienu f'idejn ir-regiment Malti, u t-tieni mibhabba z-zieda fin-numru ta' strangieri f'Malta.

Bir-riorganizzazzjoni li kien qiegħed jipproponi O'Ferrall, il-korp li f'dak iz-zmien kien jikkonsisti f'61 ufficċjali u 159 kuntistabbli, total ta' 220 ruh, kellu bir-riorganizzazzjoni jibda jikkonsisti fi 38 ufficċjal (tnaqqis ta' 23) u 184 kuntistabbli (zieda ta' 25) li b'kollox kienu jgibu total ta' 222 ruh (9).

Skond l-iskema tar-riorganizzazzjoni li bagħat il-Gvernatur il-korp kellu jkun maqsum hekk.

L-ispiza annwali f'salarji b'din ir-riorganizzazzjoni kienet se tkun ta' £7,297 (10). Fl-aħhar ta' l-ittra tiegħu (7.v.1849) O'Ferrall talab lil Grey biex japprova din ir-riorganizzazzjoni, sabiex setgħet tigi mdahhla fl-estimi ta' l-1850 (11).

**Tibda Tahdem ir-Riorganizzazzjoni**

Għalkemm ma gietx f'idejja r-risposta ta' Grey, m'hemm l-ebda dubju li din ir-riorganizzazzjoni fil-parti l-kbira tagħha giet approvata u ta' dan għandna zewg provi. L-ewwelnett meta f'Ottubru 1849, il-Gvern ippublika fil-gazzetta tiegħu "Abstract of the sums required to defray the expenses of the Colonial Govt. of Malta for the year 1st Jan.-31st Dec. 1850", taht l-"item", "Police, including Prisons and Goals", insibu l-korp imnizzel skond l-iskema tar-riorganizzazzjoni proposta minn O'Ferrall, bl-eccezzjoni ta' xi tnaqqis fis-salarji tas-Supretendent, tas-Supretendent għal Għawdex u l-Ajġutant (12), u billi dan l-"item" kien jinkludi wkoll il-habs, l-ispiza kienet stmata li se tilhaq is-somma ta' £7,443 9s. 8d. (13).

Skond l-istess avviz, bir-riorganizzazzjoni l-korp kellu jkun imqassam hekk: Ajġutant, 4 spetturi, 4 sotto spetturi, 7 surgenti ta' l-ewwel klassi, 13 il-surgent tat-tieni klassi, 27 kuntistabbli ta' l-ewwel klassi, 88 kuntistabbli tat-tieni klassi u 69 kuntistabbli tat-tielet klassi (14). Jekk wicħed iqabbel dawn il-figuri ma l-iskema li O'Ferrall kien bagħat lil Grey, malajr jinduna li l-imsem-mija skema kienet giet accettata.

Izda fl-istess avviz kien hemm ukoll tagħrif dwar il-pagi, il-kundizzjonijiet biex wicħed jidhol fil-korp, u l-kundizzjonijiet għall-promozzjonijiet u tkeccija mill-korp li kienu dawn li gejjin.

- kull min jidhol fil-korp, kellu jidhol fit-tielet klassi (jigifieri bhala kuntistabbli)
- il-promozzjonijiet kellhom isiru skond il-mertu

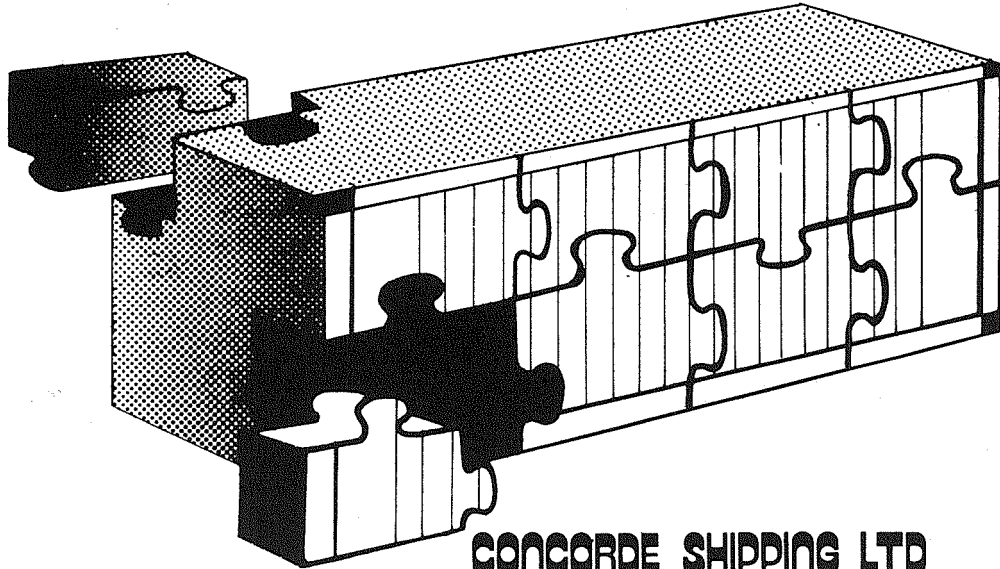

- kull min ried jidhol fil-korp kellu jipprezenta certifikat magħmul minn zewg "householders", dwar il-karattru tiegħu, u certifikat tat-tabib tal-pulizija dwar is-sahha tiegħu
- kull min ried jidhol fil-korp, kellu jkollu tul ta' mhux inqas minn hames piedi u hames pulzjeri
- fost dawk li riedu jidhlu fil-korp, kellha tinghata preferenza lil dawk li kienu jafru jaqraw u jiktbu bl-Ingliż u bit-Taljan
- hadd ma seta jiehu promozzjoni mill-grad ta' kuntistabbli tat-tielet klassi, jekk ma jkun jaf jaqra u jikteb bit-Taljan.
- il-kap seta jkecci mill-korp, wara li jkun kiseb l-approvazzjoni, xi membru wara li jkun gew stabbiliti r-rapporti kontrih (15).

## STRESS AND THE POLICE

*Stress is known to be a medical problem in many occupations. Little is known about its effects on the Police.*

"Most of the police officers who were actually engaged in removing the passengers from the plane were affected to some degree by shock, amnesia and a prolonged sense of frustration. Two of the officers who were in the centre of the rescue operations and who did magnificent work, experienced a deep sense of frustration at having to watch persons who were appealing for help, burn to death because of the utter impossibility of further approach. One officer, a week later, could not remember what sort of rescue operations he had undertaken. Another officer absented himself from duty three days after the event without any given reason and at a later stage, whilst on duty, had to be taken home. At the scene, both policemen and others who had been unable to rescue further persons, and who were confronted with a child and others who could not be rescued because of fire, simply sat down dejectedly and wept."

*(extract from the report on the Stockport Air Disaster, 1967)*

Crises are the business of the police. Each one, no matter how small or seemingly unimportant creates stress. All crises, no matter how many times they are faced, produce stress; in fact there is good evidence to show that successive crises produce a cumulative effect. In other words, when an officer faces a messy car accident, the memory of it doesn't go away, but it is added to the battered child found a month later, and a knifing after that. Stress affects all physical objects — a wire stretches only so far, then it breaks; a bridge takes only so much stress so marchers have to walk out of step across it; human beings can be put under so much pressure and then their minds change and break, except that human beings can be very adept at hiding the effects of this breakage. This article intends to outline some of the stress police officers face and what happens when it becomes too much to bear.

First it should be made clear that at present there is no helping procedure within the force that

doesn't deteriorate into some form of disciplinary and/or dismissal action. There is a post in most forces called the 'Welfare Officer', but the duties are ill-defined. No special training is required to hold the post. What is worse, many senior officers adopt the attitude that crisis reactions in an officer are signs of personal weakness.

A young officer ran into a burning house and rescued two children but was forced to stand helplessly by as two other children died screaming. He received an award for bravery. But it was months before he could admit to having recurring nightmares of children screaming and then no help was given by his department, rather he was admitted to a mental hospital and as a direct result was retired from the police service on medical grounds.

Having determined that all physical objects suffer from stress, how is it that we expect the police officer 'to be human yet inhuman'? "We employ him to administer the law and yet ask him to waive it. We resent him when he enforces the law in our own case, yet demand his dismissal when he does not elsewhere. We offer him bribes, yet denounce his corruption. We expect him to be a member of society, yet not share its values."

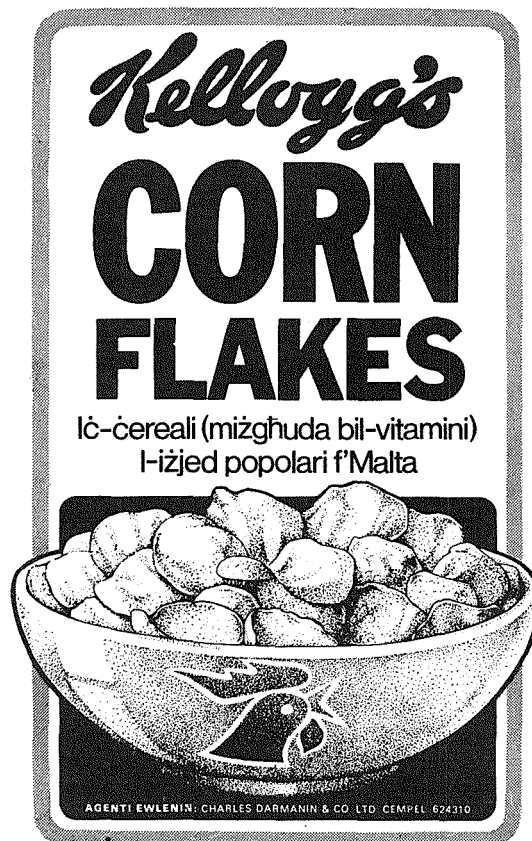
A policeman's job is not an ideal one for domestic bliss, not even for maintaining steady relationships. Hours of duty are disruptive to the household; often the husband may see little of his children, leaving his wife to carry out the larger share of the parenting. Some men try to compensate for this by buying luxuries to please their wives, and this can lead to financial hardship and further stress. The woman officer has even more hurdles to overcome. It is a rare Englishman who can accept his woman as being strong, competent and self-supporting. She is not the least susceptible to his best methods of 'chatting up' and she treats him as an equal. The Swedish man may be able to comprehend such a female, but the Englishman — not to mention an English husband — finds the prospect quite daunting. Many women officers soon discover they cannot go against the cultural values placed upon them since childhood, and quit the force to return to a 'normal' female status. If a marriage or close relationship is to last, then the partner must learn to live with a person who is reluctant to discuss his work, sometimes openly refusing to speak of happenings which have obviously affected him greatly.

Minn dan wiehed jista jikkonkludi li t-tfal jimitaw l-aggressjoni mill-ewwel u jaccettawha bhala alternattiva ghal impiegba tajba fl-ohrajn.

Wiehed ghandu jahseb li l-esperjenza li tghaddi minnha meta tkun ikkastigat isservi ta' deterrent biex iggib ruhhek tajjeb. Izda kemm l-istudju kif ukoll dawk li josservaw l-affarijiet fin-natura taghhom li jahsbu mod iehor. Sar maghruf li t-tfal li jkunu kkritikati u kkastigati bil-fomm ghandhom tendenzi li jaghmlu l-istess ma haddiehor. Izda l-forma ta' kastig mhuwiex fattur ewlieni li fuqu wiehed ghandu jiehu eżempju tajjeb. Biex wiehed ikun jista jifhem ahjar dan il-konflikt fl-idejat huwa mportanti li jirrealizza li l-bniedem adult jagħraf jgħix u jgib ruhhu fid-dinja skond l-ideja li huwa nnifsu jkollu tad-dinja. Allura jekk tifel jgħix f'ambjent

ostili u vjolenti iħares lejn id-dinja bhala post fejn il-vjolenza u l-ostilità mhux biss mħumex accettabbli, izda li huma affarijiet logici u naturali. Mill-banda l-ohra tifel li jkun imtella f'certu mħabba u ambjent socjali tajjeb, anki jekk forsi xi drabi jkun ikkastigat jew espost għal atti vjolenti, jista jemmen fil-vjolenza bhala mezz ta' azzjoni li jista jiehu, izda hemm cans kbir li jgħix fl-ambjent tajjeb bħalma fih kien trabba. Minn studji li saru fuq tfal aggressivi u zghazagh delinkwenti instab li l-kastigi li dawn kienu jingħataw kienu dejjem jikkonsistu fi tbatija fizika. Mas-swat kien ikun hemm fatturi ohra li jinfluenzaw lill-ulied, bhal nuqqas ta' mħabba mill-genituri lejhom, glied bejn il-genituri u tgergir u nuqqas ta' qbil fil-hajja mizzewwga. 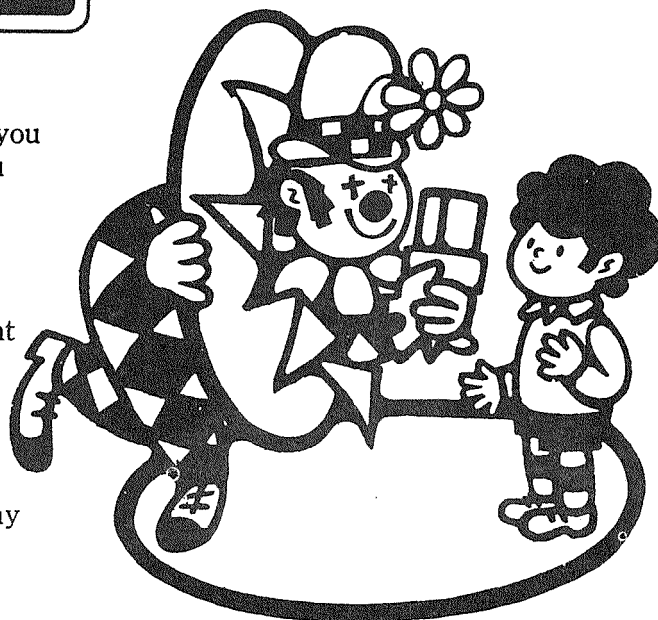

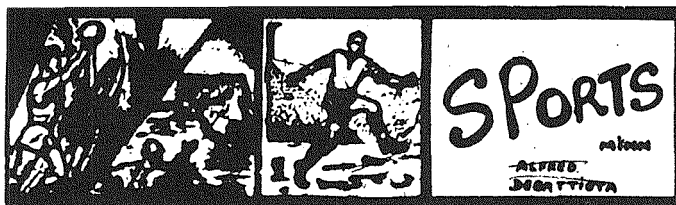

Għaddiet il-gwerra, izda qatt minsija minn min għexa, u lil Saliba tawh l-*Africa Star*, id-*Defence Medal*, u l-*Victory Medal*, midalji li hu jgħozz b'devozzjoni.

L-aktar li Saliba u l-pulizija tieghu kienu taw servizz kien fil-lejl tat-30 ta' April 1941, meta l-għadu għamel l-aqwa herba f'dawk l-inhawi.

Bejn is-snin 1944 u 1948 Saliba kien għaqquad u gabar dwar mitejn pulizija u ranks ohra biex jiffirma l-*Police Ambulance Corp*, li kull pulizija għandu jkollu hjiel ta' l-ewwel għajnuna billi hu jista jkun minn ta' l-ewwel fuq il-post ta' xi disgrazzja.

Wara 31 sena Saliba irtira mis-servizz.

B'danakollu, dan ma jfissirx li waqaf minn kull attività; fix-xahar ta' Jannar 1949, organizza n-*No. 1 Ambulance Corp* tal-Belt, li fihom kienu jagħmlu wkoll il-Furjana, il-Hamrun, il-Marsa, Hal-Qormi, Birkirkara, Hal-Balzan, Hal-Lija, u H'Attard. U fis-sena 1953 kien mexxa l-kontingent Malti għal *Coronation parade* tar-Regina, f'Londra, meta kien qed jagħmel public duty man-*No. 1 Prince of Wales District*.

Tliet snin wara, 1956, Saliba lahaq *Principal Staff Officer* għall-amministrazzjoni fil-HQ tal-*Brigade*, u għadu sal-lum, jinzal ta' kull fil-ghodu, xiwa jew sajj, biex min jistaqsi għall-għajnuna, jilqa l-vizitaturi, u jitma l-qtates, isibu hemm dejjem lest, karitattiv u hanin, u bi kliem ta' merħba.

Ma semmejtx il-kazi dwar delitti li għalihom kien respon-sabbli li qabad, u l-hati ingab quddiem il-gustizzja.
