

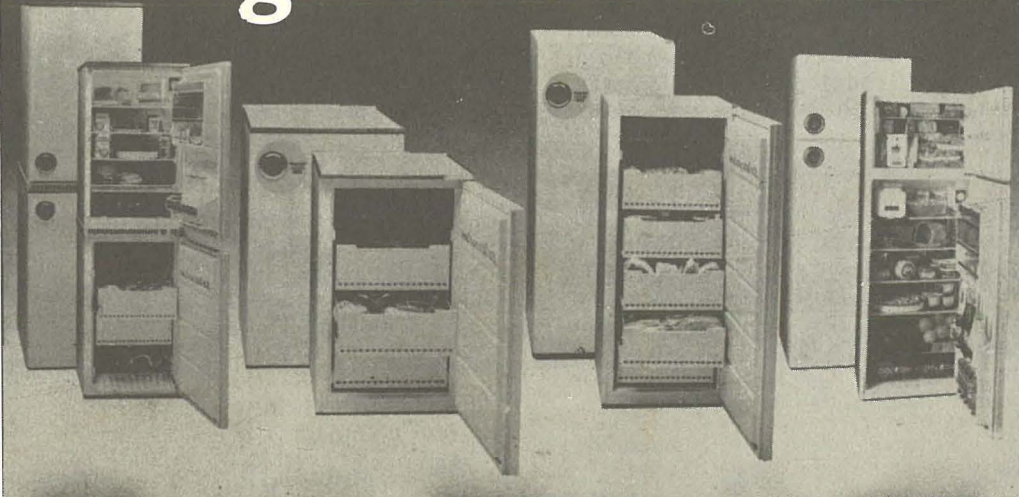

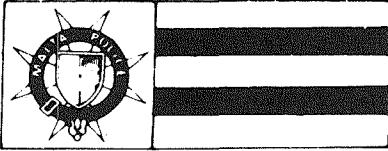

A Citation relating to this event is also being presented to P.C. Micallef.

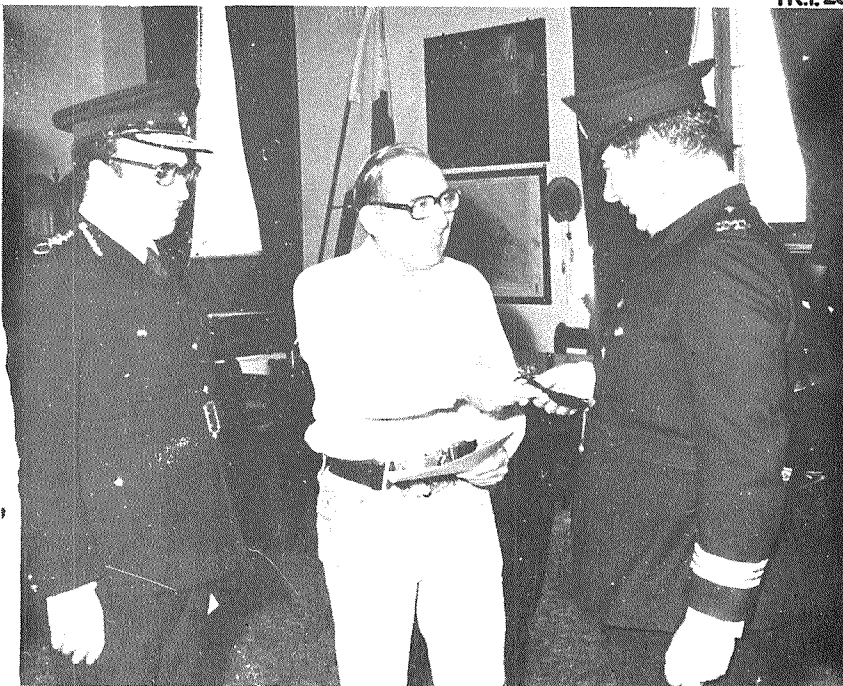
This certainly shows to every member of the Force official attitude towards the proper performance of duty and the Government's appreciation of such act and bravery.

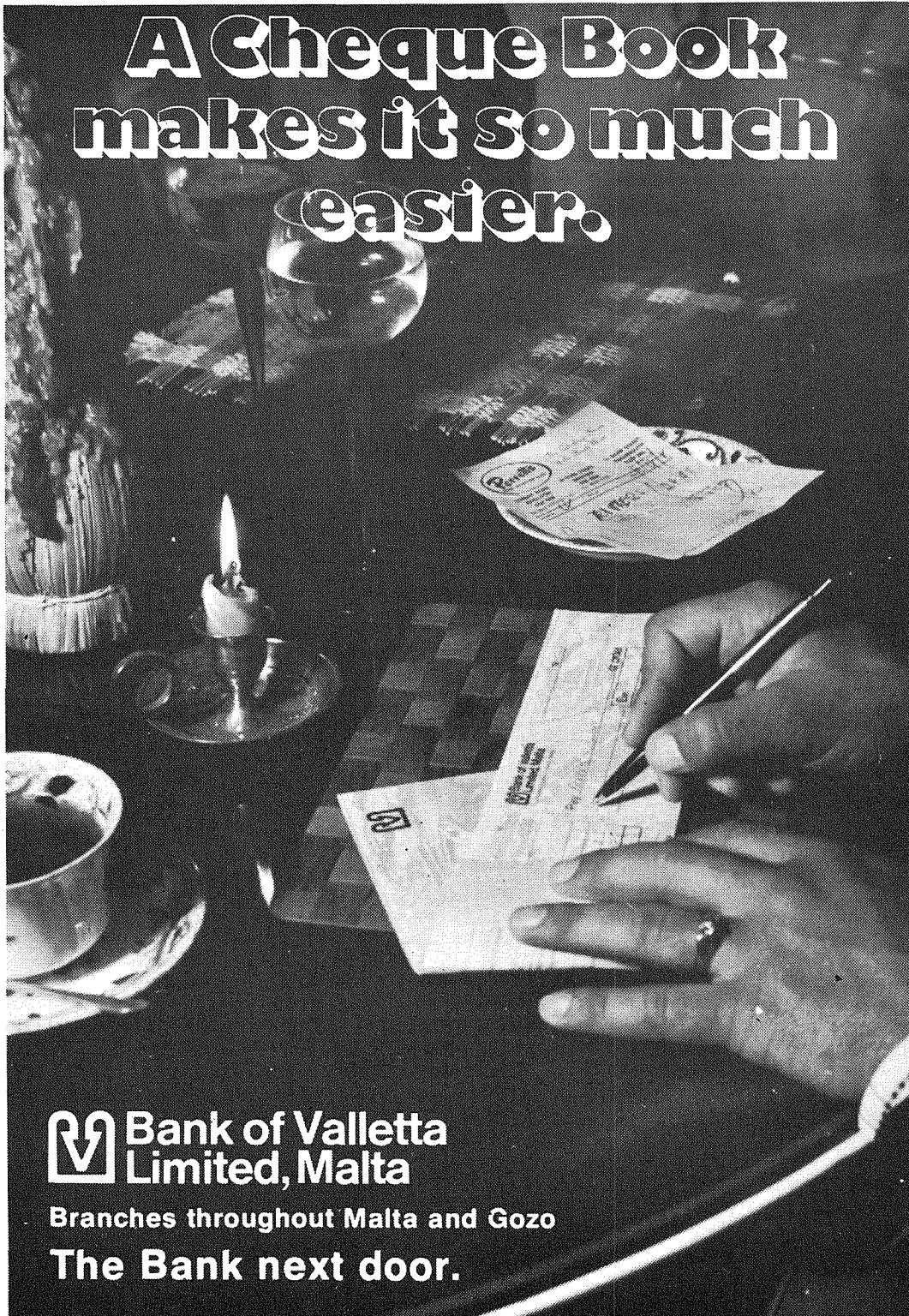

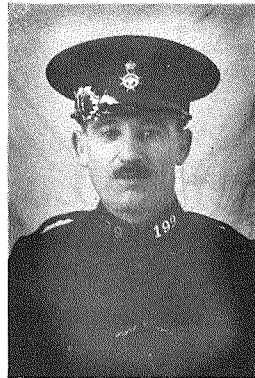

POLICE AND THE PUBLIC PART 2

Basic Obligations

A profession is that occupational group which practices its skills with the following basic obligations:

1. A duty to serve mankind generally rather than self, individuals, or groups.

2. A duty to prepare as fully as practicable for service before entering active practice.

3. A duty to work continually to improve skills by all means available and to freely communicate professional information gained.

4. A duty to employ full skill at all times regardless of considerations of personal gain, comfort, or safety, and at all times to assist fellow professionals upon demand.

5. A duty to regulate practice by the franchising of practitioners, setting the highest practicable intellectual and technical minimums: to accept and upgrade fellow professionals solely upon considerations of merit; and to be constantly alert to protect society from fraudulent, substandard or unethical practice through ready and swift disfranchisement.

6. A duty to zealously guard the honour of the profession by living exemplary lives publicly and privately, recognising that injury to a group serving society injures society.

7. A duty to give constant attention to the improvement of self-discipline, recognising that the individual must be the master of himself to be the servant of others.

By these standards it is clear that police work is not a profession. While tremendous strides have been made in late years towards improving its technology and further strides may develop a science of law enforcement, it must be borne in mind that the terms "science" and "profession" are not synonymous. For example, the fact that a science of medicine exists does not guarantee professional application of its principles. Professionalism is a subjective concept, concerned with the philosophy that directs the application of the body of knowledge. For this reason practi-

cal policemen must recognise that philosophy is a practical thing, not the exclusive possession of dreamers and theorists. If professionalism is to be achieved, policemen must concern themselves as much with police philosophy as with police techniques.

At least one question remains: should police work be a profession? A report from the National Occupation Council states: "The entire governmental structure is built upon a foundation of law and order, which, in turn, is entirely dependent upon efficient and honest police administration". In other words, order is dependent upon law, and law is dependent upon enforcement. If this is true, police work has deep significance.

Woodrow Wilson, commenting upon the place of policemen in society, characterised their obligations if he considers himself mere contracted labor with freedom to prefer private advantage to public welfare.

Few will disagree that society needs honest and efficient law enforcement of the highest type. Few will disagree that police work could attain a position equal with the most respected occupations if sincere and devoted effort were directed toward that goal. It is possible that this can be accomplished if the policeman feels pride in his place in the scheme of things.

Basic Characteristics

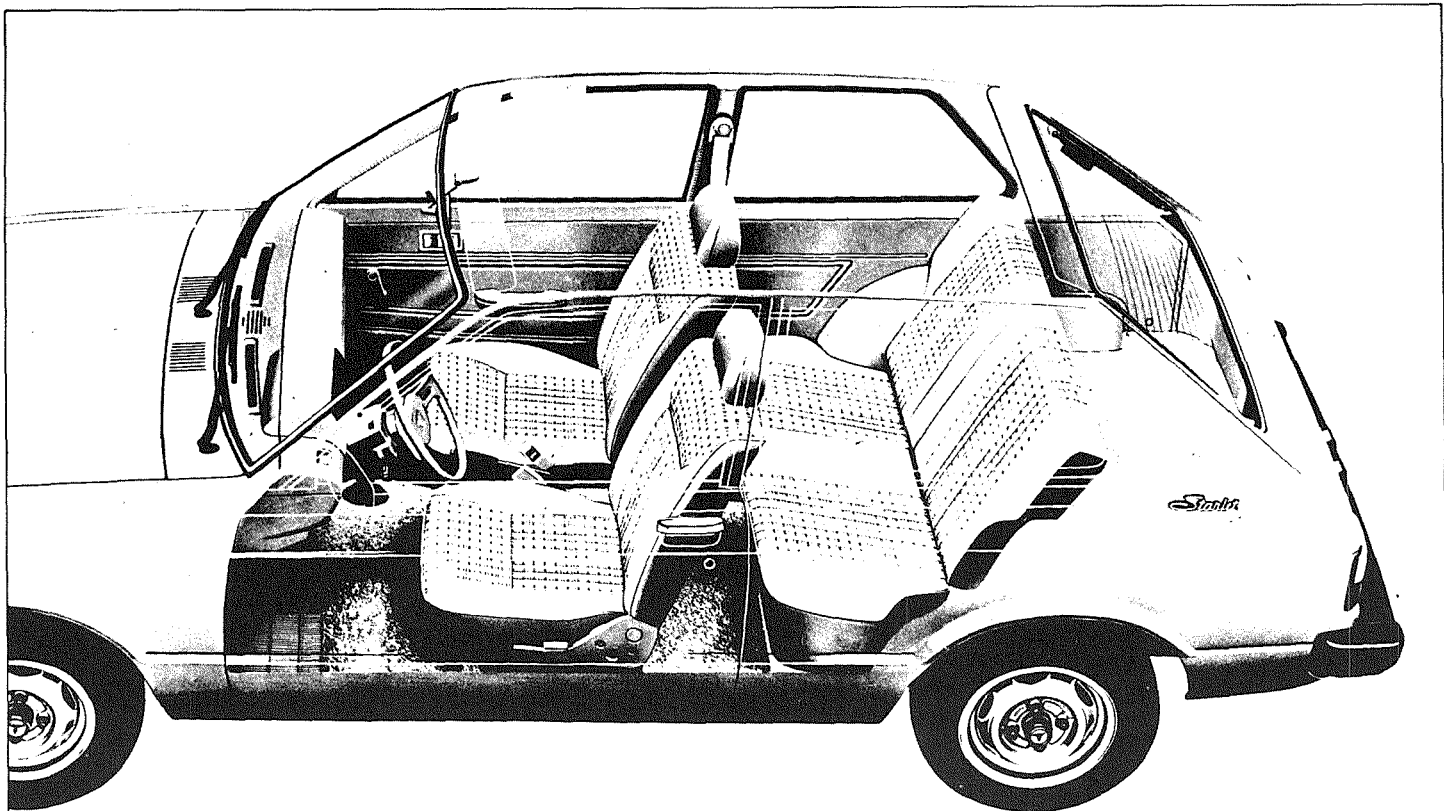
It is a natural inclination for homogenous groups to desire "professional" status — acceptance by others of their occupation as one with social standing. But professionalism carries with it certain characteristics as well as responsibilities. Some distinguishing characteristics of a professional group are: (1) a common fund of knowledge; (2) certain standards or qualifications based on character, training, and competency required for admission to the profession; (3) certain standards of conduct required with respect to relations with others in the profession and with the public, based upon courtesy, honour, and ethics; (4) constructive interest in the selection, training, and ap-

prenticeship of candidates for the profession; and (5) an organisation, formal or informal, based primarily on common interest and public duty.

Organisations

A number of organisations growing up within the police field have achieved professional status or are tending toward it. It is good policy for police officials and others in municipal government to support these organisations not only by according them recognition and encouraging their activities, but also by helping them to recognise and accept the responsibilities of professionalism. Although there are upward of one-half million law enforcement officers in this country, there is no one group that brings them all together as in England. Instead, there are numerous separate bodies, each devoted to a single segment of the police field. Among these are the International Association of Chiefs of Police, the International Association of Identification, and the Associated Police Communications Officers. In addition some state groups such as the Women Peace Officers Association of California are considered professional groups.

The objects of the International Association of Chiefs of Police are to advance the science and art of police administration and crime prevention, to develop and disseminate improved administrative and technical practices and promote their use in police work, to foster police co-operation and exchange of information and experience among police administrators throughout the world, to bring about enlistment and training in the police profession of qualified persons, and to encourage adherence of all police officers to high professional standards of conduct. Membership is open to national, state, provincial, county, and municipal police officials with command responsibilities. Associate membership is open for persons qualified by training and experience in police, or other law enforcement activity, or by other professional attainments in police science of administration. erves as a clearing-house of information relating to police administration and current activities in the field, publishes a monthly journal (**The Police Chief**), the **Police Yearbook**, bulletins on police subjects, and a directory of law enforcement officers. It also conducts an annual conference.

The International Association for Identification has a membership of police officials in charge of fingerprint and identification bureaus — specialists in fingerprints, ballistics, toxicology, microscopy, handwriting, and other phases of the science of identification. It co-operates with the Federal Bureau of Investigation, the International Association of Chiefs of Police, and state bureaus of identification. A newsletter is issued monthly, and a year book also is published.

The purpose of the Associated Police Communications Officers is to foster the development and progress of the art of police communication and intercommunication and to promote, through example and active effort, greater co-operation in the correlation of the work and activities of town, city, county, state, and federal law enforcement agencies.

Police Ethics*

The good reputation that police service bears with the public is built on favourable public relationships and is expressed by public confidence in the continued constructive accomplishments of the service. Consistent progress in police service is possible only when the internal strength of the organisation is assured. There must be high morale among the members of the service reflected in their esprit de corps and springing from their genuine loyalty and faith in the policies and objectives of their organisation. There must be a conscious effort on the part of each and every member of the service to so conduct both his official and private life that he will inspire the confidence and trust of the public.

The public demands of its servants more exacting and exemplary conduct than it expects of private citizens. It is an inescapable fact that a public official has little private life; as soon as he enters public service and so long as he remains therein his

conduct, whether on or off duty, will be subjected to the unrelenting scrutiny and critical analysis of the public he serves. The agents of law enforcement by reason of their specific responsibilities are bound to a more exacting code than any other public servant. Delinquencies may pass unchallenged when committed by other public officials. Certain conduct of citizens is accepted as commonplace. But such delinquencies and conduct are adjudged reprehensible when committed by policemen.

The honoured professions long ago recognised the importance of maintaining public confidence in their endeavours and accordingly enacted exacting rules for their membership. Policemen have long been clamouring for public recognition as a professional service, yet for many years little was done to set standards of official conduct for their members. They relied upon departmental rules and regulations to set the pattern for their public relationships.

Some law enforcement agencies put great reliance upon the solemnity of the oath of office or departmental pledge to impel men to exemplary conduct. But the rules and regulations of most police departments relate more to specific techniques and procedures than to the official conduct of officers in their public relationships, and when regulations relating to conduct are found they are usually so specific in character that they lose their influence in shaping general official conduct. Oaths of office and departmental pledges are of necessity brief and are usually too general in substance to serve as a guide to the policeman in shaping his daily relationships with the citizenry.

Code of Professional Ethics

The void resulting from the lack of a clear-cut guide for police conduct was substantially filled in 1955 when a code of ethics was adopted by several police organisations. The code was drafted by a committee of the Peace Officers Research Association of California, edited by a committee of the California Peace Officers Association, and was adopted by both organisations. The code reads as follows: As a Law Enforcement Officer, my fundamen-

tal duty is to serve mankind: to safeguard lives and property; to protect the innocent against deception, the weak against oppression or intimidation, and the peaceful against violence or disorder; and to respect the Constitutional rights of all men to liberty, equality and justice.

I will keep my private life unsullied as an example to all; maintain courageous calm in the face of danger, scorn, or ridicule; develop self-restraint; and be constantly mindful of the welfare of others. Honest in thought and deed in both my personal and official life. I will be exemplary in obeying the laws of the land and the regulations of my department. Whatever I see or hear of a confidential nature or that is confided to me in my official capacity will be kept ever secret unless revelation is necessary in the performance of duty.

I will never act officiously or permit personal feelings, prejudices, animosities, or friendships to influence my decisions. With no compromise for crime and with relentless prosecution of criminals, I will enforce the law courteously and appropriately without fear or favour, malice, or ill will, never employing unnecessary force or violence and never accepting gratuities.

I recognise the badge of my office as a symbol of public faith, and I accept it as a public trust to be held so long as I am true to the ethics of police service. I will constantly strive to achieve these objectives and ideals, dedicating myself before God to my chosen profession, law enforcement.

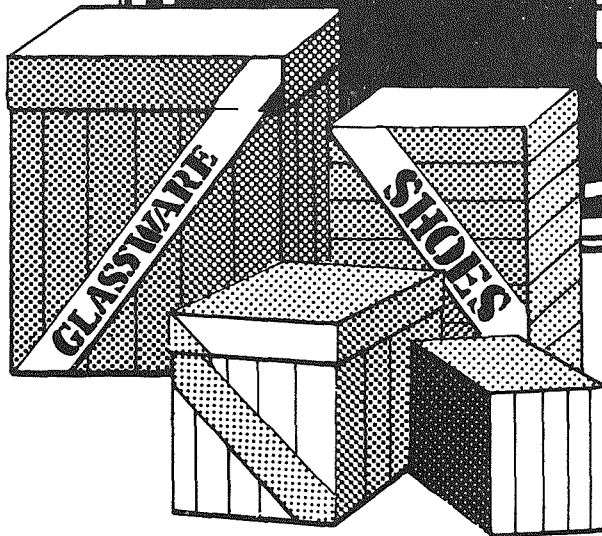

Nistghu nghidu minghajr tlaqliq li f'Malta dawn huma l-aktar drogi li qed jintuzaw, minhabba l-hajja mghagglja tal-lum u allura rridu naghmlu attenzjoni speċjali biex l-uzu ta' dawn id-drogi jservi ta' gid ghal sahhitna u qatt ghall-abbuz bil-hsara li jgib mieghu fis-sahha.

L-Uzu tal-Kalmanti

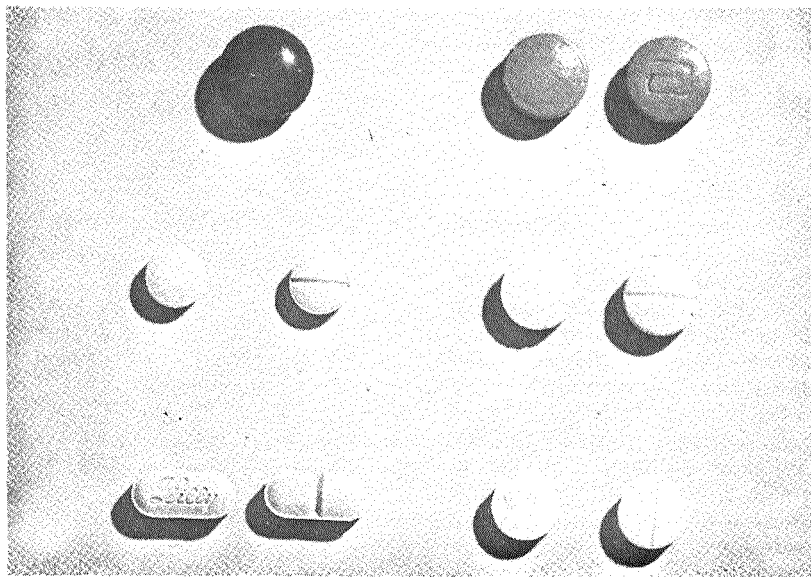
It-tobba minghajr ebda dubju ta' xejn juzaw dawn id-drogi kontra l-ansjeta, nervi, tensjoni u ghal dawk li jbaghtu minn nuqqas ta' rقاد. Meta jintuzaw bil-ghaqal skond il-parir tat-tabib, dawn huma drogi ta' utilita kbira. Izda meta kontra l-parir tat-tabib jittiehdu dozi akbar, dawn id-drogi jikkagunaw stat bhal meta wiehed jisker bl-ispirti.

Kif meta niskru mhux kulhadd juri l-istess sintomi u sinjali, hekk ukoll b'dawn id-drogi. F'dozi zghar dawn id-drogi jikkalmaw il-pazjent u jnisslu stat ta' paci u kwiet u jghinu wkoll biex wiehed jghaddi lejl mistrieh u rieqed. Izda meta jigu abbuzati u aktar u aktar meta jittiehdu max-xorb fil-hwienet u f'kumpannija perikoluza, dawn id-drogi jnisslu tahwid fil-mohh minflok kalma, min-barra l-perikolu tas-sewqan tal-verturi f'dan l-istat.

Meta wiehed id id-doza minn jeddu, bil-mod il-mod jibda jizviluppa tolleranza ghal dawn id-drogi, jigifieri biex ikollu l-istess effett jibda jiehu minn 10 sa 20 darba aktar mid-doza moghtija mit-tabib. F'din id-doza il-margini bejn doza minghajr ebda perikolu, ghal doza li tista twassal ghal mewt jonqos hafna.

Dawn id-drogi, kif ghidna, jistghu jinkisbu permezz ta' ricetti, izda wkoll permezz ta' serq u ta' traffikar illecitu mill-idejn. Dawn l-imsejknin jibdew jiehdu dawn id-drogi biex jikkalmaw in-nervi kagunati minn drogi ohra stimulanti, jew allucinatorji jew narcotici li diga' tkellimna fuqhom f'artikoli ohra. L-aktar li jnisslu sinjali komuni ta' intossikazzjoni mentali u hafna, speċjalment in-nisa, juzaw dawn id-drogi ghas-suwicidju.

Meta jkun hemm intossika-

ment, il-pazjent juri sinjali bhal bniedem fis-sakra, jigifieri jkun mitluf minn sensih, kisah u mxarrab bl-gharaq, bil-polz debboli u mghaggl u jiehu n-nifs bil-mod jew mghaggl imma hafif. Jekk ma tinghatax kura biex il-presjoni ma tkomplex titbaxxa u biex ikun jista jiehu nifs ahjar, il-pazjent jista' jmut.

Meta wiehed ikun dara jiehu dawn id-drogi, jekk iwaqqafhom f'daqqa, juri sinjali li jenhtiegu l-kura tat-tabib u generalment taht sorveljanza kontinwa fi sptar. Il-pazjent ihoosu anzjuz u agitat, jonqsu l-aptit, inhoosu mdardar, jibda jirregetta, qalbu thabbat mghaggl, jibda jxoqq l-gharaq kiesah, taqbd u roghda u ugieghat f'zaqu. Dawn is-sintomi jvarjaw skond id-droga li tkun giet abbuzata, per eżempju:

Minn 2 sa 3 ijiem wara l-waqfien tal-Meproamate u ta' certu barbiturati li jahdmu mal-ajr; minn 7 sa 8 ijiem wara l-waqfien ta' barbiturati li jkolhom effett fit-tul jew id-drogi tal-klassi tal-Benzodiazepines.

Jekk ma tinghatax kura bil-ghaqal, il-pazjent jista' jsofri wkoll konvulzjonijiet bhal morda tal-epilessija. Id-drogi li jnisslu dan kollu jinkludu: Chloral Hydrate, Barbiturati, Glutethimide, Methaqualone, Meproamate, Benzoidizetines.

Il-Chloral Hydrate huwa l-aktar droga antika li kienet tintuza biex il-pazjenti jorqdu fil-paci. Din id-droga giet maghmula fis-sena 1862 u malajr hadet il-post tal-alkohol, tal-oppju u tal-haxixa bhala droga kalmanti u li traqqad. Il-popolarita taghha naqset

hafna malli tfaccaw il-barbiturati. Izda din id-droga ghandha l-istess, rizultati bhal alkohol, jigifieri min jehodha jsir dipendenti minnha kif diga' spjegajna. Din id-droga tinstab bhala kapsoli tal-gelatina u forma ta' mistura biz-zokkor. Kazi ta' intossikament graw meta din id-droga thaltet max-xorb tal-alkohol. Abbuzi ta' din id-droga f'Malta ma iezistux.

Il-Barbiturati kienu l-aktar drogi komuni li t-tobba kienu jaghtu sa ftit zmien ilu. Fil-laboratorji tad-dinja gew maghmula aktar minn 2,500 droga differenti mill-acidu barbituriku, izda minn dawn kollha ghandhom jintuzaw madwar 15 id-droga mit-tobba. F'dozi zghar, dawn id-drogi jikkalmaw in-nervi u f'dozi ftit akbar jikkagunaw irqad minn 20 sa 60 minuta wara li jittiehdu. Bhal ma jigri meta nixorbu, xi pazjenti jhossu eccitament qabel ma jiksbu l-effett kalmanti. Il-barbiturati jinqasmu fi tliet gruppi skond l-effett dejjiemi taghhom.

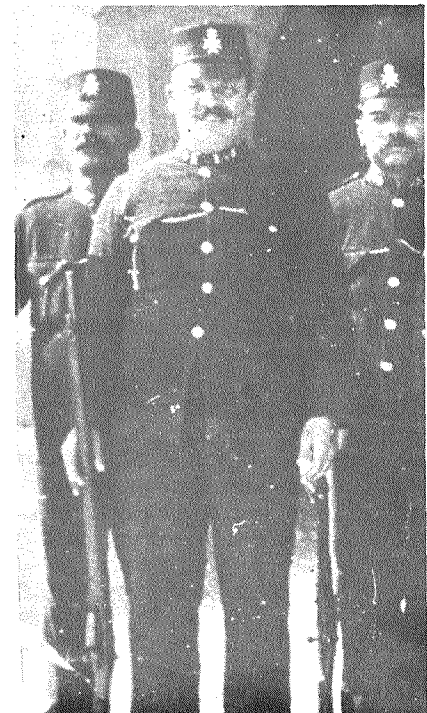

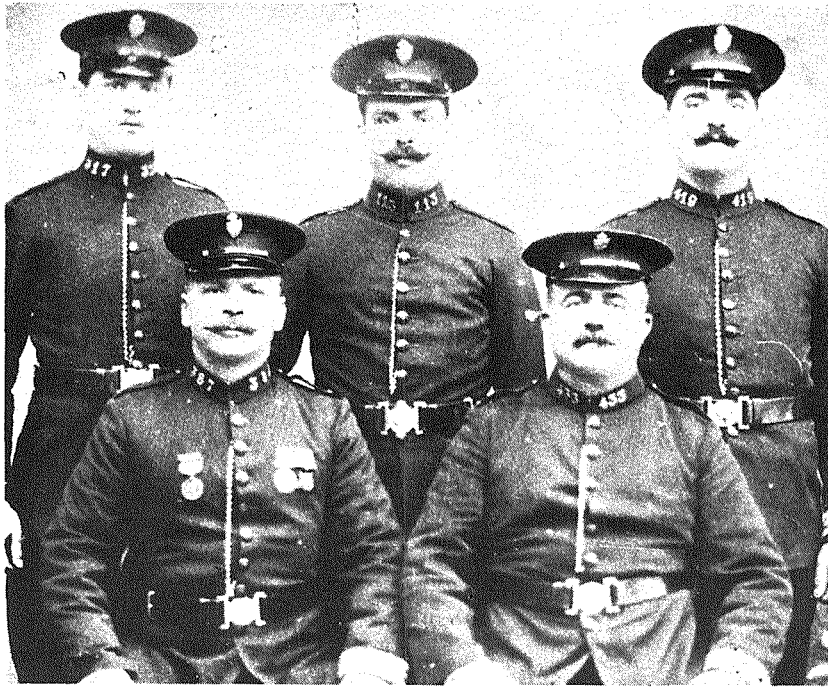

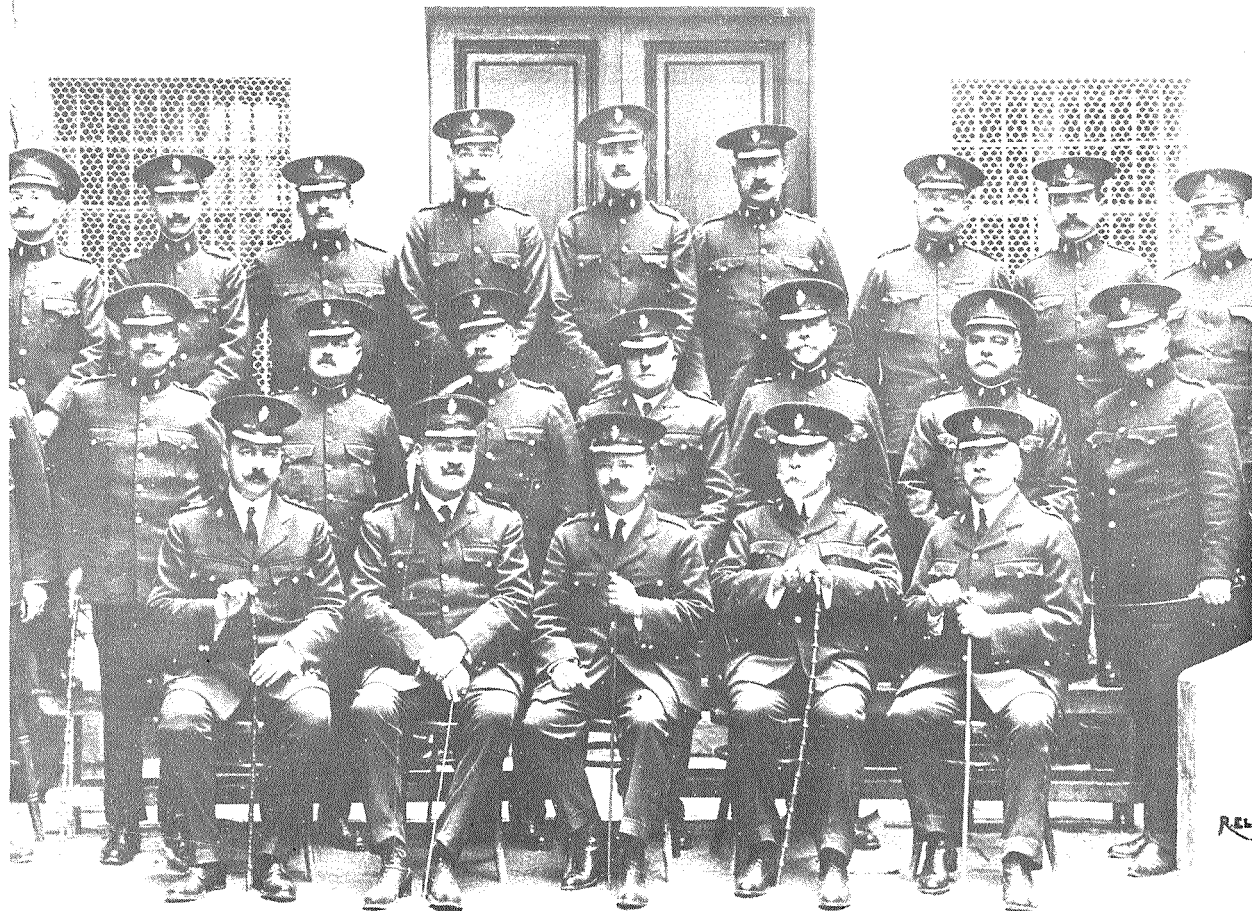
