# L-Akbar Party ghat-tfal Tal-Pulizija

FID-19 ta' Dicembru, 1979 f'Dar il-Mediterran gie organizzat l-akbar party ghat-tfal tal-membri tal-Kcrp tal-Pulizija meta madwar 750 tifel u tifla ta' eta bejn 1-4 u 12 il-sena ingabru fir-restaurant ta' dan il-post u qattghu l-isbah tlett sighet f'atmosfera mill-isbah.

Ghal party ta' din ix-xorta kienu mehtiega preparamenti kbar u min hafna zmien qabel. Bizzejjed nghidu li fis-7 ta' Mejju, 1979 harget cirkolari fejn gew mitluba l-ismijiet u l-etajiet tat-tfal tal-membri tal-Korp ta' mhux aktar min tnax il-sena sa l-ahhar ta' Dicembru 1979. Kif jigri dejjem kien hemm hafna li hallew ghall-ahhar u sa l-ahhar granet baqghu hergin il-biljetti ghal dan il-party.

Fl-imsemmija cirkolari ma ssemmiex l-eta minima tat-tfal u l-eta ta' erba' snin giet iffissata wara, mill-Kumitat. Dwar l-eta saru bosta kummenti b'mod speċjali minn dawk li kellhom it-tfal taht cin l-eta. Dwar il-kritika li saret ahna wegibna fl-editorjal tax-xahar l-iehor u ghal darb'ohra

nergghu ntenu li tfal ta' anqas min 4 snin ma joqghodux wehed-hom f'party tax-xorta taghna u barra milli ma jiehdus pjacir, dawn itelfu l-gost lil-haddiehor.

Kif inghad qabel, in-numru ta' tfal li attendew ghall-party kien ta' madwar 750. Kienet verament bicca xoghol kbira ghall-organizzaturi biex provdew l-imwejjed u siggijiet ghal dan in-numru ta' tfal ghaliex hafna minn dawn l-imwejjed u siggijiet kellhom jingiebu minn diversi postijiet u kieku mhux ghax kienet l-ghaj-nuna ta' xi rekluti li kienu ghad-hom kif ingaggaw fil-Korp, kieku ma kienx ikun possibbli li tpoggi lil kulhadd bil-qieghda madwar l-imwejjed. Attivita bhal din tintieg hafna xoghol u dan dejjem ghamilnieh bi ftit nies.

Il-party beda b'wiri ta' films ghal madwar 25 minuta. Wara t-tfal ittiedu f'parti ohra tas-sala mhejjija ghalihom fejn fuq l-imwejjed sabu ikel u xorb.

### XEWQA MAQTUHA?

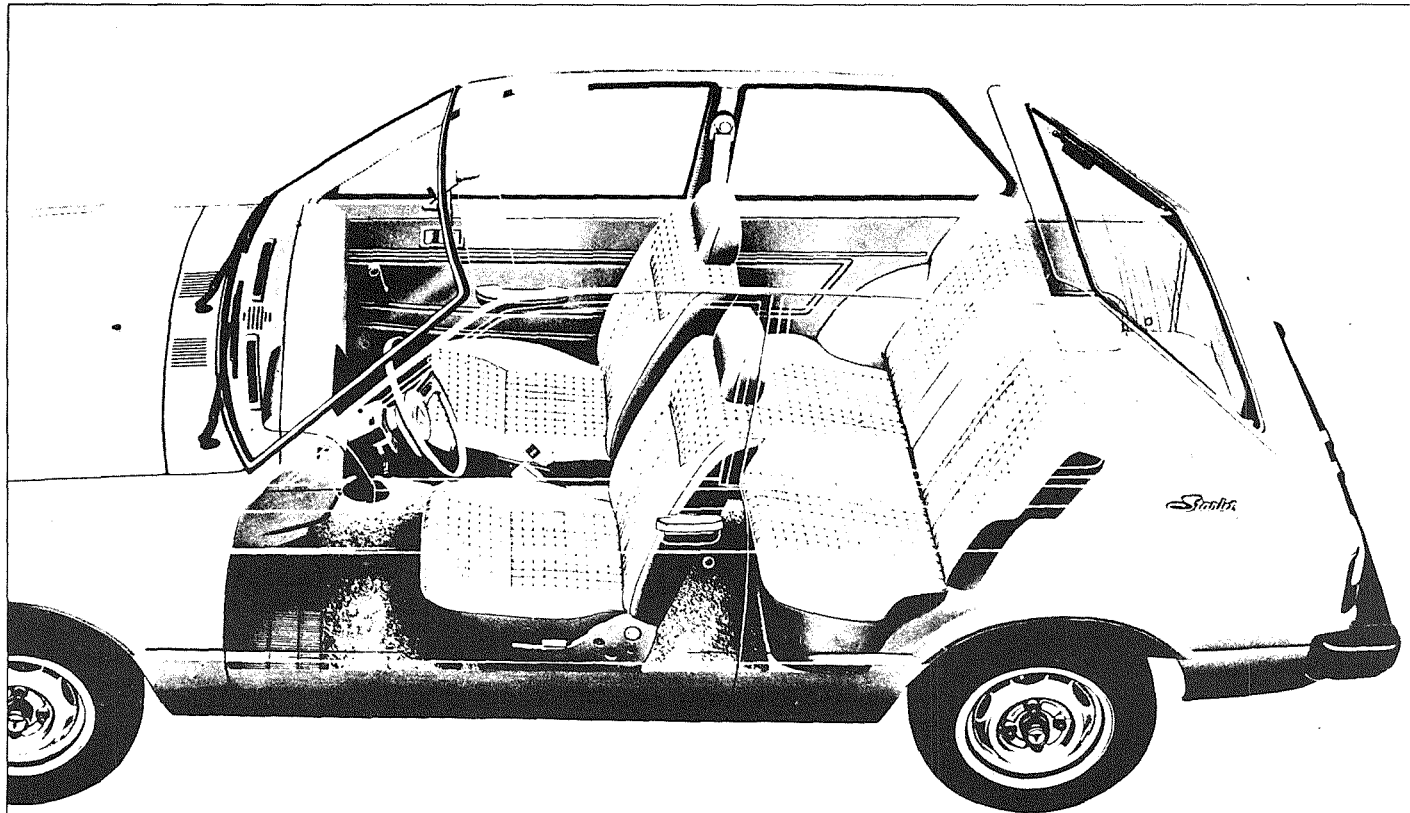
Ghal aktar min ghoxrin sena ilha tissemma l-htiega ta' Klabb tal-Pulizija, izda dan dejjem baqa' fl-imaginazzjoni ta' hafna mhux ghalkemm jinghad li darba din ix-xewqa kienet se ssehh meta kien instab post fic-centru tal-Belt. Dan kien madwar ghoxrin sena ilu.

Wara hafna snin dan il-hsieb intesa u hadd ma baqa' jtkellem fuqhu sakemm regghet twaqqfet l-Assocjazzjoni tal-Pulizija fl-1976 u ghal darb'ohra regghet bdiet il-hidma biex jinkiseb dan il-pcst. Saru anke talbiet lill-awtoritajiet ghal post fil-Furjana u iehor fil-Belt, izda dejjem kellna rizultati negativi. Ghalkemm l-isperanzi ghal xi post naqsu, izda l-moral ma naqasx u mal-hatra ta' Dr. J. Brincat bhala Ministru tal-Gustizzja u Artijiet, l-isperanzi kibru ghaliex konna certi li dan jifhimna forsi aktar minn haddiehor, u hekk kien. Ftit granet wara l-hatra tieghu bhala Ministru, l-Assocjazzjoni tal-Pulizija wrietu x-xewqa u l-iskop ta' Klabb tal-Pulizija u bi pjacir inhabbu li dan mhux biss qabel max-xewqa taghna izda anke offrila l-ewwel post, ghalkemm dan ma giex akkwistat.

Kien is-26 ta' Dicembru, 1979 waqt il-ballu tal-Pulizija meta l-Onor. Dr. Brincat habbar li kien lest jaghtina post fic-centru tal-Belt biex isservi bhala Klabb tal-Pulizija. Sakemm kien ghadu qed jithejja dan il-magazine kien ghadu ma gie xejn iffinalizzat ghalkemm dhalna u rajna dan il-post.

Wiehed tajjed isemmi li min-barra l-hidma ta' membri tal-Assocjazzjoni kien hemm ukoll koperazzjoni u ghajnuna mid-dirigenti tal-Korp li minghajr l-ghajnuna taghhom ma konriex naslu sa fejn wasalna. Insemmu wkoll l-ghajnuna li taw xi ex membri tal-Korp ghaliex dawn ukoll dejjem xtaqu li jigi akkwistat dan il-post fejn huma wkoll ikunu jistghu jippartecipaw f'dak li norganizzaw ahna.

J'Alla kollox jirnexxi biex inkunu nistghu nghidu li sehhet din il-holma.



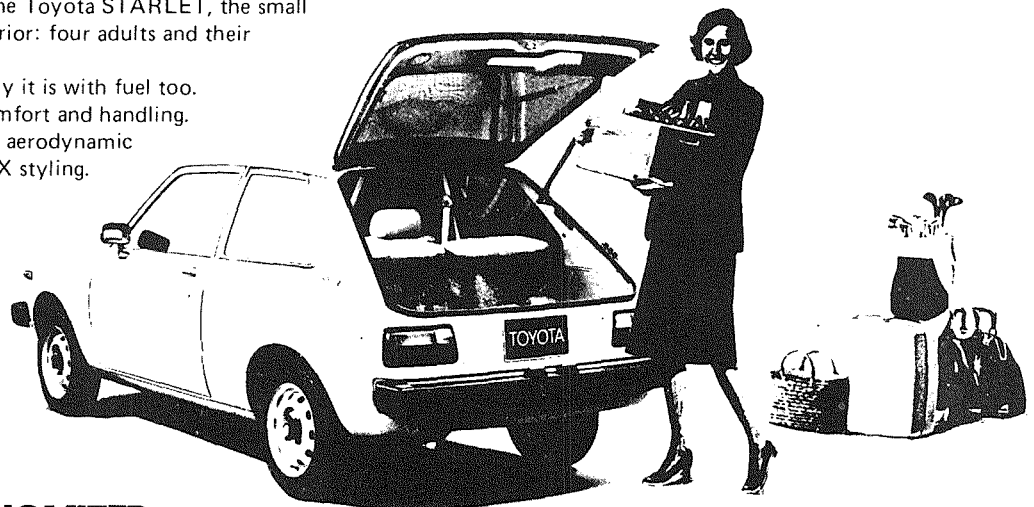

**BHANG HUWA PREPARAT** **BHANG** huwa preparat mill-weraċ nexfin tal-pjanta mhux koltivata u jissajjar u jinxtorob bhat-'e' fl-Indja u fl-Amerka. . . . **GANJA** huwa preparat iehor mill-weraċ u t-trufijiet tax-xitla koltivata u huwa qawwi daqs tlett darbiet aktar mill-**BHANG**. Inbagħad insibu preparat aktar qawwi maghruf bhala **HAXIX** li jintagħmel mir-resina li tohrog mit-trifuijiet tal-pjanta mkabbra u li huwa tlett darbiet aktar qawwi mill-**BHANG**. 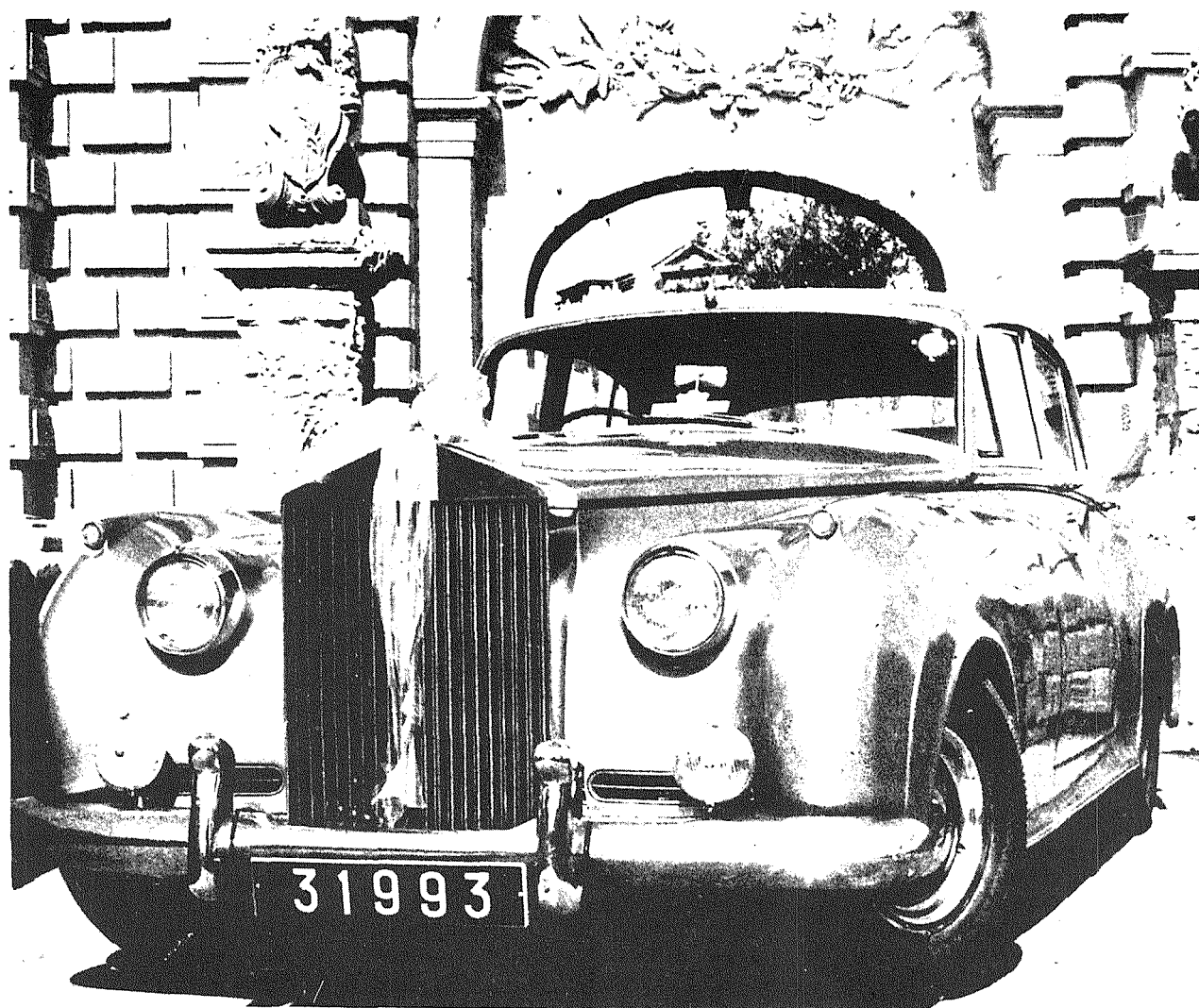

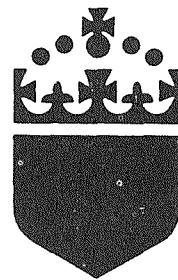

## Stat: Uniti tal-Amerika

52 mill 56 pulizija maqtula gew maqtula b'armi tan-nar fosthom 'handguns' li intuzaw f'35 kaz.

## Turkija

Semsettin, prigionier fis-Centrtal Anatolian Province of Kayseri, illu m jista jghid li huwa prigionier f'daru meta xtara l-habs bil-prezz ta' 15,000 dollaru. Wara s-sentenza ta' 18 il-xahar habs, Semsettin mistenni jbidel il-habs f'post fejn isir iz-zalxett.

## Kanada

Avukatessa f'Toronto dan l-ahhar qalet li l-prostituti jistghu jnaqqsu hafna nkwiethom ghalihom infushom, ghall-klijenti taghhom u ghan-nisa b'mod generali jekk jilbsu uniformi. Hija qalet dan waqt li kienet titkellem f'konferenza dwar l-istupri, prostituzzjoni u l-kodici kriminali li hafna nisa jilmentaw dwar fa'stidju minn irgiel. Dan kollu jista jigi eliminat jekk jintuzaw uniformijiet mill-prostituti.

Jekk il-prostituti ma jinbawx u jittrasvestu ruhhom ta' nisa komuni l-problema tal-fastidju tingata malajr, bl-uzu ta' uniformi.

## Germanja

Il-Gvern tal-Germanja tal-punent mistenni jressaq abbozz ta' ligi fejn mistennija jizdedu l-pieni ghal dawk li jittraffikaw in-narkotici. Hu mistenni li l-pieni ghal dawk li jbieghu l-heroina jkun

ta' bejn l-10 u 15 il-sena. Hu mistenni wkoll li jonqsu l-pieni ghal dawk li jinstabu fil-pussess tad-drogi li jkun ghall-uzu taghhom. Fil-Germanja tal-punent huwa kkalkulat li hemm madwar 100,000 'drug addicts' u n-numru ta' mwiet kagun tal-heroina is-sena l-ohra kien ta' 600.

## Irlanda

Waqt partita football f'Belfast, pulizija gie maqtul f'attakk terroristiku mill-Armata Repubblika Irlandiza.

Il-vittma kien flimkien ma' ghadd ta' pulizija ohra madwar il-pitch fejn kienet qed tintlab il-partita bejn il-Crusaders u l-Portadown.

Meta kien ghad jonqos madwar seba' minuti ghat-tmiem tal-partita, ragel armat resaq vicin il-vittma u sparalu. Il-qattiel irnexielu jahrab fil-kunfuzjoni li nqalghet wara li spara.

## Italja

F'hin minnhom il-pulizija waqfu peress li karozza ohra kienet wieqfa taht bridge fejn kien hemm xi nies li taparsi kienu jirrangaw il-karozza wieqfa. Malli l-pulizija resqu lejhom, dawn sparaw ghal fuqhom. L-Armata l-Hamra hadet responsabbilta ghal dan l-attakk terroristiku.

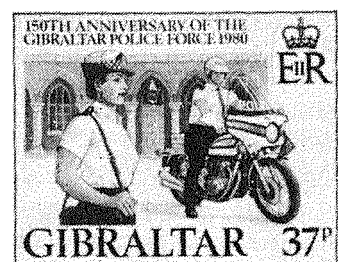
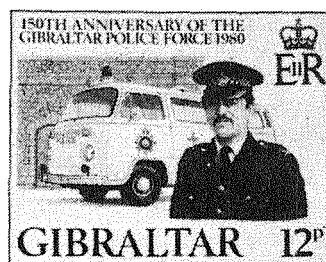
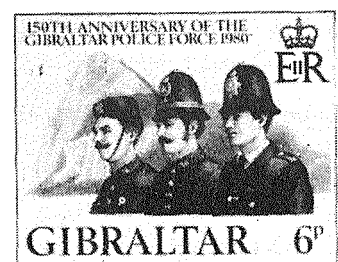
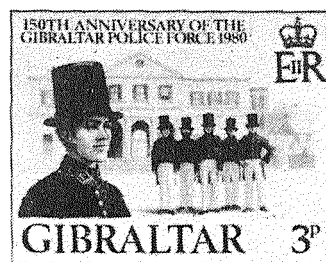

# AUSTRALIA'S POLICE FORCES

## Australia's police forces



EACH of Australia's six States, its Northern Territory and the Australian Capital Territory (ACT), has its own police force.

As well, based in the Nation's Capital, Canberra, ACT, is the Commonwealth (Federal) Police Force whose special duties include protection of political leaders and other VIPs. In most cases the State and Territory police handle the crime in their area, but there are pieces of Federal territory all around Australia, such as airports, and these are the province of the Commonwealth Police. However, there is flexibility. Like all the separate Australian police forces, the Commonwealth Police assist their colleagues where necessary.

With wide ranges in population densities, Australia offers policemen beats which can range from a few streets in a densely-populated area like Kings Cross, Sydney, to almost 4,000 square miles, in the Northern Territory and in the north of Western Australia.

In Australia, the commissioner, or chief of police, in each State and Territory is usually chosen from senior police ranks by State legislators. He is responsible

directly to a Cabinet Minister. A police commissioner retains his non-political position even if a government changes. He then becomes responsible to the new administration.

### **Commonwealth (Federal) Police Force**

The executive officers of the force — the Commissioner and three Assistant Commissioners (of Crime, Crime Intelligence and Operations) are members of the Federal Public Service. The remaining personnel are employed under the Commonwealth Police Act, 1957. On June 30, 1977, the force totalled 1,505.

The Plainclothes Branch of the force investigates breaches of Federal law. It also helps provide security for the Governor-General and the Prime Minister and is responsible for the security of foreign VIPs while they are visiting Australia.

With specialisation so essential in modern police work, organisations in the Commonwealth Police Force include: Australia Crime Intelligence Centre; Australian National Central Bureau (liaising with Interpol); Central informa-

tion Bureau; Currency Squad; Companies Squad; Document Examination Bureau; Firearms Safety Testing Section; and Neutron Activation Analysis Section (located at the Australian Atomic Energy Commission, near Sydney).

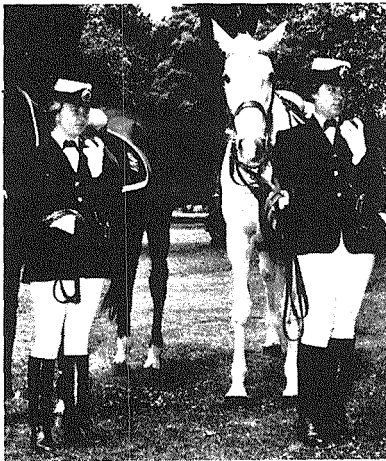
The Neutron Activation Analysis Section, with expertise in various analytical fields, handles cases for State police, the Federal Narcotics Bureau, State health departments and hospitals. It carries out analyses of distilled liquor and morphine-based drugs for the Federal Department of Business and Consumer Affairs.

The Currency Squad works closely with overseas and Australian State law-enforcement agencies. Among the squad's visitors in the year was a United States Secret Service special agent who gave evidence against a man in Brisbane, Queensland, charged with forging US\$100 and US\$20 bills. Other visitors including two of Scotland Yard's Counterfeit Division when forged British banknotes were discovered in Sydney.

of the Operations Branch were positioned to protect 66 visiting dignitaries. Their most extensive operation was for the Silver Jubilee visit of Queen Elizabeth. Within this branch is a counter-terrorist section.

The Plainclothes Branch of the force investigated in the year 25,440 cases of general crime ranging from breaches of the Wireless Telegraphy Act to hard drug offences, from tampering with the Electoral Act to aircraft bomb threats.

The force acts as a national agency for the collection, collation and dissemination of Criminal Intelligence. Resources of the Australia Crime Intelligence Centre are used extensively for preparing threat assessment on prominent Australians and VIPs from other countries. The centre is the focal point for intelligence

on illicit drug trafficking and provides Australian statistics for bodies like the U.N. Economic and Social Council and Interpol. During 1976, 85 per cent of all Australian drug charges involved marihuana — there had been a 29 per cent increase in heroin offences compared with 1975.

#### New South Wales Police Force

Under its Commissioner, the New South Wales (NSW) Police Force has about 9,100 members. It is responsible directly to the State's Premier. The force serves about 4,800,000 people. The force's functions have been defined as "prevention of crime, detection of and capturing offenders, protection of life and property, preservation of good order and control of traffic".

The Sydney Metropolitan Police Area comprises 10 police districts with a superintendent in charge of each. A district is made up of a number of divisions, controlled by inspectors. There are 36 of these divisions in Sydney. There are two special divisions — No. 20, at Police Headquarters, and No. 21 Special Squad which comes under the control of the Criminal Investigation Branch (CIB) and is sometimes used for operations against gangs of known criminals.

The rest of the state is divided into nine districts with a superintendent in charge of each. There are 34 divisions, each headed by an inspector.

The force also has various special branches such as the CIB liquor and gaming, firearms and inquiries, transport, communications, women police, scientific branch, prosecutions, ballistics, security, gold stealing, police lecturing, public relations and crime prevention branch, water police, mounted police, underwater recovery unit and an air sea rescue intelligence co-ordination centre.

#### Tasmanian Police Force

The Tasmanian Police Force has about 1,033 members, 38 of them women. The State has about 405,000 people. The force includes a deputy commissioner and two assistant commissioners (one is in charge of logistics, one of operations). These top positions

are in essence Public Service appointments and, in October 1977, were filled by former police officers with long experience.

Chief Superintendent is the highest rank for a serving (uniformed) police officer. His main functions cover discipline and welfare matters, but he often acts, as an Ombudsman (adjudicator). Each police district has a superintendent in charge, with a subordinate structure of inspectors in charge of special sections (such as: the Information Bureau, communications, search and rescue, etc.). Inspectors also are in charge at strategic geographical locations throughout the State which is divided into 12 main police divisions.

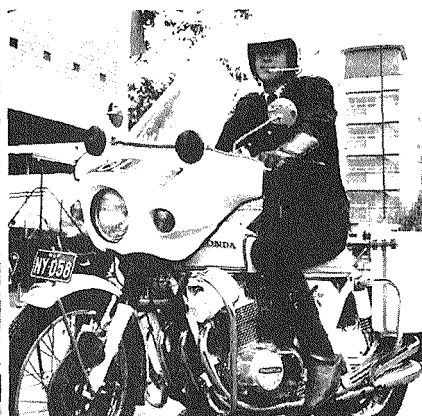
The force's transport (cars and motor cycles) are the most modern available. The cycles include many trail-bike types and many vehicles are four-wheel drives. These are used mainly in the island's rough and mountainous areas — some of Australia's most difficult — for search and rescue operations.

The State's territorial ruggedness demands and has a first rate police communications system plus the best in search and rescue equipment. There are about 20 police base radio stations. The force also has 14 coastal high-speed small craft and a larger deep-sea rescue vessel, the Vigilant, with a range of 800 miles. Crewed by three or four, the vessel can carry 24 people on rescue missions.

For land rescue work in the mountains, police experts are often helped by special parties of civilian climbers and walkers. They use a fully equipped mobile communications base.

The force's Diving Squad is in continual demand, the work ranging from shipwrecks to finding bodies, discarded weapons or the proceeds of robberies. All divers are volunteers and receive no special rewards for service.

5. 250 arma konfiskati minn skola wahda.

Tlett snin wara dan ir-rapport l-assalti zdiehu b'77.4% fuq l-ghalliema u 85.3% fuq l-istudenti; serq zdiehu b'36.7%; qtil zdiehu b'18.5%; attackki ohra sesswali zdiehu b'40.1% u n-numru ta' armi konfiskati b'54.4%.

### Effetti tal-Haxixa.

Il-haxixa u l-ingredjenti attivi taghha, (ghaliex illum it-THC qed jigi maghmul ukoll sintetikament — jigifieri maghmul f'laboratorji illeciti permezz ta' sustanzi kimici) jipproducu f'min jehoda stat ta' min ikun qed johlom, fejn il-hsibijiet jidhru minghajr kontroll u minghajr sens. Iz-zmien, il-kultur u l-ispazju jidhru aktar qawwi u wiehed jibda jithawwad meta jhars lejhom. Generalment ihossuhom aktar ferhanin u tajbin u certu ferh li ma istghux jispjegaw. Izda dawn l-effetti jiddependu hafna mill-post fejn ikunu u c-cirkost-

amzi ta' l-ambjent. Hafna jhossu wkoll biza tal-mewt, dwejjajq u jibdew jaraw certi affarijiet — dak li jissejhu allucinazzjonijiet. Mhux veru li din id-droga taghmllek tahseb ahjar u aktar intelligenti; ghal kuntrarju min jehodha aktarx jibda jhawwad u zgur jonqos il-kontroll fuq dak li nhossu. Meta tindara wiehed ihoss certu bzonn li jehoda, imma jekk jieqaf jehoda wara li jkun draha, ma jigrilu ebda hsara — ghalkemm forsi ma jkunx jista jorqod, jew ihossu ftit nervuz u xewqan li jkompli jehoda ghal ftit taz-zmien.

Ftit pariri kontra l-uzu ta' din id-droga perikoluza:

★ Ghalliema u studenti ghandhom jiddiskutu dan il-problema serju f'seminars apposta — genituri u spezialisti jigu mistiedna biex juru b'mod car u veru ghaliex wiehed ikun qed jirikorri ghad-drogi fil-hajja.

★ Naghtuhom xi ftit cifri veri. Fl-Amerika mhux anqas minn 5000 imutu minhabba d-drogi f'kull sena.

★ Sigmund Freud qal: "Bniedem normali jhobbu jahdem". Id-drogi jfixkluk zgur u ma jhallukx normali ghax kemm fix-xoghol u kemm fl-imhabba tizboxxla.

★ Kontroll ahjar kontra t-traffikar tad-drogi billi nikooperaw mal-Pulizija meta nkunu nafu bl-abbuzi.
