Nhar is-Sibt 29 ta' Settembru 1979 saret laqgħa tal-Joint Central Committee fejn gie diskuss jekk għal din is-sena humiex se johorgu l-flus mill-fond tal-Association biex isiru l-parties tal-Millied għall-membri tal-Korp u l-familji tagħhom.

Il-Kumitat qabel li din is-sena mhux se johorgu l-flus li kienu qed johorgu fis-snin ta' qabel bħala sussidju għal dawn il-parties bl-iskop li jitwaqqaf Fond ta' Beneficju għall-membri tal-Korp. Għaldaqstant, mis-sena d-dieħla se jingħata bidu għall-skema ta' għajnuniet finanzjarji liema skema tigi ppubblikata aktar tard u huwa mahsub li f'din l-iskema se jkun hemm għajnuna finanzjarja f'korrimenti, meta dawn ma jkunux graw fuq ix-xogħol u l-individwu jonqoslu s-salarju: f'xi disgrazzi fejn issir hsara fil-proprjeta tal-membri tal-Korp; f'kazijiet ta' safar in konnessjoni ma mard kemm tal-pulizija kif ukoll għal mara jew tfal tiegħu; f'kazijiet ta' mewt ta' membru tal-Korp fejn hu mis-tenni li tingħata parti mill-ispejjez tal-funeral; u kazijiet oħra li għandhom jigu studjati waqt laqgħa tal-Kumitat. ID-DROGI F'MALTA.

MINN L.J. Spiteri, M.D., B.Sc., D.Bact. (Manch), Ph.C., D.T.M.H. (L'Pool), F.R.C. Path. (Lond).

GEJT moghti permess mit-tabib principali tad-dipartiment tassanna biex mikkolabora mal-Pulizija u nikteb sensiela ta' artikli fuq il-problema tad-drogi f'Malta, ghall-magazin "Il-Pulizija". Jiena lqajt bil-ferha din l-istedina bitama li dan it-taghrif siewi mhux biss iservi ghall-membri tal-korp tal-pulizija, imma jkun mezz ta' edukazzjoni ghall-Maltin kollha u b'mod specjali ghall-istudenti u zghazagh li jiffurmaw is-sintra tal-gejjieni ta' Malta.

Tezisti l-Problema tad-Drogi?

Minghajr tlaqliq nirrispondi "IVA" u ser nghid ghaliex u nhalli fil-gudizzju taghkom jekk taqblux jew le.

Fis-sena 1968 gie f'Malta Dr. A.S. Curry M.A., Ph.D., F.R.I.C., M.C. Path. (Lond.) li kien direttur tal-Home Office Central Research Establishment, Aldermaston, Reading, Berkshire, l-Ingilterra. Dr. Curry huwa awtorita mondjali fl-analisi tad-drogi u ismu huwa maghruf fid-dinja kollha, minhabba l-korba u artikli li kiteb fuq l-analisi tad-drogi.

Jien kelli l-unur u l-pjacir li nsir nafu u nahdem meighu fis-sena 1967 meta mort Aldermaston. Meta gie Malta fil-bidu tal-1968 staqsieni jekk f'Malta kellniex il-problema tad-drogi, u jien minghajr tlaqliq, billi fhimt ghal liema drogi kien qed jirreferi, irrispondejtu "Le".

Dr. Curry baqa' skantat u ghaddejna l-isbah serata nitkel-lmu u niddiskutu ghaliex dan il-problema kien ghadu ma lahaqx lil Malta, meta dan il-problema kien ta' thassib serju kwazi fil-pajjizi kollha tad-dinja nkluzja l-Ingilterra u l-Amerka.

Fis-sena 1968 dan il-problema beda jerfa rasu, infatti jien gejt mitlub naghmel xi 12 l-analisi ta' drogi. Seba kazi kienu fuq l-alkohol jew spirtu, il bqija kienu Barbiturati, Amitriptiline, Amphetamine, Caffaina u Cannabis (Haxixa jew qanneb Indjan).

Meta Dr. Curry kien qed jikkellem fuq id-drogi ma kienx qed jirreferi ghall-alkohol, ghax dan huwa problema mondjali, imma biss ghall Barbiturati, Amphetamine, Cannabis, Amitriptiline, oppju, kokaina, ecc.

Kif taraw mill-lista li tajt jien, fis-sena 1968 kellna biss erba' kazi u wiehed biss minnhom kien tal-Cannabis.

Fis-sena 1978, jigifieri ghaxar snin wara l-migja ta' Curry f'Malta, kellna mhux anqas minn 49 kaz ta' persuni li tressqu l-qorti jew li gew maqbuda mill-pulizija fuq il-haxixa biss, u 39 fuq drogi ohra.

Altru li jezisti l-problema tal-abbuz tad-drogi kif se naraw aktar il-quddiem b'mod aktar car.

Problema serju

Dan huwa problema li jinhtieg jittiehed bl-akbar serjeta jekk irridu li f'Malta taghna ma narawx l-istragi li qeghda ssir bid-drogi f'pajjizi aktar sinjuri minnha — bhal l-Ingilterra, Amerka, Svezja u ohrain. F'dawn it-tlett pajizi li semmejt jigu vvutati miljuni kbar ta' liri kull sena biex jikkontrollaw dan il-problema serju ta' pajjizhom.

Fis-sena 1970 meta f'Malta l-problema kien ghadu biss qed jibda, fl-Amerka gew ivvotati 403 miljun dollaru fi zmien tlett snin dwar studju fuq il-problema tad-drogi, u kwazi nofs din in-nefqa saret biex il-poplu jigi edukat fuq id-drogi u fuq programmi biex jigu kkurati nies li jinsabu vittmi tad-drogi f'centri apposta.

Dr. Tim Lee Carter, membru tas-sottokomitat ta' dan il-vot qal: "Nassigura lill-membri kollha tal-professionisti medika u lix-xjenzati, li x-xoghol ta' dan il-komitat fuq id-drogi b'ebda mod mhu ser jolqot jew jaghmel hsara jew ikun ta' toqol zejzed ghalihom u ghall-pazjenti taghhom".

Is-sahha hija responsabilita' ta' kullhadd — awtoritajiet, tobbia, pulizija, knisja, familja u indvidwi.

Il-Gnus Maqghuda tant jinsabu inkwetati b'dan il-problema universali li jivvutaw mhux inqas minn zewg miljuni liri sterlini fis-sena sabiex jittiehdu passi ghall-kontroll internazzjonali tad-drogi fuq bazi internazzjonali.

Anke f'Malta ma bqajniex lura u minn sena ghall-ohra permezz ta' ligijiet ghaqlin irnexxiela b'x nikkontrollaw b'mod sodisfacenti l-abbuz ta' *certi drogi kif naraw aktar il-quddiem.*

X'nifhmu bil-kelma drogi?

Id-drogi huma sustanzi kimici li jigu wzati mit-tobba ghall-kura ta' mard, jew biex inaqqsu l-ugih u inkonvenjenzi ohra ta' mard fiziku jew mentali. Izda meta nitkellmu fuq drogi bhala PRCB-LEMA, ahna nifhmu li dawn is-sustanzi kimici jkunu qed jigu abuzzati, billi jinbieghu minghajr il-kontroll u r-ricetta tat-tabib u ghal skopijiet mhux ta' kura ghall-mard.

It-tabib celebri William Osier kiteb: "Il-bniedem ghandu kilba kbira ghall-medicini . . . ix-xewqa li jiehu xi medicini hija wahda mill-kwalitajiet li tiddistingwi l-bniedem mill-annimal. Verament li hija wahda mill-akbar diffikultajiet serji li t-tobba jridu jhabbtu wicchom maghha".

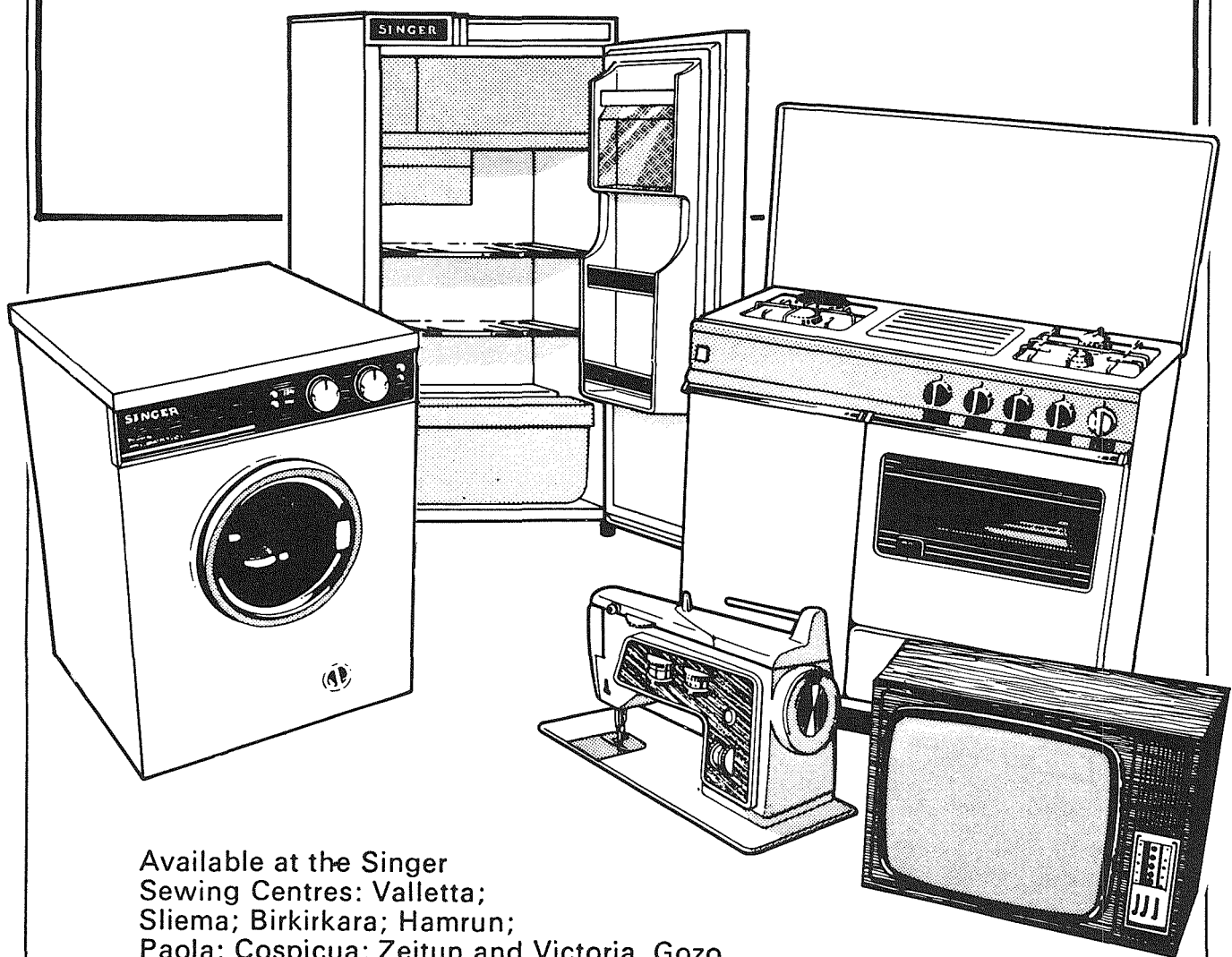
Dan inkiteb fis-sena 1894. Il-lum minghajr ebda dubju nistghu nghidu li l-bniedem kwazi impossibbli li jikber u jixjeh minghajr ma jigi bzonn li jiehu xi medicinali u anke hawn jista' jsir abuzz, ghax malajr wiehed jidhra jibla l-pilloli, jissuggerihom lill haad-iejhor jew jibqa' jehodhom meta ma jkollux bzonnhom aktar.

Jien b'ebda mod ma rrid nesa-gera u naccertakom li wara li taqraw u tistudjaw sewwa din is-sensiela ta' artikli fuq id-drogi, tintebhu b'veritajiet cari daqs il-kristall li huma dawn li gejjin:-

1. Malta llum permezz tal-gurnali, radju u televizjoni saret haga wahda mad-dinja u allura kwal-unkwe problema li jinsab fid-dinja moderna jinsab f'Malta wkoll.
2. Zewg problemi kbar tad-dinja kollha huma l-vjolenza u d-drogi. F'Malta dawn kibru fl-ahhar snin u qeghdin dejjem jikbru.
3. F'Malta l-problema tad-drogi ghadu fi stadju li jista' u ghandu jigi kkontrollat dejjem ahjar u aktar milli qed isir illum.
4. Diga' mexjin biex dan il-kontroll isir perfett.
5. Jinhtieg li kulhadd jikkolabora biex inxejnu l-problema tad-drogi u Malta tkun xempju ghad-dinja kolla **kif wiehed jirnexxielu jsolvi dan il-problema serju.**

minn Dun Peppin.

FID-DINJA, fiz-zminijiet, fil-ideologija u fic-cirkustanzi tal-lum, ma nistghux ngħaddu mingħajr Pulizija. Huma parti integrali u inqisha jien, sustanzjali mill-amministrazzjoni tal-pajjiz.

Fil-prattika, hafna drabi jistghu jsiru l-aqwa ligijiet; nistghu jkollna Ministru u Parlamentari bl-aqwa volonta' tajba; nistghu jkollna Qrati organizzati perfettissimament ... jekk ma jkolniex Pulizija organizzata u fformata tajjeb ta' Pulizija li hi, dawk l-affarijiet jitolfu hafna u hafna mill-valur tagħhom, biex ma ngħidx li fil-prattika jigu ma jiswew xejn jew jiswew ftit wisq.

Formazzjoni adegwata

Dan jitolb li l-Pulizija jkun fformati altru li tajjeb. Ma nifhimx ngħid għall-persuna "fizika", jigifieri li jkun tant metri u centimetri tul u tant kilos piz. Il-figura fizika hija pjuttost simbolika, fis-sens li għal min ma jifhimx wahdu, tista' tfissirlu li l-Pulizija hija s-sahha ezekuttiva tal-ligi. Fir-realtà, jista' jkollok Pulizija daqs iljunfant u jkun tajjeb biex jilgħabu t-tfal bih, bħala GAMBO, waqt li jista' jkollok Pulizija daqs xadin zghir, izda jleghaqlek u jikkontrollalek foresta shiha ta' tigris, iljuni u ljunfanti.

L-izjed importanti fil-Pulizija hija l-formazzjoni "morali": l-formazzjoni, jigifieri, li tizviluppali l-fakultajiet u l-kapacitajiet tiegħu persunali (intellettuali u korporali), b'mod li tagħmlu kapaci jiehu hsieb tassew l-ezekuzzjoni tal-ligijiet li jkun għamel il-Parlament u/jew ta l-ordnijiet li jkun ipprezentalu l-Ministru tiegħu għall-gid komuni u għall-buon ordni fis-socjeta'.

Hawnhekk tiffacca wehda l-importanza li fuq kollox u qabel kollox, il-Pulizija jrid jigi mghallem, iddottrinat u konvint mill-htiega tal-osservanza tal-ligi, bhala osservanza, li mingħajrha s-socjeta' tibqa' qisha merhla zbandata, merhla bla ragħaj, li ma tasal qatt, jew tasal bi tbatijiet

kbar għall-gid komuni li għalih u mghabba fih tkun saret il-ligi.

Etika

F'dan il-qasam, il-Pulizija jrid ikun ifformati b'mod, li jilmah u jxomm mill-ewwel fejn ikun hemm ksur tal-ligi, biex dak il-ksur jilgħagħlu bill-bidu u ma jhallihx isir gerha kbira, li tkun tista' tikkankra, tmarrad u toqtol is-socjeta'. Għalhekk, mat-tagħlim tal-ligi, il-Pulizija għandu bzonn ikun imharreg imqar fl-elementi principali tal-psikologija jitravwem ikun "keen observer" (sindikatur tajjeb, fin u 'brukkun'), biex isalva l-hsarat qabel isiru.

Mat-tagħlim tal-ligi, il-Pulizija għandu bzonn ikun imravwem ukoll fl-etika socjali, indipendentement minn din jew dik ir-religjon specifika, la darba qegħdin ngħixu l-socjeta' pluralistika. Irid ikollu idea kemm jista' jkun ezatta tas-Socjeta'; ta' l-għaqda li

mingħajrha ma tingħata ebda vera socjeta': u ta' l-importanza tal-ligi u l-awtorita', minnhom iridu johorgu l-holoq li jgħaqqu socjeta', u tad-drittijiet u dmirijiet persunali u principali tac-cittadin.

Illum mghadniex hamsin, sittin sena ilu, meta kienet bizzejjed ix-xbiha "somatika" (tul u hxuna) tal-Pulizija, biex ifakkar lill-kont-ravenzjonisti kbar u lit-tfal imqarbin fl-ezistenza tal-ligi. Il-lum kollox isir bi studju, kollox isir "xjentifikament", kollox isir intelligentement. Il-Pulizija jridu jkun "grieden, biex jikkontrollaw il-grieden": Pulizija fidil u bahnan twajjeb u "minn tagħna", huwa, għaliha xbiha stupida u assurda ta' Pulizija.

Għal kuljum

Dan kollu ngħidu minhabba l-missjoni edukattiva li għandu l-Pulizija. Hekk inhoss li għandna nqisuh lill-Pulizija, bhala "edukatur", bhala dak il-bniedem

mghallem u mrawwem apposta, biex jagħraf u jaqbad lil dawk li bit-trasgressjonijiet tal-ligi jheddu l-gid tal-kommunita', halli b'hekk iharsu lil din il-kommunita' fil-hajja civili, progressiva u moralment tajba li hija trid tghix.

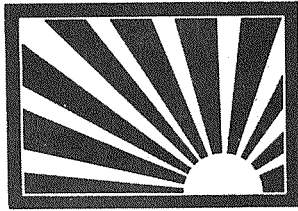
Xogħol il-Pulizija huwa xogħol **ta' kuljum**. Ma nitkellmex għall-ksur gravi, kbir u serja tal-ligi. li għall-grazzja t'Alla mhux komuni zzejjed. Nitkellem għan-nuqqasijiet li jissejhu zghar izda li fl-istess hin izommu socjeta' **indixiplinata, bi bnedmin dixiplinati, edukati u fformati tajjeb ma jghixux trankwillament fiha.**

Għaliex ma niddixiplinawx lill-poplu anki f'affarijiet li jis-sejhu zghar, izda li huma impcr-tanti hafna għad-dixiplina u għall-andament tajjeb tal-pajjiz?

POLICE AND DENTISTS FIND INSTANT IDENTITY TECHNIQUE.

AUSTRALIAN dental and police scientists have developed a faster, more accurate method of identifying bodies.

The technique, developed by the Dental School of the University of Adelaide and the South Australian Police Department, was demonstrated in May 1978 at a meeting of the International Association for Forensic Odontostomatology at Wichita, Kansas, United States. The technique quickly assures the identification of a body by superimposing the videotaped image of its skull over the videotaped image of a photograph of the dead person taken during life.

The idea of superimposing a photograph of a skull over a person's photograph in order to establish identification is not new. The precedent of such evidence in court goes back to 1935. However, this process can take weeks of trial and error to produce a negative of the skull, photographed from precisely the same distance and angle as the photograph taken when that person was alive.

By lining up one video camera on the person's photograph, a second video camera on an actual skull, and then merging the two pictures on a television screen, an hour or so of camera and object manipulations will tell whether matching images can be produced.

In attempting a match with ordinary cameras, hundreds of individual photographs sometimes have to be taken before correct distances and accuracy of

angles within less than two degrees in each of the three dimensional planes, can be achieved.

The manager of the University of Adelaide's Dental School, Dr Kenneth A. Brown, who explained the new technique to the forensic experts at the Wichita meeting, said it had the advantages of speed and indisputable accuracy. "Not only would it save a police department a lot in overtime claims, but in court a videotaped presentation of the matching of images can be made along with photographs of the blending process at various stages so that a jury can see how the matching was achieved. What is more, a negative or a photograph can be retouched. You can't retouch a television image."

Dr Brown, who studied forensic odontology in Europe and America, lectures on the subject and has worked on many identification cases in Australia and overseas since 1972. With Senior Constable First Grade Cecil Hollamby, he developed the video camera technique during a murder trial in Adelaide in 1977. "Known as the Holland case, it is to my knowledge the first and only occasion that any such technique has been recognised in court records anywhere in the world," Dr Brown said.

Murder conviction

During the trial of a man, since convicted of the murder of one of the sons of a Mrs Holland, the judge, prosecutor and defence counsel saw a videotape of how the skull of Mrs Holland, which

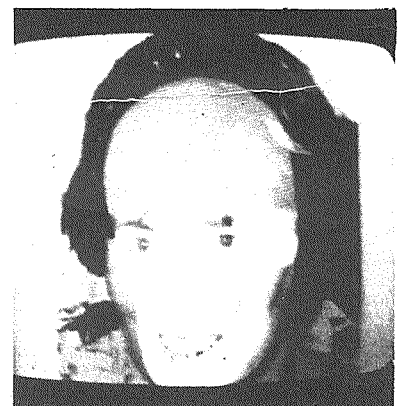
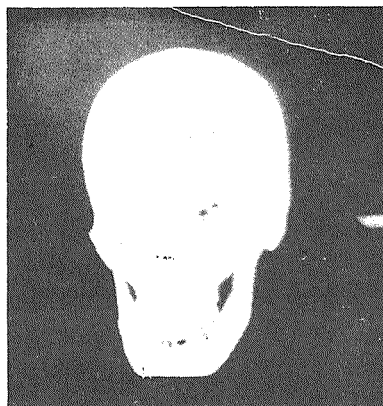

had lain for months in a rubbish tip, was matched to a head-and-shoulders photograph of her taken shortly before her death.

Dr Brown said the videotape had been used to demonstrate why the police were ready to charge the defendant with the murder of Mrs Holland if he were not convicted of the murder of her son. He said the new technique could be used quickly and easily to settle claims on insurance companies by people making conflicting identifications of a body.

Dr Brown added: "One of our most interesting identifications was of a man whose remains had been in a blast furnace for six weeks. We put together pieces of the skull, collected individual teeth, checked chemical residues in cavities against the dental history of the suspected victim, and established his identity beyond doubt when the reconstructed skull matched perfectly every asymmetrical feature of a photograph of the man taken the year of his death."

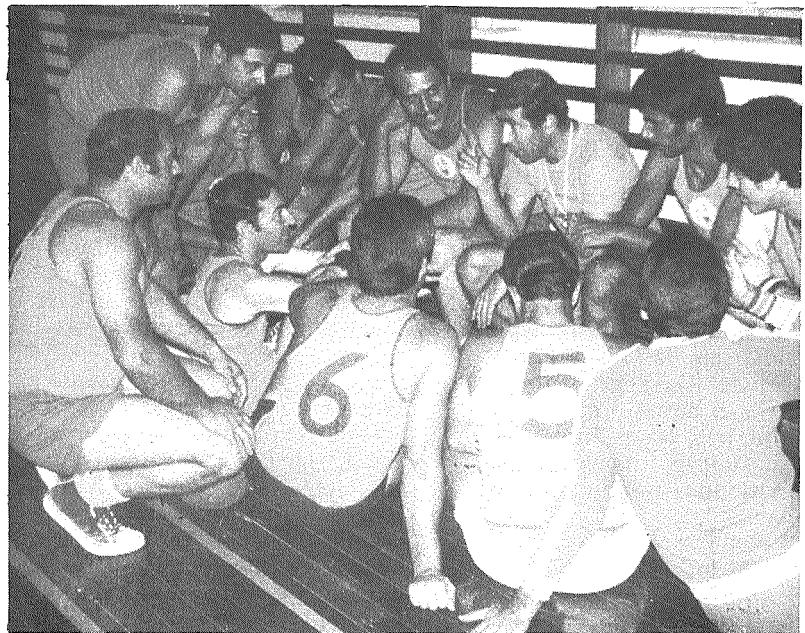
