# The Role of the Police in Contemporary Society and the Rights and Duties of Citizens

In TALKING of the position of the police in contemporary society it is first necessary to identify the type of society we mean; for the character of the society will inevitably reflect the character and function of the police.

In totalitarian or non democratic societies the police function is concerned with a monopoly of power, unchallenged and in a form unacceptable to democratic societies. Here the policeman is above the law, indeed the law may be what the policeman decrees. In such societies the word police is synonymous with terror, repression and unbridled power of a state or regime, which in itself is all powerful and all pervading.

Therefore I wish to talk about the role of the police in a liberal democratic society, where there is a clearly defined constitutional system of government with separation of powers between the executive, legislature and judiciary, and all the attendant safeguards for the freedom of the individual that denote such democratic societies from their totalitarian and authoritarian counterparts. In such a free democratic society the role of the police is one of clearly defined powers, acting within the rule of law because the liberties of a democratic society are ultimately dependent on the maintenance of the rule of law.

With legal police powers in a democracy come a series of public safeguards, determining how the police function should be carried out, regulations governing the interrogation of suspects, their detention, their rights and privileges e.g. communication with a lawyer, visits by relatives and medical examinations. In fact a framework of legal requirements and procedures that the police must strictly adhere to. Therefore the police function in a liberal democratic society must not only be capable of opera-

tional efficiency, within this framework of constraints, rules and regulations, but be seen to do so if public confidence in the police is to be maintained. The police are therefore public servants accountable to the society they police for the proper and ethical discharge of their duty. What then is the police function in such a democratic society? The police function is as broad and comprehensive as the structure of society itself. If in a totalitarian and authoritarian regime police are seen as repressive and tyrannical, it follows that in a democracy they must be regarded as the guardian of a free and democratic society, especially when that society is under attack from subversive or terrorist organisations.

No better description of the police function in a democracy, can be found than that of the Royal Commission on the 'Police in Britain in 1962'. 'The police cannot successfully carry out their task of maintaining law and order without the support and confidence of the people. They (the police) act for the community in the enforcement of the law and it is on its enforcement that the liberties of the community rest'. The scope and extent of police duties in modern times was also described by the same Royal Commission as follows:—

- (1) The police have a duty to maintain law and order and to protect persons and property.
- (2) They have a duty to prevent crime.
- (3) They are responsible for the detection of criminals and in the course of interrogating suspected persons, they have a part to play in the early stages of the judicial process acting under judicial restraint.
- (4) The police in England and Wales (but not in Scotland) have the responsibility of deciding whether or not to prosecute persons

suspected of criminal offences (proviso of prosecution of offences regulations requiring D. of P.P. authority and some cases requiring Attorney General's fiat to prosecute).

- (5) In England and Wales (but not in Scotland) the police themselves conduct many prosecutions for the less serious offences.
- (6) The police have the duty of controlling road traffic and advising local authorities on traffic questions.
- (7) The police carry out certain duties on behalf of government departments — for example they conduct enquiries into applications made by persons who wish to be granted British nationality.
- (8) They have by long tradition a duty to befriend anyone who needs their help, and they may at any time be called upon to cope with minor or major emergencies.

If one accepts that democracy is a method of choosing and removing Governments by a system of free elections and liberalism is a doctrine for determining what governments should and should not do, and above all for defining the limits to governmental power, then a liberal democratic government although desirable is an extremely fragile institution relying on a varying social contract between state and citizen. Liberal democracies have been particularly vulnerable when weakened by ethnic or religious conflict, by military defeat, by major economic crisis or by an erosion of popular support for democratic values.

The police in such a democratic society are the men and women in the middle, they are the agency closest to the public and therefore above all else they must be sensitive to the feelings and wishes of the majority. They must uphold the



law, but be satisfied that the law is just and right. Because if the majority of the people believe the law to be unjust and oppressive, then the feeling of hatred and injustice brought about by such laws will be turned on the people who enforce such unjust laws. This then is the dilemma facing the policeman in a liberal democratic state, because to effectively perform his function he must have the support and confidence of the majority of the people. Constitutional lawyers talk endlessly about the necessity of an independent judiciary free from political control. How much more necessary to a democracy is an independent Police Force. I would submit equally as important as an independent judiciary.

The police function as we have seen is extremely wide and comprehensive. The police are the main agents of social control and this role of giving help, information and guidance to citizens is never sufficiently publicised. In recent research in Britain and the USA 70% of the Police function in certain areas was found to be concerned with the social aspect of police work, helping people, either the victims of road accidents, helping the victims of assaults and crime, people suffering from mental and other illness, people who are just inadequate and cannot cope with the pressures of modern living, elderly people, people who need help for a variety of social reasons. The police are a 24-hour emergency response organisation; often they are the only organisation available to respond quickly and effectively. Policemen know this and the people we help know also, but it is seldom featured in the press or television.

In Britain we are fortunate to enjoy that degree of independence under the law I have talked about. All policemen in Britain are constables irrespective of their rank which is an independent office, who are 'answerable to the law of the land and the law alone.' Our law has developed from an Anglo Saxon concept of 'collective responsibility', where all

citizens were responsible for upholding the law, so there has always been an acceptance that the police rely on the support of the public to carry out their function in society.

To illustrate the degree of public support and co-operation we in Britain enjoy, a few weeks ago in my own police area we asked for volunteers to search a wooded area for a young girl who had disappeared under suspicious circumstances. Six thousand people responded to this local appeal, many of whom were on holiday in the area and had no affinity with the village from which the girl had disappeared. When questioned why they volunteered, many replied that it was their public duty to help the police. I accept that this relationship between police and public is exceptional, but we work at it very hard. For example, in my police area of over a million and a half people which covers over one million hectares we have sixteen police officers permanently on duty visiting schools. This is not a public relations exercise, but a hearts and mind campaign to introduce the concept of the need for laws in our society, and the protection given by these laws to all the citizens in our country. The officers go to the schools in uniform and are allocated lessons in the curriculum where they teach civic responsibilities and have discussion groups with older children. We provide a battery of initiatives in 'non conflict' contact between police and citizens. We provide a Crime Prevention Service which is free where specially trained officers visit premises that have been broken into by thieves and advise on better security measures.

We hold better driving instruction classes with car drivers and motorcyclists, where advanced police drivers and motorcyclists give expert instruction to citizens. There are always more applications than places available on such courses. We present night school lectures on the police and these too are very popular. At certain times, usually once a year we hold 'open days' at


police stations where citizens can see and talk to the policemen and policewomen and see radio and forensic equipment. We have a police band (which was founded by my friend John Woodcock). This band plays at concerts and gives displays in the police area throughout the year.

We have a police precision riding motorcycle display team and a display team of police dogs who also appear at public events. All these police officers in the band, the motorcycle and dog display teams are operational officers who take part in displays in addition to their normal duties.

We also encourage our policemen to help in their off duty time with youth clubs, and all young people who undertake the Duke of Edinburgh Award Scheme (which is a national scheme for encouraging initiative in young people) spend part of their course learning about the police role in our society. These and others are some of the police initiatives where police are seen in Britain exercising social leadership; relating to, and working with the community in constantly maintaining and improving our relationships with the public. (My colleague John Woodcock has described the wide range of such initiatives in his paper).

The police in Britain must be professional and competent in the administration of criminal justice and in the investigation of crime, and the prevention of crime and terrorism. We must be able to respond quickly and effectively to events and here again we utilise this special relationship with the population. Throughout Britain we have a very efficient public emergency system utilising the national telephone network. There is a special emergency code 999, by dialling this number from any telephone anywhere in Britain the caller is connected, without payment to an emergency telephone operator.

Minħabba f'hekk f'hafna pajjizi saru studji u eksperimenti biex jitjiebu l-alternattivi għas-sentenza tal-Habs. Saru kumitat apposta biex jistudjaw kif għandhom jigu trattati dawk li jinstabu hatja ta' offizi kontra s-socjeta mingħajr ma jintagħtu l-habs.

### Il-Kumitat tal-Ministri

Fid-9 ta' Marzu 1976 il-Kumi-tat tal-Ministri tal-Kunsill tal-Ewropa adotta rezoluzzjoni (Nru. 76/10) li tirrikorda lill-Gvernijiet tal-Istati Membri "li jezaminaw il-legislazzjoni tagħlim bil-hsieb li jneħħu xi ostakoli halli jameljoraw alternattivi flok sentenza ta' habs u biex ikomplu jiz-viluppaw alternattivi ga' ezisten-ti."

Kull alternattiva flok sentenza ta' habs trid tinvvoli lis-socjeta b'xi mod jew iehor ghax kull min jintbagħha l-habs sew jekk għal fit-tnejha kif għal snin jerga jmur lura fis-socjeta wara li jiskonta s-sentenza tiegħu u għal-

hekk is-socjeta nnifisha trid tinvvoli ruħha fil-problema ta' kif l-ahjar se tiddilja mal-hatja.

### MIN HU L-HATI?

l-hati huwa dak il-bniedem li ġie ppruvat li kiser il-ligi. Il-ksur tal-ligi jista' jkun zghir jew serju u l-kastig għal dan il-ksur ivarja skond il-kas, minn multa ta' flus sa habs għal għomor ta' bniedem; fir-rejalta, il-kastig īrid ikun skond l-aggravju tal-offiza.

Issa l-glied kontra l-kriminalita ma ssirx biss bl-arresti, processi u kundanni ta' habs lil-kull min jikkommetti xi reat. Imma hemm bzonn aktar minn hekk. Innumru ta' detenuti — dawk li kienu qeqhdin jistennew li jigu processati — matul is-sena 1978 kien ta' 215, cieo 76 aktar minn dawk issentenzjati. Biex jithaddem dan is-ser-vizz gdid tinh tieg il-koperazzjoni shiha tal-istess Socjeta, tal-Im-hallfin, tal-Magistrati, Probation Officers, Social Workers u organ-izzazzjonijiet ohra. 

# International Legislative/Police News

## LESS MINOR COLLISIONS

THANKS to a magnetic sensing device designed by Virgie Sykes, a North Carolina inventor, some fender-benders can be avoided. The device a 12.7 cm by 17.78 cm 'black box' attaches to the front or rear bumper of any motor car and provides the driver with a warning signal whenever another car or any other metal object is within a metre or two. Hooked up to a speaker in the passenger compartment, the device sounds a beeping tone that gets louder as the metal source gets nearer. It can also be equipped with a visual signal for drivers who are hard of hearing or prefer as many safeguards as they can get.

**INDIA - The Army vs The Police**  
IN June 79 the Army was called to disarm striking policemen in New Delhi where about 20 policemen and 2 soldiers were killed during bloody clashes.

The crash-down came after a threat to law and order in India, including violent communal rioting.

It is said that the Indian Prime Minister declared that the Police have no justification in revolting or taking to agitation and that if they are allowed to do that, no democracy can survive.

In Bokaro, 19 policemen of the Central Industry of Security Force and 2 soldiers were killed when troops swooped on the C.I.S.F. Barracks. About 66 C.I.S.F. men and 8 soldiers were wounded in the gun battle, which followed a ten-day strike by 2,000 CISF members agitating for more money and release of their representatives, arrested when they went to New Delhi.

In a similar operation on the outskirts of New Delhi, about 600 troops stormed the Jharoda Kalan barracks where 2,000 CRP men were on strike. Firing broke out and one CRP man was killed and 10 people were injured.

## U.K.

### NEW full face crash helmets.

A new type of crash helmet manufactured by Kangol has been issued to all motor cyclists of the Greater Manchester Police Force.



## GERMANY

IN Hamburg firemen claimed a world record after pushing a 1120 pound vehicle 350 km in 24 hours.

32 firemen took it in turns to push the specially built vehicle which matched the weight of a fire fighting appliance.

Dublin's firemen previously held the record, with a distance of 270.2 km. The Hamburg firefighter raised money for charity with their stunt.

## NORWAY

### *Norwegian oilfields guarded by a Special Force*

NORWAY is setting up a special anti-guerilla force to protect its North Sea oil well from possible attack.

The Norwegian Deputy Minister of Defence told reporters that the force would consist initially of officers and men from a special Navy Commando Group which, although under the orders of the Norwegian Defence Command, could only act following a request from POLICE.

## FRANCE

### *No Guillotine?*

THE French Parliament began debating on whether or not to abolish the guillotine.

France is one of the few Western countries which still executes convicted murderers. Many political leaders, churchmen and lawyers have expressed abhorrence at the practice.

But the Government is aware that public opinion is not behind the abolitionists. A poll published recently showed 55 per cent in favour of keeping the guillotine and only 37 per cent against.

This is the fourth time since the French Revolution and the first time since 1908 that the French Parliament had held a full scale debate on the guillotine.

The Justice Minister said that the Government does not want this fourth debate to end in stalemate like the previous three and that after discussions in the National Assembly and a similar session in the Senate (Upper House) later in the year, the Government would be prepared to introduce a Bill likely to win widespread support.
