VIENNA POLICE IN MALTA

FORTY members of the International Police Association from Vienna, Austria, and their wives visited Malta in March 1979.

During their visit on the Island the I.P.A. members called on the President of the Republic, Dr Anton Buttigieg at the Palace Valletta. Dr. Buttigieg spoke on the period of his career when he served in the Malta Police Force. Through his service he was aware of the hard duties of the Police and the individual's devotion to duty, especially nowadays when the Police had to face violence and terrorism.

Dr. Buttigieg also mentioned the new chapter in the history of Malta after the closure of the military base and its re-

placement as a centre of peace. Dr. Buttigieg said that the new spirit of Malta is hard work in peace and cooperation with neighbouring countries.

Dr. Major, after replying to the President's speech, presented a souvenir to the President.

The I.P.A. members were accompanied by members of the I.P.A. (Malta Section) namely Mr. Romeo Micallef, secretary, Mr. Spiridione Bugeja, treasurer, and other members.

The visiting policemen also toured Police General Headquarters on Friday 23rd March where they met the Commissioner of Police, Mr. J.N. Caccia and other Officers of the Malta Police Force.

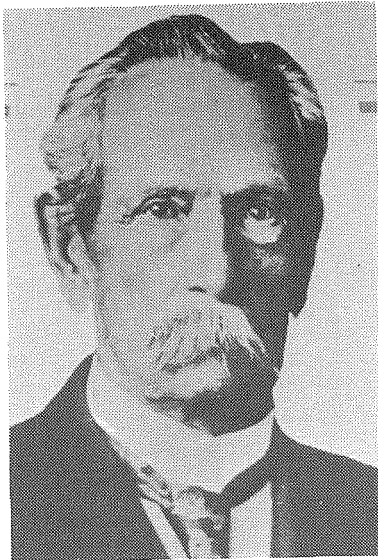
CARL BENZ

Missier il-Karozzi

Minn J. Scicluna

CARL BENZ tweled fis-sena 1844. Carl studja l-inginerija fil-Polytechnic ta' Karlsruhe, il-Germanja. Wara l-mewt ta' ommu (missieru miet meta' Carl kellu sentejn biss) Benz iltaga' ma' tfajla bl-isem ta' Bertha u fl-1871 fetah hanut ta' l-inginerija f Mannheim. Sena wara zżewweg lil Bertha li kienet tinfluwenzah hafna hafna f'xogholu. Fl-1877 Benz safa' fallut meta kien qed jipprova jibni l-ewwel makna tieghu li kellha tkun "two stroke". Il-makna "four stroke" kienet diga' giet iddisinjata minn Germaniz iehor bl-isem ta' Otto. Benz thabat hafna mal-makna tieghu biex iħaddimha u kien qata' qalbu għal kollox meta wara l-ikla ta' lejliet l-ewwel tas-sena ta' l-1879 Bertha nsistiet li jerga' jipprova darb'ohra. Din id-darha l-makna ħadmet. Fl-1884 Benz qaleb u ddisinja makna ohra "four stroke" u waħhalha fuq karozzella.

Minħabba li kellu xi problemi dwar il steering, Benz iddeciċieda illi flok żewġ roti quddiem jagħmel waħda li kien iktar sempliċi tiddisinja steering fuq rota waħda. Din il-vettura ma' l-ewwel prova tagħha spiċċat ġol-ħajt. Din il-makna kienet imkessha bl-ilma, b'ċilindru wiehed, kellha saħħa ta' 0.9 h.p. u ġiri "enormi" ta' 9 mili fis-siegħa. Fl-1877 ħabib ta' Carl Benz kien l-ewwel bniedem fl-istorja li mmonta makna fuq dgħajsa. Fl-1893 Benz kellu permess mingħand l-awtoritajiet ta' Baden biex isuq il-vettura tieghu b'veloċita' ta' mhux aktar minn 7 mili fis-siegħa fil-kampanja u 3½ fis-siegħa fl-abitat. F'din l-istess sena Bertha, il-mara ta' Carl, kienet l-ewwel mara li qatt saqet karozza. B'din ir-restrizzjoni fuq il-veloċita' Benz ma tantx sab suq tajjeb għall-karozzi tieghu għaliex iż-żiemel kien qed jiġri iktar u kien fl-1895 li Benz ħa l-permess li jista' jtella' aktar fil-ġiri. Minkejja li Benz rebah midalja tad-deheb fil-wirja ta' Munich u minkejja li giet ipubblikata storja sħiħa bl-istampi dwar il-karozzi tieghu f'gurnal f'Leipzig, Benz xorta



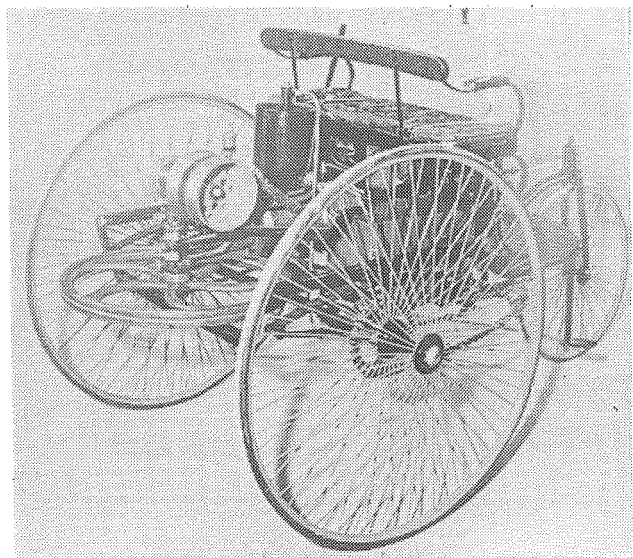

waħda ma setax isib klijenti.

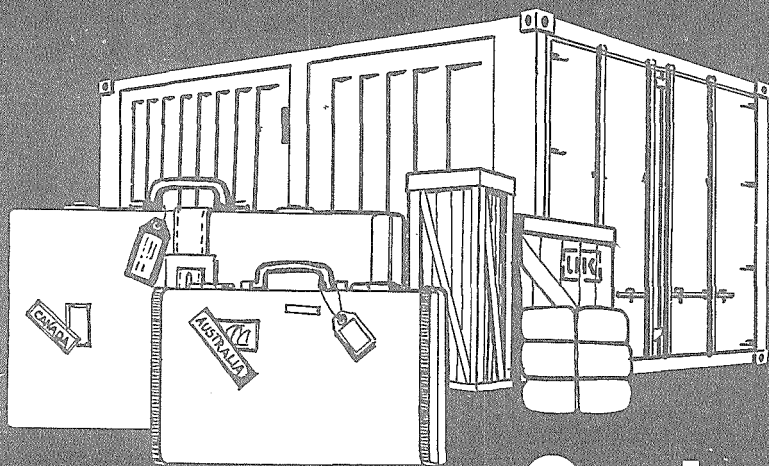
Biex l-affarijiet ikomplu jikkomplikaw irwieħhom shab Benz telquh u ħallewh waħdu jara kif se jagħmel biex iqajjem il-fabbrika fuq saqajha. Fl-1893 il-fabbrika bieghet 500 makna u dahħlet kemxa ġmielha li serviet biex ir-rotta tkompli ddur. Benz, li kien bniedem persistenti f'xogħlu, għamel sforz iehor biex il-karozza tieghu tkun aktar effiċjenti, komda, u li taħdem għal ħin twil bl-inqas manutenzjoni. Wara li Benz irnexxielu jiddisinja steering fuq żewġ roti, ħareġ l-ewwel karozza b'erba' roti. Din il-vettura għamlet suċċess kbir meta Von Liebig, neguzjant ta' l-ilbies, saq din il-karozza distanza ta' 750 mil. Fl-

ewwel 450 mil Von Liebig uża 310 libbri fuel, 330 gallun ilma, u ma waqaf bl-ebda ħsara. Din il-karozza kellha kapaċita' ta' 2.9 Litri kubi, kellha ċilindru wiehed, u kienet tiżviluppa 3 h.p. meta l-makna kienet iddur 400 r.p.m., u kienet tinbiegħ 3800 marks.

Fl-1895 il-kumpanija ta' Benz bniet 135 vettura u fl-istess sena karozza Benz rebhet l-ewwel tellieqa fl-Amerika. Fl-1898 Benz ipproduċa 434 karozza u sal-1899 2000 vettura ħarġu minn din il-fabbrika. F'din is-sena l-karozza offruta lill-pubbliku kienet qed ittella' ġiri ta' 17-il mil fis-siegħa. Mal-qalba tas-seklu fl-1900 Benz kien qed jipproduċi wkoll vannijiet, trakkijiet u anke xarabanks. B'daqshekk biss Benz ma kienx kuntent u fl-1910 immonta karozza speċjali b'makna tant irfinuta għal dawk iż-żminijiet illi fl-Amerika, eżattament f'Daytona, din laħqet il-ġiri fenomenali ta' 140 mil fis-siegħa. Il-makna kienet b'erba' ċilindri u kellha kapaċita' ta' 21 Litri kubi, jiġifieri 21,000 c.c. Fl-1925 Carl Benz u Gottlieb Daimler ingħaqdu u fl-1920 Carl miet fl-eta' ta' 85 sena. Il-mara ta' Carl, Bertha għexet għal 15-il sena ohra biex tara l-karozza ssir parti mill-ħajja ta' kuljum. L-istorja ta' Carl Benz tieqaf hawn, iżda dak li ħalla warajh ikompli iimla d-dinja b'vetturi ta' kwalita' superjuri. Il quddiem inkomplu naraw kif baqa' jkber l-isem ta' Benz u kif giet evoluta l-karozza bl-isem ta' Mercedes-Benz.

POLICE AROUND THE WORLD

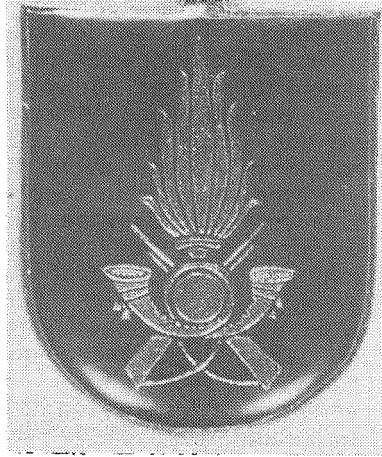
ITALY-La guardia di finanza

THIS IS a special force founded and used to defend the frontiers of Italy military-wise, to prevent smuggling and protect revenue and catch up with tax evaders. The emblem of this Corps is the Yellow Flame and its members are known as "le fiamme gialle". These revenue officers form a regular militia which since its foundation in 1774 had participated gloriously in battles in defence of the nation and in times of national calamity such as earthquakes, floods and other national disasters. Their valour is testified by twenty four medal awards to the Colours.

In 1906 the various Corps of Customs and Revenue Guards were united in an Army under a unified General Command with battalions called Legions spread all over Italy and end up in small isolated units guarding up border lines or vigilance of the coast lines.

The Academy or Training College of the Corps in Rome trains and forms up its officers who are thoroughly prepared in law and economics at university level and follow a four year course leading to a University degree in law, political science or in economy and commerce. The Officers then follow higher studies at centres of advanced military studies.

Personnel below officer rank follow up a two year training course at the Training School of Ostia Lido in military and professional preparation. Specialised Colleges for alpine and naval training are found at Predazzo and Gaeta. The Alpine School of Predazzo prepares the revenue officers for mountain duties and the isolation of the unit, the roughness of the programme, the physical and psychological solitude of the men, the silence of the environment turn these men into the crack units of the Force, expert skiers, rock and ice climbers and valiant rescuers.

The Nautical School of Gaeta sees to the complex training of students destined for sea units and various naval specialists (engineers, radar operators, radio telegraphers) needed to man the naval units which constantly patrol the Italian coastline in search of smugglers and (which engage in sea rescue operations. The Corps has about 500 naval units. An air unit was established in 1953 for helicopter observation over a large distance along the coast and over the open sea.

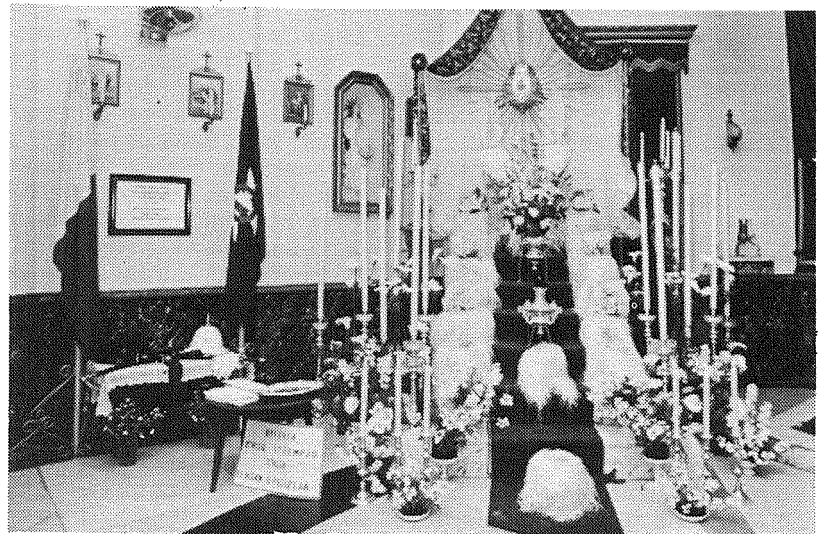
A recent addition is the Dog Section bred and trained at Castiglione del Lago, magnifi-

cent examples of German sheep-dogs perform steering service in anti-smuggling and drug-smuggling operations at the frontier posts, international airports, mountain rescue and archeological zones as well as in anti-terrorism.

The 'Guardia di Finanza' watch over the observance of law and regulations and the detection of violators of revenue, tax and customs payments, such as tax on consumers goods, goods manufacturing (salt, matches, tobacco), income tax and trade tax including IVA (value added tax) evasion.

Besides the Force is also entrusted with duties of a political-economic nature of vital importance to the national economy including the protection of archeological, artistic and historic patrimony; the prevention and repression of illicit money exchange; the clandestine exportation of capital under guise of commercial transactions; repression of drug traffic; food hygiene, pollution, illegal fishing and control of state subsidies.

The Corps also function as judicial and executive police and perform maintenance of public good order and state security duties and in times of war integrate with the Armed Forces in combat duties.

THE ROLE OF THE POLICE IN CONTEMPORARY SOCIETY — PREVENTIVE FUNCTION PART IV

The activities and initiatives of the group brought widespread approbation from the community. There were, however, many police officers who questioned the wisdom of the activities because they were a complete departure from the normal approach to police work. Since the start of the group, more and more policemen have become convinced of the wisdom of crime prevention in this more active and imaginative way. The sceptics amply illustrate the progress still to be made to shake the police service out of its entrenched attitudes. The whole experiment again points out that the police, with their experience and abilities, are leaders in society and must take positive control to encourage and stimulate the community. There is really no shortage of interested parents and adults but only shortages of people with the ability to lead.

The work of the Crime Prevention Support Unit supplemented the theory that policemen like to be appreciated. There was little doubt that their activities brought a high degree of job satisfaction. It also served to illustrate a natural reluctance of the police to work in the community where they were not particularly welcomed. In the work in the parks, the pattern quickly developed of the unit returning to areas where they had experienced the greatest response. Naturally these were the places where they were least needed. A conscious effort had to be made to work in areas less attractive and where the crime level tended to be higher. This eventually resulted in the realisation that the police did not necessarily know enough about people, what motivated them, where they committed crime and the reasons for it. At the moment a great deal of research is being carried out with the objective of identifying the problems, the people concerned in the problems and the areas where the most police help and attention is required.

It is most important to recognise that an individual police officer can soon be exposed to an over involvement with the described crime prevention philosophy. A return to normal duties every two years or so helps to keep the balance right. Likewise when working with children, too long an involvement will eventually cause the children to look upon the school liaison police officer as someone completely different from the policeman seen working in the traditional way. To put it in simple terms, one child was describing a policeman she had spoken to and when it was suggested that the officer concerned was probably the schools liaison officer, she replied "Oh no, not him, I mean a real policeman".

Crime Prevention Panels

For more than ten years many areas have run crime prevention panels aimed at improving crime prevention within the community. The panels consist of representatives of the general public, magistrates, business people and, of course, the police. Over the years they have achieved excellent successes in many aspects, particularly in getting established projects such as secure lorry parks. The advantages of the panels is that sponsorship has been found for schemes of this sort because of the involvement of business people. They have also developed crime prevention exhibitions and done good work with young people. As an example, the Crime Prevention Panel at York in the North East of England has successfully held an extensive football competition during the long summer holidays for school children of all ages. The project is now in its third year and so attractive has it become that it has been almost a full time activity for some public spirited members of the panel. The rules of the competition have been carefully drawn up to ensure that a new community spirit is created by the formation of new teams from specified areas. No established team

can enter the competition. The finals of the different age groups are held at the end of the summer holidays at the City football ground and are quite a spectacle. The panel involves many people outside of their group to provide grounds, football kit and referees. The kudos of winning the competition is tremendous because the players from the City team attend the finals. Every team that enters is guaranteed a reasonable number of games which with practice matches amounts to a heavy involvement. Again, an example of stimulating and occupying children — a worthwhile prevention activity.

Youth Clubs and Similar Organisations

Many members of the police service in Great Britain have played an active part, as a personal matter, in the running, management and control of youth clubs, ambulance training, water safety, life saving, Boys Brigade, Army, Navy and Air Cadets, Boy Scouts Association and others. The involvement has covered many years. The valuable help of policemen in this way has always been richly appreciated. It is not intended that the new crime prevention activities which have already been described, should in any way interfere with the voluntary involvement by policemen in such described organisations. On the contrary they should be given every encouragement.

Library Project

A useful educational and crime prevention project that has been successfully run in both Devon and North Yorkshire is worthy of mention. The scheme is operated during the summer holidays with the objective of creating an interest for children as well as encouraging them to use the facilities of the library service and at the same time to give them background information on the police service. It also has the additional benefit of improving the geography both nationally and internationally of the children who take part.

At the beginning of the school holidays the County Librarian in question circulated, through the schools, details of the scheme which is run in the form of a competition. As an example one of the schemes took on the guise of letting young children imagine they were detectives pursuing an international jewel thief. Many questions were posed to the children which could only be answered by them visiting their local library to gain the information. In effect the jewel thief successfully travelled through many countries of the world and for those children who managed to research the right answers, they were ultimately successful in catching the thief. In addition to the geography questions, of course, there were many questions that required the children to get information about the police service. It was a very exciting competition which demanded a lot of research by the children, but it was amazing how many took part and how successful they were. Occupying the time of the children in such a useful pursuit was well worthwhile.

Drug Addiction Liaison Committee

The ever growing tendency for people to be involved in drug addiction, especially young people, is a constant source of worry for the community and brings massive problems which affect the police service.

This crime is prevalent throughout the world and tends to bring an unusual loyalty between people involved in drug taking that is not characteristic in criminals in the wider sense.

Almost ten year ago in parts of the North of England, Drug Addiction Liaison Committees were formed in the most imaginative way with a view to reducing and possibly eliminating the drugs problem. A committee is made up of lawyers, psychiatrists, medical officers of health, general practitioners, nursing staff, education officers, university staff (both academic and administrative), teachers, probation, welfare

and social officers and youth leaders.

The committee meets every six weeks and in addition from time to time stages a one day conference at a university.

Many successes have been recorded such as:—

(a) Prompting a voluntary ban on the prescribing of amphetamines by general practitioners.

(b) Investigation into the proper disposal of syringes. Research has tended to show that many drug addicts find used syringes in disposal bins at hospitals.

(c) Drawing attention of doctors to the over prescribing of drugs i.e. sleeping pills.

(d) Drawing attention of chemists to forged prescriptions and security of the dangerous drugs held on the premises.

Because members of the university staff were members of the Drug Addiction Liaison Committee it is worthy of note that university authorities were so anxious to help with the problem that they have formed groups to deal with the drug problems.

Crime Prevention Campaign

The value of the crime prevention campaign cannot be over emphasised. Experience has shown that in order for a campaign to be successful it must of necessity be of relatively short duration, of not more than one month. Every effort must be taken to obtain the maximum publicity through the television, radio and the newspapers. The objective must be to bring to the notice of the public in general the details of the problem, e.g. theft from vehicles or burglary, and to suggest simple steps to prevent them becoming victims of the crimes concerned. Most important is to encourage the public to notify the police when they see anything that is remotely suspicious. It is extremely rewarding to find that the community in general are most anxious to co-operate, particularly if you give them details, on a daily basis, of how the pattern of the campaign is developing and whether it is showing any signs of

success or indeed exacerbating the problem. Above all it is imperative that at the end of the campaign the press should be given a full debriefing and an opportunity to question local officers about local initiatives that have been taken of any umbrella of the campaign.

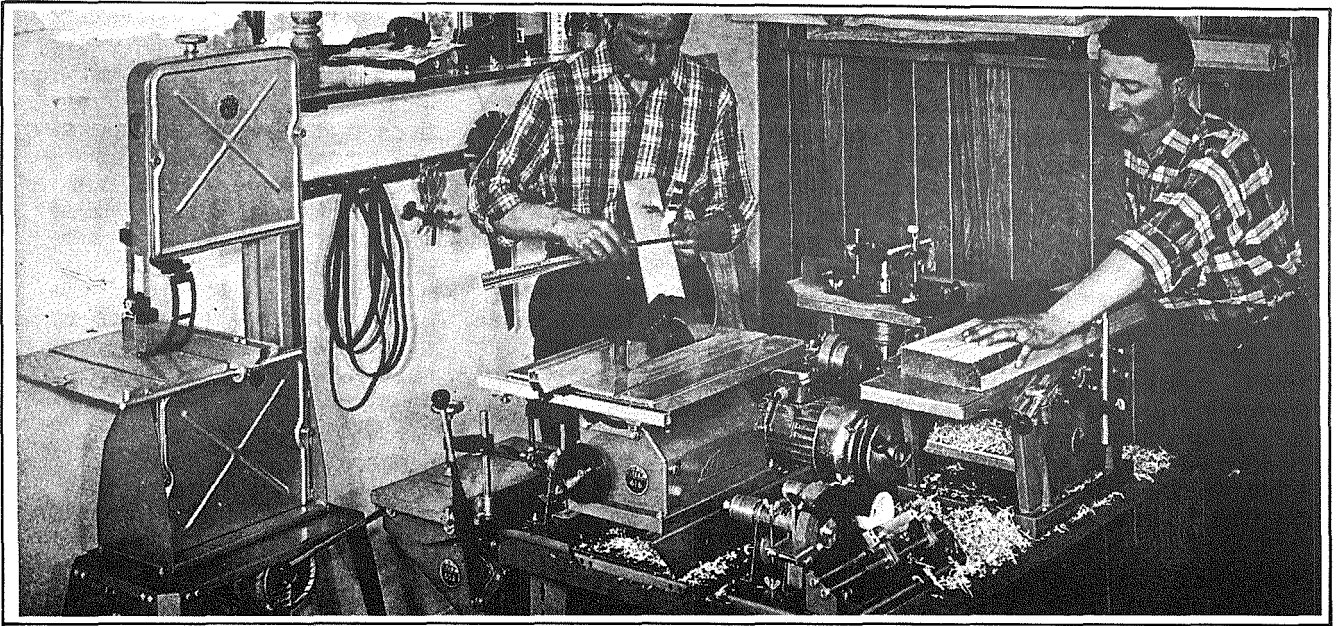
The essence of the campaign is to involve members of the public with specific problems using the principle that it is every bit their joint responsibility with the police to maintain law and order and to ensure that law and order is maintained.

Conclusion

In conclusion it must be said that whilst a lot of initiative in crime prevention has come from Great Britain, many other enterprises and ideas have emanated from other parts of the world. Each is of equal importance, for each is working towards the same goal, irrespective of international boundaries. It is vital that the community as a whole is made aware of the need to co-operate with the police and other crime prevention agencies in their everlasting struggle against crimes of every type. If the whole community could be motivated towards an active preventive role, the battle against crime could become a very positive phenomenon. The fact that their joint efforts had prevented a crime happening, or reduced the incidence of crime in a locality, would surely encourage more earnest endeavours by the populace to capitalise upon that success.

In this field, as in any other, success breeds success and any success, however small, proves that prevention is better than cure. These words are particularly apt in the world of crime.
