IL-PULIZIJA

PREZENTAZZJONI TA STANDARDI LILL-PULIZIJA

It-13 ta' Diċembru, 1977 għandu jibqa' jum ta' tifikira għall-Korp tal-Pulizija, għaliex f'din il-gurnata gie pprezentat b'żewġ standardi mill-President tar-Repubblika.

Iċ-ċerimonja tal-prezentazzjoni saret f'Misrah San Ġorġ, il-Belt Valletta għall-ħabta tal-11 a.m. fejn attendew bosta persuni distinti kif ukoll membri tal-Korp. Hija verament ħasra li għal okkażjoni unika bħal din ma kienx possibbli li jattendi kull membru tal-Korp.

Iċ-ċerimonja bdiet billi Kontingent tal-Pulizija, li kien jikkonsisti f'żewġ skwadri u l-Banda tal-Pulizija, dahlu f'Misrah San Ġorġ wara li mmarċjaw minn Triq ir-Repubblika. Mal-wasla tal-Kummissarju tal-Pulizija, dan gie mogħti 'General Salute' u ftit tal-hin wara, wasal l-Eċċellenza Tiegħu Mons. Arcisqof E. Mercieca. Mal-wasla tal-President tar-Repubblika, dan gie mogħti 'General Salute' u ndaqq l-Innu Malti. Wara li l-President spezzjona l-Kontingent, tmien 'drummers' poġġew it-tnabar tagħhom f'nofs il-Pjazza.

Żewġ Surġenti Maġġuri ħargu mill-Palazz bl-Istandardi mgħottija u wara li ġew mikxufa, tpoġġew mifruxin iserrħu fuq it-tnabar f'nofs il-misrah.

Il-Kummissarju mbagħad talab lill-Eċċellenza Tiegħu Mons. Arcisqof, li kiën akkumpanjat mill-Kappillan tal-Pulizija, Dun Fortunat Cachia, biex jitlob il-barka t'Alla tinżel fuq l-istandardi. Wara li dawn ġew imbierka, il-Kummissarju talab lill-President tar-Repubblika biex jipprezenta l-Istandardi. Il-President qabel ipprezenta l-Istandardi qal: "Hija x-xewqa tiegħi li l-Pulizija żzomm il-ġieħ taż-żewġ standardi, il-ġieħ tas-servizz tagħhom u l-ġieħ tan-Nazzjon."

Il-President imbagħad ipprezenta ż-żewġ Standardi lil Żewġ Spetturi. L-Ispettur D. Balzan gie pprezentat bl-Istandard li fih l-arma tal-Pulizija fuq il-kuluri ta' Malta. L-Ispettur A. Abela gie pprezentat bl-istandard l-ieħor, jigiġifieri, dak tal-Pulizija. Iż-żewġ Spetturi wara ħadu posthom fin-nofs tal-Kontingent 'billi

In today's society, where drugs are becoming more and more accepted as a part of the social way of life, it is important for the Police Officer to be able to recognise both the drug abuser and the drugs themselves. In previous articles we have discussed the various drugs of abuse, the signs and symptoms of their abuse, and the associated withdrawal symptoms; however, the search for, and recognition of the drugs themselves is probably the most difficult problem that he is faced with.

There are many ways in which a drug abuser may come into contact with the Police. The Police Officer may well find drugs, or evidence of their use, during a routine check or in the course of an arrest for a totally unconnected offence. He may actually see a person taking drugs or find evidence of unusual behaviour, indicative of the use. In each of these cases it is necessary for him to establish a number of points:—

- a. Does the suspect have drugs in his possession?
- b. What are the drugs and where did they come from?
- c. Is the possession of the drugs legal or not?
- d. Has the suspect taken doses of the drug(s)?

METHODS OF HIDING OR DISGUIISING DRUGS

Very often — from the criminals point of view — the best hiding place proves to be the simplest. Instead of hollowing out the heel of his shoe he will carry the drugs in the toe of his shoe. One popular way to carry drugs is to keep them in an old prescription bottle, in consequence, bottles with worn or dirty labels should be treated with caution. Amongst the many hiding places commonly used are the bottom of cigarette packets, the cigarettes are cut short and to the casual glance the packet appears normal. Drugs may also be found in fountain pens, cigarette lighters, torches, toothpaste and lipstick tubes from which the original contents

have been completely or partially removed. Tablets and capsules may be folded into letters, handkerchiefs, personal papers, books or newspapers. Occasionally drugs may be dissolved in innocent looking liquids.

There are literally thousands of drugs on the market. Some require a prescription, but many do not. Prescription drugs can normally only be obtained from a Pharmacy, however some doctors, especially those in isolated areas, often dispense drugs direct to their patients, rather than issue prescriptions.

If a person who is found in possession of drugs states that he has them legally, for the treatment of a medical condition, questions similar to the following will quickly confirm or invalidate his story.

- a. Doctors name. This should appear on the prescription label and can be verified by contacting the doctor concerned.
- b. Name of Pharmacy.
- c. Prescription date. Record of issue will be held by the Pharmacist.
- d. Dosage. Check the number of tablets/capsules, or amount of liquid in the bottle against the amount and dosage issued.
- e. Is the medicine/tablets the same as the one prescribed, or is the bottle merely being used to transport another drug. Check with the Pharmacist or have analysed.

In Malta, all Controlled Drugs prescribed by a Doctor are entered daily in a Register, showing the doctors name, the drug prescribed and the amount issued. The container itself is labelled, showing the name of the drug, the date issued. The amount issued and the Pharmacists name and address.

It is of the greatest importance that a Police Officer be sure of himself before taking a drug from a suspect. This is particularly true if the suspect is to be detained in cells. It is possible that the drug could be vital to the suspects health and possibly his life, i.e. Insulin for

the diabetic, nitroglycerine tablets for a person suffering with heart trouble. If there is any doubt in the Police Officers mind, the suspect should be medically examined at the earliest opportunity.

THE DRUG ABUSER IN CONFINEMENT

Special precautions are necessary for jailed drug abusers. To the drug abuser, (particularly the Narcotic abuser or addict) the most important thing in the world is his need for the drug and he will go to extraordinary lengths to satisfy his craving. Anything sent to him from 'outside' must be examined and contact with visitors must be supervised. Once a drug abuser establishes a source of supply, he may spread drugs through the confinement area.

Following the arrest of a person, known to be, or suspected of abusing or carrying drugs a 'skin-search' is necessary.

The drug abuser is generally very skilful in concealing his supplies. Two officers should be present for the search. The suspect's clothing should be carefully searched and his entire body surface examined, including the soles of the feet, hair, armpits and inside the prisoners mouth. A doctor will be required to search all body openings and any surgical dressings which the prisoner or suspect may have.

Drug abusers often conceal their supplies within body opening, including the sinus passages of the nose and one of the commonest methods is to swallow the drugs whilst they are contained within a balloon for later recovery. To date the record for the amount of drugs carried at one time in this way stands at 55 balloons containing a total of 3½ lbs of Heroin.

A WORD OF WARNING

If a person arrested for possession of drugs needs them, (for medical reasons) — make sure he gets them.

If he doesn't — make sure he can't get them.

Madankollu, xi opri tajba baqgħu ma ftehmux tajjeb mill-bnedmin; innuqqas ta' xi dmirijiet gravi għadu ma bediex inioqgeż il-kuxjenza ta' ħafna minna. Fost l-oħrajn, kull min tgħallim isuq għadu ma fehemx li hu responsabbli tal-ħajja ta' dawk li maqgħom jiltaqa'. Jekk bi ħtiia tiegħek minħabba s-sewqan żelied u traskurat tiegħek, int oħt il-mewt fin xi bnedem, aktarx li l-fantasma tal-bnedem maqtul tibqa' dejjem tidher dewwa moħħok. Għal żmien twil u forsi oħal haitek kollha tibqa' tħoss qalbek moħħusa għal dak li oħamilt.

Matul ix-xahar ta' Novembru, meta int ma' niesek tmur iżżur xi ċimiterju, aqti daqqa ta' għajn lejn l-oħra; minqux fuqhom, int ta' sikwit tanra li dan u dak il-bnedem miet b'disgrazzia fit-triq; mietu f'waqt li ma kienux jistennewh; mietu forsi fl-aħħar ta' ħajjithom; mietu tant drabi meta ħafna bnedmin oħra kien oħad oħandhom bżonnhom! Trid int terfa' fuq spallejk responsabbiltà' għal din? Aħna l-bnedmin, ħafna drabi, ma nitaħallimux mill-iżbalji ta' ħaddieħor loħidu li l-istorji hi l-oħalliema tal-ħajja. Imma ma natx kemm hawn li tgħallimu mill-iżbalji ta' ħaddieħor. Ħafna bnedmin ma jitgħallimux flief bl-iżbalji tagħhom infushom. Ħafna sewwieq ma jitgħallimux flief meta jagħmlu xi żball li ma jistax jissewwa iżjed. Il-qtil li qiegħed isir bla waqfien fit-toroq taqħna, sakemm ma jsirx minna stess, jibqa' ma jimpresjonanlex flief għal ftit sigħat.

Is-soċjeta' nfisha ma ħarsitx biżżejjed id-drittijiet tal-ħajja tal-bnedem. Meta pulizija tat-traffiku ma jehodhiex bl-aħrax ma' dawk li jsuqu żżejjed, ifisser li huma jkun qeħdin jitraskuraw il-ħajja ta' tant bnedmin li s-soċjeta' riedet tafda f'idejhom; dan ifisser ukoll li huma jkun qeħdin jithallu minn fuq dahar il-poplu mingħajr ma jfit-txu l-interessi tiegħu. Meta stat isawwar liqijiet li ftit jew xein ibeż-żoħu 'l min jsuq iżżejjed, ifisser li l-ħajja ma hix imħarsa biżżejjed. Meta mħallef 'il-Qorti ma jwaħħalx il-ħatjin flief ftit xelini jew xi artiklu ż3, jkun qeħed inoirttament iġħid lis-sewwieq; "Suq Suq kemm titlaħ għaliex, sakemm ma toqtolx għax

trid int, ħadd ma jista' jittgħek il-ħabs"! Imma jekk int bniedem ta' kuxjenza u taf tirrif.etti ftit, ma taħ-sibx li tkun qtilt għax ridt, meta tkun taf tajjeb li stajt ma qtiltx?

Id-dmir tiegħek lejn ħaddieħor mhux biss meta int tarah batut. Int trid tithem li għandek thares lill-ħaddieħor anki meta hu għadu b'saħħtu. Ftija ta' bnedmin li m'għandhomx sens ta' responsabbiltà', il-bniedem maqtul għandu mnejn jintbagħat quċċiem Alla bit-toqol ta' dnubietu mingħajr ma jkollu ċans jindem minnhom.

Tiġix tgħidli li "ħajtek datt ma kienet sejra ttajrek xi karozza! Jekk tgħidli hekk, jien inwiegħbek li int itit jew xejn taqbeż l-għatba ta' darek! Jekk int ilek żmien twil issuq, ma naħx kemm tista' tgħidli li qatt ma l'qajt ma' xi incident tat-traffiku! Il-ħabit tal-karozzi tant nisimgħu bih illi m'għadux jimpresjonana iżjed. Meta naqraw fil-gurnali li ħabtu xi karozzi u korrew in-nies, inħossu li dak il-qari ideijaona u aktarx ngħidu: "Iva dawn il-gurnali dejjem l-istess i'bu?" Irripetizzjoni ta' l-istess affarijiet fil-gurnali suppoost li trabbi f'na kuxjenza biex nevitaw disgrazzji bħal dawn; imma lanqas iġħaddielna minn moħħna!

Nagħtu daqqa ta' għajn lejn ġnus oħrajn Fi Franza, hemm ħabta f'kull minuta, 307 midruba fis-si-oħa, u 39 mejtin kull jum. Fil-Italja, l-aċċidenti tat-toroq jaqbuż t-300,000 fis-sena; f'ihom madwar 12,000 jis-faw mejta u 250,000 midruba.

Għandna f'idejna statistiċi dwar l-Amerika. Fl-1968, 55,000 sfaw maqtulin fl-aċċidenti tat-traffiku. Minn mindu daħal is-sewqan tal-karozzi fl-Amerka, iktar minn miljun u seba' mitt eli temmew ħajjithom maqtulin fit-toroq. Dan in-numru jfisser li l-inġenji tas-sewqan ikkaġunaw im-wiet iktar milli ġara fil-gwener kollha li minnhom għaddiet l-Amerika!

Dan ta' l-Amerika għail-Gappun m'huwa xejn! L-aċċidenti li jġiru f'dan il-pajjiż huma relattivament erba' darbiet daqs ta' l-Amerika! Li kieku l-Gappunzi kellihom isuqu tant inġenji daqs l-Amerikani, huma kien ikollhom 200,000 mejjet fis-sena!

Għadd kbir ta' disgrazzji anki fl-Olanda u fil-Finlandja. L-aċċidenti ta' dawn il-ġnus huma relattivament tliet darbiet daqs dawk ta' l-Amerika. Il-Germanja u Franza għandhom id-doppju ta' l-Amerika.

Kullimkien it-traffiku żejjed sar il-kaġun ta' ħafna mwiet.

XI NGħIDU MIS-SEWQAN ŻEJJED TAL-MALTIN?

Lis-sewwieqa tagħna m'ahniex sejrjn neħoulhom b'idejhom għaliex jekk f'Malta ma jsirux tant disgrazzji daqs postijiet oħra, il-mertu mhux tagħhom. L-esperti tat-traffiku f'Malta qeħdin jilmentaw li l-liċenzji qeħdin jingħataw 'il-ħafna li m'humliex imħejjija biżżejjed.

F'Malta, sewwieq ma jistax isuq ħafna lanqas jekk irid. L-għadd tal-

karozzi kiber bla tarf. Waqt li fis-sena 1966, il-liċenzji kienu jaslu san numru 46381, u fis-sena 1967 san-numru 53477, fis-sena 1968 huma kienu 58488. Naturalment dan ma jikkorrispondix man numru tal-karozzi li jinsabu fil-gżira għaliex in-numri l-qodma ħafna drabi ma jidux ripetuti. Fis-sena 1961, kellna f'Malta 26,800 mezzi tas-sewqan li għandhom bżonn tal-liċenzja. Sas-sena 1967, in-numru kien tela' sa 40,209.

Il-qat'liela tat-toroq, anki fostna, ħafna drabi jehilsuha ħafif. Xi drabi l-ħtiya tkun kompletament tagħhom għaliex, minbarra s-sewqan żzejjed, huma ġie li jkunu anki fis-sakra. F'kazi bħal dawn, anki s-sentenza ta' ħabs, hi ħafifa żzejjed.

L-aċċidenti tas-sena 1961 kienu 587; imma fis-sena 1967 huma waslu sa 781. Minn dawn is-781 — 241 passigġier ta' fuq il-karozzi, 291 sewwieqa, u 249 nies tat-toroq.

Matul is-sena 1967, dawk li f'Malta ltaqgħu mal-mewt fit-triq min ħabba l-inġenji tas-sewqan kienu 24. Dan in-numru hu żgħir jekk aħna nxebbħuh ma' dak ta' ġnus oħra. Id-diffikultajiet li magħhom niltaqgħu fit-toroq huma ta' vantaġġ għall-istess sewwieq. Barra minn dawk li semmejna aktar 'il fuq, aħna ma niltaqgħux mal-problemi ta' artijiet oħrajn, l-toroq taqħna jibqgħu ftit jew xejn tajbin matul is-sena kollha. M'oħandniex il-borra li fix-xitwa tiks i-t-triq u oħb tant tiđrib b'mod li l-karozza tista' tiskiddha. M'oħandniex lanqas it-toroq miksiġin bis-sild li fih hu pratikament impossibbli li wieħed isuq.

Inpoġġu hawnhekk l-istatistika j-iktar reċenti li rnexxie'na ngibu miċ-ċentru tal-Pulizija ta' Malta. Sa l-aħħar ta' Diċembru 1969, in-numru ta' liċenzi li ħareġ għas-sewwieqa laħaq 59,326. In-numru ta' liċenzi oħall-inġenji tas-sewqan laħaq 58,724. Sal-aħħar ta' Settembru 1969, l-aċċidenti tat-traffiku kienu 3260. Minnhom 12 qiebu l-mewt, 53 ikkaounaw ferimenti gravi u 645 he'suha ħafif.

Fin-nazzion okejken taqħna, għal-kemm inħossu l-problema taċ-ċokon, oħandna għax ni'ħru għaliex m'oħandniex il-problemi kbar li jlit-taqgħu maqħom oħus oħra li forsi f'oħaineina jidħru tant aħar minna. Dwar l-aċċidenti tat-traffiku, hawn Malta oħandna disgrazzji inqas minn ħaddieħor anki relattivament Madanakollu s-sens ta' responsabbiltà' għadu ma daħalx lanqas fostna. Is-sewwieqa tagħna għad għandhom ħafna x'jittgħallimu.



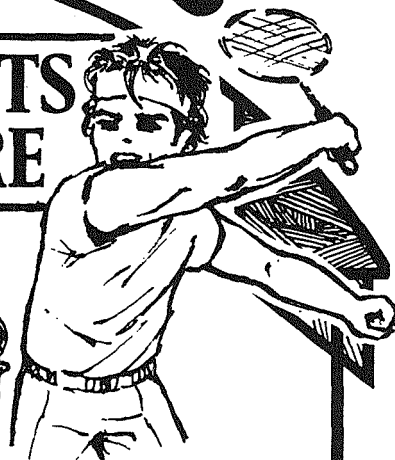

IL HABS TA MALTA minn E.A.

I-Habs ta' Malta qiegħed f'Rahaħ Gdid u għe mibni fl-1850 fuq sistema msejħa Panoptika, jiġifieri b'orma ta' ċirku biċ-ċelel ikkontrollati minn sala ċentrali. Din is-sistema għet introdotta fl-Ingilterra mill-maġħruf kriminoloġista Jeremy Bentham.

Il Habs jesa' 200 priġunier im-qassmin f'erba' diviżjonijiet. Barra minn dawn l'erba' diviżjonijiet hemm diviżjoni oħra għan-nisa, diviżjoni għal dawk il-priġunieri taħt it-tmin-tax-il sena u diviżjoni għad-debituri. Hemm ukoll diviżjoni żgħira ta' tmenin ċellel għal dawk il-priġunieri li kulltant ikun meħtieġ li jiġu kkas-tiqati billi jiġu mwarrbin mill-priġunieri l-oħra. Fil-Habs hemm ukoll diviżjoni li tiġi wżata għal kura medika meta ma jkunx hemm il-bżonn li l-priġunieri jittieħdu fi Sptar. Ta' min isemmi li dan l-aħħar, nafna mill-priġunieri li kien jeħtielhom kura medika, baqgħu f'din il-parti tal-Habs, b'hekk naqas dak inkonven-jent li l-priġunieri jittieħdu lasptar.

F'waħda mill-ħtieġi tal-Habs hemm Kannella fejn il-priġunieri jattendu għall-funzjonijiet Reġiżjużi. F'ħitha oħra hemm il-Forka li qedħda f'kamra għaliha. Il-piena kapitali għet abolita mill-Kodiċi Kriminali bl-Att Nru. XXI ta' l-1971, mentri dik il-piena tinsab fl-Att ta' Forzi Armati ta' Malta, 1970 u dan jipprovdli li l-ezekuzzjoni tas-Sentenza tal-mewt bil-mod u fil-post kif kienet is-sir taħt il-Kodiċi Kriminali.

Bejn 1876, meta tlestiet ġira l-Forka, u 1971, meta tas-Sentenza tal-mewt għet abolita mill-Kodiċi Kriminali, kien hemm tmin-tax-il ekeku-zzjon u daw l-oħra, minbarra weħħed li kien Tork, għew midfuna fiċ-Ċimiterju tal-Habs.

F-entrata tal-Habs hemm l-uffiċini minn fejn titmexxa l-amministrazzjoni tal-Habs u f'ukoll kamra apposta taħt il-priġunieri jistgħu jiltaqgħu ma' membri tal-familja tagħhom meta dawn iżu-uhom. Fis-sular ta' fuq, fejn qabel kien iservi bħala Quarters għad-Direttur tal-Habs, illum hemm kċina moderna u Mess għall-Uffiċjali tal-Habs. It-twaqqij ta' kċina moderna kienet waħda mir-riformi li saru daġ aħħar fil-Habs kif jingħad aktar 'il quddiem. L-post fejn kien iservi ta' kċina, illum qed jintuża oħra 'workshop' tal-mastrudaxxi. Għidt riforma, għaliex barra mill-apparat modern li hemm f'din il-kċina, l-post fejn tinsab huwa aktar addattat mill-post fejn kienet qabel, speċjalment f'dik li hija siqurta tal-Habs, dan oħra iex il-priġunieri ma jista' jkollhom qatt aċċess bla bżonn għaliha.

SKOP EWLIENI TAL HABS

Meta persuna tiġi mibżura l-Habs għar raġunijiet imsemmija 'il quddiem, din tiġi ntervistata mid-Direttur fejn tiġi m'akkra li ġin għet mibgħuta l-Habs għaliex għamlet xi reat. Jiġi wko'l spjegat lilha li l-Habs jista' jiġi meqjus bħala pos' ta' kastig jew post ta' riforma. Għa-kemm l-

iskop ewlieni tal-Habs huwa ta' riforma, madanakollu l-għaża tkun f'idejn il-priġunier innifsu. Jekk jagħzel li jirrifirma ruħu għandu l-faċilitajiet kollha kif jingħad aktar 'il quddiem. 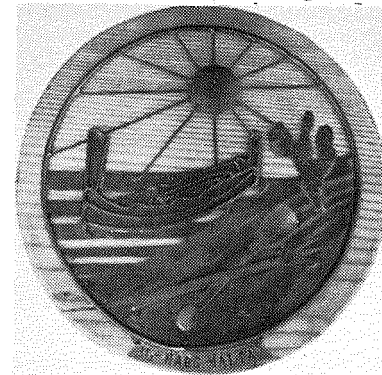

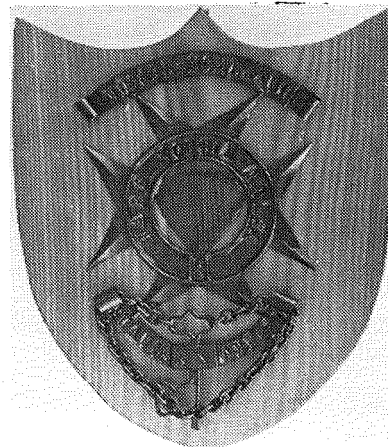

Fost dawn l-uffiċjali hemm xi wħud minnhom li huma tas-sena u dawn jgħallmu lil-priġunieri jaħdmu f'workshops apposta mgħammra b'magni u apparat ieħor. Ta' min isemmi wkoll li fil-Habs hemm membri tal-Korp tal-Pulizija li qegħdin jaħmlu xoġħol ta' uffiċjali tal-Habs flimkien ma' shabhom l-oħra li konnha nsibuhom bħala gwardjani tal-Habs. Insibu numru kbir ta' priġunieri jaħdmu f'xoġħolijiet ta' tiswiġa u manutenzjoni u xoġħol ieħor bħal ma hu xoħol ta' leatura ta' kotba, ħjata, xoħol 'il qebel, tibid, xoħol ta' mastrudaxxi u ħaddieda, xoħol ta' taoti tal-ħebel, xoħol fl-agrikoltura u xoħol ieħor utili.

Report on the working of the Police Dept. (1.4.76 to 13.8.77)

GENERAL REPORT AND SURVEY

1. During the year under review the Police Force was re-organised and streamlined in order to enhance its effectiveness in the performance of its duties in the maintenance of the public good order and peace and the enforcement of all the laws of the Republic with which the Force is charged. Apart from the general task of preserving the law and order, the prevention of crime and investigation of criminal offences in these Islands, the Force was kept fully occupied with a great number of religious festivals and processions, public political meetings and conferences and other events necessitating vehicular and crowd control. On the 17th and 18th September, 1976, the General Elections were held.

2. *Casualties.* During the year under review, 116 personnel ceased to serve in the Malta Police Force due to medical unfitness, retirement on pension, attainment of age limit, resignations etc.

3. Forty-eight (48) Constables were attested into the Malta Police Force after the usual medical and written examinations.

4. *Revenue.* The Revenue collected by the Police was £M1,993,746 mainly due to motor-vehicle licences as distinct from other police licences.

5. *Expenditure.* The expenditure of the Force during the period under review, was as follows:— Personal Emoluments £M1,883,038; Recurrent Expenditure £M257,686; Special Expenditure £M39,807.

6. *Crime Prevention and Investigation.* The fight against crime was intensified. The plainclothes section of the Criminal Investigation Department, including the Mobile Squad, continued to give the desired results. Mobile night patrols were increased in order to cover more places where crime is likely to occur. I am satisfied that the Island is adequately covered by mobile Patrols round the clock. Each vehicle can easily be contacted on the radio network from central base installed at General Police Headquarters. In

turn, these mobile cars can equally get in touch with the various Police District Headquarters. The number of solved cases of thefts during the year under review was 292.

Besides the detection of criminal offences in general, another drive was initiated in respect of the cost of living. All efforts were made by the Price Control Police to bring to book all those traders and other businessmen who were committing breaches of the Price Control Regulations.

This same Section, apart from its routine Court prosecutions, has also prosecuted several persons charged with evasion of duty in contravention of the provisions of the Customs Ordinance, besides other offences connected with drugs and the Exchange Control Regulations. Various surprise inspections of business premises have also been carried out at different times by personnel of this Section to prevent the hoarding of essential commodities. The measures taken to prevent crime are bearing the desired fruit.

Appendix 'A' shows comparative tables on offences.

Discipline these last months was satisfactory. 216 defaulters appeared before the Commissioner of Police on disciplinary offences during the period under review, besides other cases which were referred to the Public Service Commission.

7. *The Criminal Records Office.* This uniformed Branch of the Criminal Investigation Department is responsible for issuing, against payment, Certificates of Conduct to members of the public. 17,031 Certificates were issued from which £M4,393,998 were collected during the period under review. Criminal Offences:— 8,533 criminal offences were prosecuted by the Police. There were 1,105 released in terms of Sec. 9 of Act XII/57. 18 persons were released in terms of Sec. 5 of Act XII/57. 117 persons were committed to prison and 1 male Juvenile was committed to the St. Philip Neri School. During the same period, 22 persons committed a breach of recognizance under the provisions of

Sec. 9 of the Probation of Offenders Act 1957; while 22 persons under sixteen years of age were convicted. Fines were inflicted upon 6,234 persons while 902 were admonished and reprimanded. 63 persons under 16 years of age were referred to the Department of Social Services for investigation of family background. 10 persons over 16 years of age were also referred to this Department.

8. *The Immigration Branch.* This Branch, which consists of the Central Executive Immigration Office at General Police Headquarters, the Seaport Immigration Office and the Airport Immigration Office, is responsible for the recording of arrivals and departures of persons coming in and going out of Malta, besides dealing with all correspondence with the Immigration Division of the Office of the Prime Minister. 25,982 persons arrived by sea in Malta; while 366,121 persons arrived by air; 26,270 persons left Malta by sea while 372,450 persons left Malta by air, and 91,097 transited from 1st April, 1976 to 31st March, 1977.

9. *Traffic* 80,336 vehicles of different make and type, including motor omnibuses, motor-cycles and invalid chairs were licensed by the Police during the period under review. This included 57,508 private cars. The question of public transport is being actively studied.

During the period under review, 18,660 Traffic Offence Tickets were issued by the Department.

10. *General Licence.* 238,045 licences, permits certificates, etc., were issued by the Police.

11. *Fire Brigade.* 366 fire calls were attended to by the Malta Police Fire Brigade.

12. *Property found.* Lost property found is delivered to the Police. 2,596 articles were reported lost. 625 articles were reported found and delivered to the Police and 106 articles were restored to owners.

13. From 1st April, 1976 to 31st March 1977, 260 prisoners were released from Civil Prisons after serving a term of imprisonment ranging from 15 days to 2 years, for different convictions.

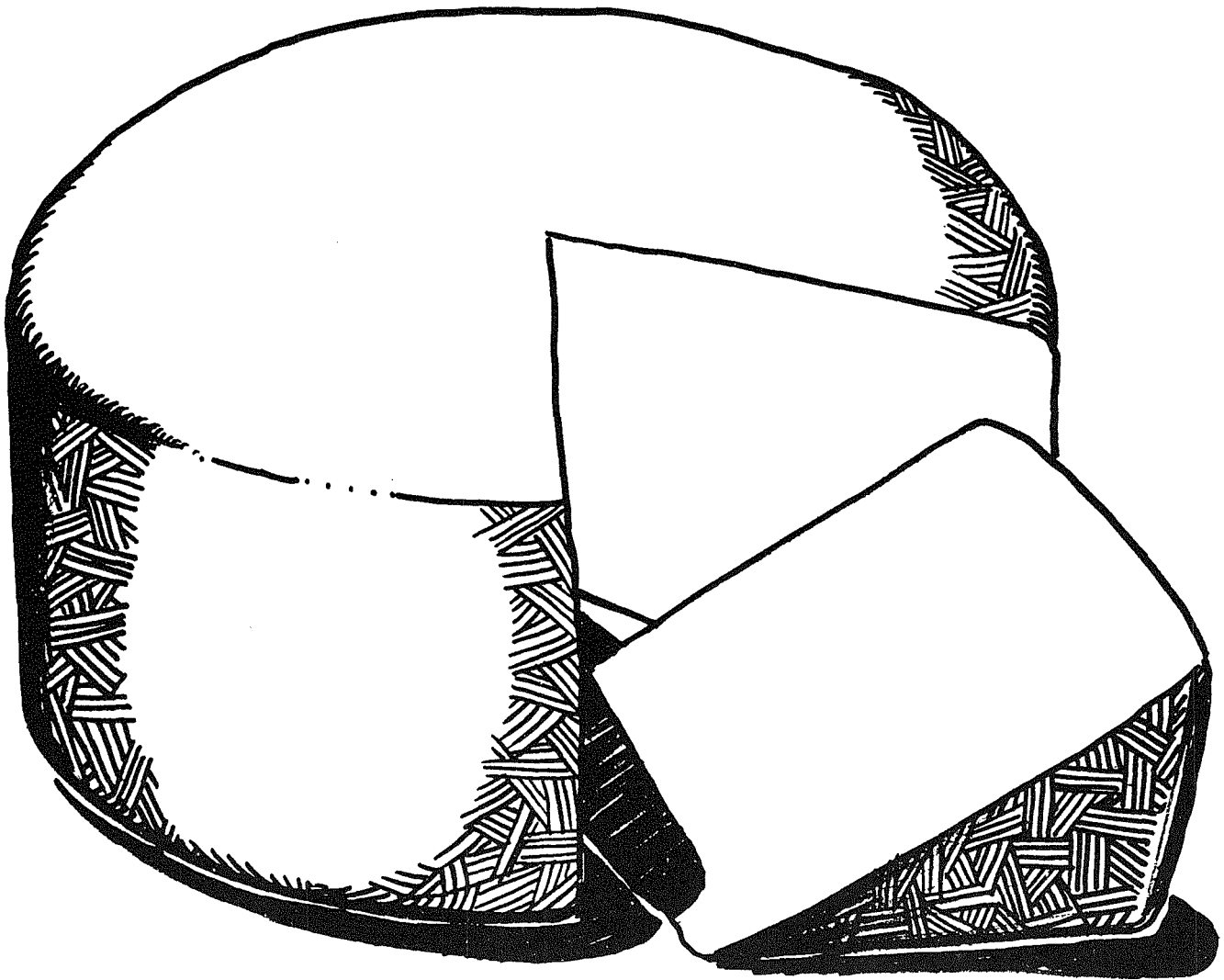

B'dan l-artiklu ingħata taġħrif dwar il-ħabs, x'riformi saru u nis-tgħu ngħidu li verament sar pro-ress. Fil-farġa ta' Ottubru ta' dan il-magazine għidna li xi darba nitkelim fuq l-armi tal-pulizija ta' Malta. Dik il-wieġhda titwettaq illum, permezz ta' dan it-tagħrif. Imma biex dan it-tagħrif ikollu s-saħħa li jist-ħoqqqu, inwiegħed minn issa li nerġġhu niltaqgħu, biex nitkel-limu f'it dwar il-buttni tal-pulizija. Bejn armi u buttni naraw medda ta' żmien li ta' l-aħħar għamlet mingħajr ta' l-ewwel.

Qabel xejn irrid ngħid illi, qabel ma kellna l-Arma tagħna, kellna diġa' l-buttni ta' l-uniformi. Dawn huma ferm eqdem. L-aktar ritratti antiki jixhdu li qabel ma kienet l-arma kienu l-buttni. Il-buttni aktarx daħlu fi żmien il-mexxej tal-korp, Ch. Godfrey (1832/1844).

Illum ngħid xi haġa dwar x'sibt s'issa dwar l-armi sbieħ li kellha l-pulizija. Skond l-arma l-Konslu, jgħid il-Malti. Nafu min hu l-Konslu (il-pulizija) u issa niflu l-armi kollha tiegħu, sa mill-bidu.

Sejrin niltaqgħu ma sett meraviljuż ta' ritratti t'armi u f'it huma dawk li għandhom il-kollezzjoni kollha ta' l-armi tal-pulizija ta' Malta. Hawnhekk nixtieq ninqeda b'dan it-tagħrif, biex niringrazzja lis-Sur C. Debattista (Ex. P.C. 945) li tiegħu hi din il-kollezzjoni, u li silifni għal dan it-tagħrif.

Huwa nteressanti hafna li ninnotaw li l-uniformi tal-pulizija ta' Malta, kif nafuha llum, ma daħlitx shiħa, imma biċċa biċċa. Minn meta twaqqfet il-pulizija fl-1814 sa ma daħlet il-beritta, kif nafuha illum, kienu għaddew bosta snin. Il-beritta ġiet introdotta fi żmien il-mexxej tal-korp, is-supprentendent Capt. R. Casolani (1884/88).

Allura wieħed jistaqs.. "X'kienu jibsu l-Pulizija t'ok il-beritta u għandna illum?" Minn ritratti qorjma jirrizuata kienu jibsu l-imu ta' ku.ur iswed. L-imu iżgħar minn dak li għandna llum, u li jixbaħ hafna u dak tal-pulizija Ingliża. U terġa', qabel kel.na beritta ċkejna qiesu xi ornament, bħal dik li dehret f'paġna 17

fil-farġa ta' Ottubru 1977. Wara l-E.mu iswed, fuq l-istess qisien ġew oħrajn bojod, sa wasalna għal dak li għandna llum, abjad ukoll.

Mela, dik il-beritta ċkejna li kienet tintlibes bla arma tal-pulizija, u li kellha biss il-kliem Malta Police, kienet l-ewwel forma ta' għata tar-ras fl-uniformi tal-pulizija, u dan qabel is-sena 1847. Wara din ingħata kif għidna, l-elm u iswed.

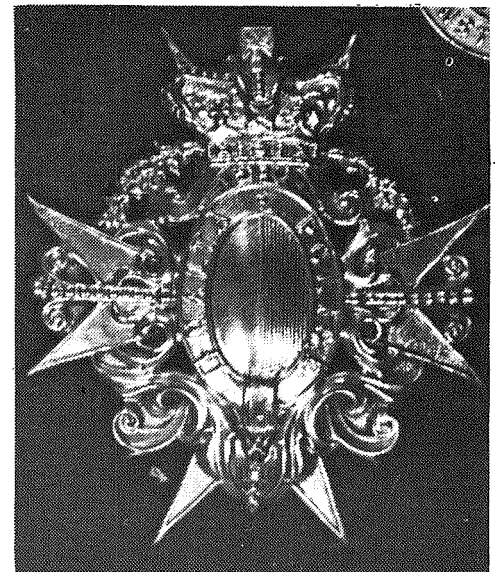
Għalhekk kien jenhtieg li dak l-elm u jew aħjar il-Korp tal-Pulizija, bħala stituzzjoni ikollha l-arma proprja tagħha, u preċiżament kif jitlob li jkollu l-Konslu. Għalhekk saret l-ewwel arma (badge) aktarx fi żmien Frederick Sedley li mexxa l-korp bejn is-sena 1844/58.

Qiegħdin nirriproduċu sett ritratti ta' l-armi kollha li kellha sal-lum il-pulizija. Tajjeb li ngħidu li l-ewwel tlett armi huma kollha ta' l-elm u, għax kif għidna aktar 'il fuq, ma kienetx teżisti l-beritta.

Jekk niflu tajjeb l-ewwel żewġ ritratti naraw, illi jixxiieb-hu sewwa. Imma ngħidu li mhux l-istess. L-ewwel waħda, il-fond tas-salib ta' San Gwann huwa ikkuskjat, fil-waqt li tattieni ma hux. F'ta' l-ewwel, l-irkejjen tal-ponot tas-salib huma bla ornament, fil-waqt li tattieni insibu disinn ornament zghir. Il-kliem huma wkoll differenti, f'ta' l-ewwel insibu l-kliem "Malta Police Force" u fl-oħra insibu "Malta Police" biss. Il-Malta Police waħidha baqgħet tintuża fil-kumpliment ta' l-armi.

Il-buttni tan-nofs ta' l-istess żewġ armi wkoll ma jaqblux. L-ewwel waħda għandha buttni lixx u l-oħra għandha buttni li għall-ewwel darba fl-armi tal-pulizija, ġiet imposta l-arma Bandiera ta' Malta. Żewġ nofsijiet indaqs, wieħed dak li hu suppost l-abjad u l-iehor l-aħmar.

Imbagħad għandna t-tielet arma. Fl-opinjoni tiegħi, l-aktar arma artistikament laborata, b'dettaġġi verament sbieħ. Arma li tindika ċerta serjeta. Minn din l-arma 'l quddiem insibu li ċ-ċirku li fih jinsab il-kliem Malta Police, minn din l-arma 'l hawn, jinbidel f'forma ta' ċintorin bil-bokkla. F'din l-

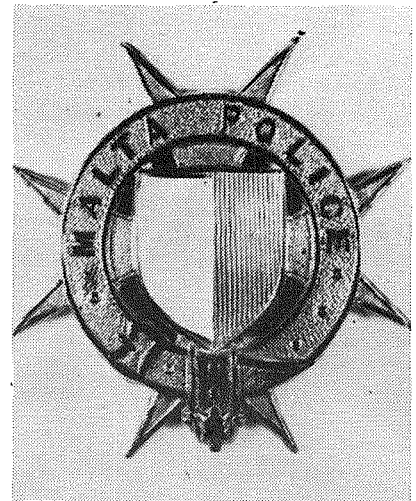
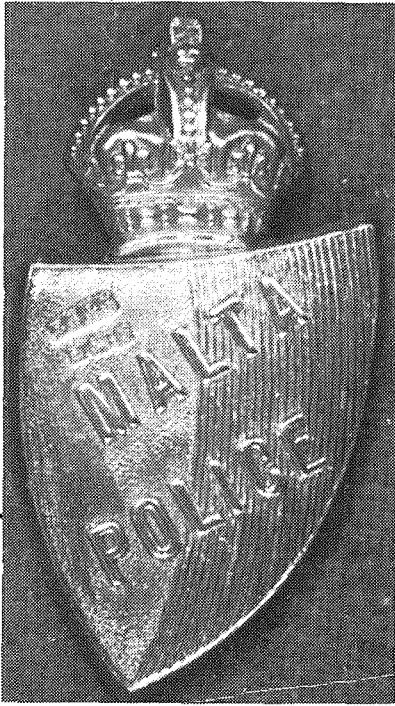

Fl-1969 fi żmien is-Sur V. de Gray, inqatgħet il-kuruna minn fuq l-arma. Ta' minn jinnota li l-armi kollha jgħibu l-kuruna bil-Fleur-de-lys, li tirrappreżenta l-Imperu Inġliż. Bil-qtuġh tal-kuruna wasalna għat-tmiem tal-kuruna wasalna għat-tmiem arma. Dan il-qtuġh tal-kuruna kien konsegwenza ta' avvoni-ment politiku li Malta kellha fl-1964 — L-Indipendenza. Wara hafna suggerimenti, proposti u disinji biex tinbidel l-arma tal-pulizija u tinghata xi forma oħra, ir-rizultat mixtieq ma ntlahaqx. Ġie deciż għalhekk, li l-arma tibqa' li hemm imma, bla kuruna. Il-kuruna kif għidna tirrappreżenta l-hakma ta' l-Imperu Inġliż — (1800/1964).

MALTA POLICE ORDINANCE PART I

AN ORDINANCE to regulate the organisation, discipline and duties of the Malta Police Force.

(10.2.61)

BE IT ENACTED by the Prime Minister of Malta as follows:—

PART I

1. This Ordinance may be cited as the Malta Police Ordinance, 1961.

2. In this Ordinance, unless the context otherwise requires

"to appoint" includes to appoint on promotion;

"Commissioner" means the Commissioner of Police;

"the Force" means the Malta Police Force;

"gazetted police officer" or "gazetted officer" means any police officer of or above the rank of Inspector;

"imprisonment" means any punishment restrictive of personal liberty awarded by a court of law;

"Malta" means the Island of Malta and its Dependencies;

"member of the Force" means any police officer other than the Commissioner;

"police" means the Malta Police Force;

"police officer" means any person serving in the Force, and includes the Commissioner;

"Public Serving Commission" means the Public Service Commission established for Malta under section 112 of the Constitution of Malta, or under such other constitutional instrument as may be applied to Malta from time to time

PART II CONSTITUTION AND ADMINISTRATION

3. There shall continue to be a police force known as the Malta Police Force.

4. The Force shall be employed for the maintenance of internal security, law and order, the preservation of peace, the protection of life and property, the prevention and detection of crime, and the enforcement of all laws with which the Force is charged; and for the performance of all or any of such duties shall be entitled to carry arms.

5. The Force shall comprise a Commissioner and such other police officers of such ranks as may from time to time be approved by the Prime Minister.

6. The Commissioner shall have the command, direction and superintendence of the Force.

7. Any act or thing which may be done, ordered or performed by the Commissioner may, subject to the orders and directions of the Commissioner, be done, ordered or performed by the Deputy Commissioner or Assistant Commissioner.

PART III CONDITIONS OF SERVICE

8. Deleted.

9. Deleted.

10. (1) The appointment of all police officers shall be subject to such conditions as may be prescribed by this Ordinance or by any

regulations or standing orders made under section 34 or section 35 of this Ordinance.

(2) Every member of the Force shall, in the execution of his duty, promptly obey without hindrance or challenge the lawful orders of the Commissioner.

(3) Every police officer shall devote his whole time to the service of the Force, and shall not carry on or be concerned in any kind of trade or business whatsoever.

(4) Every member of the Force shall be liable to be stationed at such places as the Commissioner may from time to time appoint.

(5) Every member of the Force shall undergo such training and undertake such tests or examinations as the Commissioner may from time to time prescribe by standing orders made under section 35 of this Ordinance

(6) Every police officer shall be deemed to be on duty at all times.

11. (1) No person appointed to the Force, other than by promotion within the Force, shall enter upon the duties of his office, or act in any way in connection therewith, before he has taken the following oath:—

"I solemnly swear/affirm that I will bear true faith and allegiance to the people and the Republic of Malta and its Constitution and that I will faithfully serve the said Republic during my service in the Malta Police Force; that I will subject myself to all Acts, Ordinances, orders and regulations relating to the said force now in force or which may from time to time be in force and will discharge all the duties of a police officer according to law, without fear or favour, affection or ill will. (So help me God)."

(2) The oath prescribed in subsection (1) shall be taken and signed by all officers appointed to the Force before a person duly empowered by law to administer an oath or before the Commissioner.

12. (1) No member of the Force shall be at liberty to resign from the Force or to withdraw himself from his duties in the Force unless expressly permitted to do so in writing by the Prime Minister

(2) Any member of the Force who wishes to resign nor withdraw himself from his duties shall give to the Prime Minister such notice, not exceeding thirty days, as the Prime Minister may require, of his intention to resign or withdraw himself from his duties, as the case may be.

(3) On the expiration of the notice given under subsection (2) the Prime Minister shall grant the member of the Force to whom the notice relates permission to resign or to withdraw himself from his duties, as the case may be, unless:—

(a) he is the subject of disciplinary proceedings which have not been determined; or

(b) he is charged with an offence triable by a court of criminal jurisdiction; or

(c) he has otherwise rendered himself liable to be dismissed or removed from the Force.

(4) Any member of the Force whose period of notice expires during the occurrence or apprehended occurrence of hostilities, internal disorder, or other grave emergency of any kind, may be retained and his service prolonged for such further period, not exceeding twelve months, as the Prime Minister may direct.

13. (1) It shall be lawful for the Prime Minister to remove from his office at any time a police officer who:—

(i) is considered unlikely to become, or has ceased to be, an efficient police officer;

(ii) is incapable by reason of some infirmity of mind or body of discharging the duties of his office when such infirmity is likely to be permanent; and

(iii) it is considered, having regard to the conditions of the Force,

the usefulness of the officer thereto, and all the circumstances of the case, should in the public interest no longer serve as a member of the Force.

(2) Deleted.

14 (1) When any police officer shall cease to hold and exercise his office he shall forthwith deliver up to such person and at such time and place as the Commissioner shall direct all arms, ammunition, accoutrements, uniforms and other clothing and equipment which have been supplied to him at the public expense and which he is directed by the Commissioner to return.

(2) The Commissioner may direct any person who has custody or possession of any of the articles mentioned in subsection (1) which were in the possession of a former police officer to deliver up such articles at such place and to such person as the Commissioner may appoint.

(3) Any person who refuses or fails to comply with a direction given by the Commissioner under subsection (1) or subsection (2) of this section shall be guilty of a criminal offence and shall be liable, on conviction, to imprisonment for a term not exceeding three months, or to a fine (multa) not exceeding £M100.

PART IV POWERS AND DUTIES

15. The Commissioner and every member of the Force shall, without fear or favour, exercise such powers and perform such duties as are by law conferred or imposed on police officers:

Provided that Sub-Inspector shall be vested with all such powers which under any law are conferred on police officers not below the rank of Inspector.

16. When any police officer shall cease to hold and exercise of his office all powers and authorities vested in him as a police officer shall cease.

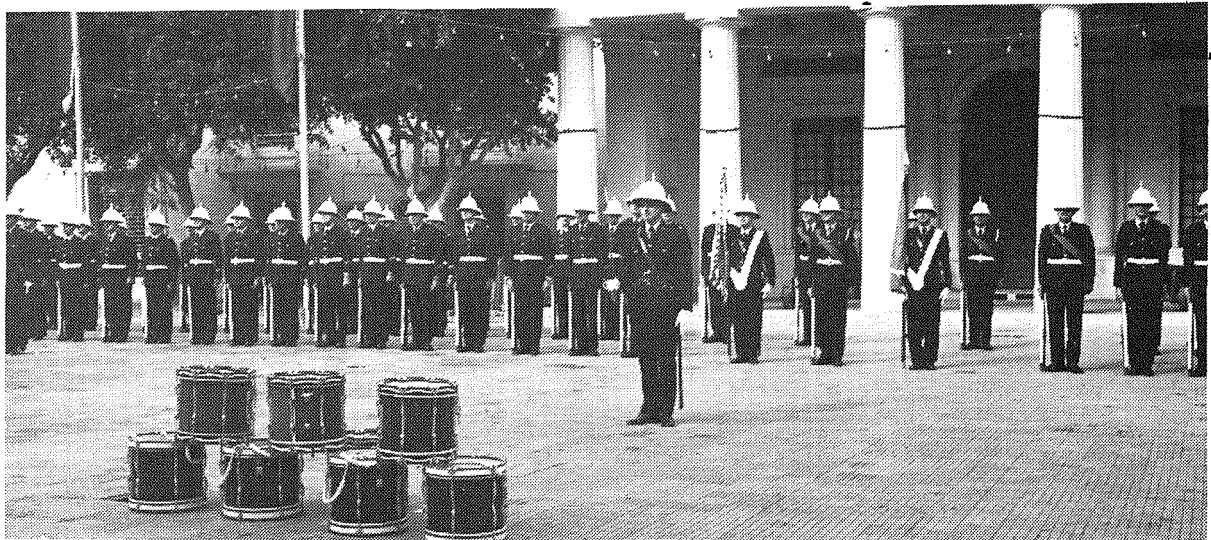

A TOURIST ASKS

THE UPPER BARRACCA

The Upper Barracca dates back to 1661 when part of the garden was covered. The roof, it is said, was removed in 1775 when it was discovered that the spot had been used by conspirators involved in what has become known as the "Revolt of the Priests". This aimed at the overthrow of Grand Master Ximenes and was led by one Don Gaetano Mannarino, who was subsequently imprisoned for life but released by Napoleon in 1798.

Among the memorials at the Upper Barracca are those of Vice-Admiral Sir Thomas Fremantle (1765-1819) a close associate of Nelson. The Australian port of Fremantle is named after his cousin, Admiral Sir Charles Fremantle, and his grandnephew, General Sir Arthur Fremantle, was Governor of Malta in 1893-99.

Also here is a memorial to Sir Thomas Maitland, Governor of Malta from 1813 to 1824; and Lord Strickland, Count della Catena, one-time Governor of New South Wales and Western Australia and Prime Minister of Malta from 1927 to 1933.

In the left-hand corner of the Barracca gardens is Les Gavroches, a dynamic group suggested by an incident in Victor Hugo's Les Misérables. It is one of the most important works of the distinguished Maltese sculptor Antonio Sciortino. In 1951, the sculptor's small bronze model was presented to the Queen by the Prime Minister of Malta.

The latest addition to the monuments of the Upper Barracca is a bronze bust of Winston Churchill (the work of Vincent Apap) presented to Sir Winston in 1955 by the people of Malta.
