MALTA DEVELOPMENT CORPORATION

The Malta Development Corporation invites sealed tenders for the supply of *CKD kits* for a period of three years to be assembled in Malta into Colour Television Sets. The kits must have at least 99 channels with a remote control incorporating at least 30 pre-programmable channels. The tuner shall be of the frequency synthesis type and the chassis should be of the "*cold*" type.

In submitting their tenders suppliers should bear in mind that great importance will be given in the adjudication stage both to the lift-up of *CTV sets* from Malta as well as to other forms of trade reciprocity.
