



## Is-Sewwa bil-Fatti

Kulhadd jemmen, u hekk għandu jkun, li għas-sewwa tal-istorja m'għandniex għalfejn niġbru lejn xawwatna. Ikun tajjeb li ninżgħu iż-żarbur li lbisna għal ghexieren ta' snin, u hekk ingarrbu u nilbsu żarbur ġdid. Iun kollu ta' xejn li nilbsu żarbur ġdid fuq dak qadim li ilna nterrqu bih. Għalhekk, se nagħmluha ċara li din hi l-ahħar kelma. L-ahħar kelma mhux ghaliex ma rridux nitkellmu aktar, iż-żda ghaliex inhossu li dan għandu jkun kapitlu magħluq u maqbul bejn kull min għandu rieda tajba.

Bħala soċjetà, il-Banda l-Unjoni ma ssib, u ma tara l-ebda xkiel li taħdem u tistinka 'l quddiem f'gieh l-arti mužikali u l-ghaqda fir-rahal ta' Hal Luqa. Biex thabrek f'kooperazzjoni shiha ha tara l-festa titolari f'gieh Sant'Andrija tikber u tisraq qlub anke l-barranin. Bħala soċjetà aħna dejjem hassejna d-dmir, u hekk għamilna u nibqgħu nagħmlu, li hadmu ma' kulhadd. Iż-żda llum wasal iż-żmien, meta kulhadd jaħseb li qal tiegħu li nagħmlu l-affarijiet ċari, mikxufa fuq il-mejda kif dejjem għamilna, dan għall-ġid tal-istorja.

Aħna, kull dokument li kellna hrignieh mingħajr biża' u ħabi. U hekk stennejna li jagħmel haddieħor, anke meta ersaqna lejh u ma kienx lest jghinna billi jurina dokumenti li tħalli. Issa wasal iż-żmien li ngħidu u nuru dak li rnexxielna nsibu, anke wara li ġie mitbugħ il-ktieb tas-soċjetà fis-sena 2005, bl-isem *Hal Luqa u l-Banda tagħha l-Unjoni*. Sa dakinhar l-għan tagħna kien li noħorġu l-istorja tas-soċjetà tagħna fl-isfond tal-iż-żvilupp tar-rahal ta' Hal Luqa. Storja li dejjem kienet konsistenti f'dak li ghedna jew ktibna.

B'dan ma jfissirx li dan li qed niktbu għandu jitqies biss bhala tkomplija ta' dan il-ktieb, iż-żda, bhala riċerka kontinwa biex jiġi stabbilit bl-aktar mod konkret u serju, l-argument li tqanqal minn haddieħor dwar liema kienet l-ewwel banda ġewwa r-rahal ta' Hal Luqa. Fehma, li sa ftit snin ilu meta bosta minn missirijietna kien għadhom hajjin, ġadd ma kelli dubju dwarha – ghax il-Banda L-Unjoni kienet magħrufa bħala l-ewwel banda Halluqja.

Dak li nkiteb fix-xogħol voluminuz *Hal Luqa u l-Banda tagħha l-Unjoni*, jidhrlna li ġie ikkritikat b'mod anonimu bl-aktar mod baxx, l-aktar fuq il-mezzi elettronici moderni. Aħna ftit li xejn tajna widen ta' dan. Aħna aktar tajna widen tal-kritici ta' veru li kitbu kliem ta' tifhir kemm dwar l-awtur kif ukoll dwar in-niġa tal-istorja nfista. Dawn żgur li ma kinu imxaqilba, iż-żda kitbu fuq dak li qraw fil-ktieb dwar l-istorja tal-Banda L-Unjoni.

Iż-żda, meta s-soċjetà l-ohra tar-rahal waslet biex hi wkoll toħroġ il-ktieb tagħha f'għeluq il-125 sena, bl-isem *L-Għaqda Mužikali Sant'Andrija - Twelidha u Gräjjietha* fl-2008, iggranfat ma' hwejjeg li lanqas huma dokumentati biex tikkritika l-pubblikazzjoni tal-Banda L-Unjoni. U terġa', biex bnew l-istorja tagħhom tal-bidu, ftit li xejn hemm referenzi, anzi l-parti l-kbira, l-ewlenin huma referenzi mingħajr bażi għax imsejsa fuq ghajd. Allura bilfors tithasseb u thewden, kif wara dak l-għażżeq kollu, ma johroġ xejn

solidu, dokumentat jew imsejjes fuq riċerka metikoluża.

Il-Banda l-ohra ta' Hal Luqa, jiġifieri mhux dik anzjana ta' L-Unjoni, daqqet ghall-ewwel darba fil-pubbliku nhar il-15 ta' Awissu 1884.

Dan m'ahniex nghiduh aħna, iżda nkiteb fil-ġurnal *The Malta News and Independent* ta' nhar l-Erbgħa 27 ta' Awissu 1884. Ghall-grazzja t'Alla, dan il-ġurnal ħadd ma skoprieh min-naha tal-Għaqda Mużikali Sant'Andrija għax kieku ma nafux jekk illum kienx ikollna din l-evidenza ċara u dokumentata. Ghall-benefiċċju ta' kulhadd, minbarra li se ngħibu kopja tal-paġna ta' dan il-ġurnal fejn hemm din il-ktiba, se naqilbu ghall-Malti dak li nkiteb bl-Ingliz. Il-kitba tghid hekk:

*"Waħda miż-żewwg Soċjetajiet ta' Casal Luca għamlet l-ewwel dehra fil-pubbliku nhar il-Ġimgħa wara nofs inħar tal-15 tax-xahar ġo Casal Asciack, ghall-festa tal-Madonna mtella' s-Sema; din is-soċjetà fil-preżent hija magħmula minn 16-il persuna. Xi tliet xhur ilu qabel ma kienu f'idejn id-direttur preżenti (il-magħrufis-Sur T. Galea) bilkemm kienu jafu jaqbdū strument b'idejhom, iżda minn mindu ilhom taħt idejn id-direttur preżenti, din għalkemm Banda żgħira, irnexxielha tesegwixxi dan il-programm:*

*Dan il-programm ġie esegwit b'mod eċċellenti minn dawn in-novizzi mužiċisti. Aħna sincerament u mill-qalb nixtiequlhom progress u succcess. Ix-xewqat tagħna ma jistgħux ifallu dment li jinsabu f'idejn Surmast tant magħruf."*

Meta ltqajna ma' din il-kitba, m'emminniex li għamilna xi sejba kbira. Hassejna biss li din il-kitba hija dokument awtentiku li jikkommemora l-ewwel harġa ta' 16-il alliev, li donnhom lanqas kellhom isem ta' Banda. Jew forsi kien għadhom ma nghatawxi il-permess li jagħmlu użu mill-istess isem tal-qaddis fl-isem tas-Soċjetà? Fuq kolloq lanqas daqqew f'rahħalhom. Insomma, kienet Soċjetà żgħira li rnexxielha tiġib lejha Surmast tant bravu, is-Sur Tommaso Galea biex fi żmien tliet xhur ħarġu jdoqqu fil-pubbliku ġo Hal Ghaxaq għall-festa ta' Santa Marija.

Iżda f'din il-kitba hemm stqarrija oħra, xhieda qawwija li l-Banda L-Unjoni kienet digħi stabbilita u magħrufa. Ghaliex hawn, iswed fuq l-abjad inkiteb *one of the two Philharmonic Societies of Casal Luca*. Allura kienu digħi tnejn, u t-tieni wahda, dik li magħad saret Banda Sant'Andrija xirfet barra ghall-ewwel darba nhar il-15 ta' Awissu 1884, ghax l-ohra L'Unione kien ilha ddoqq.

Imma żomm fit, dawn il-bravi bandisti novizzi wkoll fi tliet xhur irnexxielhom jitgħallmu nofs tużżana marċi? U hawn il-mohħ ġera lura lejn il-ġrajjha tal-Banda L-Unjoni, u ftakarna fl-ittra ta' Wieħed Luki li dehret f'paġna 3, fil-ġurnal *Il-Habbar Malti* tad-19 ta' Diċembru 1883.

F'dik il-kitba, dan il-Wieħed Luki ftakar u stagħġeb kif dawk il-bandisti rnexxielhom johorġu jdoqqu wara tliet xhur studju biss! Allura, min kiteb fil-ġurnal *The Malta News*

*and Independent* kważi sena wara, kellu wkoll, jew hass il-bżonn li jfahhar din il-banda ġdida li wkoll harget iddoqq fil-pubbliku *wara tliet xhur!* Iżda fil-kitba tagħna dwar l-istorja tal-Banda L-Unjoni, iżda wkoll dan il-paragrafu, li fid-dawl ta' llum naraw li jagħmel aktar sens minn qatt qabel, u nifhmu ahjar ghaliex kien hemm dik l-ġħira u mibegħda. Fl-istess ittra, Wieħed Luki kompla hekk:

*"Kien xieraq iżda li kulħadd jagħmlilhom fit tal-kuraġġ lil dawn iż-żgħażagh hekk ta' ħila. li biex jagħtu gost qiegħdin jagħmlu dmirhom kollu, imma huma ma jarawx ħlief zebleiħ minn min imissu fl-erbat ijiem li għandu x-xorti jismagħhom u jgħinhom b'qalbu kollha biex jgħaddu 'l quddiem."*

Fil-ktieb tal-Banda L-Unjoni, slitna din il-parti ghaliex bassarna, mhux hrafa ta' Esopu kif kien hemm min kiteb, iżda li veru ġo Hal Luqa kien hemm ġħira u tfixxil kbir għal dawn l-ewwel bandisti ta' L-Unjoni. Bir-raġun kif kiteb l-awtur tal-ittra, dawn il-bandisti rċevel żebleiħ! Illum, jidher aktar ċar minn qatt qabel. L-ewwelnett ghaliex dawn kienu jsawru l-ewwel banda minn meta seħħet il-firda, u allura kienu l-unika banda Halluqija. It-tieninett ghaliex dawn il-bandisti kienu qed idoqqu fir-raħal ta' Hal Luqa, meta kien waqa' ffit tas-skiet wara l-firda u bdiet tiġġedded l-ewwel banda mharrga mis-Surmast Vincenzo Camilleri, mghejjun minn ibnu Gavino. Illum, din ir-rabja tinfiehem aktar ghax fejn il-banda L-Unjoni esegwiet programm ghall-ewwel darba ġo Hal Luqa, it-tieni banda li harget minn Hal Luqa ma daqqitx fl-ewwel ħarġa tagħha fil-pubbliku f'Hal Luqa, iżda bogħod minn darha, ġo Hal Ghaxaq. B'din is-sejba jinkixef ukoll li l-Banda Sant'Andrija mhux veru daqqet f'Dicembru 1883 għall-quddiesa tal-qassis Dun Mifsud kif jgħidu xi whud.

Issa ejjew inkomplu nressqu l-bċejjeċ lejn xulxin biex hekk nibnu l-istampa ta' x'tassew ġara mill-fatti li għandna f'idejna. F'din l-ittra tal-ġurnal *Il-Habbar Malti*. *Wieħed Luki*, jfakkar u jfahhar il-ġraja ta' nhar il-Hadd 9 ta' Dicembru 1883 meta saret il-festa tal-istatwa tal-Kunċizzjoni tal-Misrah li ġewwa Hal Luqa kienhemm devozzjoni kbira lejha. U jghidilna li f'din il-festa, Il-Halluquin kellhom ix-xorti jisimghu l-ewwel darba l-banda l-ġdida tagħhom, banda li b'ħila kbira, taħt it-treġija taż-żagħżugħ Gravino Camilleri, marret tajjeb hafna. Għal darb'ohra, fl-ittra ta' sena wara naraw xebħi iehor ghaliex, l-isem tal-banda ma ssemmiex, u ssema' biss is-surmast Tommaso Galea.

Issuktajna bir-riċerka tagħna, ghax emminna li xi mkien għandu jkun hemm dokument li jsaħħah dak li digħi kellna f'idejna. Emminna, li jekk kienhemm min għal xi raġuni warrab jew ċahhad lill-pubbliku minn ġertu tagħrif siewi li jitfa' dawl fejn sa llum kellna d-dlam, xi haġa harbitlu. Lilna ghajruna li ma konniex serji fir-riċerka, li l-istorja hi dixxiplina li tistrieh fuq l-evidenza u d-dokumentazzjoni... li l-ghajdut, ix-xniegħat, u s-suppożizzjonijiet mhumiex fl-aġenda tal-istoriku... ecc. Hekk kitbu fil-ktieb annwali tal-Għaqda Mužikali Sant'Andrija tal-2006 f'paġna 173.

S'issa digħi urejna bil-kitba li dehret nhar is-27 ta' Awissu 1884 kemm aħna serji u kemm infittxu. Huma, li jippretduha ta' serji u bravi, ghax *tas-Surtun* allura jridu jgħallmu lil haddieħor, jew ma fittxewx jew inkella riedu jaħbu, ghaliex fil-ktieb tal-Ġħaqda Mužikali Sant'Andrija mahruġ fl-2008 ma sibna l-ebda referenza għal din il-kitba. U wkoll, ma sibna l-ebda referenza dwar din it-tieni prova li se nressqu, li tkompli tissustanzja li **I-Ġħaqda Mužikali Sant'Andrija kienet it-tieni banda ġewwa Hal Luqa mwielda fl-1884.**

Mela, fil-ħarġa tal-ġurnal *The Malta News and Independent* ta' nhar l-Erbgha 3 ta'

Settembru 1884, harġet ahbar ohra li kompliet tqawwielna qalbna li konna sibna tarf il-kobba li xi whud xtaqu li tibqa' mħabbla. Fi-paġna mal-editorjal reġa' kien hemm artiku żgħir iżda mimli b'aktar dettalji, lifih inkiteb hekk. U hawn se nerġgħu nipproduċu din il-kitba bil-Malti biex kulhadd jifhem sew:

*"Is-Soċjetà Filarmonika Sant'Andrija ta' Casal Luca, taħt id-direzzjoni Mužikali tas-Sur T. Galea għamlet it-tieni wirja tagħha fil-pubbliku f'dak ir-raħal nhar il-Hadd wora nofs inħar nhar il-31 ta' Awissu, u daqqet il-programm li ġej:*

*Hafna rġiel u professuri tal-Mužika li ncetaw prezenti qalulna li dan il-programm ġie esegwit ferm tajjeb. Hafna tifħir huwa dovut lill-mexxej tagħhom, għaż-żelu u l-enerġija li bihom irnexxielu fi żmien tant qasir, igib lil dawn il-ħaddiema (workmen) kapaci jdoqqu l-programm li semmejna. Aħna ġejna mgħarrfa li s-Sur T. Galea qed iħejji programm ferm iż-żed diffiċċi għall-wirja li jmiss. Grazzi ħafna lis-Sur T. Galea u l-ġabrab ta' studenti tiegħi."*

X'naraw u x'nitghallmu minn din it-tieni kitba, jew ahbar? L-ewwel haġa hi li għandna konferma li din hi t-tieni darba li harġet iddoqq is-Soċjetà Filarmonika Sant'Andrija, u li allura l-ewwel ahbar fil-ġurnal tas-27 ta' Awissu 1884 kienet b'referenza ghall-istess banda. It-tieni li f'din l-okkażjoni, il-banda Sant'Andrija daqqet il-marċi li esegwiet l-ewwel darba, u żiedu tliet marċi oħra jidher, dejjem jekk il-Marcia - Casino S. Andrea ma kinitx l-istess Marcia li fethu l-programm biha fl-ewwel harġa! Ghax allura jigi li fit-tieni harġa daqqew dawk tal-ewwel darba u żewġ marċi oħra jidher.

Barra minn dan, tidher haġa ohra li mill-ewwel hsibna fiha, iżda meta terġa' taqra din il-kitba tidher ferm aktar qawwija u čara. L-imsieħba fis-Soċjetà Sant'Andrija kellhom seba' mitt għenn biex juru li jeżistu. Kellhom ġenn akbar li jdoqqu f'pajjiżhom, jiġifieri Hal Luqa, u hekk forsi wkoll, biex jagħtu risposta lill-avversarji tagħhom.

Dan għaliex daqqew f'Hal Luqa nhar il-31 ta' Awissu, jiġifieri sittax-il ġurnata wara li daqqew f'Hal Ghaxaq. U l-ġurnata jidher li kienet fl-okkażjoni tal-festa taċ-Ċintura. Biex inkunu ġusti mal-istorja rridu nghidu li l-ġurnal Malta tat-3 ta' Diċembru 1884 qal li daqqew is-Sibt u l-Hadd. Imma allura kif dan l-awtur li kiteb b'tant tifħir fil-Malta News and Independent ma semmiex li daqqew lejliet il-festa wkoll. Jekk xejn, dan jurina l-ghatx u n-nuqqas ta' tagħrif dokumentat min-naħha tas-Sur Ciappara kif ukoll mill-awtur Jesmond Grech li la rriċerkaw u lanqas ivverifikaw - anzi kitbu fuq dak li semgħu.

Dan it-tagħrif ikompli jtella' aktar żejt f'wiċċi l-ilma. Jidher li sa dik is-sena l-festa tal-Madonna taċ-Ċintura ma kinitx tiġi cċelebrata daqshekk bil-kbir. U għalhekk il-Banda Sant'Andrija setgħet iddoqq mingħajr inkwiet, aktar u aktar meta l-prokuratur tagħha kien Ĝużeppi Micallef. Iżda s-sena ta' wara l-1885 inqala' l-inkwiet għaliex bhala l-ewwel banda u l-aktar banda anzjana, il-Banda L'Unione applikat u nghatat il-permess iddoqq

copy, county Sligo, and was at present under a charge of conspiracy to murder. He had pleaded guilty to that charge, and had been sentenced to death. He recollects being asked to join the Fenian organisation seven or eight years ago, when he lived at Tabbencarry. A man named Pat Moran took him to a public-house, where he was sworn in. The oath was to be loyal to the Irish Republic, to obey its superior officers, and to take up arms. This was upon Sunday, and at once at Tabbenecarry. Durkin, who was with him, and pointed out Daly to him. witness afterwards saw Daly in company with a man named Pat Sheridan, who told witness that he was organizing the west of Ireland. Witness saw Daly five or six times after that. On April last witness was arrested at Tabbenecarry for conspiracy to murder. Although he pleaded guilty he had not yet been sentenced.

During the trial of Moran's evidence, Daly was in a very excited state, and as soon as the Attorney-General resumed his seat he jumped up hurriedly, and glancing sharply at Moran, said:

"Then you are the Irish informer we have heard about coming even to prove so much. You are, then, an informer."

Witness: "I give evidence."

"You joined the Fenian Brotherhood of your own free will. What did you do with the Invincibles?"

"Committed outrages with them, by order of our superior officers."

Daly (shouting): "You swore their liberties away, you refused; and you are brought here now."

The Judge: "You really must not address the witness thus."

Daly: "I beg your pardon, but I am excited. I will not repeat it. (To witness:) How many rebels now in the grave did you see?"

"None."—What has happened to the men you swore, apolitical?—They are waiting their trial."

of the Government will be called to the necessity of enacting permanent regulations on the subject of quarantine, and of reorganizing the medical department of the Island, with the view of preventing, as much as may be found practicable, the introduction and progress of that disease, with all its attendant misery and death.

The Courts of Law should also engage the attention of the government and the Council, but above all the Government, the elected members and the press should keep an eye on what is going on in the Contract Department.

Before concluding we wish to say one word with reference to the water supply. Some years ago a plan had been proposed for removing all rubbish from the principal valleys in the Island, and constructing fences across those valleys, and at suitable distances, in order to prevent soil, rubbish, stones etc., from being carried to the sea, and filling up the several harbours, thus making their periodical dredging imperatively necessary.

It is to be hoped that this useful plan will not be abandoned, unless it is intended to keep the dredging machines constantly at work. The quantity of materials carried to the sea during the rainy seasons is said to be immense; and it will not take many years to completely fill our harbours, unless proper measures be taken to prevent the accumulation of such materials in the several valleys, and their being carried by the floods into the sea.

Anzi l-festa taċ-Ċintura f'Hal Luqa f'Awissu 1885 kibret bis-saħħha ta' L'Unione tant li żanżan innu f'gieħ il-Madonna b'mužika ta' Ferdinando Camilleri u versi tal-Halluqi Frangisk Azzopardi, u kor tat-tfal kanta mal-band! Ta' min jinnota li mill-1886 u fis-snin ta' wara għal taċ-Ċintura dejjem daqqet biss il-Banda *L-Unjoni*. Galea.**

B'hekk, dak li ilu jintqal u jinkiteb b'mod konsistenti għal dawn l-ahħar sittin sena jew aktar li l-Banda l-Unjoni taf għeruqha fis-sena 1880 u m'hemm l-ebda dubju li l-Banda Unjoni hija l-ewlenija u l-aktar anzjana f'Hal Luqa.
