## Kompetizzjoni ta' Disinn ta' Bolli

Il-Postmaster General iġharraf illi l-European Conference of Postal and Telecommunications Administrations (C.E.P.T.) stiednet lill-Amministrazzjoni Postali ta' Malta biex tiehu sehem f'kompetizzjoni miftuħa għall-Amministrazzjonijiet membri għall-għażla tad-disinn għall-bolli tal-pustaġġ ta' l-Europa 1984.

2. Iz-żewġ disinni li se jiġu sottomessi mid-Dipartiment tal-Posta se jiġu magħżula wara kompetizzjoni pubblika ta' disinn ta' bolli miftuħa biss għal ċittadini Maltin. Il-kompetitur jew kompetituri rebbieħa jistgħu, għalhekk jiġu mitluba biex juru xhieda ta' ċittadinanza Maltija. Il-kompetituri li joqogħdu barra minn Malta għandhom jipprezentaw din ix-xhieda flimkien mad-dettalji mitluba fil-paragrafu 6 ta' dan l-avviż u jissottomettuhom kif jingħad fl-istess paragrafu.

3. Il-kompetituri jistgħu jibagħtu aktar minn disinn wieħed. Kull disinn għandu jirrapprezenta b'mod astratt il-koperazzjoni Ewropeja fix-xogħol postali u tat-telekomunikazzjoni. Id-disinn għandu jagħti, kemm jista' jkun possibbli, l-idea tas-sugġett ma' l-ewwel daqqa t'għajn. Jekk it-tema tad-disinn tkun maħsuba biex turi l-P.T.T., kemm il-posta kif ukoll it-telekomunikazzjonijiet għandhom jidhru fid-disinn. Kull disinn, madankollu, għandu ikun oriġinali fil-kunċett u adattat biex jiġi riprodott kollu kemm hu fuq il-bolli proposti mix-xogħol oriġinali ta' l-arti. Disinni li jirrapprezentaw jew li jinkludu mappi u disinni inkullati jew maħduma fuq il-kartun ma jiġux ikkunsidrati. Ma' kull disinn għandha tintbagħat deskrizzjoni fil-qosor ta' l-ideat u l-intenzjonijiet tal-kompetitur.

4. Id-daqs ta' kull disinn għandu jkun sitt darbiet il-qisim tad-daqs tal-bolla proposta. It-titlu territorjali, il-valur u l-emblema tas-C.E.P.T. għandhom isiru fuq kull disinn fuq *overlay* trasparenti separata. Kull disinn għandu jiġi sottomess fuq folji sfużi tal-għamla A4.

5. Kull disinn mibgħut għall-kompetizzjoni għandu jkollu *nom-de-plume* li għandu jinkiteb fuq in-naħa ta' wara tad-disinn. Marki oħra ta' identità fuq id-disinn jew fuq il-*cover* jeskludu awtomatikament id-disinn milli jiġi ikkunsidrat. Jekk jintbagħtu aktar minn disinn wieħed mill-istess kompetitur, għandu jintuza *nom-de-plume* differenti għal kull disinn. In-*nom-de-plume* mgħandux ikun tali li jindika l-isem jew l-identità tal-kompetitur b'xi mod, ikun kif ikun.

## DEPARTMENT OF POSTS

## Stamp Design Competition

The Postmaster General notifies that the European Conference of Postal and Telecommunications Administrations (C.E.P.T.) has invited the Postal Administration of Malta to participate in a competition open to member Administrations for the selection of the design for the 1984 Europa postage stamps.

2. The two designs which will be submitted by the Department of Posts will be selected after a public stamp design competition open only to Maltese citizens. The successful competitor or competitors may, therefore, be asked to produce evidence of Maltese citizenship. Competitors residing abroad must produce this evidence together with the particulars requested in paragraph 6 of this notice and to submit them as stated therein.

3. Competitors may submit more than one design. Each design should represent in an abstract manner European co-operation in postal and telecommunication work. The design should evoke, as much as possible, the idea of the subject at first glance. If the theme of the design is intended to evoke the P.T.T., posts and telecommunications should both be depicted. Each design should, however, be original in concept and suitable for full reproduction on the proposed stamps from the original artwork. Designs representing or including maps and designs pasted or executed on hardboard will not be considered. Each design must be accompanied by a brief description of the ideas and intentions of the competitor.

4. The size of each design must be six times the dimensions of the intended stamp size. The territorial title, the value tablet and the C.E.P.T. emblem must be carried on each design on a detachable transparent overlay. Each design must be submitted on loose A4 format sheets.

5. Each design submitted in the competition must bear a *nom-de-plume* which should be inscribed on the back of the design. Other identity marks on the design or on the cover thereof will automatically exclude the design from being considered. If more than one design is submitted by the same competitor, a different *nom-de-plume* is to be used on each design. The *nom-de-plume* must not be such as to indicate the name or identity of the competitor in any way whatsoever.

6. Id-disinni għandhom jiġu konsenjati lill-Uffiċjal inkarigat mir-*Registry*, Uffiċċju Generali tal-Posta, Auberge d'Italie, Triq il-Merkanti, Valletta, mhux aktar tard mill-5.00 p.m. ta' nhar it-Tnejn, il-11 ta' Jannar, 1982, magħluqa f'*envelope* issigillat u markat fir-rokna tan-naħa t'isfel tax-xellug "Kompetizzjoni għal Disinn ta' Bolli". Mhux aktar tard mid-data u l-ħin speċifikati f'dan il-paragrafu, kull kompetitur għandu jibgħat ukoll ismu sħiħ u l-indirizz tiegħu, b'indikazzjoni tan-*nom-de-plume* magħżul minnu, f'*envelope* magħluq ieħor, indirizzat lis-Segretarju, Ministeru ta' l-Iżvilupp, Energija, Port u Telekomunikazzjonijiet, Auberge de Castille, Valletta, u markat "Kompetizzjoni għal Disinn ta' Bolli".

7. L-għażla tad-disinni ssir mill-Ministru ta' l-Iżvilupp, Energija, Port u Telekomunikazzjonijiet wara konsultazzjoni mal-Bord Konsultativ dwar id-Disinn tal-Bolli. Id-deċiżjoni tal-Ministru tkun finali.

8. Id-disinni magħżula wara jiġu ġudikati, flimkien mad-disinni mibgħuta minn Amministrazzjonijiet Postali oħra, mill-Kummissjoni Postali tas-C.E.P.T.

9. L-artist tad-disinn li jintagħżel fl-aħħar mill-Kummissjoni Postali tas-C.E.P.T. jingħata premju fi flus ta' 5,000 frank tad-deheb (bejn wieħed u ieħor £M740).

10. Il-kompetitur jew kompetituri li d-disinni tagħhom jintagħżlu biex jintbagħtu lis-C.E.P.T. għall-għażla finali għandhom jirrinunzjaw id-dritt tagħhom ta' awtur tad-disinn jew disinni favur id-Dipartiment tal-Posta. Dan id-dritt ta' awtur għandu jiġi rinunzjat ukoll favur l-Amministrazzjonijiet membri kollha tas-C.E.P.T. fil-każ li d-disinn jew disinni jiġu magħżula biex jiġu riprodotti fuq il-bolli proposti tas-C.E.P.T.

11. Id-disinni tal-bolli mibgħuta jistgħu jkunu għall-wiri fl-Uffiċċju Generali tal-Posta f'dawk id-dati u matul dawk il-ħinijiet li jista' jordna l-*Postmaster General*.

12. Jekk xi kompetitur jonqos li josserva xi waħda mill-kondizzjonijiet imsemmija hawn fuq, jista' jiġi skwalifikat mill-kompetizzjoni.

13. Aktar tagħrif dwar din il-kompetizzjoni jista' jinkiseb minghand is-Segretarju tal-*Postmaster General*, Uffiċċju Generali tal-Posta, Auberge d'Italie, Triq il-Merkanti, Valletta. (Telefon Nru. 24421).

6. The designs must be delivered to the Officer i/c Registry, General Post Office, Auberge d'Italie, Merchants Street, Valletta, not later than 5.00 p.m. on Monday, 11th January, 1982, enclosed in a sealed envelope marked at the bottom left-hand corner "Stamp Design Competition". Not later than the date and time specified in this paragraph, each competitor shall also send in his full name and address, with an indication of the *nom-de-plume* adopted by him, in a separate sealed envelope, addressed to the Secretary, Ministry of Development, Energy, Port and Telecommunications, Auberge de Castille, Valletta, and marked "Stamp Design Competition".

7. The selection of the designs will be made by the Minister of Development, Energy, Port and Telecommunications after consultation with the Stamp Design Advisory Board. The decision of the Minister shall be final.

8. The designs selected will then be judged, along with the designs submitted by other Postal Administrations, by the C.E.P.T. Posts Commission.

9. The artist of the design finally selected by the C.E.P.T. Posts Commission will be awarded a cash prize of 5,000 gold francs (approximately £M740).

10. The competitor or competitors whose designs are selected for submission to C.E.P.T. for final selection must relinquish his or their copyright of the design or designs to the Department of Posts. Such copyright must also be relinquished in favour of all the member administrations of C.E.P.T. in case the design or designs are selected for reproduction on the proposed stamps by C.E.P.T.

11. The stamp designs submitted may be exhibited at the General Post Office on such dates and during such times as the *Postmaster General* may direct.

12. If a competitor fails to comply with any of the above conditions, he may be disqualified from the competition.
