## HENRIK IBSEN



HENRIK IBSEN

Id-dramm ta' Henrik Ibsen "DAR TA' PUPA" mhix play femminista kif jiddeduċu wisq hażin mili-isem tagħha, dawk kollha li qatt ma qrawha jew rawha; hija ma tittrattax fuq l-emanċipazzjoni tal-mara fis-soċjetà, xejn affattu!

F'din il-play, miktuba fl-1879, insibu żewġ drammi kbar: l-ewwel wieħed dak ta' Nora li wara bosta snin miżżewga, tinduna li kienet għexxet il-hin kollu ma bniedem li qatt ma għarraf x'inhija; u t-tieni dramm huwa ta' żewġha Torvald Helmer li għaliex dnub kontra s-soċjetà huwa akbar minn dnub kontra l-imħabba u l-familja.

Ibsen b'dan id-dramm tiegħu kkritika bl-aħrax il-ligijiet tad-dinja u ġerti fehmiet tas-soċjetà; b'din il-play huwa qanqal ferment kbir fl-Ewropa kollha u ssokta jqanqal aktar ferment bl-istess teżi li żamm b'qawwa akbar fid-dramm l-ieħor tiegħu GHOSTS — SPETTRI. Il-kritika kienet qawwija u d-drammaturgu norveġiż wieġeb għall-kritika mhux b'polemika fuq il-ġurnali, iżda bi dramm ieħor "An Enemy of the People" — "Il nemico del Popolo", li fihi wera d-deni kbir li jagħmlu lis-soċjetà dawk kollha li jaħbu il-mard tagħhom.

Ibsen twieled fi Skien, Norvegia, fl-20 ta' Marzu, 1828, u miet fl-1906; bid-drammi poderuži tiegħu għaddha ħajja mqanqla jeħodha kontra għamil u fehmiet ħażiena u ligijiet għaliex immorali. Id-drammi tiegħu kienu maqluba b'bosta ilsna u baqgħu u ghadhom isiru sal-lum mhux biss għaliex sbieħ u perfetti teknikament, iżda għaliex fihom huwa kkritika u jsostni teżżejjiet li għadhom ħajjin wara sittin sena.

# DAR TA' PUPA

## SYNOPSIS

Torvald Helmer has been married for eight years to Nora, who, although has proved herself a good wife and a devoted mother to their three children, yet has always been considered by her husband as a charming and extravagant plaything.

One Christmas eve, an old friend of Nora, Christine Linde, appears on the scene by paying a visit to the Helmers. During an intimate conversation with her best friend, Nora reveals to her that, soon after her marriage, she had borrowed a large sum of money from Krogstad, a money-lender, so that her husband could spend a year in Italy to regain his health. It was generally believed, at the time, that Nora had procured the money from her father whilst actually to obtain the loan, she had forged her father's signature on a document promising payment to Krogstad.


With the passing of time, Torvald has become the manager of the Bank where Krogstad is now employed. Torvald detests Krogstad and in order to dismiss him from the bank, offers his post to Christine. Krogstad becomes aware of this and threatens to expose Nora's forgery unless she intercedes with her husband to have him reinstated.


Nora discards Krogstad's threats as she is confident of her husband's love and understanding. However, she is bitterly disillusioned by her husband's behaviour when he receives a letter from Krogstad denouncing her as a forgerer.

A new development changes this awkward situation. Christine who was once engaged to Krogstad, promises to marry him. Krogstad is so pleased with this news that he repents by writing a letter to Nora returning, at the same time, the promissory note.

Torvald, satisfied now that the scandal is to remain a secret, forgets all the harsh words he has said to his wife and tries to make amends by telling Nora that between them everything is normal once more. But Nora is now fully aware of the real motive underlying her husband's attempt at reconciliation and, tired of being treated as a plaything, she decides to desert him in order to live a life on her own.


ANTOINETTE SOLER
