Intercultural dialogue in Malta: the way forward

The expression intercultural dialogue is becoming a popular buzz word, extensively used nowadays in the media to foster understanding between people sharing different cul-tures and/or religions. This year has been earmarked by the Euromed countries as the year of dialogue between cultures.

Through the creation of a Euro-Mediterranean partnership, the European Union desires that the people of Europe and the Mediterranean region open their doors for the encounter between cultures. The European Union has already shared such an idea when through a partnership with Mediterranean countries it created a foundation to foster dialogue among cultures. This Euromed Organisation, which took the name of the Anna Lindh Foundation (it was named after the assassinated Swedish minister of foreign affairs) is undertaking a number of initiatives in this direction, after having created what is known as a network of networks of NGO associations.

Malta is actively present in the operations of the foundation, both through the Foreign Ministry as well as through the head of network which is headed by the Mediterranean Institute at the University of

Malta.

To honour the need expressed by the European Union for culture exchange and the cultural richness which can be offered by diversity, the Anna Lindh Foundation and its members joined together in a campaign titled "1001 actions for Dialogue". The aim of this campaign is to help NGOs organise activities -aimed at fostering mutual comprehension, curiosity and knowledge among groups of different social and cultural background.

The Anna Lindh Foundation gave a "micro grant" to a number of associations in Malta, to organise cultural activities and events, aimed at fostering mutual understanding among cultures. Thursday, 22 May has been earmarked as the day during which a number of activities will be taking place all over Europe and the Mediterranean area to celebrate dialogue between cultures. As a result, Malta will be joining the other 37 members of the Anna Lindh Foundation by the organisation of a number of activities focused on music and theatrical activity as a way of promoting dialogue.

Five of the 16 members that make up the Malta Network will be organising a number or activities aimed at fostering the concept of dialogue among cultures. These include the Vittoriosa local council, St

James Cavalier, the Malta Intelligent Energy Management Agency, the Senglea local council and the Fondazzjoni Temi Zammit. The central theme of all these activities is the migratory experience and society, the valorisation of local artists and the vision of a common Mediterranean heritage.

The Mediterranean Institute, as the head of the Malta network, will be organising its own activities in the form of two musical concerts and seminar that will take place on 21 and 22 May. Taking advantage of its academic structure, the Mediterranean Institute will be organising a seminar tackling the intercultural dialogue and migration. The seminar will take place on campus between 2 and 4pm and will be diffused on the internet to all partner members.

Music will bring emotions of shared cultural heritage on the following day. The first concert will be at noon, at St James Cavalier, where mezzo soprano Claire Massa will sing operatic arias accompanied at the piano by Caroline Muscat. The concert starts at noon. Then, at the Sacristia Vaults, at the Waterfront, an evening concert is being organised featuring local and European by past and conter rary composers. The concert starts at 7.30pm. Entrance to all these activities is free of charge.

Manifesto for children: Poverty and social exclusion

The Office of the Commissioner for Children undertook a major project in 2007 and carried out extensive research to identify the present needs of children in Malta, in view of the 2008 general election. The manifesto project involved consultation with a wide range of professionals aiming to improve children's rights in crucial areas including family, justice, education, health, work, sport and culture and the environment Empowering children to express their views and opinions was a recurring principle emerging in all

areas. Owing to the wealth of information collected in the project, it was felt vital to follow up the manifesto with a series of public discussions. The first session, on poverty and social exclusion, will be held on 21 May, from 5,30 to 7.30pm at the Office

of the Commissioner for Children, 469, St Joseph High Road, Sta Venera. Following a 15-minute presentation by chairper son Charlene Mizzi, the floor will be open for a general discussion. Central to the debate will be questions that ask how many children in Malta experience poverty in Malta today? How does social

exclusion affect children? Does the labelling of very challenging behaviour, asylum seekers' children and unaccompanied minors, disabled children, children suffering from a mental illness, drug users and victims of domestic violence stigmatise children?

Is there consensus on the need to provide adequate safeguards to all children experiencing social exclu-sion and to establish a national policy on looked after children? This is an opportunity for children, authorities, NGOs, and the public to voice their opinions with and on behalf of children. Everyone is welcome.


