

BirdLife Malta has shortlisted 6 sites to be included in the European database on **Important Bird Areas**. The sites are:

Filfla: This familiar rocky offshore islet holds one of the largest known colonies of storm petrels in the Mediterranean, and has in fact been designated a Mediterranean Special Protected Area. It is also a breeding station for Cory's shearwater and yellowlegged gull. The islet is a nature reserve.

Ta' Cenć: The impressive sheer cliffs at Ta' Cenċ harbour the largest colony of Cory's shearwater in the Maltese islands, and the garigue surroundings hold most of the other breeding species, including blue rock thrush, corn bunting and spectacled warbler. The cliffs are threatened by major hotel expansion.

L-Irdum tal-Madonna: A stretch of cliffs along the L-Ahrax headland. It is a breeding station for Yelkouan shearwater. The area is threatened by the presence of hunters.


Buskett: the only sizeable, albeit artificial, grove of mature woodland in Malta, and therefore a magnet to incoming birds of prey, especially during the autumn migration. The wood is a bird sanctuary, but it is threatened by illegal shooting and major disturbance. **Ghadira:** a saltmarsh saved from the onslaught of development, and now a rare resting post for migrating waders. The area is a bird sanctuary and nature reserve.

Kemmuna: a windswept upper coralline island, a stronghold for blue rock thrush and short-toed lark. The island is a bird sanctuary, but it is threatened by development.

What is sadly certain is that birds were (and still are) being massacred. With the election game in full swing and law enforcement at a standstill - mustn't irk the precious voter, you know - this was only to be expected.

And once more birds foot the bill for our games - with their lives.

Day of the Watchers

On 28-29 September, 20,000 birdwatchers across Europe had their eyes set on migratory birds. BirdLife Malta members were among them, joining in the fun of the European Birdwatch 96.

Close to **1.7 million birds** were observed in 20 countries. Species included white-fronted geese in Finland, lesser spotted eagles in Bulgaria and sparrowhawks in Andorra.

In Malta 45 species were logged. Highlights included hundreds of migrating swallows and yellow wagtails. At Buskett a merlin (a rare falcon) conveniently perched on a wall metres from the birdwatchers' post. NTT network is giving BirdLife International US\$10 for every species seen.


Big job, small force


Throughout September BirdLife activists monitored the situation at Buskett, and were in continuous contact with the Administrative Law Enforcement (ALE) section of the Police, reporting law infringements. Such cooperation and the ALE's own surveillance of Buskett led to 13 arrests in September alone. And yet, there were several occasions on which dozens of hunters were killing raptors with impunity within the sanctuary.

Several members of the ALE are dedicated, but the section is pathetically understaffed. Furthermore, the small unit is overburdened with other duties - from coastal patrol to shutting down illegal farms. No wonder their piecemeal action is ineffectualon a large scale.

BirdLife has long insisted for a properly equipped enforcement section to deal exclusively with bird protection. A network of regional or local wardens will also go a long way to stem the destruction.

Meanwhile, BirdLife's appeal in last issue of BirdTalk brought in a number of reports which would otherwise have gone unnoticed. We thank those members who phoned in the info, and again urge you all to join this special 'neighborhood' watch. Here's the numbers again:





Osprey Delights

Feeding ospreys are more often associated with breathtaking scenes from television documentaries than with our humble reserves. Yet, last September an osprey gave a rare spectacle. Lured by mullet and eel at Ghadira, an osprey showed off its amazing hunting abilities to a group of lucky birdwatchers. The swoop, the dive, the catch, the lift, the dog-shake and the strong winging off! Heart-stopping!

Most osprevs that pass over Malta are inexperienced first year birds from Scandinavia making their maiden flight to Africa. Unfortunately many of these sturdy youngsters stop short of completing their journey. They fall victim to the macho Maltese shotgun. One danger their mother never prepared them for ...

Great Whites

Like oversize little egrets, great white herons are very rare and irregular visitors to our islands. In 50 years there have only been 40 local reports of this species. Yet in the short span of six days last September-October, no less than three specimens made separate stopovers for refuelling at Ghadira.

King's Country

BirdLife members who last September joined the European Birdwatch logged 2 kingfishers in just one afternoon at Is-Simar. Last month alone, more than 12 kingfishers graced the water's edge at this tiny but teeming wetland reserve.




