Nota Editorjali

Il-ħakma fuq pajjiżna matul diversi snin, wasslet biex Malta tkun involuta għal kemm-il darba f'kunflitti u gwerer internazzjonal. B'mod plawsibbli nistgħu nsemmu l-Assedju l-Kbir u t-Tieni Gwerra Dinjija, li fihom, sehem Malta hu rikonoxxut mad-dinja kollha. Ovvjament, biex jipparteċipa, pajjiżna ġtieg riżorsa ta' suldati li jkunu ppreparati u mħarrġa għal kulma jista' jinqala'. F'dan l-artiklu, Charles Farrugia jikteb dwar għadd ta' suldati Koppin u l-karriera tagħhom fi żminijiet li jeħduna 'I bogħod saħansitra għal aktar minn 150 sena ilu.

Matul is-sena 2014 diversi pajjiżi qed jikkommemoraw l-Ewwel Gwerra Dinjija u qed isiru diversi avvenimenti sabiex wieħed ifakkars dan l-anniversarju. Il-kelma gwerra tnissel swied il-qalb għaliex tissarraf f'imwiet ta' nies u f'tiġrif fiziku. Minkejja dan, il-gwerra hi element fil-ħajja umana li wieħed ma jistax jinjora. Marbut mal-gwerra hemm l-eluf ta' nies li jkunu fuq quddiem nett tal-azzjoni – dawk il-persun miktuba fil-militar. Kien b'dan f'moħħi li id-deċidejt li nitfa ftit dawl fuq kollezzjoni nteressanti li għandna fl-Arkivji Nazzjonali ta' fajls ta' suldati Maltin. F'dan l-artiklu ser niffukaw biss fuq suldati Koppin li kienu miktuba f'diversi riġmenti bħar Royal Malta Regiment of Militia. L-intenżjoni mhux ta' kulħadd kienet xorta. Kien hemm dawk li kienu jaraw f'dan il-pass professjoni li jridu jħaddnu, u għalhekk li wħud minnhom kibru f'din il-linjal u kellom karriera. Oħrajn kienu qed jaraw biss li jaqalghu xi-ħaġa tal-flus.

F'dan l-artiklu ser nelenka l-ismiċċiet u dettalji bažiċi li wieħed kien isib f'dawn ir-rekords. Tassebbi wieħed jgħid li wħud minnom fihom dettalji aktar minn oħrajn. Kull wieħed jirrappreżenta storja partikolari, u kull persuna tat kontribut, kbir jew zgħir, bil-hidma tiegħu. Ha nagħtu ħarsa lejn id-dettalji bażiċi ta' kull każ. Uħud mill-fajls jinkludu ferm aktar dettalji minn dak li qed nagħti jiena, iż-żejjur l-ispazju ma jippermettix

dan id-dettal.¹ Minkejja dan, l-iskop tal-artiklu hi wkoll li nhajru l-pubbliku jgawdi minn din il-minjiera ta' nformazzjoni li għandna maħżuna fl-arkivji tagħna.

In-numru tas-servizz kien 2798. Falzon kien ġuvni jgħix fid-dar numru 3, Triq Sant' Andrija u qabel mar suldat kien ġaddiem tal-id.
- Rosario Sacco, imlaqqam "Tal Contistabbi" kcellu 24 sena meta ngaġġa bħala suldat mar-Royal Malta Regiment of Militia fit-23 ta' Mejju 1897 għal 5 snin bin-numru 2799. Huwa beda bħala suldat imma fit-22 ta' Novembru tal-istess sena kien appuntat Lance Corporal u spiċċa s-servizz bħala Kapural, liema grad ingħata fl-1 ta' Frar 1898. The original document is a handwritten attestation form for the Royal Malta Fencible Regiment, Limited Service. It includes a title, a list of questions, and a section for the witness's signature. The document is dated January 1898 and signed by Emanuele Sacco.

12. Leonardo Vassallo, imlaqqam "Tal Balaks" minn Triq San Leonardu, kien haddiem tal-id miżżewweġ ta' 24 sena meta ngaġġa mar-Royal Malta Regiment of Militia fit-23 ta' Mejju 1897 u dam suldat sat-22 ta' Mejju 1906 meta fl-20 ta' Mejju 1902 reġa' ġedded l-ingaġġ tiegħu bin-numru 2857.

Leonardo Azzopardi, imlaqqam "Ta Custanz" kien jgħix fi Triq Leonardu u ta' 28 sena huwa ngaġġa mar-Royal Malta Regiment of Militia bin-numru 2941 nhar il-5 ta' Ĝunju 1897 għal ħames snin, imma kelli l-ingaġġ tiegħu imwaqqaf erba' xhurx wara, fil-31 ta' Ottubru 1897, minħabba li ma kienx suldat effiċjenti. Huwa kien ġaddiem tal-id, miżżewwiegħ u kelli żewġit itfal.





of Militia bin-numru 4127. Kien ġuvni, jgħix fi Triq Valletta, Numru 5 u kien ħaddiem tal-id. Spiċċa mis-servizz fit-28 ta' Settembru 1904, wara li temm il-kuntratt tiegħu ta' ħames snin. Kien mgħajjat għas-servizz mil-Logo-Sargent G Grasso.

26. Giuseppe Sacco, imlaqqam "Ta Sacco" kellu 17-il sena u 3 xhur meta ngaġġa bħala suldat mar-Royal Malta Regiment of Militia fit-18 ta' Mejju 1902. Huwa kien ġuvni u kien jaħdem bħala waiter. Sacco kien ingaġġat għal 5 snin imma wara sena u 359 jum, huwa ġareġ mis-servizz by purchase. In-numru tiegħu kien 4940. Aktar 'il quddiem, l-istess Giuseppe Sacco, li kien magħruf ukoll bħala "Tal-Pisatur" applika għall-passaport fit-2 ta' Frar 1920 bil-ħsieb li jmur Detroit u l-Istati Uniti.

27. Leonardo Callus, iben Pawlu mis-Siggiewi, kellu 15-il sena u 7 xhur u kien għadu student meta ngagħha bħala boy mar-Royal Malta Artillery fis-6 ta' Settembru 1886, bin-numru 1160. Ftit xhur wara, fit-22 ta' April 1887 huwa kien promoss għal trumbettier u kważi sentejn wara kien promoss għal gunner fil-15 ta' Frar 1889. Wara reġa ġie promoss għal membru tal-banda (bandsman) fit-28 ta' April 1892. Fl-istess sena, fis-6 ta' Settembru 1892 kien imħallas bir-rata ta' żewġ soldi (2d) għall-kondotta tajba

li kellu. Huwa spiċċa mis-servizz bħala gunner fis-6 ta' Settembru 1898 wara 12-il sena. Bħala certifikati, huwa ingħata certifikat tar-Raba' Klassi (4th class) fl-20 ta' Diċembru 1886 filwaqt li fid-19 ta' Marzu tal-1887 ingħata certifikat tat-tielet klassi (3rd class).

28. Giuseppe Callus, bin Paolo mis-Siggiewi, kien ħaddiem fil-ġebel qabel ma ngaġġa mar-Royal Malta Artillery fl-ġiet ta' 19-il sena u 10 xhur. Beda bħala gunner fil-22 ta' Novembru 1892 u spiċċa fil-21 ta' Novembru 1904, wara tħallax il-sena. Huwa ingħata miżata ta' sold (1d) minħabba li kellu kondotta tajba u meta ġie tħtasferit għar-Riserva huwa tħallas 21 lira u 5 xelini (£21.5s). In-numru tiegħu kien 1444.
29. Leonardo Farrugia, bin Saverio, kien ħaddiem tal-id u ta' 18-il sena ingaġġa bin-numru 1772 bħala gunner mar-Royal Malta Artillery fl-20 ta' Lulju 1896. Fl-20 ta' Lulju 1898 huwa tħallas sold (1d) tal-kondotta tajba li kellu u erba' snin wara, fl-20 ta' Lulju 1902 reġa' tħallas żewġ soldi (2d) għall-istess kondotta. Fl-istess data tal-1903, huwa ġie itħtasferit għar-Riserva u spiċċa mis-servizz nhar id-19 ta' Lulju 1908, tħallax il-sena wara li beda s-servizz militari tiegħu.

30. Luigi Lanfranco, bin Paolo minn Tas-Sliema, kien skrivan meta ta' 21 sena u 4 xhur ingaġġa mar-Royal Malta Regiment bin-numru 1531. Beda fil-21 ta' Novembru 1891 u wara 5 snin u 139 jum, fis-6 ta' April 1897, huwa qaleb mar-Royal Malta Artillery u ngħata n-numru 1962, minn fejn spicċa s-servizz tiegħu nhar is-16 ta' Ġunju 1897. Kien ta' kondotta tajba ħafna u meta spicċa ingħata s-somma ta' £8.

Konklużjoni

'il bogħod minn hekk. Qed iñħarsu biss lejn sezzjoni ta' nies fil-korpi militari u fuq medda ta' seklu wieħed.
