1. "Writing of the plague which scoured Rome in the second century, A.D., Dion Cassius, the Roman historian, relates, "Many died in another way, thru the practice of miscreants who, on being paid for it, communicated by small poisoned needles the horrid infection so extensively that no computation could be made of the number that perished. Our chronicles may describe in similar language the vaccinators who, by small poisoned bacnepoints, are spreading disease broadcast and sending to untimely grave thousands of innocent children". — DR. J. W. HODGE, M.D., Niagara Falls, N.Y. (U.S.A.)

3. 6. "The German Vaccine Commission reported 750 persons syphilized between 1880 and 1884, and OUTBREAKS OF SYPHILIS DUE TO VACCINATION (as well as leprosy, erysipelas and glandular blood-poisoning) Whenever the sores produced on cow or vaccinated child are effective sores says DR. HUBERT BOENS, of Charleroi, Belgium, the cow was found to have been attended by a groom having syphilitic sores on his hands. SIR THOMAS WATSON wrote: I can readily sympathise with, and even applaud a father who with the presumed dread of misgiving in his mind, is willing to submit to multiplied judicial penalties rather than expose his child to the risk of an infection so ghastly". — "THE NINETEENTH CENTURY, vol 111, p. 1806, June 1878).

7. "The real affinity of cow-pox is not to the small-pox, but to the great-pox, (syphilis)" — DR. CH. CREIGHTON, recognised in Encyclopedia Britannica to be the world's ablest authority on vaccination.

8. "Think of it! mothers and fathers who would bring up your daughters comely, chaste and pure, that your state or mu-

nicipality should place you under absolute compulsion to taint these maidens with the disease against which civilisation revolts", — J. M. PEEBLES, A.M., PH.D., M.D., (Vaccination is a Crime) An old friend of mine in Los Angeles.

9. "Continue gentlemen, to vaccinate if you choose, and because you make money by it, but never forget, pseudo-scientists and false physicians that you are, that while you sow vaccine among the people they reap the pox (syphilis). — DR. HUBERT BOENS of Charleroi, Belgium.

10. "A real and serious danger incurred in vaccination is that every individual is destined to undergo, one or several times in his life, the danger of vaccinal syphilis" — PROF. FOURNIER of Paris.

11. "Vaccination at the Hawaiian Islands has not only failed its purpose since 1864, but has resulted in the rapid and extensive spread of SYPHILIS, LEPROSY, and other diseases". DR. BRIGHAM, M.D., director of the famous Museum of Natural History at Honolulu, an eminent writer and one of my best friends.

12. "The Great-Pox (Syphilis) appeared in frightful form throughout Europe at the end of the sixteenth Century, with hideous eruptions, gland abscesses, destruction of tissues to the bone, and death or life-long suffering. This disease is still present in every community, often progressing beyond medical control. Incurred solely thru exposure to the syphilitic poison, when once established it is a life-long disfigurement and shame. Great-Pox was followed in after years by small-pox, a disorder comparatively so moderate in danger and disfigurement that it thus gained the milder appellation. A name, however which was given ignorantly and inapplicably, for small-pox (variola) has no kinship with syphilis the lifelong. Small-pox is an eruptive fever; after running its course it leaves the body. Modernly treated this malady seldom brings death or disfigurement, nor more of contagion than measles or scarlet fever. Compared with Syphilis the smaller disease constantly grows less to be feared.— DR. CHARLES FESSENDEN NICHOLS, M.D., Boston, Mass.

13. 'For over forty years, vaccination in its effort to protect from small-pox has been officially suspected of implanting the sores (chancres) of the great-pox (syphilis). If syphilis is thus transmitted, vaccination must altogether cease.' — DR. RICORD of Paris, whose authority in medical science is unquestioned. In 1863 Ricord accepted reluctantly and with repugnance the evidence which established the truth of the accusation, and "it is now acknowledged that every effective vaccination takes which of necessity begins with a sore closely resembling a syphilitic sore, or chancre, is, as in syphilis, liable to be followed by lifelong eruptions, loathsome ulcers, destruction by decay of the bones of the nose, etc., paralysis and cerebral and spinal disturbances typical of no other poison but that of syphilis. This is however, but little more than the verification of fears felt in Jenner's time and handed along thru a century of clinical experience, until the abuse smells to heaven and the highest of our authorities report that it is impossible to make an effective vaccination save from material infected either by human small-pox itself or by Syphilis'. In France, to Dr. Ricord's testimony is added that of DR. TROUSSEAU, of DR. AUZEAS TURENNE and of PROF. FOURNIER, who hold that vaccination can produce no characteristic sore, save from a syphilitic-poisoned quill.

14. "Our State Boards of Health compel by law the universal infection of the material above described. In addition to its probable contents of Syphilis, thousands of painful deaths caused by vaccination are now officially recorded from year to year, with the addresses of the patients and physicians. Samples of the vaccine material supplied by health-boards and dealers are shown by rival distributors to be loaded with unspeakable filth, for effective vaccine virus cannot be pure and the best endorsed glycerinated lymph is found to contain millions of colonies of bacteria." — DR. L. BADGER (U.S.A.)

15. DR. CHARLES CREIGHTON, the greatest epidemiologist in the world and considered by the Encyclopedia Britannica as the greatest authority on vaccination, testified before the British Royal Commission on Vaccination, when asked whether in his opinion vaccination affords any protection against small-pox : "IN MY OPINION IT AFFORDS NONE". (Second Report, minutes of Evidence, Q,5430, p. 179).

16. "Inoculation of Cow Pox does not have the least effect in affording immunity from the analogous disease in man, Syphilis,

and neither do Cow-Pox, Horse-Pox, Sheep-Pox, Cattle-Plague, or any other radically dissimilar disease exercise any specific protective power against Human Small-Pox"—EDGAR M. CROOKSHANK, M.B., Prof. of Comparative Pathology and Bacteriology in King's College, London. (*History and Pathology of Vaccination*, vol I, p. 464.)

17. "PROF. CROOKSHANK testified before the Royal British Commission on Vaccination (Q. II, 119) that we have no known test by which we could possibly distinguish between a lymph which was harmless and one which might be harmful to the extent of communicating Syphilis, and (Q. II, 126) that he did not know of any kind of test of any character whatever which he could apply to a lymph tube which would enable him to ascertain that it was harmful to the extent of communicating Syphilis". (*FOURTH REPORT, Minutes of Evidence*, p. 51.)

18. "I still maintain there is no scientific support for what is generally understood by vaccination, and that the practice is destined in more enlightened times to fall into desuetude"—DR. CROOKSHANK in the *LANCE*.

19. SIR WILLIAM J. COLLINS, M.D., and MR. PICTON have shown that symptoms indistinguishable from those of Syphilis and which have been hitherto regarded as characteristic and diagnostic have arisen when vaccination has been performed with matter derived from the Calf. (*BRITISH ROYAL COMMISSION ON VACCINATION, FINAL REPORT*, p. 201. Statement of Grounds of Dissent, paragraph 213).

20. "I can produce children of three different families, where scrofula was never heard of till they were vaccinated, but those necks are now a sad sight to see"—T. MACKENZIE, M.D., F.R.C.P. Edinburgh.

23. "Vaccination has stood for nearly one hundred years on three legs: theory; practice and profits. Now it is fast tottering to fall. The English know more of it than any other people. There it started, there it has been tested and studied, and there it is falling into desuetude". DR. E. B. FOOTE, JR., N. Y. City.

24. "Ordinary vaccinia, the name given by the vaccinists to the disease produced by vaccination, is a more severe disease than ordinary small pox. Severe vaccinia is a much more severe disease than severe small-pox, and often lasts throughout the life of the patient. Fatal small-pox is less to be dreaded than fatal vaccinia, because it is less painful and less lingering. John Pfaender, a child of sturdy Swiss parents was healthy until vaccinated, as were also his four brothers and sisters. He walked at the age of 9 months. He was vaccinated by the official vaccinator. Eight days later his feet began to swell, abscesses formed, his teeth began to rot, his glands to swell. Fistulous sores appeared on his hands and feet. When six years old he could neither walk nor stand; several of the bones of his hands had rotten out. It was such a case like this and the spirit of liberty, not yet dead in Switzerland, which led that freedom-loving people to reject on a Referendum the infamous system of blood-poisoning called vaccination, which a medical clique was seeking to impose upon them. When will the good sense, parental affection and love of liberty of Americans rise to the level of that of the brave burghers of Switzerland? There are thousands of such cases in this doctor-ridden land." — M. R. LEVERSON M. D., of New York.
