7. SEC Vocational Subjects

Appeals and Synoptic Assessment

The SEC regulations give the right to students to ask for a review of their Unit Assessment Mark. Registrations for an appeal will be accepted at the MATSEC Support Unit on Monday 3rd October and Tuesday 4th October from 8:30am - 12:00pm and from 1:30pm - 4:00pm. Students and their parents/guardians are informed of the mark obtained before the date of registration. Should a student decide to ask for a review of his/her assessment mark a fee of 35 euro is to be paid upon registration. This fee is refundable if a change in mark is recommended by the Board of Examiners following the review process. Students may also apply for a Synoptic Assessment if the total mark scored in the Unit is less than 50 marks. Application will be accepted on Monday 3rd October and Tuesday 4th October from 8:30am - 12:00pm and from 1:30pm - 4:00pm. The fee for the synoptic assessment is as follows: (i) a registration fee of 15 euro, and (ii) a subject fee of 21 euro. Students who were eligible for waiving of fees at the time of registration will have their fees waived. The synoptic assessment for all subjects is scheduled on the 1st November 2016. Further details will be communicated to students at a later date.

Students who missed the controlled assessment for a justifiable reason are also eligible to sit for the synoptic assessment. You are kindly requested to send the relevant reasons for such cases. Further information can be accessed through the following link: http://www.um.edu.mt/matsec/regulations/legalnotices/sec_regulations.

In the case of students failing a unit, the synoptic assessment will replace the mark of the whole unit provided that the mark obtained by the student in the synoptic assessment is higher than the original mark. The maximum mark that a student can obtain is that of 60%.

Registration of new students

Students who will start studying SEC Vocational subjects in Form 3 in the scholastic year 2016-2017 are to register with the MATSEC Support Unit. Registration for the SEC Vocational Subjects can only be done online through the following link: http://www.um.edu.mt/matsec/applyvoc between 10th - 19th October. A registration fee of 15 euro and a subject fee of 21 euro are to be paid upon registration (the registration fee will not need to be paid again should a candidate decide to register for other SEC subjects in MAY 2019 session). Payments can be settled online through major debit/credit cards or through a cheque payable to University of Malta. Payment is to be settled by the 19th October. Late and very late application fees will apply if students decide to register later than this date.

Candidates eligible for an exemption from examination fees are to register online and submit the relevant Waiving of Fees document to the MATSEC Support Unit by the 19th October. The form can be downloaded from

http://www.um.edu.mt/ data/assets/pdf file/0005/225419/Waiving of examination fees form.pdf. The form must be presented duly filled in and appropriately stamped and approved by the relevant Social Services Office at the time of registration.

External Verification visits and Controlled Assessments

External Verification visits will be carried out in the months of March and June 2017. During the March external verification visit, external verifiers will review Assignment 1 for students who are either in Form 3 or in Form 4. However they will review assignment 1 and assignment 2 for those students who are in Form 5. In the June external verification visit, external verifiers will review assignment 2 and the controlled assessment for students who are either in Form 3 or Form 4. The controlled assessment of students in Form 5 will be reviewed in the same month.

As per procedure external verifiers will communicate with the quality assurance nominee, teacher/s teaching the vocational subject and internal verifiers. It would be greatly if a quiet room with wifi access, master files and assignments are readily available for the verification visit. Teachers, internal verifiers and the quality assurance nominee should be available for feedback. The exact date when the external verifier will visit your school will be communicated at a later date.

The controlled assessments for students in Form 3 and Form 4 are going to be held in the beginning of June. The exact dates will be communicated at a later date. The date of the controlled assessment of students who are in Form 5 will be held in the week beginning 3rd April 2017.

8. Access Arrangements for Students following Vocational Subjects.

Form 3 students who wish to apply for access arrangements for the assessment of vocational subjects at SEC level need to apply by the end of January 2017 since the first controlled assessment will be held at the end of Form 3. Students who require access arrangements for Specific Learning Difficulties (SpLD) and/or AD(H)D and Dyspraxia will need to present a full psychological report based on tests made at any time during their education together with a literacy/assessment update carried out no earlier than the beginning of July 2016. Access arrangements granted on this basis will be given for all assessments, including SEC examinations for other subjects at Forms 4 and 5. Students who do not present an updated report will not be eligible for access arrangements.

A gentle reminder to students who presented a report in Form 3 with an assessment that was carried out prior to July 2015 that they have to present an updated literacy report by the end of October 2016.
