<u>Eligibility to vote:</u> All students enrolled at the International School for Foundation Studies during the current academic year.

Voting for these elections will take place on <u>Thursday 7 November, 2024</u> between 9:00 a.m. and **5:00** p.m.

An **ONLINE** election system will be used. On the day of the election, you will receive an e-mail on your University e-mail account with a link to vote. You can only vote once and your voting choices will remain anonymous.
